

FURNISH AND COE AGREE TO LET ALL LITIGATION DROP

Furnish Takes Over Bonds of
Two Companies and Coe
Retires; Stanfield Citizens
Rejoice.

(Special Dispatch to The Journal.)
Pendleton, Or., March 13.—The end of the famous Furnish-Coe controversy came this morning when the suit instituted by W. J. Furnish and his company against Henry W. Coe et al was dismissed. Following an agreement reached late Saturday night between the parties to the suit by which all differences were amicably settled. While the exact terms of the agreement are kept secret, the attorneys for both sides have given out a statement to the effect that W. J. Furnish takes possession of all the bonds of the Inland Irrigation company and of the Portland Ditch company, and that Henry W. Coe retires from all connection with both companies.

Coe Drops Damage Suit.
The settlement here carries with it, besides dismissal of suit in the local court, which asked for an accounting between Coe and the Inland Irrigation company, the dismissal of the two Portland suits also, one of which was the famous million-dollar damage suit instituted by Coe. All that yet remains to be done is the discharge of the receiver, E. J. Sommerville, who was appointed last month to take charge of the notes, contracts and other instruments relating to Coe's transactions as selling agent for the Portland interests. There is great rejoicing in Stanfield over the settlement of the controversy, as it has retarded the growth of that community by stagnating the movement of lands.

OLDS, WORTMAN & KING DEAL REQUIRES TIME

The sale of the Olds, Wortman & King store to Max and Aaron Holts will not be concluded in all its details until between June 1 and July 15. Before all the formalities can be attended to the entire stock must be inventoried and lease rights and other matters verified. A deal in real estate of \$3,000,000 to \$4,000,000, such as is represented in the purchase of the store, would require comparatively but a short time. But in buying a department store every article in the great stock must be gone over and the casting up of the total is a matter of great labor.
"Business Portland is flooding us with congratulations," said Max Holts this morning. "Everyone tells us a better transaction, from our point of view, could not have been made. We think they are right in this. Portland has given us a royal welcome and we are simply being inundated with good wishes."
"We made the purchase of the Olds, Wortman & King store in the middle of the spring season. Before the whole matter can be concluded and possession taken it will be necessary to inventory all the stock. That is the reason it will require so long to conclude all details. But in the meantime, we are glad we came to Portland, and glad we are going to stay."

ARTIST'S LONELY LIFE IS ENDED BY HIMSELF

A life of brooding, melancholy and loneliness has resulted in the death of Henry Epling of Portland, a landscape artist, who committed suicide probably last Friday evening on Council Crest. The dead body was found yesterday afternoon by Charles Begley, M. A. Henderson and O. J. Irving, while they were walking through the woods. A bullet hole over the right ear at the revolver were the mute evidence of the manner in which the life had been ended.
A note in the pocket stated: "This is a case of self-destruction." No reason was given for the act and none has been found. Epling was known to his friends and acquaintances as a morose character.
A letter addressed to his sister, Miss Mary Epling, 1187 Sanchez street, San Francisco, which was found in his pocket, stated that he was going to take an eternal sleep and expressed a wish that she have his property, but the property is not described.
A telegram from San Francisco this morning says relatives will arrive tomorrow to take charge of the body. Epling made a reputation with his paintings, most of which were landscapes, many local and near local views being included.

ST. JOHNS, 436 TO 16, VOTES FERRY BONDS

By the overwhelming majority of 436 to 16, St. Johns voted the bonds to purchase approaches to the ferry slip so that the approaches could be presented to the county, which agreed then to operate a free ferry. VALE'S NEW MAYOR IS PROGRESSIVE

Harry Flynn Is Youngest Man
Ever at Helm at "Last
Frontier City."

Vale, Or., March 13.—Harry Flynn was elected mayor of Vale last Monday in a spirited election, winning by nearly two to one over Thomas Jones of the Citizen's ticket. Mr. Flynn has the reputation of being the youngest mayor the "last frontier" city has ever elected to conduct its business affairs. He is 28 years of age, but one of the biggest boosters of Malheur county. Harry Flynn is an orchard man and has, during the past two years when he came to Vale from Fallside, Colo., been devoting his entire time to the development of the rich arid lands of this section.
His ability as a booster has been recognized by the local chamber of commerce, who a few weeks ago placed him on the board of directors, and on last Monday evening made him secretary of the important committee which is endeavoring at this time to entangle the Bully creek water rights that the project may be turned from the present owners to the Oregon and Western Colonization company.
Mr. Flynn is a member of the Flynn Land company of Vale, of the Flynn Lumber company of Brogan and Jamieson, the two new towns in whose development he has taken an active part since coming here two years ago. He is also a member of the Oregon Fruit Land Development company and of the Union Loan, Land & Trust company, which have extensive fruit holdings north of Vale in the Willow river valley, the former company owning the new townsite of Jamieson.
Vale's new mayor is a booster and as soon as the city charter can be revised will start to work on the improvement of the city streets and sidewalks.

ENDS 50 YEARS OF SERVICE IN ARMY

Major General Hodges, Who
Rose From Ranks, Goes
on Retired List.

Washington, March 13.—Major General Charles L. Hodges, for some time past in command of the department of the Lakes, was placed on the retired list for age today, leaving behind him a brilliant record of efficiency through a long career in the army. General Hodges was born in Providence, R. I., in 1847, and entered the army as a volunteer and a private in 1861, serving through the civil war. At the end of the war he was a sergeant major. In 1869 he entered the regular army service and has served continually in it since, becoming a brigadier general in 1907 and a major general last year. Prior to his transfer to Chicago General Hodges was in command of the department of Dakota, with headquarters at Bismarck, with headquarters at Bismarck.
The prospective retirement of General Hodges led to a vigorous contest in the early part of the winter for the vacant major-generalship. The contest was waged between friends of Brigadier General Arthur Murray, chief of Coast artillery, and Brigadier General Frederick Funston, who has headed the list of brigadier generals for several years. The contest ended in favor of General Murray, who consequently was advanced to the rank of major general today upon the retirement of General Hodges.
The new major general had an enviable record in the Philippines. He was colonel of the forty-third regiment of volunteers, which, according to the war department records, experienced service unexcelled in action by any other organization in either the Philippines or Cuba. Murray was sent to Samar and Leyte with the regiment in 1900. For 16 months he kept the insurgents in subjection and penetrated the interior, where even the Spanish had never ventured. His troops participated in 451 engagements, 381 of which were marked with casualties and captures.

JAPAN IS EXPECTED TO BECOME FACTOR IN TROUBLE TODAY

Washington, March 13.—Although no official has yet accepted the responsibility of being quoted, there is a growing sentiment today that the next few hours will produce developments that will cause Japan to loom up as an important factor in the army and navy mobilization in the Mexican trouble zone.
What the developments are likely to be is unknown, but the attitude of the attaches of the state and war departments indicates concern. It is rumored that Pacific coast reports tend to connect other forces than the Mexican government with the military demonstration.

SOLDIERS PROVOKE RIOT AT GALVESTON

On Leave, They Attack Mex-
icans and Colored People;
Troops Held in Camp.

(United Press Leased Wire.)
Galveston, Texas, March 13.—Galveston is under a form of martial law today as a result of soldier riots in the Mexican and negro sections of the city. In order to prevent a renewal of attacks on Mexican residents, 1200 soldiers are restricted to the camp and provost guards patrol the Mexican and negro quarters.
Colonel Bailey today cut down leaves of absence to 15 daily. Twenty-five soldiers are in the guard house, following yesterday's battle between soldiers and Mexicans and negroes, in which two houses were burned.
The riots started when the soldiers, on leave, entered the houses of Mexicans and negroes. Furniture was demolished, the occupants driven out and several buildings set on fire.
In a street fight that followed, Private Winfield Joel, 144th company of coast artillery, from Fort Moultrie, was stabbed in the side. He was the first patient to be taken to the military hospital.
Policeman Patrick Reagan and other patrolmen attempted to subdue the soldiers and several of them were knocked down by policemen's clubs. The fire department was called out but the riot was not quelled until Colonel Bailey and 50 picked men appeared. A military guard was then thrown about the disturbed sections.

400,000 JAPS WATCH AMERICAN AVIATORS

Osaka, Japan, March 13.—Prince Kuni Yoshi Kuni, grandson of the mikado, today complimented "Bud" Mars and Captain Thomas S. Baldwin, American aviators, who yesterday gave the first demonstration of aviation in Japan. The aviators made three flights before 400,000 people.

REPUBLICANS MOST CORRUPT, HE SAYS

Power Has Given Them More
Gold Than Democrats; As-
serts President Jordan.

Sacramento, March 13.—President David Starr Jordan of Stanford university sailed into political parties in general and the two dominant parties in particular while speaking on the topic, "The Needs of the Nation," before the Civic league here. He claimed that the Republican and the Democratic parties, as such meant nothing today.
"The Republican party has been bought most frequently because it has had most to give," he said.
He cited a quotation that "the Democratic party has often bowed down before the golden calf," and then said: "It never has obtained much, because it has not been able to offer reciprocal advantages."
"Personally, I have always voted a straight ticket by scratching off every crooked candidate to make my ballot straight."
President Jordan rapped the tariff and referred to a suit which he had paid \$16 for in England, on which he had to pay a high duty to get it through the New York custom house.
"The tariff is a method," said Dr. Jordan, "of separating most people from their money for the benefit of certain classes. This increases both the aggregate and the average of wealth in a community, but decreases the average wealth of those not in the privileged classes."

LAST ROAD TAKES BACK ITS SCHEDULE

Washington, March 13.—All schedules for advanced freight rates disallowed by the interstate commerce commission have been withdrawn. The last schedule was withdrawn today and a formal order of suspension will not now be necessary on the part of the commission.

O. N. G. OFFICERS GO ON GENERAL STAFF

White, Hammond, Welch and
Bowman Are Four Men
Assigned.

Adjutant General W. E. Finzer has issued a general order detailing four officers of the Oregon National Guard for duty on the general staff. The following are the officers named in the order: Colonel Samuel White, Judge advocate general; Major Creed C. Hammond, Fourth infantry; Captain Loren A. Bowman, Third infantry. The officers thus detailed are not relieved from duty with their respective commands.
General Finzer believes that the secretary of war will ultimately decide to send all National Guard officers, who desire to go to Texas to witness the army maneuvers now in progress along the Mexican frontier. Even if war comes and the National Guard of the various states is not called out, it is considered of incalculable benefit to the National Guard officers to go to the scene of hostilities. General Finzer believes that the war department will take that view of it and offer all guard officers the opportunity.
"Nearly every guard officer in the state has asked me to put his name on the list of officers to be sent to Texas," said the adjutant general. "I would like to go myself, and if hostilities break out I intend to go, whether the Oregon National Guard is called out or not."

DICKINSON POSTPONES TRIP TO PANAMA

New York, March 13.—Unexpected complications in negotiations pending between the Panama Railroad company and the steamship lines operating for the government were given this afternoon as the reason for the postponement of Secretary Dickinson's inspection trip to the Panama canal. Dickinson was scheduled to sail today. The war secretary emphatically declared that the Mexican situation had nothing to do with the change in his plans. He was unable to say when he would leave.

SUFFRAGETTES DIE; POLICE GET BLAME

London Women Plan Resort-
ing to Parliament to Ob-
tain Investigation.

(United Press Leased Wire.)
London, March 13.—Two deaths alleged to have been the result of brutality by the police in connection with the suffragette riots will result in representations to parliament, according to the members of the Women's Social and Political club. The home office has been asked to conduct an investigation of the police and if it should refuse to do so parliament will be asked to take action.
It is estimated that 135 women have suffered permanent injuries at the hands of the police.

COPIES OF PHILIPPINE TRADE ADDRESS ARRIVE

Copies of an address by Harold M. Pitt, chairman of the publicity committee of the Manila Merchants' association, to the honorary commissioners representing the Associated Chambers of Commerce of the Pacific Coast, delivered at the time the commissioners visited Manila a few months ago, have been received by the Portland Chamber of Commerce. The address touches upon trade conditions and relations between the islands and the states. Longer Life for the Broom

A little intelligent care will make quite a noticeable difference in the work a broom will do and the length of time it will wear.
