

### SOUND DISGUSTS THE SOUTHWEST; CANCEL BANQUET

#### Development Association Now Realizes Seattle Offers No Hope of Equitable Road Legislation for District.

(Special Dispatch to The Journal.) Seattle, April 21.—Disgusted with the division among Seattle business men regarding state road legislation, the executive council of the Southwest Washington Development association at Chehalis has decided there will be no banquet of 200 or more representatives of the 40 commercial clubs of the southwest part of the state to be held at Seattle April 27, as partly planned. The action was taken following a report of the situation in Seattle regarding the Pacific highway and other state road projects, made by Secretary J. A. Barnes after he attended the meeting here of the Pacific highway association. Assurances had been given southwest counties that Seattle had matters shaped for results at the proposed gathering of Seattle business men and those from the southwest part of the state.

Following the investigation the southwest business men were satisfied that Seattle's various factions were as wide apart as ever and that no earnest effort would be made to bring pressure on the legislative delegation of King county to provide satisfactory road legislation even if an extra session were convened, consequently the strained feeling still exists.

### TOWN TOPICS.

**Four Fined \$100 Each.**—Four fines of \$100 each were assessed this morning by Judge Tazewell in support of section 6 of the new liquor ordinance which provides that the possession of a government liquor license without a city license is conclusive proof that the holder is selling liquor unlawfully. The fines this morning were assessed against Peach Truelove, Irene Craig, Nora J. Wade and Anna Borglund. In each case notice of appeal was given and the cases will all be threshed out in the circuit court.

**Confesses Robbery; Insane.**—The police and detective department was thrown into a near panic last night when Albert C. Hardy walked into the station and announced that he was a fugitive from justice and wanted to give himself up. "Three years ago, at the point of a gun, several tramps compelled me to help them hold up a train between Minot and Wilson, South Dakota. They stole considerable money, but I did not receive any of the booty. The police have been searching for me ever since." He is insane.

**Sold Watered Milk; Fined.**—Theodore Schallenberg, who conducts a dairy near Beaverton, was fined \$75 by Judge Tazewell this morning for selling watered milk. The case was heard several weeks ago, but judgment was reserved until today. This is the fifth time that Schallenberg has been fined in the past five months. Four fines have been imposed for selling watered milk and the other was for selling milk from tuberculous cows.

**Charles McMurray Dead.**—Charles McMurray, a traveling salesman for the Irland Bros. lines manufacturers at New York city, died suddenly last night at the Hotel Oregon. His dead body was found in his room shortly after 6 o'clock by the maid. He was lying across his bed when found. Death was due to heart disease.

### STORK HALTS MOTHER'S TRIP TO PRISON CELL

(Special Dispatch to The Journal.) Vancouver, Wash., April 21.—Miss Sibyl Wolfe, convicted of larceny, friendless and submissive to her fate, was to have been taken to the penitentiary from the county jail this morning. She was not taken because shortly after midnight she became a mother.

The prison successfully concealed her condition from the officers and Judge McMaster had received no intimation of the new arrival when he passed sentence Wednesday. Miss Wolfe pleaded guilty and went stoically back to her cell in the jail to await the arrival of the woman guard who was to take her to the penitentiary. The guard, Mrs. Reed, came last night and was astounded today to find two prisoners instead of one.

Miss Wolfe's story is one of peculiar sadness. She is 25 years old and formerly taught school in Idaho. She came to Vancouver a few weeks ago and told a pitiful story to Mrs. D. McClane of 1012 West Thirteenth street. She was employed to work for her room and board, but on the following Monday took about \$200 worth of jewelry and clothing. She was arrested in Portland and returned here, entering a plea of guilty.

### MALHEUR PHONE LINES MAY BE CONSOLIDATED

(Special Dispatch to The Journal.) Ontario, Or., April 21.—H. S. Johnson of Vale, manager of the Malheur Independent Telephone company of that place, has secured an option on the Malheur Home Telephone and the Ontario Independent Telephone company, both of this place. The purpose is to merge these two companies and other independent companies in Malheur county. Mr. Johnson recently secured a franchise for a telephone system in Vale, and is conducting an exchange there in connection with the Bell toll line. In Ontario both the Bell and Independent toll lines will be reached through one switchboard if the present deal is concluded. Mr. Johnson guarantees to preserve all existing agreements as to free exchanges and to continue the present rentals and rates throughout the territory served by both lines concerned in the deal.

### MINISTER WITNESS IN VICE INQUIRY

#### Rev. Mr. Trimble Admits the Charge Made in Sermon Is Based on Hearsay.

A sermon delivered by Rev. Delman Trimble, pastor of Centenary Methodist church, in which he charged that 105 resorts were existing in the city, was responsible for his appearance this morning before the grand jury in its investigation of the vice situation. Rev. Mr. Trimble, however, told the jurors that he had no first hand information concerning the existence of these resorts. His sermon was based upon figures given him by others which he believed to be absolutely reliable.

Frank Hennessey, deputy district attorney, who gathered considerable vice evidence, and Ted Lansting, a newspaper reporter, were before the jury this morning also. Hennessey was not in the jury room very long.

Sig Sichel, chairman of the police commission, will appear before the grand jury this afternoon. He made the request that he be called.

Sudden and intense interest was exhibited by the jurors yesterday afternoon in the supposed widespread existence of vice and calls were sent out for Captains Moore and Baty, Sergeant Riley and other members of the police force. Captain Moore is in charge of the detective squad. He could give no information while Captain Baty and Sergeant Riley are on the day relief and do not come in contact with conditions as do the night men. Both said they were obeying orders in regard to the subject and at present knew of no resorts.

W. G. MacLaren, superintendent of the Portland Commons, was also a witness yesterday. He is supposed to have considerable information concerning the situation. It is probable that Chief of Police Cox will be called before the investigation is over.

### BRIDGE CASE IS ON TRIAL TODAY

#### Government Prosecuting Multnomah County Court for Closing Draws.

The case of the United States government against the Multnomah county court went to trial before the federal court this afternoon. Judge Cleeton and Commissioners Lightner and Hart of the court are charged with criminally violating the federal navigation laws in that they prescribed regulation of the drawbridges and persisted in continuing evening closed periods after the government had permitted the enforcement of a morning schedule. The government is represented by United States District Attorney John McCourt, aided by Major J. F. McIndoe of the engineering department. The county court is represented by Attorneys A. E. Clark and C. W. Fulton.

While, nominally the government prosecutes the county court, the case is really an arraying of the navigation interests against the people and business interests who use the bridges spanning the Willamette. In the past the draws have been required to open most frequently for the passage of towboats with sand scows. These boats are manned by a small crew and the scows are frequently empty. Figures obtained by the county court, the street railway company and the Civic Improvement league prove that more than 200,000 people cross the bridges daily with the heaviest traffic during the morning and evening, when going to or coming from work. The opening of the draws at these times congest the streets leading to the bridge for several blocks, it is claimed.

### REBECCA TONGUE, PIONEER, IS DEAD

#### Mother of Late Congressman Passes Peacefully at Age of 87 Years.

Mrs. Rebecca Tongue, mother of the late Congressman Thomas H. Tongue of this district, died at her ranch home on the North Plains near Glencoe shortly after 10 o'clock this morning. Mrs. Tongue was 87 years old, and death was due to natural causes. The interment will take place in the Tongue family plot at the Hilltop cemetery, where her remains will be laid to rest beside those of her late husband and son. The date for the funeral has not yet been determined.

Notwithstanding her advanced age, the news of Mrs. Tongue's death was a great surprise to her grandchildren and friends in the city. She was the possessor of a strong constitution and until 10 days ago, when she was forced to submit to her physician's care, had never been sick in her life. The end came peacefully.

With her husband, who died seven years ago, Mrs. Tongue came to America from England in the '60's. Mr. Tongue was at the time connected with the famous Hudson's Bay company, but severed his interests with that company upon coming to this state. They acquired the property where Mrs. Tongue's death occurred some 52 years ago. Mrs. Tongue lived there continually until she died.

The late Congressman Thomas Tongue, Mrs. Tongue's only child, died about eight years ago while representing this district at the national capitol. She is survived by the following grandchildren: Mrs. Gay Lombard, Mrs. Elizabeth Freeman, and Mrs. H. M. Munger of this city; Mrs. A. E. Reames of Medford; Miss Bertha Tongue, E. B. Tongue, district attorney for Washington and Clatsop counties, and Thomas H. Tongue Jr., city attorney of Hillsboro.

### FINAL RECIPROCITY DEBATE IN HOUSE

(United Press Leased Wire.) Washington, April 21.—Final debate in the house on the reciprocity bill began today. McCall (Republican, Massachusetts), who fathered the measure passed in the house in the last congress, defended Underwood's identical measure today, and Dalsell (Republican, Pennsylvania) attacked it. Chairman Underwood of the ways and means committee occupied the final hour of the debate.

A vote on the measure will be taken this afternoon.

In his address McCall charged that the "trusts" were using the farmers of the country to try to defeat reciprocity. Underwood, in closing the debate, denounced the steel trust.

"I was asked by the gentleman from Illinois (Cannon), how the steel trust stood on the bill," he said. "I said I did not know. I know now. Two years ago the protected interests in my district resolved to turn me down for congress if I voted to reduce the tariff on iron and steel. I have received telegrams today stating that these corporations have stopped work on some plants and that 2000 workmen are idle because I am supporting reciprocity. I regret that the trust is punishing my constituents, but I intend to vote for reciprocity and the free list bills unamended because I believe I am right."

**Auto Speeders Arrested.**—Traffic Officer Sherwood at Third and Washington streets arrested James Galley and Homer Thomas, both drivers of auto trucks, for having no license. Judge Tazewell fined both \$10 but suspended sentence, this morning. Ernest Browley, driving an auto for R. F. Cox, was arrested yesterday afternoon at Twentieth and Washington streets for speeding. Herman Sigglin, son of Charles O. Sigglin, was also arrested for speeding. Both of these cases will be tried tomorrow.

### WEAVER, RECAPTURED, HELD FOR MAY TRIAL

(Special Dispatch to The Journal.) The Dalles, Or., April 21.—Tiring of confinement in The Dalles hospital and desiring to escape trial, Fred Weaver fled from a room in the hospital Tuesday night, but was recaptured and conveyed to the county jail, where he will remain until the May term of circuit court, having been bound over after awaiting examination in the justice court yesterday.

On the night of March 22, Weaver was discovered by V. H. French and Sherman Braynard in the residence of Mrs. D. M. French, and was shot by Braynard when he refused to surrender. At first it was thought he was fatally injured, but he has made a remarkable recovery, and for more than a week has been able to walk about his room. Fearing that he might attempt to get away, Sheriff Christman had placed leg irons on him and left him in the hospital until the doctors would say he was out of danger. Tuesday night while the nurses were busy Weaver took a blanket, made a rope of it, and fastening one end to the bedstead and passing the other cut of the window, let himself to the ground. He then quietly made his way to an old barn some three blocks away, and climbing to the roof, secreted himself by lying flat. After about three hours' hunting, someone discovered him crouched upon the roof. He had a cache of clothing near town, but when he escaped from the hospital all he had on was a nightshirt. Weaver is a foreigner, and claims to be only 19 years of age.

**Mrs. J. F. Perry Dies.**—(Special Dispatch to The Journal.) The Dalles, Or., April 21.—Mrs. Perry, widow of the late J. F. Perry, died at the home of her son, Hugh Perry, yesterday, aged 66 years. Mrs. Perry was born in Maine in 1845, and spent the greater part of her life in that state, coming to Oregon about six years ago. Her one son is storekeeper for Porter Bros.

**Return From Tacoma Dog Show.**—Frank Watkins and Billy Fehchheimer returned this morning from the Tacoma dog show, where they bunched their bull terriers and fox terriers. Fehchheimer's fox terriers won all prizes, while a bull terrier bitch entered by Watkins, which won in the eastern shows, was judged fourth in general average.

#### First Ten Are Sold at Auction at Noon Today; One Brings \$300.

Charity was at a premium when Portland society bid for Kirmess boxes beginning at noon in the Hellig theatre today. First choice of the 10 \$150 boxes for the Kirmess performances Thursday, Friday and Saturday nights with matinee Saturday, fell to O. A. Jones, bidding for Miss Failing, who paid a premium of \$50 making the cost of the box \$200. Bidding for the honor of first choice was spirited, Jones' competitors being Scott Brooke, Allen Lewis, Henry Ladd Corbett and B. S. Josselyn. Mr. Jones' choice was box C.

### HELMKEN PLEADS GUILTY; FINED \$75

#### Moore's Fines Are \$550 With Costs; Woodburn Liquor Profits Disappear.

(Special Dispatch to The Journal.) Woodburn, Or., April 21.—The trial of J. C. Moore closed last night with a verdict of guilty on six counts of selling intoxicating liquors in the Bachelor's club to Detectives White and McDermott, one case being dismissed on account of hearsay evidence. Moore's fines amounted to \$550 and costs. Al Edgar was found guilty of the same charge and was fined \$50 and costs. The cases will be appealed to the circuit court.

Harry Helmken this morning pleaded guilty to giving a flask of whiskey out of his vault to Detective White on April 1, and paid a fine of \$75 and costs. The three other cases against him were dismissed.
