

BEWARE OF LAND SHARKS DECLARES CHURCH SPEAKER

Canadian Minister Warns People Against Luring Ads That Got Into Official Paper—Convention Abhors War.

Warning by a Canadian preacher against land sharks who are using the publications of the Disciples of Christ to deceive people in regard to conditions in Canada, the selection of Louisville, Ky., as the next meeting place of the national convention and charges of radicalism made when the report of the committee on recommendations was being considered, were chief features of yesterday afternoon's Christian convention sessions.

A large part of the afternoon was taken up by speakers from the northwest, who told of the wonderful development materially and religiously. Rev. Mr. Nickelson of Manitoba told of the great strides being made by Canada and of the struggles of some communities to support the work of Christ, and of their generosity in doing it. Then he warned the great audience in the White Temple to beware of land sharks who are luring citizens of the United States to invest in Canadian lands, and urged the preachers who were there to return to their pulpits and repeat the warning.

Warning Against Land Sharks.
"Look out for the land sharks," he said. "Don't put too much confidence in the advertisements in our own periodicals. Some have been lured by them, and I know it."

It was impressive when the big audience arose to its feet and waved hundreds of handkerchiefs as an expression of appreciation felt for the pioneer religious work done by Rev. W. F. Cowden.

Rev. J. S. Baum of Montana had told of the work in his field and of the fact that during the next five years, when the people of the east were flocking to the west, would be the critical time in the building up of their churches. He said that for every dollar loaned to the churches of the west from the church extension fund now would be returned tenfold in 10 years. As he was speaking Rev. Mr. Cowden could hardly keep his seat, and as soon as opportunity presented himself I. N. McCash, who was presiding, called him to the platform and introduced him as "Uncle Johnny Apple Seed of the northwest."

Given Vote of Thanks.
"I have nothing to say but this: I tell you so." Here this applause was vociferous. When it had subsided, Mr. Cowden continued: "I told you so 20 years ago and you wouldn't believe it. I thank God you believe it now."

Charles Reigh Scoville, who was in the gallery, then moved that the convention give Mr. Cowden a vote of thanks for his pioneer work in the northwest. The handkerchiefs were waved with enthusiasm.

One of the most masterful addresses of the convention was delivered by Rev. John L. Brandt of Missouri on the subject, "The Supremacy and Influence of the Anglo-Saxon Race on the Civilization of the World."

He said that the Anglo-Saxon race was supreme in intellectual activity, and that he believed that God had designed this race for the redemption of the whole world.

Adoption of Report.
When the committee on recommendations made its report, someone immediately made a motion that the report be adopted. But A. McLean, president of the Foreign Christian Missionary society, objected, as he said there were items in the report which he did not think the convention would want to adopt in any form. So by common consent the report was considered item by item.

The first two items were adopted without discussion, as follows:
"1st.—We recommend that there be a co-ordination of our national missionary interests as far as possible.
2nd.—That a uniform system of weekly contributions be encouraged.

"3rd.—That we approve the work done by the committee on unification." This item was stricken from the report until a special committee had time to report.

"4th.—That our several societies combine in issuing a year book equal to that issued by other communions." M. M. Goode of St. Joseph, Mo., lead the objections against the words, "equal to other communions," which were quickly stricken out of the report.

"5th.—That an official reporter be employed and be on the ground where the convention is to meet at least one week before the convention and all material for the secular press must pass through his hands.

"6th.—That after next year our conventions meet bi-annually, holding three great conventions, one on the Atlantic coast, one in the middle west, and one on the Pacific coast."

Objection to Mada.
A. McLean quickly objected to this item. "I think this resolution is of doubtful propriety," he said. "We ought not adopt anything so radical. Anything of a revolutionary nature should be considered at least a year. It should not be sprung upon us so suddenly." He then moved that the resolution be stricken from the report. I. N. McCash explained that the conventions as now held were so large that they were unwieldy. But the convention was not ready to adopt such a radical change in the manner of meeting and the whole question was referred to a special committee to consider such questions. The resolution was referred to a special committee to be considered a year.

"8th.—That the titling of our incomes be encouraged.
9th.—That family prayers be urged in all homes.
10th.—That more time be given for the observance of the Lord's supper.

PEDAGOGUES BY HUNDREDS GOCK TO THE DAY CITY

Forty-Ninth Session of National Convention Is Expected to Be Enlivened by Differences Between Factions.

(United Press Leased Wire.)
San Francisco, Cal., July 5.—San Francisco rapidly filling with delegates and visitors to the forty-ninth annual convention of the National Education association, some 30,000 of whom, representing all branches of educational work from the kindergarten to the university, will make this city their mecca during the coming week.

The national headquarters were opened this morning at the St. Francis hotel by Secretary Irwin Shepard of Winona, Minn., with a large force of assistants will be in continual session save during sleeping hours, until the delegates have gotten into working order the first of the week.

The first general session of the association, in the ball theatre of the University of California, will not be held until Monday afternoon, but the convention will be preceded tomorrow by several of the affiliated organizations. At the formal opening Monday afternoon, president of the association, Mayor McCarthy of San Francisco and President Wheeler of the University of California. Response for the visitors will be made by Dr. Elmer E. Brown, late president of the association, who is now in charge of the education, and who is soon to enter upon his new duties as chancellor of New York university.

Notable List of Instructors.
Mrs. Ella Flagg Young of Chicago, president of the association, will preside at the session and deliver the opening address. Dr. David Starr Jordan, president of Leland Stanford Junior university, will be another noted speaker at the initial session.

Bailey, president of Valparaiso University; George B. Cook, state superintendent of Arkansas; Thomas C. Mott, superintendent of schools of Richmond, Ind.; J. W. Crabtree, state superintendent of Nebraska; Nicholas J. Butler, president of Columbia University; John R. Kirk, president of Missouri State Normal School; J. H. Phillips, superintendent of schools of Birmingham; W. E. Harmon, state superintendent of Montana; Thomas F. Kane, president of the University of Washington; C. A. Dunlap, president of the University of Montana; and P. L. Campbell, president of the University of Oregon.

Lively Session Expected.
From an instructive viewpoint the program of speakers of the most successful conventions in the history of the organization. Aside from this, however, the convention is likely to prove of more interest to the membership than any of the annual meetings of recent years. The subject of the week is "The future of the big teachers' organization."

It will be a fight against the "old order" led by the combined forces of the teachers of Illinois and New York. The main issue, and the one which is expected to bring up the most serious opposition, is the proposal to abolish the national council, which is vested with the power of recommending appropriations and fixing the expenditure of funds. The so-called insurgents charge that the council has fought against progressive methods for the association, and it is also hinted that the expenditures have been recklessly and imprudently made.

TRANSFER STRANDED STEAMER'S PASSENGERS

Los Angeles, Cal., July 5.—At 1:30 p. m. today Captain Ferrar, of the stranded steamer Santa Rosa, arranged with the steam schooner Centralia to transfer all passengers to the latter vessel. When this is done the Centralia will proceed to Port Harford where the passengers will be landed.

It was found impossible to float the Santa Rosa at high tide 12:30 p. m. Another attempt will be made at 3 p. m., when the tide is extremely high.

Phone Rate Row Unsettled.

Hood River, Ore., July 5.—The attempt by the telephone company to charge an extra toll of 10 cents for each message over the line south of the Booth hill has met with strong resistance, the phone users refusing to pay this amount. It was then endeavored to distribute a general charge over the entire system to equal the probable amount of the additional toll charge would make but the general phone users protest against that. The railroad commission has been implored to take a hand in the regulating of phone rates here but says it is not within its jurisdiction. A general move is on foot among the phone users to have the matter of paying in advance for phone service tried out in the courts. The local company has in several instances cut out the phones where the monthly service was paid in advance. It is rumored here that the Pacific States company, which formerly owned the lines in the Hood River valley, is making an effort to secure possession of the Home system.

Two Hurt in Cameron Mill.

Hood River, Ore., July 5.—E. H. Hardacre, who has been in the employ of the Cameron Mill near Pine Grove, had his hand badly crushed in one of the cogs of the planer Thursday. It may become necessary to amputate some of the fingers. On the same day L. G. Gates, who works in the same mill, had a sharp stick thrown into his face by the planer, cutting his lip and bruising his face.

WANT LIBRARY IN NEW EAST WING

Attorneys Petition County Court to Install Law Books as First Planned.

Several petitions were put in circulation today among the lawyers in which the county court is urged to allow the law library to be placed in the east wing of the new court house. Rooms were set aside by the former county court and these have been specially arranged for the library, which the court now says cannot be used.

The petitions were drawn by a special committee from the Multnomah Bar association consisting of Attorneys Thomas O'Day, A. E. Clark, Samuel White, Charles J. Schnabel, John Hall, and A. L. Venzie. When the petitions have the signatures of the lawyers, the committee will present the question to the county court.

It is set forth in the petition that the law library was started about 21 years ago, when several attorneys made up a fund of \$10,000 with which to start it. For several years, a fee of \$12 a year was paid by the members to maintain the institution, but a few years ago the law was changed to allow part of the filing fee in suits to apply on its maintenance.

The necessity of such a library for the courts of this county no well informed person will question, for it is recognized everywhere, both by the state and progressive communities, that the courts are the backbone of the government. The judges will confirm our statement that the presence of the law library and the facilities it affords are invaluable to them, and that its removal will seriously hamper the transaction of the judicial business in the county. The judges have not time to go elsewhere to consult the books, and they ought not to be required to do so. There is no other library which can afford them anything like the facilities given by this one.

"If therefore does not appear to us that there can be a compelling necessity that the library should be removed the courts and members of the bar put to the serious inconvenience which this will entail, and we respectfully urge that it be given the rooms which were designed and built for its use."

The east wing will afford about three times the office space the present court house gives. Some of the county offices are now outside the courthouse, and the county has to pay rent for these. The county court contends that since space in the east wing is so valuable, the law library should seek quarters elsewhere until the west wing is finished, which will be in about 18 months.

When this wing is completed, the library rooms in the east wing will then be given the institution. These rooms have been specially arranged for it, having telephonic communication with each of the 12 court rooms, special lighting and ventilation, and a soft tread floor.

HEALTH EQUIPMENT IS UNSURPASSED
