

GIRL, IN MOURNING, ARRANGES TO BURY HUSBAND SHE SLEW

Nineteen-Year-Old Widow As-
serts Right to Take Charge
of Funeral of Mate She
Killed.

(United Press Leased Wire.)
San Francisco, Aug. 5.—Because the grand jury investigation has not been completed, the preliminary hearing of Mrs. Annie Gaffney Langley, on a charge of having murdered her husband, James Langley, which was scheduled to be held before Police Judge Deasy this morning, was postponed until August 10. The young widow, accompanied by her mother, arrived at the court house garbed in deepest mourning. Just as she was about to enter the court room she became hysterical and was taken into an adjoining room in a state of complete collapse.

After being revived sufficiently to walk into the court room, the girl's case was called. Assistant District Attorney Roach urged the postponement and Judge Deasy agreed.

Mrs. Langley was carried quickly from the building and taken to her parents' home in an automobile.

Any animosity swept away by the death, leaving only the love which no brutality could lessen, Anna Gaffney Langley today has asserted her right to make all arrangements for the funeral of the husband who died by her hand. The young widow insisted on herself purchasing the little plot of ground which will receive the remains. The Order of Moose, of which the deceased was a member, will assist at the funeral Sunday, but the widow will be the chief mourner. The services will be held at an undertaking establishment, and interment will be in Mount Olivet cemetery.

who have gone beyond the problems of Euclid then it has been stopped with the multiplication table.

Oregon Makes Good.

"At the first election after adoption of the initiative and referendum in Oregon, the people enacted a law under which we have chosen three senators by popular vote, the legislature merely ratifying the popular choice. If the senator really desires to secure popular election of senators in his state he should first secure the practical operation of the initiative, after which absolutely nothing can stand in the way of popular election of senators."

"Hasty consideration of the wholesale bartering of votes in Adams county, Ohio, and Danville, Ill., would lead to the belief that the people are unworthy of the elective franchise. Careful study and deduction demonstrate otherwise. Those voters had for years witnessed the operation of machine politics. They had only the opportunity to vote for one of two candidates, each nominated by political bosses. Self respect was finally obliterated, honor blunted, moral fiber destroyed, selfishness intensified. They naturally concluded that they might as well benefit themselves for the taking of the few paltry dollars for the surrender of what little right they had, for sale of their votes was so much gained in cash without any loss in public service."

Vote Selling Detestable.

"While I would not say anything that could be construed as approval of the citizens who sold their votes, I can readily understand how they excuse themselves after witnessing the barter and sale of votes in legislative halls and the use of patronage for the purchase of influence. Self respect was two wrongs will not make a right, but those who condemn the barter and sale of votes among people who have not gone beyond the multiplication table should be as loud in their denunciation of purchase and sale of votes among those who have mastered the problems of Euclid."

"The people of Arizona would better lose statehood than yield their right to control their state government. What a mockery it is to start a constitution with a preamble declaring, 'We, the people of Arizona, grateful to Almighty God for our liberties, and then harbor for an instant the thought of surrendering or limiting that God given liberty at the instance of any man who happens to occupy temporarily the office of president.'"

ity. It was during this time that he received word that two representatives of the steel corporation wished to see him.

"The next morning I was told that Frick and Gary were in my office," Roosevelt continued. "Attorney General Bonaparte was in Baltimore. I called in Secretary Root and together we talked things over. I dictated a note to the attorney general setting forth what I had told me."

Roosevelt Assumes Responsibility.

Roosevelt then read a letter, made public some time ago, in which he told Bonaparte that in view of conditions he would interpose no objection to the absorption of the Tennessee company by the steel trust.

"I wish it distinctly understood," said the ex-president, "that I acted solely on my own initiative and that I wish to accept all responsibility connected therewith. The panic was due to unreasonable fear and the only way to stop it was to restore public confidence."

Morgan Interests in Bad.

"At that time the so-called Morgan interests, only one retained the confidence of the people of New York. That was the Knickerbocker Trust company. The others were on the firing line. It was known that they or those interested in them had Tennessee securities. The proposal of Frick and Gary was that the steel corporation take them over immediately. It was necessary

WIRE "POOL" HEADS CONFESS; FINED \$1000

New York, Aug. 5.—Herbert L. Satterlee, son-in-law of J. Pierpont Morgan, confessed to having violated the Sherman anti-trust law in connection with the operations of the wire trust, of which he was a member, and was fined \$1000. Seven other members of the pool also confessed and were fined.

Edwin Johnson, promoter and organizer of the wire pool, was fined \$5000 on each of nine counts, a total of \$45,000, after he had changed his plea of not guilty to guilty. Prosecuting Attorney Wise demanded a jail sentence for Johnson. The judge, Archbald, refused.

Johnson was the last indicted member of the pool to come before the court.

HARRIMAN LINES DENY DEMANDS OF EMPLOYEES

San Francisco, Aug. 5.—General Manager E. E. Calvin of the Harriman system has denied the demand of employees of the system for shorter hours and increased pay. Calvin's dictum followed a lengthy conference with a committee of the federated employees. An eight hour day and 7 per cent increase in pay for helpers and semi-skilled workmen all over the system was asked. The new schedule would mean a total yearly increase of between \$1,800,000 and \$2,900,000.

dependence.

New York, Aug. 5.—Weeping hysterically Miss Louise Swan, the runaway heiress, threw herself into the arms of her mother, who had suffered only such tortures as a mother can suffer whose beloved daughter had disappeared from sight and ken of a loving parent. The beautiful young student of economics was shocked to find the effect that had been produced by her yielding to her longing to taste the "freedom" of a working girl. Her wealthy father brought her back from Philadelphia, where she was found after a long search.

"I am terribly humiliated by what has happened," she cried. "If I realized that my quest of a position and an opportunity to earn my own living was to result in so much publicity I should have taken some other means to gratify my life ambition."

In order to afford his nerve-wrought daughter a much-needed rest, Mr. Swan afterwards committed Miss Louise to the care of friends in Brooklyn. Here she will rest for a few days, and then continue her quest for independence—this time with full permission of her father.

Tells of Her Adventures.

Miss Swan is 19 years old and has been given all the advantages of education and training possible by wealthy and loving parents. Telling of her adventures, she said:

"I always have believed that a girl of intelligence could earn her living if thrown upon her own resources. I have had an opportunity to prove this, and I think I have done so—to my own satisfaction at least."

"I always had planned exactly what I should do if ever it became necessary for me to earn my own living, and I carried those plans out like clockwork."

"When I left home I put on my oldest clothes, so I would look more like a working girl, and then I went to the Dime Savings bank, in De Kalb avenue, in Brooklyn, and drew out \$15.35. I had a right to this money. Father had told me often it was for my use alone."

Goes to Philadelphia.

"Then I went to the Pennsylvania station. I looked up the time table, saw there was a train leaving for Philadelphia in a few minutes and bought a ticket."

"I did not feel at all frightened when we arrived at the Broad street station in Philadelphia. Everything was just as I had planned, and I did not see why a girl should be frightened when she had money in her purse, even though she was in a strange city."

"It was too late to seek a position that night, so I went to a cheap hotel near the railroad station. I asked for a room, and the clerk wanted to know if I wanted a cheap room or a good one. 'Do you think I am a millionaire?' I asked. 'Give me the cheapest room you have.'"

GERMAN CHANCELLOR EXPECTED TO RESIGN

London, Aug. 5.—Failure of their plan to grab a part of the Moroccan sea coast through Great Britain's bold stand and the resulting agreement, in principle, which has been reached between France and Germany, is expected here today to result in the resignations of Chancellor Von Bethmann-Hollweg and Foreign Secretary Von Kiderling-Waechter. It is declared that the Kaiser compelled his ministers to yield to France and to recede from part of their demands.

While the British foreign office expects ultimately amicable settlement of the Moroccan affair, there are still delicate questions to be settled, in some of which England is concerned.
