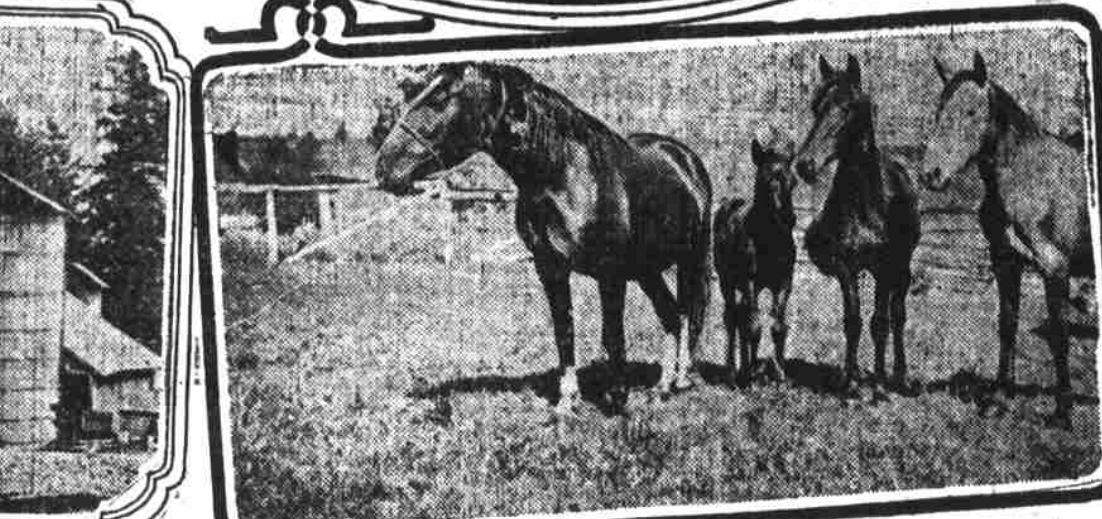
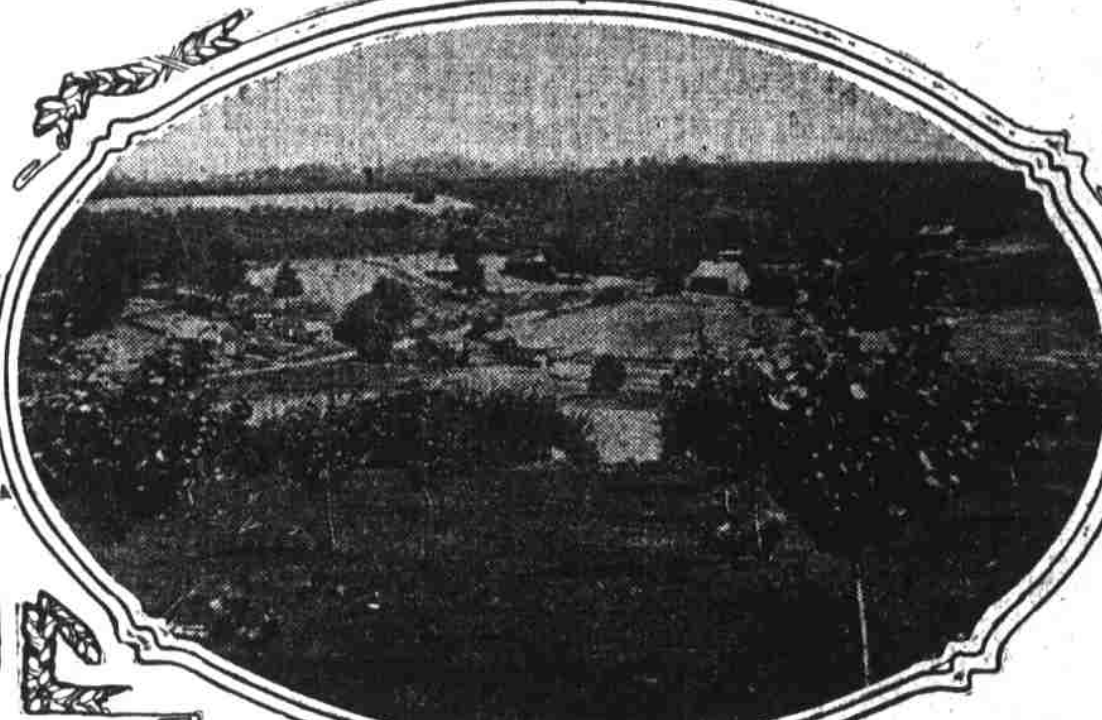
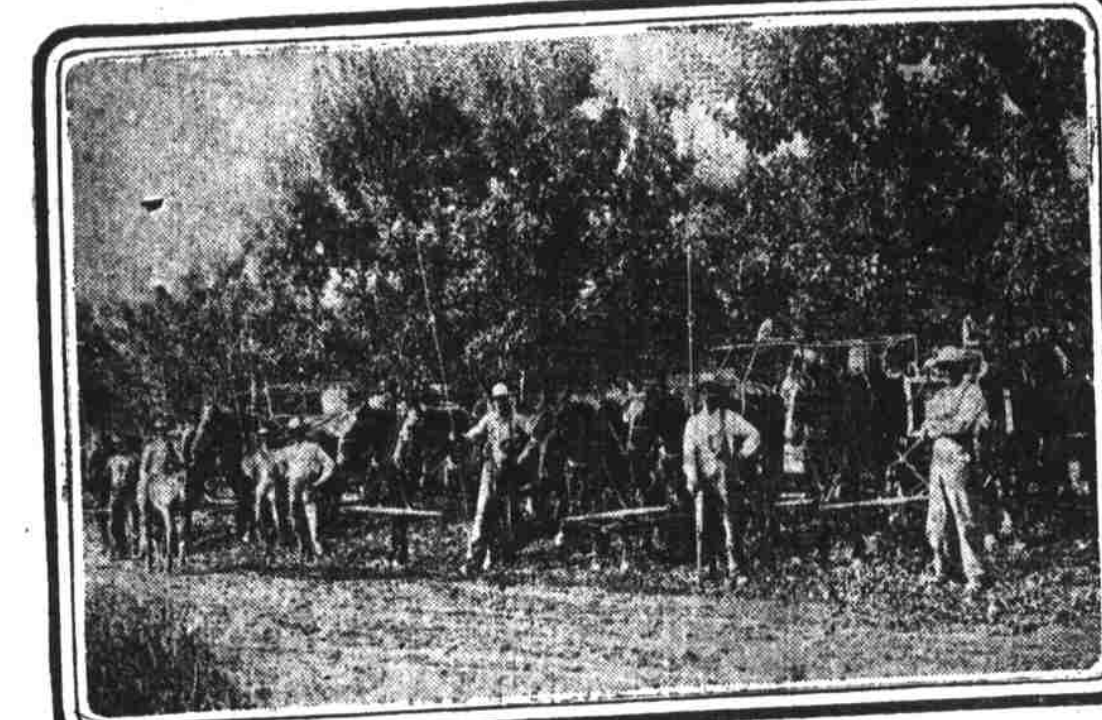


Registration of Oregon Farm Names Is Becoming Popular

Salem, Or., Aug. 12.—That the farmers of Oregon are taking to the idea of naming their farms and having the names registered under the new law so that no other farms may wear the same names is proved by the long list of registrations from almost every county in the state now in the secretary of state's office. These names are catchy, representing usually the nature of the products of the farm, the history of the farm or its scenic attractions.

of his county. Only one farm in the state can have one particular name. Up to the present time farm names have been registered with the secretary of state for farms in 25 counties. The correspondence regarding names is growing rapidly, and it is expected that within a few years a majority of the farms will have been named officially. Advocates of rural improvement believe that the naming of farms is an important factor in fostering farm pride and the improvement of the conditions of country life in Oregon.

BRASS BANDS FAIL; PASTOR HAS NO JOB

Chicago, Aug. 12.—Brass bands and vaudeville performers have failed as church attractions in Maywood and as a result Rev. Percival H. Barker of the First Congregational church is out of a job. His once honored name has been painted off the announcement board in front of the church, without his knowledge or consent.

Two years ago when Rev. Mr. Barker first occupied the pulpit of the Maywood church, he started his congregation by introducing innovations to attract communicants to his church. Brass bands and parades were among the features, with an occasional moving picture show in the church preceding the sermon.

Older Members Disapprove. The older members of the congregation, who had been accustomed to "take their religion straight," without any frills, and their heads, but the younger ones enjoyed the novelty. The church was filled at each "performance" and it prospered financially. The older members left but their places were filled by others. The pastor congratulated himself on the success of his plans to make his church popular.

Whether he failed to book good attractions, or whether his flock preferred the old methods of worship, is not known, but for the last year he has preached to empty pews. A month ago he announced that he needed a vacation and intended to take one of two months duration. The trustees met and decided that he might prolong the vacation indefinitely, and they obtained the services of a painter to blot his name out of their sight, if not out of their memory. The painter performed the job on the announcement board, leaving the space blank, and the printer performed a similar feat on church announcements.

Refuses to Talk. The trustees have not officially announced that they are looking for a new pastor, neither will Mr. Barker admit that he is looking for another pulpit. He refused yesterday to be interviewed on the subject. One of the trustees admitted that the announcement of the pastor that he intended to take a vacation without asking the consent of the board, was the last straw. He may begin the vacation at any time and end it when he pleases, so far as the trustees are concerned, as they consider him "fired."

COMMITTEE FAVORS INDIAN MEMORIAL

(Washington Bureau of The Journal.) Washington, D. C., Aug. 12.—Congressman E. W. Townsend of New Jersey, for the house committee on library, has filed a report favoring the movement to provide a suitable memorial of the North American Indian. It is based upon a bill offered by Congressman Forbes of New York, which proposes that no expense shall be incurred by the government, the site only being given by it on the government reservation in the harbor of New York.

Rodman Wainmaker of New York city has offered to build a statue of heroic proportions, and the commission of fine arts is to have the supervision of the work. A bill practically the same as the present Forbes bill passed the house at the end of the sixty-first congress and was favorably reported by the senate library committee, but was too late to permit getting the bill enacted.

The secretary of war and the secretary of the navy are to select the site on ground already owned by the government. Mr. Townsend speaks for the entire committee, members of which hope that it will be possible soon to carry the measure through and permit the work to proceed without further delay.

BANKER HELD UP IN RESTAURANT BY BLACKMAILERS

Sensational Crime in Paris Unearthed in Trial and Conviction of Prominent Business Man and Employee.

Paris, Aug. 12.—The trial and conviction of a local business man and one of his employees which occurred recently in the assize court, recalls one of the most sensational crimes in the history of this city. Readers may recall the remarkable adventure which fell to the lot of Prosper Poch, a local banker in January, when he was compelled to sign a receipt for 41,000 francs, which was owed to him, and other papers as well. The case was recently on at the assize court. Poch told the story in a plain, simple manner. He stated that on the day in question a business man, Boulois, to whom he had advanced money, called at his office and told him of a client who wished to negotiate a loan, adding that if he would accompany him to Villembolie, where he resided, the matter could be settled at once.

Captured in Restaurant. They went to a restaurant, and then they started for Villembolie, where the banker was taken to a rather out of the way cottage. Hardly were they in the hall when another man, Musnier, an employe of Boulois, producing a revolver, cried, "Not a word! You are caught!" And, addressing his accomplice, he added, "We shall take him down to the cellar."

The terror of Poch may readily be imagined. Boulois declared that Poch would not be hurt if he would do as he was told, and, as the unlucky banker had no choice but to consent, he was ordered to hand over, as a preliminary, all the cash that he had about him. Out came his purse, which Boulois took, but when the banker hinted timidly that this would leave him nothing for his journey home he returned 15 francs.

"Sign or Die." Poch was then made to seat himself at a table, where several papers were laid before him. He was looking them over when the revolver was once more in evidence, Boulois exclaiming, "Sign or die!" As the lesser of two evils, the banker preferred to sign the papers. Besides the receipt for the 41 francs he signed several promissory notes, amounting in all to 15,000 francs. Yet, in spite of his compliance, he was detained until night came, and then he was led off to a wood, where he wandered about in the dark for hours.

An attempt has been made to demonstrate that the banker lent money at exorbitant interest, several witnesses being called in support of this contention, but the public prosecutor said it was a mistake to imagine that anyone who had dealings with an usurer could obtain complete liberation.
