BROTHERS WILL BE TRIED IN LOS ANGELES

McNamaras Closely Guarded Are Taken to Hall of Records in Los Angeles; Younger Man to Be Tried First.

The McNamara brothers, John and James, were taken to the Los Angeles hall of records on October 11, 1931, on suspicion of being involved in the dynamiting of the Los Angeles Times building.

On the night of October 1, 1931, an explosion occurred in the Los Angeles Times building, which was a result of dynamite being placed in the building.

The pair in chains were John J. McNamara, high labor official, and his brother, James B. McNamara. They were en route to face a charge of murder.
