

LISTEN, SPEAKS GYPSY SMITH, AND 7000 ARE SILENT

Words of Short, Dark Man Move Something Far Within in Each Soul, in Opening Sermon at Seattle, Wash.

Seattle, Wash. (Special to The Journal.) "This world is drunk in the message of love and the promise of hope, as the words dropped from the lips of Gypsy Smith were yesterday afternoon. Gypsy Smith will begin work in Portland on November 10.

The momentous risk was passed. Old men and young women, young gallants and maidens in Sunday attire sat hunched up in the balcony and covering every available seating convenience which had been provided. At 7 o'clock, an hour before the meeting was scheduled to start, the whole of the central portion of the auditorium and balcony was filled, and the every desirable seat was taken, and only a few were left at the edges. At 7:45 the risk was capably filled and hundreds waited outside in vain.

As Gypsy Smith took up his discourse and with a simple message, from one end to the other, followed his every word. When his voice faltered as he spoke of the sacred things of the average man, the spirit of the audience sighed in sympathy; when with a quiet turn he smiled, the crowd laughed happily with him.

Where Would This Woman Go?

"Suppose a fallen woman in your city tonight were to feel the light and were to cry out, 'God help me, where would she go? Would she knock on the door of your fashionable church, or go to the fine house of the lady who is so prominent in the social events of the church? No. In nine cases out of ten she would go to the Salvation Army, and you know it. It is a reflection on you. It means that they have lost confidence in you.'"

PROSECUTION WINS A STRONG POINT IN M'NAMARA'S TRIAL

(Continued from Page One.)

the guilt or innocence of the defendant or was based on positive knowledge of the conditions. The defense had bitterly combated this point and had insisted that anyone having any opinion whatsoever regarding the cause of the explosion must necessarily be disqualified.

Charges Judge With Bias.

So bitter was the disappointment that Attorney Scott of the defense forces virtually charged Judge Bordwell with bias and unfairness and was rebuked in strong language by the court. Judge Bordwell said he had no opinion on the guilt or innocence of the defendant," said the court, "and he says such opinion will not bias him in his reaching his verdict. This court has no discretion but to hold the juror qualified under the code."

This ruling caused consternation in the ranks of the defense, and the attorneys began to argue with the result that Attorney Scott was finally rebuked by the court.

"Does this court then hold," demanded Scott, "that a juror who believes that dynamite was used is qualified, while one who believes that it was gas that caused the destruction of the Times is not?"

Judge Loses His Calm.

For the first time since the trial began Judge Bordwell lost his calm and seeming good nature pose. He was indignant and demanded: "Why do you ask me this question? Do you think that I want to use one side more partially than I do the other? What do you mean?"

"You will see by the record in this case," he said, "that this juror has said that he believes the Times was destroyed by dynamite—a felonious act—and that he also said that it would be plainly wrong for him to remove that opinion. Now, is it fair to this defendant to ask him to go to trial with such a juror? He is entitled to an unbiased juror, to one that will give him the presumption of innocence. That this juror cannot do. He has said as much and keeping him on this jury is an invasion of this defendant's constitutional rights."

But that was not all he said, Mr. Darrow said Judge Bordwell. "He has said a great deal, and I have taken all he said into consideration in arriving at my conclusion. The law and the facts at the present time make it necessary to disallow this challenge."

"Well, then I suppose that we can do nothing but to conserve our strength and enter an objection," said Darrow, sinking into his chair.

Asked by Darrow if he would reopen the matter, should it be shown that he was in error, but that for the present the ruling would stand.

The decision greatly dashed the hopes of the defense, as they will now have to

resort to a peremptory challenge to eliminate McKee.

This decision left in the jury box the following men only, subject to peremptory challenge. Robert Bala, F. D. Green, George W. McKee.

All Utilities Meet.

The rest since Friday was utilized by attorneys for both sides in preparing citations for Judge Bordwell in the work of passing upon the eligibility of opinionated jurors. Both sides were still pessimistic when court reconvened regarding the immediate prospect of getting a jury. The general opinion of counsel was that it would be Christmas at least, and possibly much longer, before 13 men satisfactory to both sides are secured.

The jury will, it now seems certain, have to come from the small ranchers and orange growers of the outlying portions of the county. All other men are

not backward in expressing them.

Judge Bordwell was 30 minutes late in arriving, having been delayed by other legal business. Call of the roll of the veniremen revealed that only 13 members of the original venire remain subject to call for examination regarding their qualification for jury service.

Would Reopen Matter.

Judge Bordwell announced that he had set aside his ruling disallowing the challenge by the state against E. C. Robinson because he was opposed to capital punishment, and that the matter would be reopened.

"From reading the report of the examination of Mr. Robinson," said Judge Bordwell, "I am satisfied either I or the district attorney misunderstood his answers or that the report was in error."

The court called Robinson to the witness chair and read to him the answers made both to the court and the district attorney. To the court Robinson said that he was opposed to capital punishment, but would return a verdict of guilty of murder, "as long as he did not have to impose the punishment" while he had told the district attorney that he could hardly condemn a man to death on circumstantial evidence.

Explains to Juror.

Bordwell then explained to the juror just what was meant by circumstantial evidence. He cited half a dozen incidents of concrete circumstantial evidence, but to them all Robinson said that he feared that purely circumstantial evidence would always leave such a doubt in his mind that he could hardly convict where he knew that the penalty was death.

Judge Bordwell then allowed the challenge, eliminating Robinson, and then took up the case of A. R. McIntosh, previously challenged by the state because

PRELIMINARY SURVEY FOR WATER SYSTEM

Centralia, Wash., Oct. 21.—City Engineer Artberry has completed the preliminary survey for the pipe line from the headwaters of the Newaukum river into Centralia to supply the water for the proposed gravity system to be installed in this city and Chehalis. The line will be 13 1/2 miles in length, and the estimated cost of installing a 20 inch main, which would be necessary in the event the proposition was gone into jointly with Chehalis, would cost \$112,000.

A majority of local voters are in favor of issuing bonds for the plant, and a bond election will probably be held about December 1. In this case it is believed the plant will be completed by June 1.
