

PROGRESSIVE LAWS ATTRACT CAPITAL TOWARD ARIZONA

Insurgent State's Constitution and Officeholders Do Not Serve to Drive Moneyed Interests Away.

(Special to The Journal.)
Los Angeles, Jan. 8.—Progressive laws and a progressive constitution, with progressive men in office, do not drive capital away from a state. Much to the contrary, they act as an incentive to business. At least such is the experience of Arizona in the last year.

"Well advertised scores that a 'radical' constitution would injure our commercial prospects," said Charles Akers, proprietor of the Arizona Gazette of Phoenix, here, "have been thoroughly disproved. On the other hand, Arizona's progressiveness in politics and her strong fight for progressive constitution, have been of tremendous advantage."

Inquiries Four In.
"Since the framing of the constitution, thousands of inquiries regarding the resources, both agricultural and mineral, have poured in from all parts of the country. The first year of statehood will see an enormous increase in population and in money invested. Set here have been attracted from the ring-ruling cities of the east and middle west by the prospect of living under our government where each one has a real voice in affairs."

"The Salt River valley is filling up with settlers and ranch owners and in the mining districts there is renewed activity. Capital, instead of fleeing in terror, finds itself more secure than in less progressive communities. While many industries face a thoroughgoing regulation their securities are firm because conditions are stable."

People Pleased.
In fact, so thoroughly pleased is the average Arizonian with the new deal in politics, that the coming session of the legislature, the first under statehood, will undoubtedly enact many progressive laws, among them one permitting the people to vote on re-instating the recall of judges, provided that President Taft found so objectionable.

As to the form of recall to be enacted there is some difference of opinion, both the Swiss and Oregon systems having strong advocates. Under the Swiss system the only issue voted on at a recall election is whether or not the accused official shall continue to hold office. In the event of his elimination the governor appoints a successor. Under the Oregon plan the candidate under fire at the recall election faces the added issue of an opponent's possible superiority.

Will Propose Swiss System.
A. A. Worsley, a state senator-elect from Tucson, will propose the Swiss system. He is at work on a bill and will defend it on the ground that the recall of judges is an official under fire is handicapped by the double fight to an unfair degree. Worsley's bill will provide that when the recall is submitted to the people for incorporation in the constitution that both plans be placed on the ballot, so that the voters may choose between them.

However, Worsley will have considerable opposition, the Oregon system having many advocates in the new state. They point to the fact that wherever tried the plan has proved successful and fair.

Seaport Badly Wanted.
Among other level matters of legislation likely to come before the new legislature, will be the problem of getting for Arizona a seaport. Of course, this will have to be achieved through the agency of the federal government, if achieved at all, but the legislature will do what it can to prod along Uncle Sam toward an end that is dear to the hearts of the baby state.

The scheme in brief is to purchase from the republic of Mexico the strip of land east of the Gulf of California and south of the Arizona border, annexing it to Arizona. Ralph H. Cameron, delegate in congress, has been working on the plan for a year and is using his utmost activities at Washington to bring it about.

ACCUSED O-W. CO. CLERK ARRESTED

Temple Alexander Released Under \$3500 Bonds; Examination Waived.

Accompanied by his attorney and his bondsmen, Cord Sensiack and J. H. Brook, Temple W. Alexander, the O-W. R. & N. clerk accused of the theft of \$15,000 through forged vouchers, appeared at police headquarters this morning and was formally arrested by Acting Detective Captain Day. He was released on \$3500 bonds and waived preliminary examination. The evidence against him is being presented to the state grand jury today and the railroad officials expect his indictment tomorrow.

While the railroad officials say they expect Alexander will plead guilty, they claim that if he does not the two banks alleged to have been swindled—the Lumbermen's National and United States National, and the National Surety company will unite with the railroad in prosecuting Alexander, with the result that he will have sentences piling up on him that will keep him in the penitentiary for a long time.

Experts who have examined the vouchers Alexander is alleged to have forged say that Alexander's campaign plans and his nerve, in addition to his skill as a forger, are such as to make him a criminal of national reputation. WANTS PERMISSION TO SUE MILTON W. SMITH
The president and trustees of Pacific university and Tualatin academy at Forest Grove have asked permission of the United States district court to bring suit for the collection by foreclosure of a promissory note for \$4500, said to have been given the university by Attorney Milton W. Smith, a former trustee of the institutions, in 1889, and which they claim has been due since 1889.

As Mr. Smith's property is in the hands of the federal court through bankruptcy proceedings, it is necessary to obtain permission of the court to bring suit. E. Plowden Stott is trustee of the estate in bankruptcy.

The petition alleges that September 15, 1889, the trustees of the two schools received a promissory note for \$4500, signed by Milton Smith and John Sweek. The note was guaranteed by a mortgage on lots 1, 2, 3, 4, 6, 7 and 8, in Carothers' addition, and it is alleged that January 23, 1911, Mr. Smith was owner of an undivided one third interest in these lots. Permission is asked to foreclose the mortgage, as it is alleged Mr. Smith paid interest on the loan up to June 25, 1909, since when, it is claimed, he has paid nothing. The petition states that the trustees voluntarily reduced Smith's interest March 24, 1894, from 9 per cent to 6 per cent. Napoleon Davis and Newton McCoy are attorneys for the trustees.

Witness Against Chinese Missing.
Upon request of Assistant United States Attorney Evans, the case of the United States against Chee Wah for alleged violation of the federal white slave act, was continued today until February 23. It is said that the complaining witness against the Chinaman is missing. Chee Wah is a federal prisoner at Kelly's Butte.

Chee Wah is said to have brought a white woman from South Bend, Wash., to Portland, for immoral purposes. The woman was not kept in jail following Chee Wah's arrest, and has disappeared. The federal officials believe they will locate her before the date set for trial.

Postoffice Robbed.
When the drug store of A. W. Allen, at Fifteenth and Lovejoy streets, was robbed late Saturday night, among other property stolen were 67 cents in cash stamps taken from a postoffice drawer. The drug store is substitution No. 12, of the Portland postoffice. Post-office inspectors are investigating the robbery, though they think it was not directed primarily at the postoffice funds.

LAKEVIEW IS HAPPY WHEN FIRST TOUCH OF WORLD IS FELT

Celebration of "Railroad Day" Marks Opening of Most Important Epoch in History of Lake County.

Lakeview, Or., Jan. 8.—"Railroad day" marked the end of one of the hardest fights that any community in Oregon has made to get into touch with the outside world. It is the culmination of a dream that has been handed down from father to son. The weather has been colder than usual and the outdoor sports were set aside for the Central Oregon Development league meeting in June. With the dawn of Saturday morning the people were awake to the necessity of handling the many hundreds of visitors who were coming from points along the Nevada-California-Oregon railway which was running special trains for their accommodation. The doors of nearly every home in town were opened to strangers. The ladies of the Civic Improvement club and the Lakeview Commercial club worked hand in hand in this matter and saw that every one had a place to sleep.

When the whistle sounded at Bagley Point two miles south of town a great cheer arose. When the crowds finally met, the panting engine drawn up at the station site, they were led by the Lakeview band, a splendid organization, to the courthouse, where all awaited the arrival of the second section of the train. Its passengers were escorted to the same place where all were addressed by Mayor E. E. Rinehart and President E. L. Britten of the Commercial club, who turned over the keys of the town to the visitors. Manager T. F. Dunaway of the N.C.O. railway, responded in a few words to the welcome extended. The visitors were then escorted to the opera house, where a bountiful spread had been provided by the ladies of the Civic club.

The visitors were amazed at the large expanse of territory that the new railroad opens up and expressed the belief that a few years hence the people would not recognize the valley from any of its old landmarks now in evidence. When told that this was the fourth largest valley in the county and that the others were fully as good from an agricultural standpoint, they marveled.
