

DEED EXECUTED AS SECURITY FOR LOAN IS CONSTRUED AS A MORTGAGE.

(Salem Bureau of The Journal.) Salem, Ore., March 6.—By a decision written by Judge Bean and handed down from the supreme court yesterday afternoon, Elizabeth Grover, widow of and executrix for Lafayette Grover, wins in her suit for title to about 50 acres of land in the vicinity of the city of Portland, near the west reservoir. The lower court is reversed by the decision.

The suit was brought by Mrs. Grover against the Hawthornes and the Multnomah county circuit court held the deed was valid. The case in the supreme court was argued in time of stress the Hawthornes loaned money to the Grovers and as security a deed was given to the Grovers' interest in the property involved. When an effort was made to redeem the property, Hawthornes contended the deed was bona fide. Grover contended it was on the same basis as a mortgage.

The case was taken into court and the Multnomah county circuit court held the deed was valid. The case in the supreme court was argued in time of stress the Hawthornes loaned money to the Grovers and as security a deed was given to the Grovers' interest in the property involved. When an effort was made to redeem the property, Hawthornes contended the deed was bona fide. Grover contended it was on the same basis as a mortgage.

An important decision was rendered in the case of the Hawthornes and the Grovers in which the decision of Judge L. T. Harris of the Lane county circuit court is reversed. This was a case involving the validity of an election held by the town of Springfield under the provisions of the Home Rule law at which the town went over Judge Harris held the election not legal because the boundaries of two precincts used in the general elections were not within the town limits, Justice McBride wrote the opinion, Justice Brown dissented. The lower court, Justice Burnett dissenting.
