

MEXICAN FEDERALS AND REBELS CLASH NEAR CEBALLOS

Fate of Mexican Revolution Depends, It Is Believed, Upon Battle Being Waged To-day by Two Armies.

(United Press Leased Wire.) Mexico City, May 18.—With the life of the Mexican revolution at stake, the rebel forces led by General Pascual Orozco and government troops commanded by General Huerta, this afternoon are engaged in a terrific struggle near Ceballos, according to dispatches received here. Meager reports of the clash received before the federal troops cut the telegraph wires say that the battle is being fought furiously, the two commanders fully realizing that the fate of Mexico hangs on the outcome.

The advantage undoubtedly lies with the federal troops. General Huerta's men are well clad, well fed and provided with the full equipment necessary to carry on modern warfare.

Soldiers Tired and Hungry. General Orozco's soldiers are tired, hungry and discouraged and it has been a struggle for the rebel chieftain to obtain sufficient ammunition to withstand federal advances. Recent reverses have served to discourage many in the revolutionary army and desertions have been frequent.

Just before Huerta's men attacked the rebel force General Orozco ordered the second column of his army to attack Torreon, 1500 other revolutionaries at the same time besieging Monterrey. General Baniagua at the head of 2000 federal troops is rushing to the relief of both cities.

The general situation throughout Mexico this afternoon is critical. Rebel troops are moving things with a high hand in the state of Oaxaca and in Vera Cruz the situation is such that the American consul in the city of Vera Cruz has ordered all Americans to leave the state.

Decisive Battle Expected. The government troops have established headquarters at Cuernavaca in the state of Morelos and a decisive clash is expected there.

The Red society expects the battle to be a stubbornly fought and is rushing nurses to Cuernavaca.

A force of 1200 rebels, according to reports received here, was defeated in a battle with 300 rurales yesterday near Taxico, the revolutionary losses totaling 70.

FORMER LEGISLATOR ASKING FOR DIVORCE W. E. Burke, a former member of the state legislature, is today asking the circuit court to grant him a divorce from Alameda Burke, whom he married for the second time November 1, 1911, after divorcing her, June 24, 1910. That she has an "unfavorable temper" is the chief ground upon which the complaint is based.

Burke sets forth in his bill that the woman secured a divorce June 24, 1910, from Gilbert Mills. She married Burke the same day, not knowing the Oregon law prohibited a remarriage within six months from divorce. When they discovered this, they had the marriage annulled, and were properly married November 1, 1911, at McMinville. During the greater part of their married life they lived on a ranch in Yamhill county. Considerable help was employed on the place, the complaint recites, and Mrs. Burke continually quarreled with them, thereby causing them to leave the place.

MORRIS PAROLE UP TO GOVERNOR TUESDAY

(Salem Bureau of The Journal.) Salem, Or., May 18.—It is not likely that the parole board's recommendation of parole for W. Cooper Morris, convicted banker, will reach Governor West before Tuesday. The delay is due to the fact that after the recommendation is written up by the secretary of the board it must be sent to each member for signature.

Until it officially reaches Governor West he declines to make a statement as to what action he will take. It is known that he believes others should be in the penitentiary with Morris.

In the light of this and from the fact that he has nearly always followed the recommendation of the parole board, it is the general belief here that the governor will act favorably on the parole board's recommendation.

LONGSHOREMEN WOULD SETTLE HARBOR STRIKE (Special to The Journal.) Hoquiam, Wash., May 18.—T. V. Conner of Buffalo, N. Y., president of the International Longshoremen's union, accompanied by John Keen, president of the coast seamen's union, are here today to effect a settlement with the Grays Harbor Stevedoring company. Stevedoring officials say that a compromise will not be effected and the longshoremen officials hint at refusal to handle lumber from this port, which they control. The strike of longshoremen here began in 1908 and since then open shop has been in vogue.

Warrant Issued. A warrant has been issued for the arrest of Nils Bergstrom for forging a check for \$14 on the United States Bank. He cashed the check through Otto Evensen, signing it William Lind, making it payable to himself and endorsing it. He will be taken before Judge Olsen in the justice's court.

STRIKERS MAY CLOSE 'EATERIES'

Waiters Threaten to Walk Out in Sympathy With Cooks and Bakers.

(United Press Leased Wire.) San Francisco, May 18.—With a general strike of all union restaurant and hotel employees in San Francisco threatened, the union cooks in all places against which a boycott has been levied by the striking union bakers, are out on sympathy strike today. The bakers declare they will fight until the Master Bakers' association concedes their demand that all union made bread shall bear the union label, and in all places where non-union labor is being engaged they will place the cooks on strike and walk out. The cooks' helpers, waiters and waitresses declare they will follow suit soon.

The bakers declare their strike is already won, as far as the small shops are concerned, but that the three large concerns are still standing firm. The Bakers' union today issued 2,000,000 labels to the small bakeries, while a rush order for more labels was placed.

APPOINTED MANAGER OF TOURIST AGENCY

With the intention of establishing its first office here, the Grand Trunk system has appointed Dorsey B. Smith, manager of the Tourist Agency and Travel Bureau, located in the Commercial club building, city passenger and ticket agent. Mr. Smith will run the ticket office in connection with his agency and expects to move into larger quarters here before opening the tourist agency. Mr. Smith was manager of the Open River Transportation company and for a number of years prior to that he was connected with different railroads and in handling the passenger business here of the immense system which is about to open a city office in Portland.

Hiker Arrested in Utah.

(Centralia, Wash., May 18.—According to word received heretofore, Clyde Patton, the Rochester boy who is walking from Centralia to New York, was arrested on a charge of murder. Patton was passing through the town shortly after the murder and being a stranger and travel stained, was taken on suspicion. Letters on his person from Governor Hays to Governor Dix of New York proved his identity, however, and Patton was later released.

Suit to Rescind Contract.

Suit to rescind a contract on a sale was started yesterday in the circuit court by Mrs. Edith Owen against Mrs. Minerva Jones. The plaintiff alleges she purchased a rooming house, it being represented that the place was a good money-maker. After operating it a few weeks it proved a money loser, she complains in the complaint. The place is at 927 Union avenue.

STAYTON GRANTS FRANCHISE TO RY

J. F. Mounce Given Right to Use Streets for Electric Line.

(Special to The Journal.) Stayton, Or., May 18.—A railroad franchise for rights of way on three Stayton streets was granted to J. F. Mounce by the city council at a special session Thursday night. Mr. Mounce agrees to begin actual construction work within 90 days. He further agrees to complete his road within 24 months. These provisions are incorporated in the franchise, and failure to meet them will invalidate the measure.

Mr. Mounce has been projecting an electric line from Salem to Stayton, and his application for a franchise was a culmination of a successful effort to obtain a right of way between the two cities. There is much conjecture as to what interest Mounce is representing. Recent announcements by the Portland, Eugene & Eastern railroad leads to the belief that he is being backed by that company.

Will Vote on Bond Issue.

(Special to The Journal.) Stayton, Or., May 18.—As a result of an effort to get needed street improvement an amendment to the city charter providing for the issuing of bonds will be put to a vote at a special election June 17. The proposed amendment, which has been prepared by Attorney Helzel, embodies the essential provisions of the Bancroft act.

Celebration Is Planned.

(Special to The Journal.) Stayton, Or., May 18.—A big celebration will be held in this city July 4, according to plans formed at a meeting just held. An unusual number of concessions and special attractions are planned. Committees have been appointed.

Accident on Stayton Ferry.

Stayton, Or., May 18.—While crossing on the Stayton ferry with 60 pounds of dynamite in the buggy, the team of William Follis backed off the boat into the swift current and narrowly escaped drowning. The horses managed to land on the island below town, but the dynamite was lost in the river. The driver was not in the buggy.

Pursuit of Knife Wielder.

San Bernardino, Cal., May 18.—Twenty men, heavily armed, today are pursuing H. Garcia, a Mexican section hand, who stabbed a pioneer family, Ygnacio Martinez, a desert railway station agent, Garcia fled, armed with a rifle and two revolvers.

FEDERAL EXPERT IN TREE NURSERY HERE

C. R. Tillotson, an expert in tree planting and seed germination of the United States forest service, is in the city from Washington, D. C., on his way to the Wind River nursery where he will assist in experiments leading to the establishment of an permanent station. Mr. Tillotson will give the local forestry men what information he can. He will work in cooperation with the local headquarters during the coming summer.

E. L. EMERY, ST. LOUIS CITIZEN, DIES SUDDENLY

(Special to The Journal.) Gervais, Or., May 18.—Eugene L. Emery, single, age 43, residing with his mother, Mrs. L. L. Emery at St. Louis, Or., died suddenly this morning at 1:30 o'clock from thymia. He belonged to a pioneer family and was born and raised on the St. Louis farm. He leaves a mother, four brothers and four sisters. Burial will be at St. Louis and will probably be on Monday.

ARBITRATION VS. GUN, SUBJECT OF MANY ADDRESSES

Principals of Portland Schools Tell Pupils the Meaning of Peace; Would Have Day Set Aside for Observance.

Today is Peace day, a day set aside to commemorate the meeting of the first international peace conference at The Hague May 18, 1899, when 100 delegates representing 26 nations of the world, met in the famed "House in the Woods," formerly the summer residence of the royal family of Holland, and took the first steps to crystallize the movement for world peace. Although the day is observed in Russia, Holland and several other European countries, in America little attention has been paid to this far outside the public schools. In Portland the day slipped past without official notice.

It was generally observed in the public schools yesterday, however, when the significance of May 18 and the peace movement was explained to Portland's 26,000 students, by the principals of the various schools, in accordance with instructions issued by Superintendent of Schools Frank Rigler.

Origin of Movement. In their addresses, the school principals explained the origin of the peace movement, from the time when Czar Nicholas of Russia, in 1898, addressed letters to every nation of the world represented at the Russian court, inviting them to send delegates to a meeting and conference on peace, leading toward world peace, until the present time.

The heavy toll that is demanded of the citizens of the United States to keep the army and navy in operation is pointed out in time of peace, the direct and indirect cost of war was told, and the plans now being considered and the steps being taken toward world-wide peace were explained.

It was pointed out that the cost of keeping the civilized nations armed and ready for hostilities is \$2,000,000,000 annually, a burden that is steadily growing greater, and that 14,000,000 able bodied men were sacrificed in war during the nineteenth century.

How several new wars had been prevented as a result of the creation of The Hague court of arbitration, which has settled several grave disputes, such as the "Dogger Bank affair," when the Russian fleet fired on British fishing vessels during the Russo-Japanese war, were also touched upon, as illustrations of the good that the movement has already brought about.

To Make It World Holiday.

The students were told of the workings of The Hague court and its organization, particularly of the court which consists of a panel of 19 eminent jurists, appointed by 40 sovereign countries, each country appointing from one to four members.

Proponents of the movement toward a world peace, which include the leading men of practically every nation, are working to the end that May 18 may be set aside throughout the world as a great international anniversary to proclaim the gospel of good will among all men.

Among the organizations that are contributing materially to the advancement of the movement in the United States, Eugene & Eastern railroad, the National Education association, and the American School Peace league. Both organizations through their members have undertaken to educate the school children in regard to the meaning of world peace and the general good that would result throughout the world should arbitration replace the gun in the settlement of governmental disputes.

THIEF SENTENCED 3 HOURS AFTER CAPTURE

Within three hours after having been captured for the theft of \$11.95 from Thomas L. Kiley, tenant at the Merchants hotel, C. Yancen, alias Donahue, had been sentenced to one year in the county jail and was on his way to serve a sentence of 100 days in the jail. Thomas L. Kiley, tenant at the Merchants hotel, entered his room and stole his trousers from under his pillow in which the money was contained. When Night Clerk John Roberts spied upstairs at Kiley's room, on being advised that he had stolen the money, he called the police and they met Yancen in the hall and was knocked down by the thief as he sped by. He ran into a room, however, and locked himself in. Patrolmen Munwaring and Dalrymple were called and invaded the room and after placing the man under arrest, made a search of the room for the stolen clothes and money, which was found under the dresser. Yancen entered a plea of guilty this morning before Judge Taxwell.

LOVERS INTERRUPT WIRELESS SERVICE

Newport, R. I., May 18.—The matter of the radio amateurs and others with the wireless communication of the naval torpedo station and ships of the Atlantic fleet has reached a climax in the last two weeks. Maidens living in Boston and other cities along the coast send the most trifling messages to their seafaring friends.

One of the most ardent messages intercepted here was from "Sweetheart Maggie" to "Darling Jack" in which Jack was informed that she was as good as dead because Maggie's heart was "just melting away" for him and he "hadn't kissed her for so long her lips were dry."

Captain Williams, commanding the torpedo station, has incorporated many of the intercepted messages in a report to the navy department, and they will be placed before congress in an endeavor to show why there should be government regulation of wireless.

GETS MONEY ON WHICH TO LIVE, FALLS DEAD

While making arrangements through Attorney R. Citron in the Hamilton building for an income to provide for himself in his declining years, A. Friedberg, aged 72 years, who has lived for some time on a houseboat at Linnton, fell dead in the attorney's office just after having signed the necessary papers. The deal involved the sale of some property that would have provided an income for several years. Heart failure is given as the cause of his death. It is said that he has children in California, who will be advised at once of their father's demise. The remains are at the Dunning & McKee parlors.

ROOSEVELT MAY HEAD 3D TICKET

Bolt at Chicago Predicted in Case Taft Followers Use Steam Roller.

Washington, May 18.—That Theodore Roosevelt may bolt the Chicago convention in case he is unable to obtain the desired nomination is hinted at here. That he may run independent at the November election is suggested in an editorial printed in Collier's yesterday. The editorial treats of the tense situation between the two wings of the Republican party with unusual clearness. In part the editor says: "In the Republican party the immense personal popularity of Colonel Roosevelt, built up by 30 years of devoted and trustworthy leadership, has focused the 'progressive' vote to an extent thus far unexampled. If, in spite of the overwhelming evidence that most of the Republicans want Roosevelt, the nomination of Taft is pulled through, and if, on the other hand, the Democrats nominate Underwood, Harbord or Clark, Roosevelt will, in our opinion, be forced by irresistible pressure to run on a third ticket—non-partisan progressive ticket. With a strong and progressive Democrat running with him as candidate for the vice presidency, both the old parties would be up against a problem, even in the south."

The Ohio primaries will be held Tuesday, May 11. The delegates then chosen are the biggest political game yet to be bagged before the Chicago convention meets, and for that reason both are concentrating their efforts to carry the primary election. Double interest centers around the Ohio fight, however, because Ohio is the president's own state and a Roosevelt victory there would place a heavy handicap on the president should a bolt of southern delegates ever be started.

La Follette Denounces Colonel.

(United Press Leased Wire.) Bowling Green, Ohio, May 18.—Senator La Follette left for Columbus today, where tonight he will continue his fight against President Taft and Colonel Roosevelt for a portion of Ohio's delegation to the national convention. The Wisconsin senator is centering his fight in the Ninth, Twelfth, Twentieth and Twenty-first districts, and will be content if he can secure control of the delegates from these districts. In his address here last night Senator La Follette referred to President Taft as "an amiable, easy-going fat man" and bitterly denounced Roosevelt, asserting that the latter's campaign is being financed by representatives of "big business."

Colonel Has Many Speeches.

(United Press Leased Wire.) Columbus, Ohio, May 18.—Colonel Roosevelt left Columbus early this morning to carry out today's itinerary, which calls for 11 speeches in as many cities and towns. The former president will speak tonight in Cleveland and will spend Sunday at Mentor, Ohio, the home of the late President James A. Garfield. Colonel Roosevelt will close his Ohio campaign Monday.

PIONEER WOMAN DIES AT AGE OF 80 YEARS

Death removed another pioneer who came to Portland at the time the present city was a mere hamlet, when Mrs. Elizabeth Dart Johnson, 80 years old, passed away last Wednesday at the home of her daughter, Mrs. Kate E. Thew, 773 Johnson street. Her death came very quietly.

Mrs. Johnson was the daughter of Anson Dart, commissioner of Indian affairs of Oregon territory before the great Northwest was divided. Her mother, Elizabeth, a sister of the noted traveler and portrait painter, George Catlin. With her parents she came to Portland in 1852. The first years of her married life she spent in the government house at Milwaukee. She was an aunt of the cartoonist, Harry Grant Dart.

Mrs. Johnson was the last of a large family, all of whom lived to ripe old age. She was the mother of nine children, three of whom survive, Mrs. Kate E. Thew, Mrs. C. E. Johnson of Chico, Cal., and S. S. Johnson of Morton, Idaho.

The funeral was held yesterday afternoon at the parlors of the East Side funeral directors at 2 o'clock. Rev. William Douglass officiated. Interment was in the Rose City cemetery.

TWO MOTHERLESS CHILDREN IN COURT

The two minor children who were made orphans by the murder of Mrs. Margarette Bellaire by Lew Torbet were before the juvenile court this morning for care. Since the death of the mother no one has taken charge of the two girls except an older sister, who is 18 years old, but has not the facilities for looking after their welfare. Judge Gatens suggested that the older sister be made the guardian of the girls, however, and the juvenile court will give all aid possible. After the murder of the mother, the home was closed, rent being due, and their clothes are now held at the place. A sewing machine with only a few dollars due was taken from the place by the company selling the machine. The girl over whom Torbet is alleged to have killed the woman was recently taken into custody and placed in the county jail, but she was released from that place upon petition of Lola Baldwin, head of the department of safety for girls. She is now in an east side home.

TWO COMPLAIN AGAINST LOAN SHARK METHODS

A complaint has been made to the grand jury by Mr. and Mrs. George Tiemyer about the loan shark methods used upon them by M. E. Schouweiller and Adolph Lane. The two latter men have offices in the Abington building. Tiemyer claims he negotiated a loan of \$50 several months ago, and has paid \$268 on the same, still being in debt to the two men.

Logs Jam at Bridge.

(Special to The Journal.) Stayton, Or., May 18.—A part of the log drive being brought down the Santiam river by the Spaulding Lumber company, jammed about the piers of the bridge and carried off some of the false work from which the steel bridge is being erected. The main portion of the drive is expected to reach here today.

RESTAURANT MAN CRUSHED BY AUTO

William H. Donohue, Speeding on Linnton Road, Is Killed.

William H. Donohue, 37 years old, proprietor of two local restaurants, was crushed under his 90 horsepower Thomas car on the Linnton road last night and died before he could be extricated. Leonard Lash, his brother, Louis J. Lash, Walter Shepard and Walter Dickinson, riding in the Dickinson automobile from Linnton, were among the first to reach Donohue, being attracted by the flames of his burning car.

"We had to make three attempts before we could get Donohue from under his burning car," said Lash this morning. "His feet were wedged under the engine, and the blaring car made it so hot that it was hard to get near enough to extricate him. He was dead when we finally got him out. From the position his car was in I imagine that it skidded completely around on the road and threw him under the running gear, the tank exploded and set the car on fire."

Detective William H. Royle and Mrs. Royle, who were riding on the Linnton road on a motorcycle, were also among the first to reach Donohue and do what they could to rescue him. H. W. Metzger, C. F. Berg and G. E. Carroll, who were riding in an automobile toward Portland, were soon at the wreck and gave what assistance they could.

The body was taken to the morgue and friends of the dead man were notified. Mrs. Donohue, who left Thursday night for Boston, where she was going to visit, was telegraphed to, the message reaching her on the radio, and she is now on her way back to Portland.

Donohue lived at the Rose Friend apartments at Seventh and Jefferson streets. He was the owner of the Linnton dairy lunch place at 247 Washington street and 16 Sixth street. No inquest will be held.

BASEBALL STRIKE ON TODAY UNLESS COBB REINSTATED

"Ty Cobb will not be reinstated, and if the Detroit team or the players of any other American league club refuse to play this afternoon, as they have threatened they will be punished also. The league will make the club owners stand aside and will act directly in cases like that of Cobb."

Johnson declared he witnessed the affair for which Cobb was suspended and that the players' assault on a bleacher spectator was unwarranted. He wired Jennings at Detroit for full particulars and will make Cobb's suspension definite when a reply arrives. Johnson said he did not fear a strike of the Tigers or the players of any other American league team. He wired Jennings to call for 11 speeches in as many cities and towns.

"Fiery Tempered Georgian." "Cobb is a fiery tempered Georgian, which may have something to do with his action," said Johnson. "No player has a right to attack a spectator. If anyone abuses language, a player need only notify the umpire, who will call a policeman, and the spectator will be put out of the park."

"There was a policeman within 20 feet of the spot where Cobb attacked this spectator and he could send these called the officer, instead of taking the matter into his own hands."

"Cobb has been in similar difficulty before," declared President Johnson. "He attacked a spectator in Detroit once, and got into trouble during the world's championship series between Detroit and Pittsburgh. Once there was a warrant out for his arrest in Cleveland."

General Call Is Issued. That the "strike" of the Detroit and Philadelphia players will spread throughout the league is threatened. They have issued a general call for the players everywhere to refuse to play if Cobb is suspended.

The Tigers and Athletics declare they are willing to compromise the matter if Cobb is fined or if his suspension is definitely limited. Messages were sent today to every team in the American league asking them to send representatives to this city to attend a general meeting of the players tomorrow when it is proposed to form a players' protective association. The Tigers and Athletics declare they are willing to accept Johnson's ruling if modified so that players will be forced to submit to any abuse.

This afternoon the Tigers formally announced that as far as possible they would accept the ruling of President Jennings. It is understood that the striking players have agreed that enough regulars from their number shall play to make up a team after Jennings has procured the available stands.

It is reported that Jim McGuire, former manager of the Cleveland Naps, will catch at this afternoon's game, while Jennings himself will play an infield position.

The Tigers are still standing firm, but intend to protect Jennings against the \$5000 fine which he will have to pay, according to the rules of the American league, if he fails to produce nine men this afternoon.

Thousands of fans cheered the Tigers as they left the grounds with Ty Cobb in the lead.

Georgians Commend Cobb.

(United Press Leased Wire.) Washington, May 18.—Commendation of the action of Ty Cobb, star player of the Detroit baseball club of the American league, in thrashing a fan in the bleachers at last Wednesday's ball game, was forwarded to the suspended player today by the Georgia members of congress, consisting of United States senators Augustus Bacon and Hoke Smith, and congressmen Edwards, Roddenberry, Hughes, Adamson, Howard, Barker, Loe, Tribble, Bell, Hardwick and Brantley.

The telegraphed message of the delegation to their fellow Georgian is as follows: "We Georgians commend your action resenting uncalled for insult. Hope for your complete exoneration and speedy restoration. We are proud of your record as leader of your profession."

INDICTMENT AGAINST LOVELL IS DISMISSED

The indictment against Samuel Lovell, in which he is charged with larceny by baillee, has been dismissed in the circuit court. He was originally accused of appropriating \$2500 to his own use, this sum belonging to the Colonial Oil company of Seattle. A. J. Hosom was the complaining witness. Lovell was arrested at Rainier two months ago, in dismissing the indictment, warrants were served charging another crime in Seattle, where the case will be prosecuted.

CUNNINGHAM HAS HIGH PRAISE FOR LOCAL SHRINERS

Few Stragglers of Red-Fezed Nobles in City; Members of Al Kader Temple Worn and Weary but Happy.

Only a few belated stragglers from the great army of nearly 4000 Shriners that passed through Portland this week are in the city today. Not more than 10 or 12 of the red fezzed nobles could be rounded up by Harvey Beckwith of the Al Kader reception committee, who was on hand all day with automobiles, ready to take any who appeared out sightseeing.

The enthusiastic welcome for Imperial Potentate William J. Cunningham yesterday marked the finale of a week of pleasure. "Some of the pleasure at that has been mixed with great bodily weariness for Portland Shriners who have had to arise early and remain up late to receive and entertain each new-coming host of nobles."

Mr. Cunningham's visit here was made more than ordinarily pleasant by his reunion with three old comrades. They were W. G. Bristol, potentate of Al Kader temple; J. G. Merrick, past potentate, and W. G. Haskell, of Cedar Rapids, Iowa, a friend of many years. Mr. Haskell's visit was enlivened by meeting here B. S. Josselyn of the Portland Railway, Light & Power company, with whom he was a railroad telegraph operator 20 years ago.

Mr. Cunningham was warm in his appreciation of the reception tendered him by Al Kader temple. He declared that it eclipsed anything he had seen on the Pacific coast, and he paid a further high compliment to Al Kader Shriners by telling them that while he was here he had not seen a single act by a single Portland Shriner that was not that of a thorough gentleman.

TWO COTTAGE GROVE PIONEERS PASS AWAY

(Special to The Journal.) Cottage Grove, Ore., May 18.—The funeral of two well-known citizens took place here this week. Funeral services for William H. Arne were held from the M. E. church. Rev. Sutcliffe officiating. Appropriate eulogies were conducted services at the grave.

Apparently in good health Sunday, when he received a visit from Governor Oswald West, and enjoyed a hearty dinner at the home of his daughter, Mrs. F. E. Phillips, Mr. Arne passed quietly away Tuesday morning, after a lingering illness with a complication of diseases.

William H. Arne was born in New York December 6, 1845, being nearly 66 years of age at time of death. He was a veteran of the Civil war, serving three years and being wounded at Cold Harbor. He was married in 1871 to Nettie M. Creswell of Parkersburg, Iowa, making for them a home in South Dakota and to Cottage Grove 14 years ago. Mr. Arne had been a member of the M. E. church for 41 years.

A widow and seven children survive the deceased. The children are Mrs. E. E. Phillips, Rufus, Leonard, Claude R., all of Cottage Grove; Mrs. L. M. Little, Iroquois, S. D.; E. D. Arne, Everett, Wash.; R. W. Arne, Fossil, Or. The funeral of William Churchill was held Wednesday afternoon from the Christian church, 123 Jones street, officiating. Mr. Churchill was one of Lane county's best-known pioneers.

Mr. Churchill was born in Kentucky, but in early childhood moved to Illinois and later to Iowa. From Iowa he came to Cottage Grove with two children, J. S. Churchill of Marcella and Mrs. S. L. Knox of Cottage Grove, drove across the plains with an ox team to Oregon in 1851.

Mr. Churchill was the father of nine children, six of whom survive. He has a paralytic for six years.
