If I were a little, tiny girl, I'd never Never Land, do you think I'd pick out that sort of woman for my mother? Would I choose a woman who bores everyone to death telling about her children, a woman who doesn't know a thing in the world but the nursery, a woman who couldn't tell a story to save her life unless it was something about the safety pin and a little girl who swallowed one, and what happened to her? Not I, never!

I'd toddle right up to you, dear Madame Schumann-Heink, and I'd look right straight into those deep, clear, loving eyes of yours, and I'd say: "Please be my mamma, and please go on singing, just the same. You wouldn't be you if you didn't sing. I'd rather have a chance to inherit my nature and my brains and my smile from you than from any other kind of woman in the world, and I'd take my chances with the bringing up."

Just give me a few of those qualities that have made you the glorious woman that you are, and I'll risk growing up all right, even if you do have to hire some one to wheel my baby carriage, and pay some one to curl my hair."

CLUB WOMEN UPON MOST LAVISH TRAIN

New Yorkers Travel Across Continent in Luxurious Pullman Special.

(United Press Special Wire.) New York, June 12.—When the Empire State club women's \$10,000 special train pulled out of the Grand Central station yesterday, bound for San Francisco and the national convention of the General Federation of Women's clubs, a new standard of lavish travel was set. The solid vestibule Pullman train is the most splendidly equipped and most luxurious train that ever crossed the continent. The big delegation to the California metropolis is due to the desire of New York state clubwomen to elect their candidate for national president of the federation—Mrs. Philip Carpenter of Yonkers. Daily coaches will be held on the train en route. The trip toward the setting sun will be enlivened by stops at several cities, where receptions will be tendered to the fair tourists. Five hours will be spent in St. Louis, and the Kansas City clubwomen also will entertain the party. Clubwomen of Los Angeles, Santa Barbara and Riverside will host the Golden State brand of hospitality. The special train will remain at San Francisco during convention week, beginning June 14, and will bring the clubwomen home via Portland, Seattle and British Columbia.

Are We Up-to-Date?

Editor Realms Feminine—I should like to say a few words in reply to "A Bar to Divorce," by Dorothy Dix. Having followed the discussion of the matrimonial question a few months ago I have come to the conclusion that our ideas about marriage have become antiquated. They originated perhaps at a time when woman was nothing better than the slave of the husband. When the husband discovered that his wife did not suit him as a life partner he was at liberty to enjoy himself with other women, while his wife was only his servant and had no rights whatever.

With the arrival of the new woman, woman suffrage and the ability of an ever growing number of women to make their living independent of man, I believe the time has come that trial marriages will be necessary to induce young men and women to get married. I believe the main reason why our young people shrink from marriage is the knowledge that as soon as they take the step they will be tied for life and can only under great difficulty and heavy expense retract the step, in case it proves a mistake. Mrs. H. E. wrote to Darra More under the head, "Urges Common Sense": "Too many wives complain of a lack of affection in their husbands. Why do they not use a little common sense and take husbands as they find them? . . . If woman would study the masculine mind before marriage, she would be better able to understand a husband."

Now, I assert that it is almost impossible for a young couple to find out whether or not they may be suited to

live together until they try. But what would be the good of marriage at present? They must be tied for life before trying, and perhaps in nine cases out of 10 be made unhappy for life. Of course, it must be a matter of honor on the part of the man to provide for the future child according to his ability, and in case he may have no honor he should be compelled by law to do so at the complaint of the girl without any expensive lawsuit. As the woman is the real parent, because she has suffered for and borne the child, and is endowed by nature to nourish the same, she may have the privilege of keeping and rearing the same. G. M. P., the twentieth century girl, said in one of her letters: "I have hopes and aspirations (I am not ashamed to say it) of possible wifehood and motherhood some day." 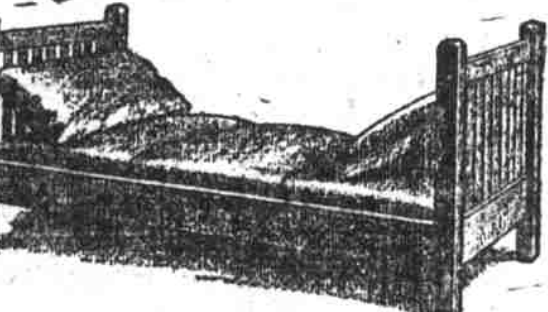
