

ROOSEVELT THIRD PARTY MEN WILL MEET ON JULY 1

Call to National Progressives Issued by Daniel Kellaher, Committeeman; Meeting to Be Nonpartisan.

Bying the bandana as its emblem, the Roosevelt third party latest will make its first step in Oregon next Monday night. A call for a meeting of "National Progressives" was issued by Daniel Kellaher, committeeman, who stated he had been requested to do so by a large number of Progressives. The feature of the call is the invitation extended to members of all parties to attend and the announcement that the meeting will be nonpartisan. This is taken to mean that Senator Kellaher is prepared to have his Republican badge and swing with tag and baggage into the new third party.

Acting with Kellaher in the movement are several of those who aided in the Roosevelt primary campaign. Among them are George Arthur Brown, who made speeches for the group from Oyster Bay, and L. M. Lepper, who was secretary of the Roosevelt campaign committee.

Fred W. Murky, national Roosevelt committeeman for Oregon, is expected to return Monday and to be present at the meeting called by Kellaher. The two uncompromising Roosevelt delegates to Chicago, Dr. Henry Wain and Charles W. Ackerson, are also expected to be back in Portland by that time, and they may add a few fireworks.

The call for the meeting reads as follows:

Call for Convention.
"At the request of a large number of Progressives, a meeting is hereby called to be held next Monday evening, July 1, at 8 p. m., in the auditorium of the East Side Library, corner East Eleventh and East Alder streets, for the purpose of organizing the Roosevelt Progressive Bandana club for work in the coming campaign. The meeting will be nonpartisan and progressives of all parties are invited to aid the movement. Human rights are supreme. Wealth should be the servant, not the master of the people."

"DAN KELLAHER, Committeeman."
As Kellaher is one of the regular Republican nominees for state senator and also a nominee for president-elect, his position as a party candidate may be called in question by participation in the new party movement. In filing his declaration as a candidate before the primaries he was required to promise that if nominated he would accept and would not withdraw.

Mr. Kellaher today stated that he does not know that his party standing will be affected by the course he is taking. "I am the Republican nominee, already nominated," he said, "and I am a progressive Republican. I have no intention of resigning from the Republican ticket, either for state senator or elector. Why should I?"

"I am not leaving the party. If somebody wants to put me out, they don't start something."

Chairman E. C. Wright of the Republican county committee said today he was not prepared to give an opinion as to how any desertions from the Republican party by candidates nominated at the primaries may be dealt with.

"If that condition arises, we will have to deal with it," he said, "but I am not looking for trouble. We will mark time and see how the situation turns. Some one spoke to me about the case of Kellaher, but I have given the matter no thought. I cannot say whether a desertion of the party by a candidate creates a vacancy on the ticket or not. It is a serious question and will have to be carefully inquired into."

Cheer Grows Bally.

This rally was greeted with a wild cheer.

"I'm for free sugar because it will take two cents off the cost of every pound of sugar," shouted James amidst tumultuous scenes. Another burst of applause followed when he continued:

"Don't take money, but if you do, have the courage to say you do."

"Roosevelt did not have to go to Africa to find wild beasts," James declared a moment later. "He could have found them right in Wall street opposing the people."

He believed Roosevelt is right when he says he made a mistake in picking President Taft for the presidency, but I believe it would be even worse to select a man who made the mistake for the job.

Reference to Bryan. The chairman's reference to Bryan started a veritable riot of yells and applause that James finally stifled by raising his mammoth hand. The cheering broke out anew, this time from all over the convention, when James said:

"I paid tribute to Representative Sherman of Ohio, whose pension bill, he said, had fitly recognized the Civil war veterans. The crowd went wild with enthusiasm as he referred to the pension bill in spirit and feeling with the north."

"James concluded with a final burst of oratory just as Senator La Follette of Wisconsin came on the platform as an invited guest."

Representative Palmer of Pennsylvania moved that the convention take a recess until 8 o'clock tonight and then begin the nomination of candidates for president. There were yells of "No, no," from the floor, mixed with utter confusion while many delegates, figuring that the motion would be carried, scurried for the exits.

Jerry South of Arkansas rushed to the platform and yelled an amendment that the convention proceed at once to nominate presidential candidates, but Chairman James went ahead with Palmer's motion, declaring it carried after an overwhelming chorus of "ayes" had attested to the majority's will.

HOTEL CLERK KEEPS HIS HANDS DOWN AND SHOTS ROBBER DEAD

Seattle, Wash., June 27.—S. R. Dawson, night clerk at the Hotel Norman, early this morning shot and killed Frank Redmond, a marine fireman from San Francisco, who had attempted to hold him up.

Redmond, with an unknown companion, entered the hotel and asked for a room. The clerk turned to answer the telephone, and when he advanced to the room again he was met by Redmond's revolver and a command to throw up his hands.

Instead of doing so, Dawson reached for his own revolver under the counter and fired at the holdup man, killing him instantly. Redmond's companion escaped.

C. J. REED'S CONDITION PRACTICALLY UNCHANGED

C. J. Reed, former United States marshal, who is seriously ill at his home, 715 Everett street, is still maintaining the same condition. The crisis is expected tomorrow and hopes are held that there will be a change for the better. His two sons who were in the east when the illness began, are with him having been summoned hurriedly to his side.

WOMEN PLEAD FOR REFORM IN PRISONS

Convention of Women's Clubs at San Francisco Listens to Able Speakers.

San Francisco, June 27.—Civil service reform, the subject of the defection of the nation—the state wards in prisons, reformatories, asylums and hospitals—was the principal topic before today's session of the Biennial Convention of the General Federation of Women's Clubs.

A number of militant addresses were made in defense of women's entry into the sphere of political conduct of state institutions. Among the speakers were Mrs. L. J. Hagganburg of Philadelphia, who presided. Mrs. Fred H. Tabor of Nebraska, who told of the fight of federal women for better conditions in the institutions of that state. Mrs. John Russell of North Carolina, who spoke on "Civil Service and the Municipal Government," and others.

C. C. Moore, chairman of the board of directors of the Panama-Pacific exposition, made an appeal for the 1915 fair, telling of the model playgrounds and other features to be presented.

DARROW DEFENSE SCORES GOOD POINT

Judge Intimates He'll Sustain Objection to Fallow's Testimony.

Los Angeles, June 27.—The Darrow defense apparently scored a point today when Judge Hutton intimated that late today he will sustain the defense's objection to testimony offered by Waldo Fallow, a stenographer, who copied by dictagraph an alleged conversation between Darrow and John R. Harrington.

Fallow admitted on the witness stand that the conversation came to him in a fragmentary manner and that all of it was not transcribed.

Hutton withheld his ruling for further consideration, hinting, however, that it would favor the defense.

SON OF DR. HOUSE ACCUSED; LARCENY

Two Hood River Girls Complain of Having Lost \$350; Bail Given.

Hood River, Or., June 27.—E. E. House, son of Dr. E. L. House, former pastor of the First Congregational church of Portland, now pastor of the First Congregational church, Spokane, was arrested on a charge of larceny by bail for securing \$350 from two girls employed as domestic servants in this city. Mr. House was admitted to bail.

He was formerly a teacher in the Hood River High school.

SELLS INTERESTS IN WASHINGTON-OREGON

A. Welch, organizer of the Portland, Eugene & Eastern railroad, which, it is announced, has been purchased by the Southern Pacific, has also disposed of his interests in the Washington-Oregon corporation of which he has been general manager for some time. J. A. Story of Tacoma, and associates, are the purchasers.

Mr. Welch stated this morning that negotiations for the purchase of his interests have been under way for some time and that they have now been closed. I. W. Anderson of Tacoma, is president of the corporation which has offices in the Yeon building, this city. The company owns and operates several light and power properties in this state and Washington.

Having disposed of his interests in the Portland, Eugene & Eastern and the Washington-Oregon corporation, Mr. Welch still retains interests in power and light properties in Rouseburg and Seaside in Oregon, Lewis county, Wash., and in various towns in Idaho.

SAILING RACES WILL BE HELD ON RIVER

Sailing races will be pulled off on the river next Saturday afternoon and on the afternoon of the Fourth of July by the Oregon Yacht club. If the wind is favorable they will start at 1:30 or as soon thereafter as possible.

Decision to pull off the races was reached last night at a meeting of the club officials and a committee was appointed to map out the program. Heading the committee is H. C. Hastorf. The other members are Thomas J. Mendon and E. O. Cronay.

Sixteen yachts are expected to enter the races, the feature of which will be for the Barbae trophy, now held by Mr. Cronay.

50,000 EXPECTED AT PENDLETON ROUND-UP

William A. Brown, proprietor of the Pendleton hotel, at Pendleton, is in Portland today in the interest of the Pendleton Roundup, to be held September 23-28. Mr. Brown is the originator of the slogan, "Letter Buck," that is now known all over the country, in connection with the Roundup.

"We are going to have a bigger and better Roundup this year than ever and it will certainly be worth seeing," said Mr. Brown. "Last year 30,000 people visited Pendleton to see the bronchos and the wild cattle handled by the cowboys, but this year we believe the number of visitors will reach the 50,000 mark. We will have special trains from all over the country bringing people who have read about the big and novel attraction."

CRISIS IN MEXICAN REVOLT AT HAND; HUERTA ATTACKS

Rebels, Strongly Entrenched, Await Onslaught of Federals; Foreign Residents Raise Flags Over Residences.

Chihuahua, Mexico, June 27.—With federal troops sending his full force of 1000 troops against the rebel stronghold at Bachimba, 45 miles from here, and confidently asserting that he will be in Chihuahua within five days, the crisis in the Mexican revolution is believed to be at hand today. The rebels, well entrenched and strongly fortified, are awaiting the attack with future success to that of the federal. General Huerta has moved his artillery up to within seven miles of the rebels. With this he will attack them from the center, while he has sent out two tanking columns to attack from either side.

Confederation reigned here among foreign residents, many of whom have raised the flag of their own nation's over their dwellings. It is thought that in case of defeat the rebels will flee into Chihuahua, which is now under their control, burning bridges behind them. In this event a disorganized fight is looked for, ending with rioting and looting within the city.

S. P. CO. TO ACCEPT COMMON USER SEEKS ELECTRIC FRANCHISE

Fourth Street Litigation to End; Hill Agreement Being Sought by S. P.

Mayor Rushlight was notified by officials of the Harrington lines today that the Southern Pacific has agreed to drop all litigation over the Fourth street franchise and to apply for an electric power franchise on the street subject to the common user provisions of the city charter.

The officials also stated that they are negotiating with representatives of the Hill lines in an effort to reach an agreement with regard to the common use of proposed franchises of both companies on the east side. The hope is expressed by the Harrington people that they will be able to announce a definite agreement between the two railroads at a very near date.

TAPS SOUNDED FOR OLD LINCOLN HIGH

The old Lincoln High School building, at Fourteenth and Morrison streets, the oldest high school in the city, was officially closed last night. More than 300 former students and graduates were present and took part in the exercises, which were the first of the kind in Portland. Addresses were given by President Earl Hammond of the Portland-Lincoln High School Alumni association; Miss Christina McConnell, the oldest teacher in the service of the Portland high schools; F. K. Warren, the first principal of the Portland high school; T. T. Davis, present principal, and others.

Miss McConnell, who has taught in this city for 28 years, in her talk looked back over the growth of educational system and spoke of the old days at the school. Mr. Warren also talked along the same line. Earl Hammond spoke on the history of the school building. Following Mr. Hammond's address, Miss Lila Rogers gave a vocal selection. Hopkin Jenkins, principal of the Jefferson High school, then spoke on the school spirit which pervaded the old school. Miss Florence McElroy and R. Haehlan played in a violin duet, and Miss Rogers sang another solo. D. A. Groat, assistant superintendent of schools, was also present at last night's exercises.

Several talks were made by members of the committee in charge of the Alumni association moonlight excursion, which is to be given Friday evening, July 19, and which is the first party of the kind to be given by the society since its organization.

Following the exercises a reception was held on the first floor of the building, where punch was served by young women. Later large masses of reds were burned in the street in front of the structure. Then the old school building was closed, for good, as an educational institution.

FIRE COMMISSIONER COHEN ARRESTED

D. Solis Cohen, fire commissioner and a prominent Portland attorney, was arrested last night by Patrolmen Humphrey and Adams, as he was trying to get through the exit gate at the Union depot after the gate had been closed. He was charged with being disorderly.

When the case came up this morning in the police court, Chief Slover appeared for Cohen, and after a few words with Judge Tazewell the case was continued indefinitely.

Johnson Given Great Reception.

Sacramento, Cal., June 27.—Five hundred cheering adherents wearing red bandana handkerchiefs on hats and collars, today welcomed Governor Hiram W. Johnson home from his journeying of the new party in Chicago. They met him at the train, forced him to hold a reception before he entered his automobile and then followed a brass band and a score of motor loads of Rooseveltans up to the capital. It has been a busy night, a real bull fight, this time," was Johnson's first comment on the Chicago convention and its results.

Injured by Fall.

Nels Hyllested, an employee of the St. Johns Lumber company, of St. Johns, fell a short distance from a pile of lumber, landing on his side. It was thought that he was seriously injured so the Red Cross ambulance was called. The machine made rapid time in reaching the scene. The injured man was taken to the Good Samaritan hospital, where he is suffering from bruises.

GREAT RECEPTION TO BE TENDERED THREE ELK HIKERS

City Officials to Take Part in Meeting Men on Arrival From Brookfield, Mo.; More Decorations.

Planes were launched today by the local Elks to make the arrival in Portland of three Elks hikers on July 4 of the three Brookfield, Mo., hikers, the leading event in Portland's celebration of the Fourth. Secretary Harry McAllister of the 1912 convention commission said that the state, county and city officials would be invited to participate in the parade that will welcome the hikers on the outskirts of the city. It is planned to bring the Missourians into the city at 10 o'clock in the forenoon of the Fourth.

The marching squad of the Portland lodge, the administration band, and several hundred Elks and friends in auto will meet the trio and they will be accompanied to the Elks building where the message to Exalted Ruler C. C. Bradley of the local lodge, from the exalted ruler of the Brookfield lodge, will be officially presented.

A reception will then be tendered the hikers and they will be quartered at the Oregon hotel during the grand lodge reunion at the expense of the local lodge.

Beach Dances Today.

The Elks, P. M. Lyon, M. E. Clark and C. D. Stone, are at the Ballies today. They will remain at the Ballies tonight to attend lodge meeting and will leave for Hood River tomorrow. They expect to reach Troutdale, on the afternoon of July 1. There they will go into camp and remain until the early morning of the Fourth when they will complete their 2100 mile hike.

Secretary McAllister held a long telephone conversation with the hikers and told them that they should be prepared to shade trees and the open. They said they were in splendid physical condition and felt fine, despite the fact that they have averaged nearly 20 miles each day since they left Brookfield.

The headquarters of the commission which were on the fourth floor of the Elks building, were moved last night to the new quarters on the northeast corner of Seventh and Oak streets, where offices were opened today. The offices of the hotel commission are located in the new quarters also.

More Decorations.

John Burgard, head of the decoration committee, is negotiating a contract today for the decoration of other business streets of the city not included in the court of honor. The decorations outside the court of honor, he said, would consist of Elks' flags and colors.

One hundred men are at work on the decorations within the court, which includes the blocks bounded by Sixth and Seventh streets and Yamhill and Stark. It is expected that the decorations will all be in place before the opening of the convention on July 5 unless adverse weather delays the workmen.

A large force of men will be put to work on Monday, adorning the walls of the big structure with flags and bunting.

LONG BEACH, WASH., FIRE BURNS 2-STORY BUILDING

Long Beach, Wash., June 27.—Fire of doubtful origin destroyed the two-story frame building occupied by the saloon of William Black and the Lyndell billiard parlor. The loss on building and fixtures is estimated at \$1500, well covered by insurance. R. M. Dickinson, bartender for Black, was examined by officers this morning.

County Division Political Issue.

White Salmon, Wash., June 27.—K. R. Brooks, an attorney at Goldendale, has announced his candidacy for representative. He claims to be a progressive and is opposed to county division. William H. Brooks of Goldendale, is a candidate for reelection as representative. The west end of the county may bring out Charles Spencer of the First National bank of this place, as its candidate on a county division platform.

AUTOMATIC TELEPHONES IN ENGLAND

Automatic Call Completed in 9 Seconds

"ALMOND'S HOTEL, LONDON."

London, England, May 20, 1912.

Dear Sir: The enclosed clipping is self-explanatory, and no doubt will be of interest to you and give some measure of gratification. In another paper I notice the government is starting in to install the Automatic, presumably account of economy and dispatch.

In this small hotel, which I am told is of the "swagger" variety, when I use the telephone (a process involving about ten minutes before getting into communication) and hang up the receiver, the bell rings constantly and the central operator says: "Are you there?" When I have convinced her that I am there in the flesh, she asks me to disconnect. I then take the lift and go to the office and arrange with the proprietor for a disconnection.

There will be only one danger in the Automatic in London, which is that many people will die of heart disease when they first use it.

GET YOUR NUMBER YOURSELF. Call in 9 seconds. Automatic Telephone at Work.

The new automatic telephone exchange at Epsom—the first of its kind to be tested in this country—was put into practical operation on Saturday afternoon. Experiments carried out by a Daily Mail representative showed that the new method of working is appreciably quicker than the old.

To transfer themselves from the call system to the automatic, all that subscribers had to do was to move over a small switch near their instruments. Each instrument has a circular dial fitted at its base with the numbers 1 to 9 and 0 round it. Raised a little above the dial is a movable disc, with circular apertures round it corresponding to the numbers below.

When obtaining a number, say 141, the subscriber first removes the receiver. Then he places a forefinger in the aperture in the disc above 5, and rotates the disc from left to right until his finger comes in contact with a small metal projection or trigger, raised above the surface of the disc. When it reaches this point the disc is released and automatically moves back to its former position. The process is repeated with the other numbers. If engaged the familiar "buzz" is heard.

A MINUTE SAVED PER CALL.

On Friday evening, for comparative purposes, four calls had been made under the old system and the times taken carefully noted. On Saturday evening, with the automatic system, these four calls were repeated. The times under the old and new systems, respectively, were as follows:

Old system, first local call: Obtaining operator's reply, 55 seconds; connection, 15 seconds. New system—Operating disc, 4 seconds; obtaining subscriber's reply, 5 seconds.

Old, second local call: Obtaining operator's reply, 5 seconds; connection, 30 seconds. New—Operating disc, 5 seconds; obtaining subscriber's reply, 10 seconds.

Old, call through outside exchange (Kingston): Obtaining operator's reply, 10 seconds; connection, 65 seconds. New—Operating disc and giving number, 6 seconds; connection 45 seconds.

Old—Call through outside exchange (Holborn): Obtaining operator's reply, 20 seconds; connection, 45 seconds. New—Operating disc and giving number, 7 seconds; connection, 25 seconds.

The purely automatic calling arrangement applies only to local calls. In regard to outside exchanges, certain specified numbers are signalled on the subscriber's disc, and then the number is given to an operator.
