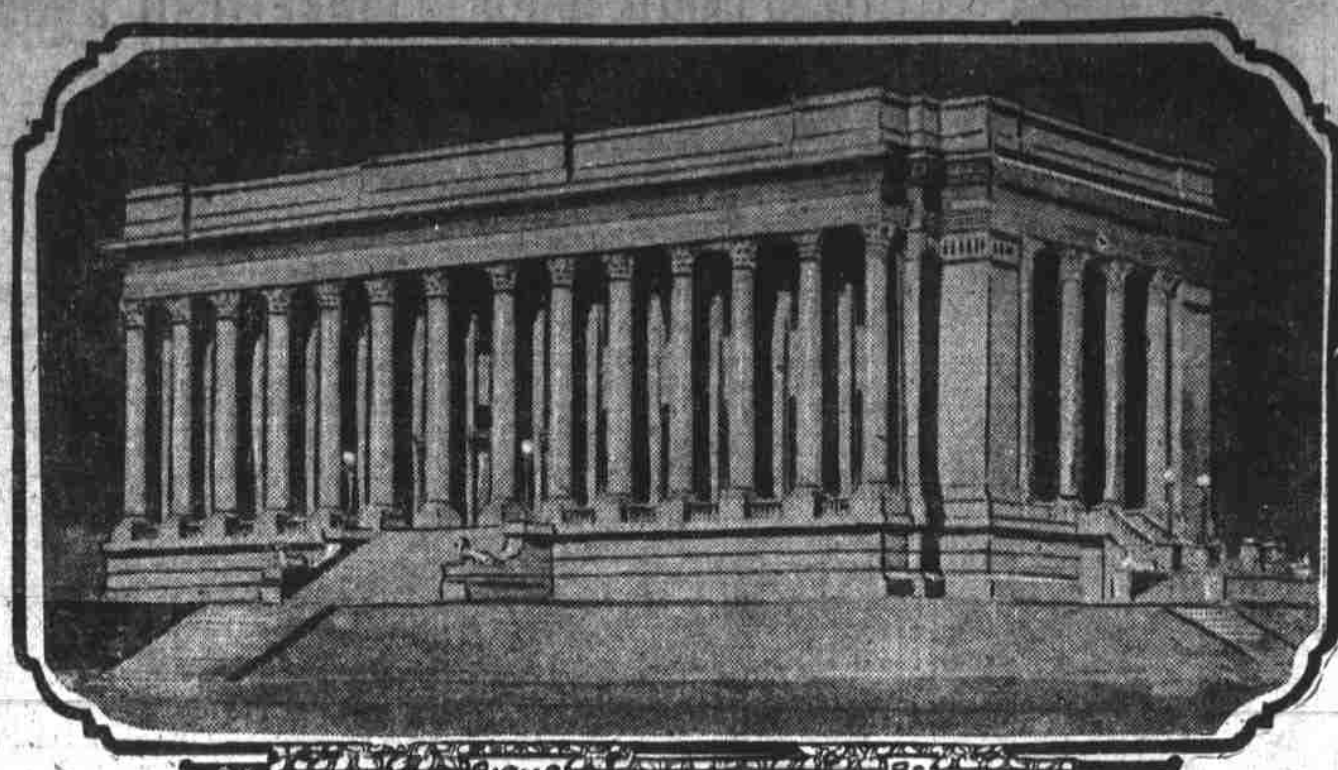


Klamath County Courthouse Is to Cost Taxpayers \$165,000

Scenic Location and Equipment Unusual Even in West



As the Klamath county courthouse will appear when finished; ground was broken last Friday.

In the presence of various members of the Central Oregon Development league advance agents, William Worden, county judge of Klamath, broke ground Friday morning for the new \$165,000 courthouse, soon to be erected on the land recently donated by the Klamath Development company. The site occupies an eminence in the heart of the city and overlooking Lake Evans and the great Klamath basin, which fades away to the south to be lost in the distant California mountains. Mount Shasta can be seen on the right; directly in

front is the White Pelican hotel and to the north are numerous city additions and attractive suburbs. The new main line of the Southern Pacific will pass within a few hundred feet and the courthouse will be in plain view of the passengers of the overland trains. The site comprises five acres in a half circle, around the edge of which an 80-foot Alameda with heavy reinforced embankments will be constructed, presenting an immense attractive driveway.

The courthouse will be of Grecian architecture and most attractive in character. It will be 175 feet long, 75 feet wide and 60 feet high. There will

be a full basement, two stories above and on top the jail will be located behind the fire wall. The courthouse will be absolutely fireproof, having concrete foundations, concrete floors, steel frame and steel casings, in fact a class A building in every respect. The outside finish will be terra cotta, backed with brick and there will be no furnace, for the entire building will be heated by hot water from the hot springs about 1000 feet away. The interior arrangements are up to date and complete, and when completed will constitute one of the best advertisements that Klamath county will have.

BENEFICIARIES OF HANFORD'S WORK TO BE SHOWN UP

Congressman Berger Says Include the Men Who Have Made Easy Money.

Washington, July 24.—That the men whom he believes forced United States Judge Hanford of Seattle to resign when they themselves became in peril of exposure through threatened disclosures before the congressional subcommittee which investigated the acts of the Seattle jurist are not to be allowed to escape if he can help it, was the statement here today of Congressman Victor Berger, on whose initiative in part the impeachment proceedings against Judge Hanford were begun.

Berger, to the United Press, has threatened that if Attorney General Wickensham did not continue the inquiry into Hanford's record, he would introduce a resolution in the house to have the United States grand jury at Seattle dig the Hanford affiliations to their depths. Berger said:

"I am informed that Judge Hanford and his 'secretary friends' got rich while Hanford was on the bench. Then the millionaires associated with him induced Hanford to resign to save themselves from exposure. I propose to show them up, although the impeachment proceedings against Hanford himself are dropped."

As a result of the resignation of United States Judge Hanford of Seattle, it was learned here today that the house judiciary committee has practically decided to drop the proceedings against Hanford. The committee has ratified the action of Chairman Clayton in ordering the subcommittee to stop taking testimony and return to Washington.

The subcommittee, it is reported, will be asked to report on the evidence before a vote is taken to dismiss the charges.

Congressmen Berger and Norris, authors of the original charges against Judge Hanford, refused today further to discuss their accusations against the jurist.

BLOODY DOG REVEALS DEATH OF HIS MASTER

WINCHESTER, OR., PLANT BE DOUBLED BY WELCH

Roseburg, Or., July 24.—The power plant of the Roseburg water and light systems, located at Winchester, five miles north of here, is to be doubled this summer at a cost of \$20,000, so announces A. Welch, the new owner. Twenty men are now at work on the plant and the work will be pushed to completion as rapidly as possible. The new company has another power site in the timber belt on the North Umpqua river 20 miles above Winchester capable of developing 12,000 horsepower. Mr. Welch said: "Some day you might have an electric railroad here and these power sites would then come in very handy." Mr. Welch said he was not here to build a railroad but that if he started out to build a railroad this city he certainly would complete it.

HOOD RIVER BOND ISSUE SOLD TO SEATTLE FIRM

Hood River, Or., July 24.—A bond issue of \$36,000 was disposed of to Carstens & Earle of Seattle at a premium of \$1051. The issue is for 10 years, drawing 5 1/2 per cent interest annually. This is the first bond issue sold by the city of Hood River for general purposes. An additional \$90,000 issue has been advertised and the funds will be used for the installation of a municipal water system. A committee from the council and a committee of property owners affected by the paving ordinance will visit Portland to examine the several pavements in use there in order to select a pavement for Hood River. SEERESS CHARGED WITH 9 MURDERS

Chicago Woman Center of a Long List of Mysterious Disappearances.

Chicago, July 24.—Suspected of having caused the death of at least nine persons, mostly by poison, Mrs. Louise Lindloff, seeress and spiritualist, is charged today in a grand jury indictment with the murder of her 15-year-old son, Arthur.

Forty-five counts are contained in the indictment, the greatest number of

counts returned in a murder indictment charge since the days of Johann Hoch. Among other murders of which the woman is suspected is that of her first husband, Julius Graunka. Collection of life insurance is said to have prompted the alleged crimes.

ENGLISH MINERS FAVOR SHORT WEEK

International Miners' Congress to Determine When Change to Be Made.

(United Press Leased Wire.)

Amsterdam, July 24.—The proposal of the English delegates to the International Miners' congress, meeting here, in favor of a uniform working policy of not more than five days per week has been adopted. The next congress will decide on the date when the new regime shall go into effect.

The congress also has adopted a reso-

tution introduced by the Dutch delegates declaring that the greatest possible safety to the miner can be insured only by the employment of inspectors elected by the workmen and paid by the state, mines to be inspected as often as the men demand.

MRS. ANNA CHRISTENSEN PUTS UP \$20,000 BOND

Pasco, Wash., July 24.—The \$20,000 bond which Judge Holcomb demanded of Mrs. Anna Christensen was furnished by the woman's relatives at Kent, King county. The bond was submitted to County Clerk Barnes in the absence of the judge, but as he declined to assume the responsibility of approving the papers, they were forwarded to the county auditor at Seattle for approval. The chances of securing a conviction in the case are said to be only fair, as it is proving difficult to secure witnesses.

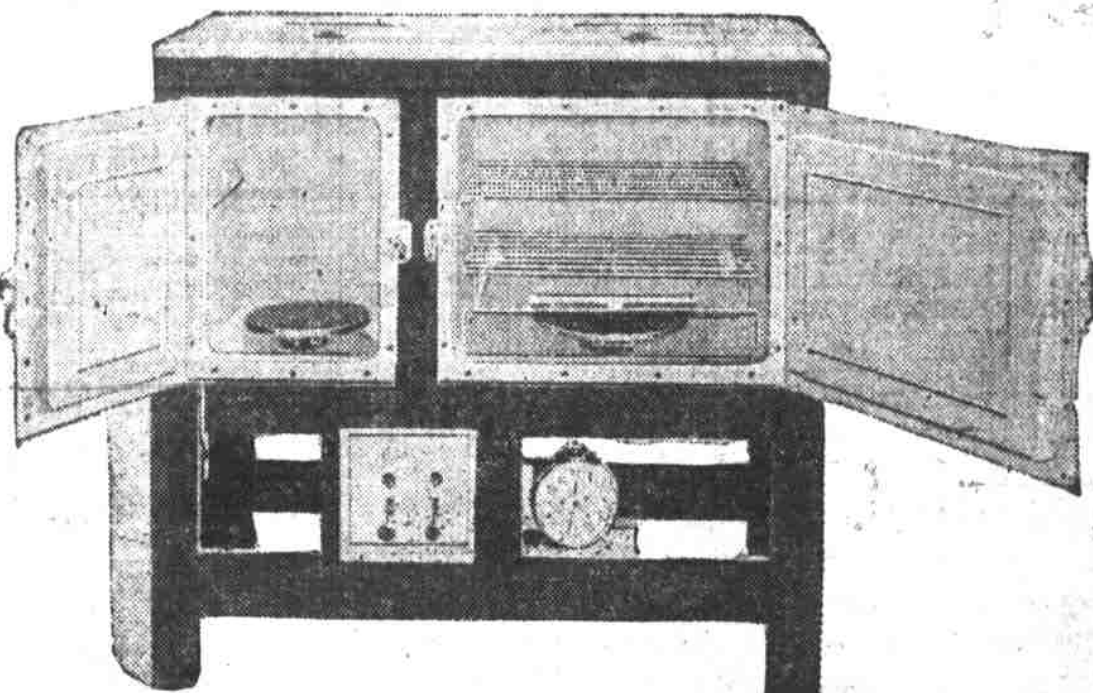
