

PLAN TO IMPEACH JUSTICE OLSON IS NOW UNDER WAY

W. J. Clemens Says Automobile Club to Investigate Record of Justice; Olson Would Send Speeders to Jail.

"Jail sentences for any and all autoists convicted of fracturing speed laws, whenever possible," will be the rule in the court of Justice of the Peace Fred Olson hereafter, Judge Olson made this announcement today following a verbal clash in the hall of the court yesterday afternoon with W. J. Clemens, president of the Automobile club, over the conduct of his court in fining members of the organization arrested for speeding.

Clemens, in his turn, stated today that the Automobile club has undertaken an investigation of Olson's judicial record, with a view to bringing impeachment proceedings, should the club officials find evidence to substantiate Clemens' assertion that Olson is "unsafe, and temperamentally unfitted for the position he occupies."

The controversy between the two men was in growth when Olson tried over the day before H. E. Seymour, a member of the club, was fined \$10 for speeding and when he demanded an appeal Olson raised the fine to \$50.

Clemens was standing in the hallway waiting to answer a similar charge in Justice Bell's court, and as Olson passed, he asked Clemens why he was present.

"I'm here just to see whether the word of three men is as good as the word of one man," Clemens is quoted as having said. Olson, believing the remark was made for his benefit, turned and asked Clemens why he had not told the newspapers that the one man had a speedometer while the other three men were guessing at the speed.

He referred to the Seymour case. Then began a wrangle which grew more heated as it proceeded. During its course, Olson invited Clemens to start a recall, and said that a rockpile sentence awaited the Auto club president if he ever convicted the third time for speeding. Clemens retorted by declaring that Olson was "unfit" for his position and intimated that he would make trouble for the justice later. Friends then intervened and ended the affair.

As a direct result of the quarrel, Prosecutor Frank Hennessy moved that the Clemens case be indefinitely postponed, which was granted by Justice Bell. Hennessy said today that Clemens would be brought to trial later, possibly within two weeks.

Clemens declared today that the case would continue indefinitely because Motor Policeman Truesdell, who made the arrest, was convinced that he had made a mistake in gauging Clemens' speed.

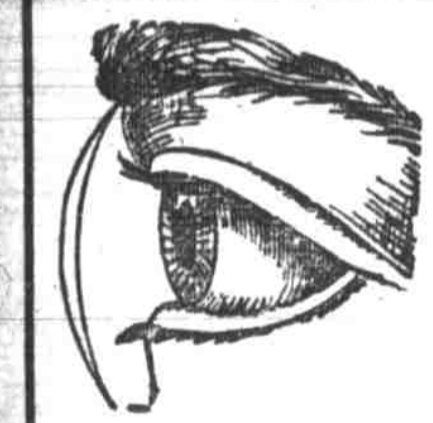
"I was traveling at a rate of 15 miles an hour," said Clemens, "and Officer Truesdell in overtaking me, naturally had to speed up. As a result his speedometer registered almost double my speed, because he was traveling at the rate I was going plus additional speed necessary to overtake me."

BECKWITH OR SPOONER WILL SUCCEED ROBER

BULL MOOSES TO GATHER AND 'MOO' Kellaheer Calls a Meeting for Next Monday Night to Plan for Mass Convention.

Dan Kellaheer, as president of the National Progressive club, has issued a call for a meeting next Monday night of the progressive forces to ratify the nomination of Roosevelt and to designate a time and place for holding a mass convention of the third party in Multnomah county.

This meeting will be held at the east side branch library, East Eleventh and Alder streets.

The purpose of the county mass meeting is to select a member of the new state committee of the progressive party, and it is expected that the question of a county ticket will be fought out at that time. It is probable that the date for the county meeting will be fixed for Monday evening, August 13, which is one week prior to the meeting of the state committee.

The call for the state committee meeting is being circulated by George F. Rodgers of Salem, ex-officio chairman. It requests the progressives of each county to select a committeeman to be present at a meeting at the east side library auditorium on August 27, at 10 a. m. If any county sends more than one committeeman the delegation will be entitled to only one vote, on the principle of one vote to each county.

The call sent out by Chairman Rodgers also asks for the organization of National Progressive clubs to "get busy for a square deal, and share with us in this great forward movement for integrity and honesty in American politics."

Charles W. Ackerson, one of the Bull Moose men who bolted the nomination of Taft as a delegate at Chicago, was notified by Medill McCormick of his selection as an assistant sergeant-at-arms of the national convention. He was unable to attend because of his business arrangements.

L. M. Lepper, secretary of the third party state committee, yesterday received the following message from Dr. H. W. Coe, one of the delegates in Chicago:

"The earnestness of purpose of the convention is a stirring inspiration. Highest morality is today receiving a baptism of real life which will make the country a new nation. The aspect of 12,500 men, many, doubtless, who had not voted since at their mother's knee, repeating the Lord's Prayer, was an event full of significance. The hour's devotion showed what faith and love the people have for Roosevelt. No one here questions the election of Roosevelt in November. Reactionaries are now seeking to grasp the new movement. Therefore urge that none but tried Rooseveltians, free from local and state ticket affiliations, are elected county chairmen. Don't forget that the enemies of progress, few as they are, work at night."

SEATTLE HIGHER-UPS MAY BE INVOLVED IN JUDGE HANFORD QUIZ

Attorney-General Wickersham Plans to Look Farther Into Judge's Dealings.

(United Press Leased Wire.)
Washington, Aug. 7.—A government investigation of the alleged higher-ups behind Cornelius H. Hanford, former judge of the United States court for the western district of Washington, in his alleged misconduct on the bench, is the plan of Attorney General Wickersham, according to an announcement made this afternoon by Congressman Victor Berger of Milwaukee.

Berger all along has insisted that the investigation in Seattle by the subcommittee of the house judiciary committee showed there were rich men behind Hanford who should not go unpunished. Berger was cited today for several hours with Attorney General Wickersham, and later announced that a federal grand jury would probably convene in Seattle to expose alleged higher-ups.

It is predicted that if the investigation starts prominent Seattle lawyers, politicians, and business men will be drawn into the government's net through indictments. Berger flatly charges that Hanford was forced to resign to protect alleged higher-ups from disclosures.

OFFICERS COME AFTER ALLEGED SWINDLERS

Word has been received from the San Francisco authorities that officers have started for Portland to take back Mrs. Alice Brown, the diamond bedecked, fashionably dressed, beautiful woman, and her male companion, George Montrose, who were arrested in a fashionable apartment house on Twenty-first and Irving streets Monday night, and who are wanted for an alleged swindle in the bay city.

The charge against the woman is that she became engaged to David Napping, a well-to-do Illinois farmer, and that, on the strength of their engagement, she bounced him out of \$17,000, which was secured in various amounts. After finding that she could no longer levy tribute on the man, she quietly left the city with Montrose, carrying quite a swath of the good hotels and cafes and making an effort to break into society.

Montrose, fashionably dressed, and bearing the appearance of a well-to-do business man, and the woman, carefully gowned, and who, by far, is the most handsome and striking woman ever taken by the police, were in the regular morning "line-up" of criminals yesterday morning, by they refused to talk or make any comment on their case.

ROADS DELEGATES PICK VANCOUVER FOR NEXT MEETING

International Highway Convention Closed With Turning of Earth on New State Line.

San Francisco, Cal., Aug. 7.—With the turning of the first spadeful of earth in the construction of the new \$15,000,000 state highway through California near San Bruno, the three days' international highway convention here came to a close today.

At the invitation of F. McD. Russell, president of the Vancouver Automobile club, to hold its next meeting in Vancouver, and a second speech by A. E. Todd, president of the Victoria Automobile club, a unanimous vote by the delegates favored the proposal. This selection will take the next meeting to a section of the coast that has not yet entered the association.

Burton A. Towne, chairman of the state highway commission, turned the first spadeful of earth today. Speeches were made by him, Percy J. Walker, president of the California State Automobile association, and W. J. Martin of South San Francisco.

Rev. William A. Brewer, president of the San Mateo Development association, under whose auspices the ceremonies were held, acted as chairman of the day.

After a barbecue, the northern road enthusiasts went on an auto tour of San Mateo county.

KELLER COMPLAINT MAY COME WITHIN SIXTY DAY LIMIT

Question of Delivery of Registered Letter May Enter Into Legal Status of Protest Against Selling's Statement

(Salem Bureau of The Journal.)
Salem, Or., Aug. 7.—In his letter to Secretary of State Olcott giving his reasons for returning the complaint of Arnold Keller against Ben Selling, District Attorney John McNary fails to take into consideration the fact that the complaint was mailed by register service before the expiration of the time limit in which charges might be filed.

McNary states that he returns the complaint without action because it was received by the secretary of state July 5, which was after the expiration of the 60 days from the time Selling's expense statement was filed. He says:

"The legal rule for computing time within which an act is to be done excludes the first day and includes the last."

According to this construction the last day on which charges could be filed pertaining to Mr. Selling's expense statement was July 7, which is the day the complaint was registered in the Portland postoffice. But it did not reach the secretary of state until July 5.

"It has generally been the rule of this office to accept matter when the postmark shows it was mailed within the legal time," said Mr. Olcott, "and that is why I accepted Keller's complaint and referred it to the district attorney."

It appears this point has been entirely overlooked by McNary, in the letter given out for publication last night. Olcott says when he receives the letter the matter will be closed so far as he is concerned, as his office is administrative and he acted when he referred the complaint to the district attorney.

If the question of time is gone into further it will be on the initiative of the author of the complaint.

"OLYMPIAD" PRAISED BY DR. E. G. AUSPLUND

"The world will probably never see a more successful Olympiad than that just held in Stockholm," said Dr. E. G. Ausplund, who returned from the Swedish capital this morning. "It was a tremendous success, remarkably well managed."

"That there wasn't a hitch in the program during the entire season speaks volumes for the officials," continued Dr. Ausplund, "for the stadium, a magnificent building, was a scene of the greatest activity every minute of the day. We athletes in contact in every direction, the immense floor space was busier than a three-ring circus and it was impossible for anyone to watch all of the events. At the same time other features, such as swimming and target shooting, were pulled off on the outside of the immense building."

"The Marathon race was probably the most exciting event of the series, at least, it attracted the most attention. Hundreds of thousands of people lined the 25 mile course and it was impossible to get within several blocks of the stadium early in the day. This notwithstanding, the best of order was maintained. The death of the Portuguese runner from stroke was keenly regretted and cast a gloom over the festivities but the heat did not become intense until the athletes had the race to start, and it happened that it proved the hottest day of the summer."

FINDS PERSONAL FEELING IN CASE

Attorney Benbow Argues to Have Charge Against the Mayor Dismissed.

Arguments to dismiss the indictment against Mayor Rushlight, Chief of Police Slover, Captain of Detectives Bay, and Police Sergeant E. F. Smith are being made today before Presiding Judge Gantenbein. It will require about an hour this afternoon to complete these arguments, when the verdict is expected to pass immediately upon the matter.

Attorney W. C. Benbow opened the case for the defendants, who are charged with committing an indecent and immoral act, being against public policy, by attempting to entrap Deputy District Attorney Collier in taking a bribe. This indictment is the second one to have been returned, the first being dismissed.

"The facts in the present indictment are identical with those set forth in the first charge," said Attorney Benbow. "If the first charge was insufficient, the present indictment is insufficient. If the first one was dismissed on the ground of irregularity, this one should be dismissed."

"It appears to me that the chief trouble in this case is one of a personal nature. Everyone knows the personal feeling in the district attorney's office, and in my opinion, this is a case where criminal action was taken to gratify personal grievance. Does the district attorney plan to turn Reed and Maddux loose, in order to secure testimony on a frivolous misdemeanor charge against me, the chief of police?" The city already has been scandalized by such petty acts of the prosecutor's office. The case at best is the outgrowth of personal feeling. It lacks dignity. It has no business in court."

Attorney L. R. Webster has been retained, as special prosecutor for the district attorney. He prefaced his argument by saying that the district attorney could not very well, present his side of the case. Continuing he said the administration was using Reed and Maddux to force a bribe upon Deputy Collier, thereby bringing a humiliating case out of the element of crime in the case consisted of the administration of officers inducing, offering an opportunity, and inviting the deputy to do an unlawful act.
