

RAILROADS OF U. S. PRODDED BRITAIN, AVERS HUMPHREY

Foreign Steamship Combine, American Lines and C. P. R. United, He Charges, to Kill Free Coastwise Tolls.

(Special to The Journal.)
Seattle, Wash., Aug. 30.—Congressman W. E. Humphrey, just home from Washington, said regarding the amendment to the Panama canal bill that making the canal free for American coastwise ships was entirely non-partisan, adding:
"But for the influence of the foreign steamship combine and the United States railroads, working together behind England's protest, which was part of the general scheme and instigated by the Canadian Pacific, the bill would have been free to all American ships."
"American people, having built the waterway will never consent to any other nation dictating."

MILLER DENIES HE HAS SPLIT WITH LAWLER

Indianapolis, Ind., Aug. 30.—United States Attorney Charles Miller flatly denied this afternoon reports that there is friction between himself and Oscar Lawler of Los Angeles as to which shall have charge of the case against the members of union labor organizations charged with illegally transporting dynamite. The case is scheduled to begin in October.
Miller declared that he had not heard of the reports, before and that they must have been the outgrowth of somebody's imagination. The district attorney is arranging to have Orville McManigal now held in Los Angeles, brought here to testify.

DRUNKEN CAROUSAL LEADS TO CITY JAIL

A night at the theatre followed by a drunken carousal in the Fay rooming house, Third and Taylor streets, a ride in a taxicab and the theft of a pony on which a trip to Oregon City was attempted and the arrest of James Robinson, aged 19 years, of 688 Sherrett avenue, is the story revealed by the report of R. E. Rich, 542 Sherrett street. The pony belonged to Harry Simmons, and the saddle and bridle belonged to Helen Johnson, 1734 East Thirteenth street.
With the report of the theft of the pony came a report to Patrolman Trout from a man named Robinson, 1730 East Seventeenth street, to the effect that his daughter had run away with James Robinson. When Robinson was found he stated that Wednesday night he took the Robinson girl to the theatre and later had gone to the Fay rooming house where he had engaged a room and where the girl became drunk on a quart of port wine. When the girl became too drunk to take home, Robinson left her in the hotel and went to his home. About 3 o'clock yesterday morning the girl appeared, saying she wanted \$3 to pay for a taxi. The money was given her by Robinson and she was told to go home, but she refused, saying she was going to get a horse and go to Oregon City. Later the girl was found with the pony taken from Rich. Robinson was locked up on a charge of giving liquor to a minor.

WOMAN TAKES POISON, DIES AT THE HOSPITAL

Within four hours after being taken to the Good Samaritan hospital, Mrs. Le Verne Stoenky, 21 years old, of 33 East Twenty-second street, died at 6 o'clock yesterday afternoon from taking a solution of "rough on rats" in a glass of water some time during the night, Tuesday.
Although the woman died yesterday afternoon and the body was removed to a local undertaking establishment soon afterwards, the coroner's office was not notified of the affair until this afternoon, after nearly 24 hours had elapsed, when a message was received from the undertaker that the body of a woman who had committed suicide.

DEVELOPERS OF SOUTHWEST FIND SOUND THEIR FOE

Must Overcome Politicians of North if They Are to Get a Road Appropriation at the Next Session.

(Special to The Journal.)
South Bend, Wash., Aug. 30.—The largest attendance that has yet turned out to a meeting of the Southwest Washington Development association is in South Bend this morning. Though the weather is bad there is a spirit of optimism which is certain to produce good results before the session ends tomorrow. The delegates are from every town in the western part of the state from Seattle to Portland.

The first business taken up last evening was the report of the various commercial bodies composing the association. Five minutes was allotted to each speaker to tell what his town was doing. C. J. Lord reported Olympia making rapid strides in civic improvement. Albert Johnson said Hoquiam had recovered from the recent labor troubles and was prospering. L. D. McVie of the Olympic Peninsula Development league made an ardent appeal to the association to join with his body in its plea for better roads and more of them. H. J. Clark told of the organization of the Goldendale Fruit Growers' association and H. M. Robertson of the Centralia Commercial club urged the necessity of encouraging the farmers to develop the soil. A. H. Innes of Kalama, and P. A. Hazeltine of South Bend, told what their towns had been doing and the reports closed with that of Colonel J. A. Munday of Vancouver.

Other clubs are reporting this afternoon.
This afternoon the developers are in the midst of a good road session. Eli Rockey, president of the Pacific Coast Good Roads association, opened the meeting at 10 o'clock. James McNeely of Buckley made the first speech and urged the necessity of immediate action if southwest Washington is to get a road appropriation this year. He said that a bunch of politicians and legislators on Puget sound have determined to oppose an appropriation for the completion of the road along the North Bank of the Columbia in the hope of getting money for their Stevens Pass highway.

James Morrison, engineer for King county, and Eli Rockey are yet to speak.

POLL ON OVERLAND: WILSON 37 AND TAFT 11

Seattle, Wash., Aug. 30.—Returning from an eastern trip, Rev. M. A. Matthews, moderator of the Presbyterian assembly, said business men are enthusiastic over the commercial outlook but doubtful as to politics, being puzzled as to the outcome.
"Whenever I could," he said, "I quizzed people as to business and politics. The replies relative to business were indeed optimistic. But the answers that I received about politics were peculiar in character. Many of the strongest men in the east are doubtful for whom they will vote for president. I took a poll of the train coming west and 37 votes were cast for Wilson, 29 for Roosevelt and 11 for Taft."

The big dog made friends with everyone who came near him, and showed every sign of affection.

"CODE OF ETHICS" COST CUSTOMERS

Trade Generally Understood to Whom Wholesalers Were to Sell.

Seattle, Wash., Aug. 30.—Examination of Victor H. Beckman, former secretary of the Pacific Coast Lumber Manufacturers' association, and one of the most prominent lumbermen on the coast, took up all this morning's session in the alleged retail lumber trust hearing. Beckman testified to substantially the same general facts concerning the alleged "understanding" among retail dealers and wholesalers and manufacturers, as the witnesses who preceded him. He explained that the trade generally "understood" without any specific agreement that wholesalers were not to sell direct to consumers or mail order houses.
Louis Schwager and E. G. Butterfield, local lumbermen, testified yesterday afternoon. They told of losing customers in the retail trade in middle western states because they had sold to others than those who were recognized as legitimate dealers by the so-called Minneapolis "code of ethics" adopted in 1908.

MELLEN WILL SUCCEED FOWLER AS PRESIDENT

New York, Aug. 30.—Thomas P. Fowler, president of the New York, Ontario and Western railroad, will retire tomorrow and will be succeeded by Charles S. Mellen, president of the New Haven railroad. This is in accordance with the New Haven policy of having its president act in a similar capacity for all of the subsidiaries.

BLOW IS AIMED AT CIVIL SERVICE

Amendment Affecting Police Favored; To Go on Ballot in November.

Slipping through the city council so quietly that most of the councilmen themselves did not know what they were voting on, an amendment to the city charter abolishing the civil service so far as the police department is concerned, was ordered placed on the ballot for the people to vote on in November, at the council meeting this morning.
The amendment, in effect, provides that members of the police force may be dismissed and appointed without regard to civil service rules. It came up unannounced and so unostentatiously that it was passed unanimously and without discussion by members of the council.

Behind the proposed charter amendment is recalled a remark made by Mayor Rushlight to Governor West at the dow famous "vice meeting" in the mayor's office last Friday. At the time Mayor Rushlight told the governor that he had been handicapped by his efforts to control vice by his inability to discipline members of the police force when they protected vice. It is this civil service shelter from executive wrath that the amendment would remove.

POLICE RAID HOTEL; FIVE ARE ARRESTED

Sergeant Harms, with Patrolmen Martin and Long, last night raided the Alma hotel at Twelfth and Burnside streets and arrested L. P. Stone, Claude Harper, Elsie Denner on a charge of conducting a bawdy house and Alma Peck, on a charge of selling liquor without a license. The case will be heard tomorrow. Patrolman Bales, assisted by W. G. McLaren, yesterday arrested J. E. Grady, Florence Alexander and Ethel Smith on a vagrancy charge and their cases will be heard tomorrow.

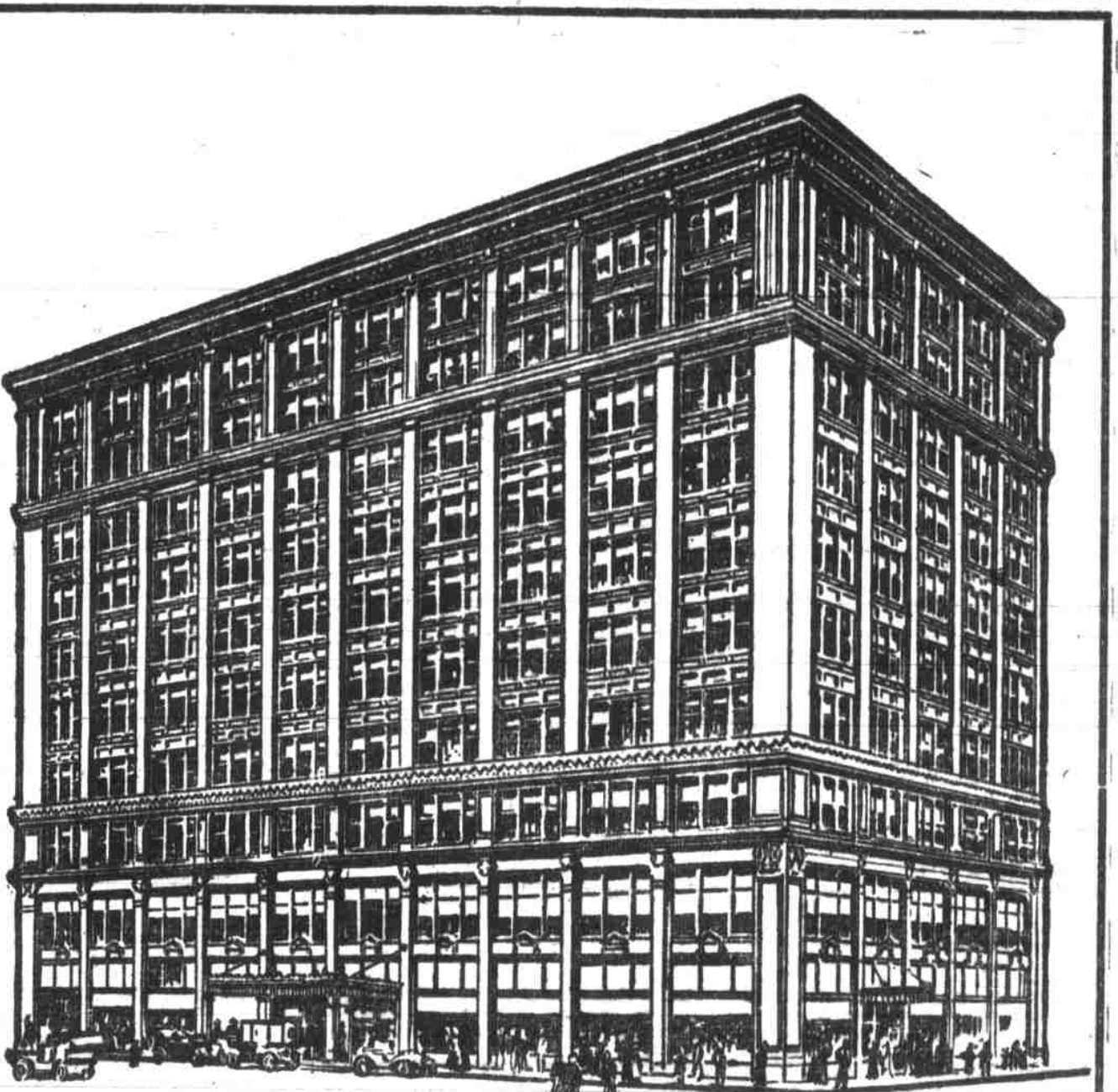
PRICE OF LOGS IS BOOSTED \$1 PER 1000 BY LOGGERS

Advance in Cost to Mills Follows General Shortage During Late Summer; Output Has Been Decreasing.

Logging camp operators are notifying sawmill men that September 1 log prices will advance \$1 per 1000 feet, placing fir on a basis of \$7, \$10 and \$13, according to grade. The price for a year or more has been based on \$6, \$9 and \$12.

The advance on fir logs at this time is due to the small quantity available for immediate use, the surplus having been greatly reduced the last month. It is reported much smaller than usual at this time of the year. While practically all of the camps in the Columbia river district are in operation, the output is not up to the full capacity as some of the camps are employing parts of their crews on extension of logging roads. Three or four camps that last year supplied logs have cut out and the effect of this is felt to some extent. The surplus on hand three months ago was worked off during July and the early part of August, when nearly all of the camps shut down for a general overhauling and to give their men the customary summer vacation.

From Grays Harbor comes the report that logs are so scarce that it is impossible for mills to run nights.
