

HUNT EVIDENCE OF FRAUD BY THE LOS ANGELES T. R. MEN

Democrats Threaten to Carry Alleged Illegal Ballots to Congress if They Fail to Secure Action in California.

(United Press Lined Wire.)
Los Angeles, Nov. 13.—Demanding a square deal, which they intimate they are not receiving, the Democratic law committee watching the count of Los Angeles county ballots by the board of supervisors today renewed their fight before that body and threatened that if the ballots were shown to be in any way illegal they would carry the matter to the next session of congress. The Democrats, headed by County Chairman H. L. Cotton, allege they are experiencing difficulty in keeping a private count of the tally book totals, as they are enumerated by the 46 deputy clerks.

Over the protest of Attorney J. Chandler, a member of the committee scores of election judges were questioned as to the correctness of their tally books, which the Democrats claim have been opened illegally.

A formal protest filed Monday by Democratic County Chairman Cotton, alleging that all the envelopes containing ballots and tally books had been broken open before the day of the official count in violation of the political code, is under consideration by Deputy District Attorney Hanna, who will hand down his decision in the matter soon. The Democrats charge that on November 7, four days before the official count began, when the envelopes should be opened according to law, the packages were broken open and the returns inspected by several persons.

A protest was also made against the supervisors counting any returns not written in ink, and which are not properly sealed and authenticated by the election officers. In presenting the charges, which are signed by the full committee appointed by the Democrats to watch the returns, Chairman Cotton intimated that two courses were open—either to apply to the superior court for a writ of mandamus, compelling the supervisors to eliminate from the canvass those returns which have been tampered with, or to apply to the next session of congress and have that body pass upon the questions involved.

Cotton intimated that no further steps would be taken pending the action of the board of supervisors.

Spokane's Great Apple Show Opens; Robert Strahorn Portland, to Preside

Spokane, Wash., Nov. 13.—Robert E. Strahorn, president, from Portland, is to preside over the fifth national apple show.

There are now 27 carload exhibits and thousands of less than carload exhibits in place.

Contrary to expectations, no carload exhibits are here from Oregon, but about 15 smaller entries, according to the clerks.

Robert E. Strahorn, builder of the North Coast electric road in the Yakima valley, and at present located in Portland at the head of the construction of another gigantic electrical enterprise, the Portland, Eugene & Eastern scheme for the Willamette valley was chosen president of the fifth national apple show last year.

Fruit to Go Into Eastern Windows.
At the suggestion of President Strahorn all the fruits which can be secured will be turned over to the railroads for exhibit in the windows of buildings in eastern cities. The O. W. R. & N., the Southern Pacific and the Great North-

ern have already placed applications for as many of the exhibits as they can be given. The fruit will go to such cities as New York, Chicago, Boston, Cincinnati, Cleveland, St. Louis, Detroit and Buffalo, and each display will carry cards giving full information as to where they were grown and by whom. The advertising value of this plan can hardly be estimated.

Twelve different states are represented in the exhibits, the farthest from Spokane being Maryland and Tennessee. The Canadian provinces also will send in fruit.

Oregon Men and Program.

The program for serious discussion during the week carries such subjects as Choice of Site, Varieties, Cultivation of Orchard, Pruning, Spraying, Harvesting, What to Grow Between the Rows, Financing, By-Products, Storage and Preservation and Marketing. The speakers from Oregon include such well known names as C. I. Lewis, chief of the experiment station, Oregon Agricultural college; C. L. Smith, chief agriculturist of the O. W. R. & N.; A. J. Mason, Hood River; W. H. Lawrence, Hood River; Truman Butler, Hood River; R. E. Miller, traffic manager of the O. W. R. & N.; M. M. Hill, Hood River; E. H. Shepard, editor of Better Fruit; J. H. Young, president of the S., P. & S. railway, and Wilmer Selig, of Hood River. The address of President Strahorn which will deal with the condition of the apple belt of the northwest, will be delivered Thursday morning. Mr. Strahorn is known in Washington as much as a grower of fruit and developer of land values as he is as a railroad man. He is now concerned in planting a tremendous apple farm near Pasco.

CHILE AND PERU WILL SPEAK AFTER 30 YEARS

The two countries went to war and have been disputing since 1882 over sovereignty of the provinces of Tacna and Arica. The new agreement provides that Chile shall rule over these provinces for the next 20 years.

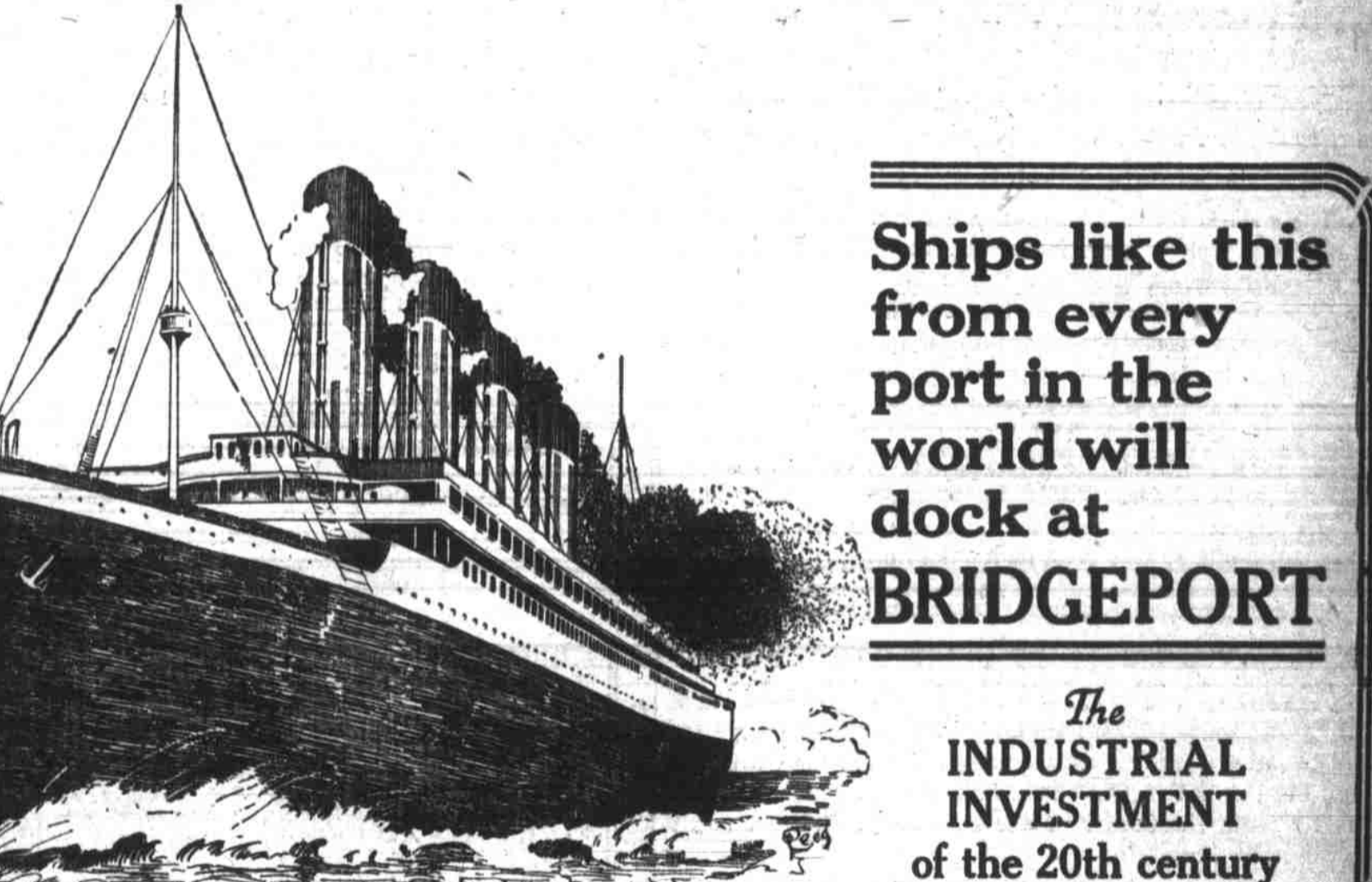
