

McINNIS' DEATH IS BIG LOSS TO LYLE

Developer of Klickitat River Country Will Be Much Missed.

Klickitat, Wash., Nov. 12.—The Klickitat river country has received a severe blow in the passing of Malcolm McInnis, the merchant of Lyle. He was known in his time as the Klickitat homesteaders' friend. Without his timely assistance to some of the first settlers, development of isolated sections would have been delayed. His demise is felt more keenly at this time because he was a man who did things and he was on the eve of building an extensive general mercantile store at Wahkiakus to be a branch of his Lyle institution. Less than a fortnight ago Mr. McInnis had conferred with Wahkiakus Indians and verbally agreed on the grounds and rate of annual rental. He expected to have the lease legally executed before the end of the year.

Mr. McInnis was born of Scotch parents on Prince Edward Island, Canada, August 16, 1854. He was given a business education and was particularly trained to be an expert bookkeeper. In 1887 he accepted the position of bookkeeper for a pioneer merchant of The Dalles, Or. At the age of 35 he married Miss Elizabeth Leslie of his birthplace. The year 1891 found him assembled with a number of the most wealthy men of The Dalles incorporating the Wasco Warehouse company. He was with the company for 12 years, and saw it grow into a most healthy corporation.

When Homer C. Campbell and associates became busy building a railway by the Klickitat falls in 1902, McInnis and his boyhood playmate, A. M. McLeod, since deceased, incorporated the Lyle Trading company with abundant capital. Since McInnis' death in San Francisco in May, 1911, Mr. McInnis and family have been sole owners of the Lyle Trading company.

Mr. McInnis always headed the list with the most substantial subscription that would aid charity or benefit the town. There survives a widow and four children. Two daughters are grown, Misses Mabel and Ruth, the latter of whom was her father's confidential clerk and stenographer, and two young boys are respectively Leslie and Eugene.

GROUND IS BROKEN FOR DORMITORY

Oregon Normal President Has Hope of More Ceremonies of This Kind.

Monmouth, Or., Nov. 12.—Ground was broken Tuesday for the new girls' dormitory at the Oregon Normal school. The ceremonies consisted of short speeches by prominent citizens and class officers, songs by the student body and the actual breaking of the sod.

The students grouped in classes and led by the faculty marched from the main building to the dormitory site, immediately north. President J. H. Ackerman turned the first shovel, and made a short address. He said in part:

"This occasion is of peculiar interest to the students of the normal school, the citizens of Monmouth and of the state at large, in that we are breaking ground for the first new building added to this institution for many years. I sincerely hope that we may come together again in the future for a similar purpose."

He was followed by State Senators Ira Powell and C. L. Hawley, who were largely instrumental in getting the appropriation for the building through the legislature. They were followed by Miss Mary Kelly of Astoria, president of the student body, and by the class presidents.

The dormitory and heating plant, which are to be erected at the same time, will cost \$50,000. The dormitory will have a large dining hall and reception room, and will care for nearly 100 girls. This will be only about one-half the number in attendance. It is to be situated north of the main building and immediately east of the gymnasium.

DELEGATION MEETS TO STUDY LEGISLATIVE NEED

Salem, Or., Nov. 12.—Marion county's legislative delegation met this afternoon and organized permanently for

work during the coming session of the legislature. Senator John A. Carson was chosen chairman of the delegation and Representative James G. Hittell, secretary. They will hold meetings each Friday night until the session begins.

Today they discussed a proposition of abolishing the rural school supervisor system adopted by the last legislature, and also enactment of a law abolishing compulsory teaching of drawing and painting in the public schools. Another question considered was the method of tax collection. The idea was presented that the sheriff should be compelled to send notice to each taxpayer just before taxes are due of the amount of taxes. Various questions will be discussed at

each meeting and members of the delegation invite every one interested to appear and express their opinions. In addition, one or two public meetings will be held at the courthouse to which various public bodies will be especially invited.

CRIMINAL LIBEL CHARGE GROWS OUT OF ELECTION

Tillamook, Or., Nov. 12.—Rudolph Zweifel, a prosperous Swiss rancher of this county, was indicted Saturday for criminal libel. Zweifel, as a supporter of George R. Edner, Republican candi-

date for county commissioner, issued a printed statement over his signature in which he accused Louis Osterberger, an adherent of H. V. Alley, the present incumbent, of having stolen a recall petition containing 500 names which was to be filed against Alley. The statement was circulated on the day before election. In his circular Zweifel offered to substantiate his claims and it is probable that this will be his defense. The case will be heard Monday afternoon before Circuit Judge Kelly.

SENTENCE OF INDIAN BLOW TO HIS FELLOWS

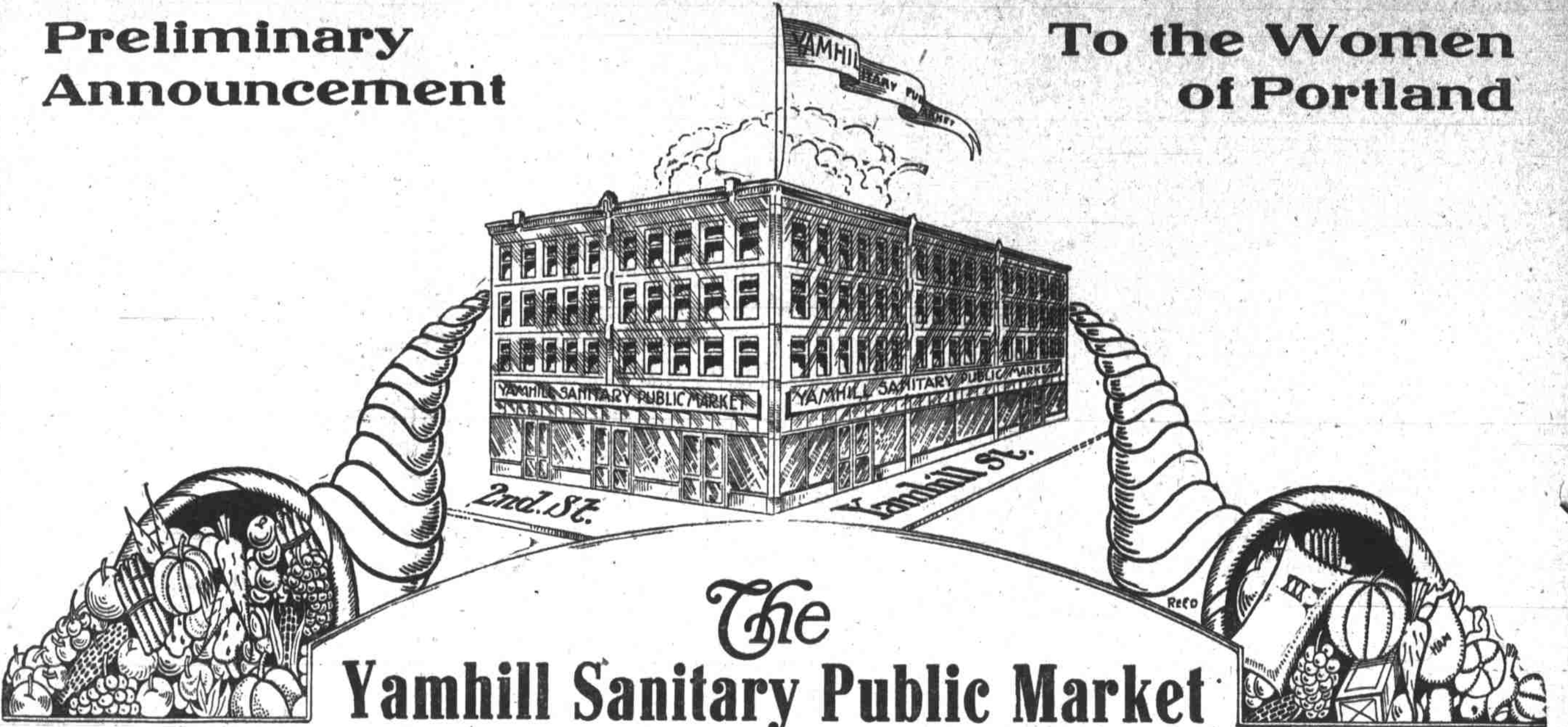
Such a demonstration of tears on the part of a group of Indians as was given Saturday morning just outside the door of the office of the United States marshal in the federal building, is rarely seen. It was just after Ralph McBean, a half breed from the Umatilla reservation, had been convicted of horse stealing and sentenced to two years at McNelli island. Two dozen braves and Indian women had made the trip to Portland to attend the trial, some as witnesses. Completely stolid during the progress of the trial, the announcement

of the sentence brought on a rare exhibition of emotions, and some of the hardened federal officers were even moved by the display. McBean, who is serving a second sentence, was taken up to the Puget sound prison last night. Deputy United States Attorney Everett Johnson accompanied Deputy Marshal Griffith as special guard.
