

WILCOX QUITS FACE ON BOARD, ACCOUNT CRITICS

Resignation Is in Mayor's Hand, Chairman Says; Be- lieves Funds Are Insufficient to Buy Site and Build, Too.

"My resignation is in the mayor's hands. He is at liberty to notify me at any time that my successor has been appointed."

Chairman Theodore B. Wilcox, chairman of the auditorium commission, made this announcement last night at the annual meeting of the Greater Portland Plans association in the Metropolitan hotel. It was in response to criticisms that have been voiced against the commission for its delay in constructing the public meeting place which was authorized by vote of the people two years ago.

"Give me a little time. Don't be afraid this present body is going to run away with your money. We are not buying wheat with it," commented Mr. Wilcox.

Though he discussed other sites, Mr. Wilcox described detailed plans for the use of the Market block only, as a place for the auditorium. A delegation that had come from South Portland loudly applauded his reference to the Market block. A delegation from the East Side Business Men's club advocated the proposed site on the corner of Grand and Holladay. Dan Kellaher, spokesman, saying that 75 per cent of the population of Portland would be better served.

Will Await Architect.

The location at Nineteenth and Washington, Mr. Wilcox said, had been found impossible because of cost. Only, as he had never believed he was appointed to buy a site, but to put up a building, and when the people rejected the additional \$200,000 bond issue for the site, the commission resolved to "knock down" and do the best it could with the money.

As to the proposal to buy a 50 foot strip on three sides of the Market block, Mr. Wilcox said one 50 foot strip could not be purchased, and how, then, three? He said that the half block to the south should be bought, and later the remainder of the block, so that there might be open space for the disposition of crowds on either side. He said Architect Friedlander of the commission was coming from New York and would give advice as to location. Following the suggestion that it would be best to wait until the opinion of the architect had been given, representatives appointed to speak for the South Portland booster, A. A. Botary and Progressive Business Men's club, were not heard from. In answering his critics, Mr. Wilcox declared:

"I know the auditorium cannot be built to please everybody. My only hope is that it will please somebody and that somebody is me. I would not consider myself true to people or administration if I negated my own judgment and proceeded to the construction of a building that could not be finished until more money was appropriated, or one unworthy of the city."

Indorse J. H. Teal.

Growth of the Greater Portland Plans association and increase in its influence were described in the reports made by President Arthur H. Devers and the secretary. The report of the auditing committee, consisting of W. A. Holt, P. E. Fuller, W. H. Chapin, John M. A. Lane and Will A. Knight, showed the finances of the association had been accurately handled, and the report of the treasurer showed a balance of more than \$100 in the fund raised for the year's work.

The election of officers resulted in the choice of G. F. Johnson as president. Vice presidents, J. C. Almsworth, William M. Ladd, C. S. Jackson, Edgar B. Eiger, John P. Carroll, William P. Woodward, Dr. Andrew C. Smith; secretary, Marshall N. Dana; treasurer, George W. Hoyt; executive board, Richard W. Montague, Frank B. Riley, Harry W. Stone, W. G. Elliot Jr., Rabbi Jonah B. Wise, Judge H. G. Morrow, Robert H. Strong.

Resolutions were presented and adopted approving the choice of Joseph N. Teal for secretary of the interior and expressing confidence in the Y. M. C. A. and deploring the unfounded attacks against the institution.

McNAMARA ON STAGE TELLS HOW HE CARRIED "SOUP"

McNamara Dropped Suitcase With Infernal Machines in San Francisco Bay; Tried to Kill Ortie in Woods.

(United Press Leased Wire.) Indianapolis, Nov. 21.—Ortie E. McManigal, star witness of the government in the cases of 47 labor leaders charged with the illegal transportation of dynamite from state to state, resumed the witness stand shortly before noon today and continued his description of dynamitings, which he declares he engineered under the direction of the officials of the International Association of Bridge and Structural Ironworkers.

McManigal said he usually rode in smoking cars when carrying nitro glycerine for the various explosions he caused. He named all the railroads over which he traveled from June, 1907, until his arrest.

In his testimony today McManigal referred to November, 1910, when he declared Jim McNamara tried to shoot him in San Francisco's woods. He said he and Jim went into a dugout and Jim described the Los Angeles dynamiting.

Drops Suitcase in Bay.

The informer declared Jim said: "This would be a fine place to stay all winter. The authorities would never find us."

He declared, referring to Jim, he wrote to John McNamara November 11: "The old carpenter has arrived and is looking fine."

McManigal testified Jim told him that when he left San Francisco following the Times explosion, he dropped into San Francisco's bay a suitcase containing four infernal machines. He said he declared that Olaf A. Tveitmo was to meet John McNamara at the ironworkers' convention in St. Louis and there tell him the details of the Times explosion.

Frightened From Train.

Following up the coast exploits of the pair, McManigal testified that Jim McNamara said a guilty conscience drove him from the train at Salt Lake when he was returning from Los Angeles. He said the other passengers stared at him too much.

Jim McNamara, McManigal said, visited in Salt Lake under the alias of Williams.

Jim McNamara told him, McManigal said, that the nitro glycerine he used on the Los Angeles Times job resembled plum jelly.

Jim McNamara declared he would have put a "mess of soup" under the Times auxiliary plant if he had known where it was at the time of the explosion.

Reporter Testifies.

Samuel Meyers, a Denver reporter, testified that an earlier defendant, Henry Leggett, told him that the "inner circle" handled the organization fund which the government alleges was used to defray the expenses of the dynamitings. Other witnesses detailed incidents connected with the Kansas City bridge dynamiting in August, 1910. James Vaughn, a watchman, testified that he put John McNamara off the premises of Armour & Co., there, shortly after the bridge explosion.

James E. Ray and Edward Smythe are still in custody. Their bondsmen have not yet appeared.

Protection Among Defendants.

Serious disagreements are suspected among the 47 labor leaders on trial here on charges illegally transporting dynamite from state to state as part of the alleged conspiracy which culminated in the destruction of the Los Angeles Times. It is reported the defense attorneys will do all in their power to block the testimony of H. B. Hornin, secretary treasurer of the International Association of Bridge and Structural Ironworkers. Hockin, in the minds of many of the defendants, has been a traitor to their cause.

George Cumston of Pittsburg, a former ironworker, testified today that during the ironworkers' strike at Kansas City in 1906, W. J. McCain, one of the defendants in the present trial, offered him a job of "putting non-union work on the bum." Cumston replied that he did not need the money.

Offered \$100 for Evidence.

Testimony that Fred J. Sherman, business agent for the Indianapolis Ironworkers' local, offered her \$100 to steal incriminating dynamite evidence from the home of a Patrick Dugan while the latter was in Los Angeles as a witness in the McNamara trial, was offered at the dynamite conspiracy trial yesterday by Mrs. Mary Jarrell. Sherman is one of the defendants, and Dugan, a former member of the auditing committee for the International association of Bridge and Structural Ironworkers, gave damaging testimony earlier in the day against the accused men. Mrs. Jarrell admitted she ransacked the Dugan home several times, but could not find any papers bearing on dynamitings.

Mrs. Dugan corroborated much of Mrs. Jarrell's testimony, telling of the numerous visits she made to her home. She said that Mrs. Jarrell several times had tried to induce her to leave home, Mrs. Jarrell promising "to take care of things."

SUSPECT FREED BY JUVENILE AUTHORITIES

Another man, Robert L. Johnson, was freed from the county jail where he was held in connection with the scandal which the juvenile court officers have unearthed as the evidence against him was found to be insufficient.

No developments have been made today though the investigation is proceeding and the grand jury is still probing the cases already brought out. Some new witnesses have been found and these are said to be disclosing more details.

No word has been received by the district attorney's office from E. R. J. McAllister, who he said to be on his way to the city and Deputy District Attorney Collier, who is in charge of the investigations, declares he will order his arrest unless he appears today.

The men already held appeared before Circuit Judge Gaten yesterday for arraignment but all waived examination and their cases will be considered by the grand jury.

Dr. Harry A. Stuart, who is out under \$5000 bonds, was arrested on a second charge yesterday and additional bonds of \$2000 were at first required but he was later allowed to go on the original bond.

PARTY LINES ARE FORGOTTEN IN THE TEAL MOVEMENT

The Credit Men's Association, Portland Plans Association and the Transportation Club Take Active Steps.

Three prominent Portland organizations swung vigorously into the campaign to secure the appointment of Joseph N. Teal as secretary of the interior, yesterday.

Departing from its usual rigid rule to vote no indorsements, the Portland Credit Men's association at its formal meeting in the Metropolitan hotel last night unanimously called upon President-elect Woodrow Wilson to consider the honor due Oregon, the worth of Mr. Teal and his fitness for the position. A special communication from the association will be at once forwarded to the president-elect.

Move Is Non-Partisan.

Sustained cheers greeted the submitting of a resolution approving Mr. Teal's appointment by William F. Woodward, at the annual meeting of the Greater Portland Plans association last night. This organization is practically representative of all Portland interests since it includes in its official list delegations from all business, civic, and improvement organizations.

Authorized by unanimous vote of the Transportation club at its last meeting, President J. E. Werlein yesterday forwarded to President-elect Wilson resolutions vigorously calling upon him to appoint Mr. Teal as secretary of the interior.

"Mr. Teal is not of my political faith," said Mr. Werlein, "but this is no time for politics or political consideration. Without any reference to politics this state can recognize a big man and support him in this opportunity for even greater usefulness."

Has Earned Honor.

The resolutions read as follows: "Whereas, It seems highly probable that the state of Oregon will be honored by the selection of one of its citizens by President-elect Woodrow Wilson to fill a position in his cabinet, and, "Whereas, the citizenship of the entire state, regardless of political affiliations, feels this as a great honor, trusting that the probability may be brought to a full realization, and

"Whereas, in the selection of the person to fill this honored position, we feel that the president would appreciate the knowledge that there is in Portland a citizen, who by his untiring and unselfish zeal and energy has established his worth and endeared himself to the hearts of all patriotic citizens; and "Whereas, our beloved and esteemed fellow-citizen, Joseph N. Teal, fills all of the qualifications above set forth,

ACCEPT LIPTON'S RACE CHALLENGE

Syndicate Formed in San Francisco With Mrs. H. J. Crocker as 1 Backer.

(United Press Leased Wire.) San Francisco, Nov. 21.—Sir Thomas Lipton's challenge to the world for a race in a 23 meter cutter in San Francisco bay in 1915 was promptly accepted here today by Thomas M. Miller, president of the West Coast Life Insurance company, who at the head of a syndicate of 25 San Franciscans, will spend \$75,000 to make their acceptance good. Miller's acceptance was handed to the knight today at a luncheon of the San Francisco Commercial club.

Miller's backing in the sport venture will come, at least in part, from Mrs. Henry J. Crocker. When Mrs. Crocker heard of Sir Thomas' challenge she said: "I am surprised that when this challenge was issued by Sir Thomas Lipton some San Franciscan did not instantly accept it. Count me in as one of the syndicate."

FAILING TO DIE AS PROMISED BY DOCTOR, HE SUES FOR \$15,000

(United Press Leased Wire.) Spokane, Wash., Nov. 21.—Because he did not die as predicted, William Goldblatt, a Jeweler, has brought suit for \$15,000 against Dr. G. H. Rober here today. He alleges that the doctor told him he was suffering with cancer of the stomach and would live only a short while, so he sold his business at a sacrifice and waited for death. Waiting five weeks became tiresome and he consulted a specialist, who found that he was in perfect health.

Combined with rare ability and integrity, therefore, he is "Resolved; by the Portland Transportation club, that we unhesitatingly indorse Joseph N. Teal for the position of secretary of the interior in President-elect Wilson's cabinet and, be it further "Resolved; that these preambles and resolutions be forwarded to President-elect Wilson, assuring him of the loyalty of the Portland Transportation club to his administration."

LAWRENCE CASE IS UP TO JURY

Attorneys for Defendant De- nounce State for "Dragnet Policy" With Witnesses.

(United Press Leased Wire.) Salem, Mass., Nov. 21.—Joseph J. Ettor, Arturo Giovannitti and Antonio Caruso, on trial for the murder in Lawrence of Anna Lopizzo, a striker, during the big industrial strike here last winter, will soon be in the hands of the jury.

Attorney Mahoney made the final plea for the defendants this afternoon and Judge Quinn is expected to deliver his charge this evening. Then the case will go to the jury.

Attorney Mahoney made an impassioned plea for the defendants, virtually charging that Ettor is the victim of a frameup.

"The men interested in big corporations," he said, "are often able to move the law's machinery. Everybody knows that the workers do not receive the same consideration from the authorities that the owners do."

Mahoney also denied that Ettor had ever conspired violence.

As a final argument on behalf of Arturo Giovannitti, accused, together with Joseph Ettor and Antonio Caruso, of murder growing out of the Lawrence textile strike, Attorney Peters denounced the "commonwealth's dragnet process" of bringing only witnesses who would discredit the defendants, and for "side-tracking witnesses tending to show their innocence."

Peters portrayed in his speech the picture of 25,000 starving and freezing persons in Lawrence, driven beyond human control.

WAIT NEW HEAD FOR SUFFRAGISTS

Westerners at Philadelphia Fa- vor Successor to Dr. Shaw as President.

(Special to The Journal.) Philadelphia, Nov. 21.—When the forty-fourth annual convention of the National American Woman suffrage convention opened this morning, a feeling of trouble pervaded the headquarters. The western element of the association are backing younger blood in the affairs of the organization, and President Anna Shaw, who represents the old regime, will likely give way to another.

Mrs. M. L. T. Hidden, president of the Portland Suffrage and Political Equality League, and Mrs. Thomas G. Halley of the same organization registered together this morning, may line themselves up with the western element.

When seen at her residence today, Mrs. Solomon Hirsch declared that there must be some mistake as to Mrs. Thomas G. Halley and Mrs. M. L. T. Hidden, Oregon delegates lining up against Dr. Anna Shaw for reelection as president of the National Equal Suffrage association, as both were instructed to vote for Dr. Shaw.

"I don't believe," continued Mrs. Hirsch, "that there is any movement among western delegates to defeat Dr. Shaw; but I have heard that there is some dissatisfaction in the east with the Shaw regime, and there may be an effort to defeat her. At any rate, I am sure it is a mistake to ascribe to western delegates a desire to displace Dr. Shaw."

Rabbi S. S. Wise of New York, formerly of Portland, will also represent the Portland Suffrage league at the Philadelphia convention.

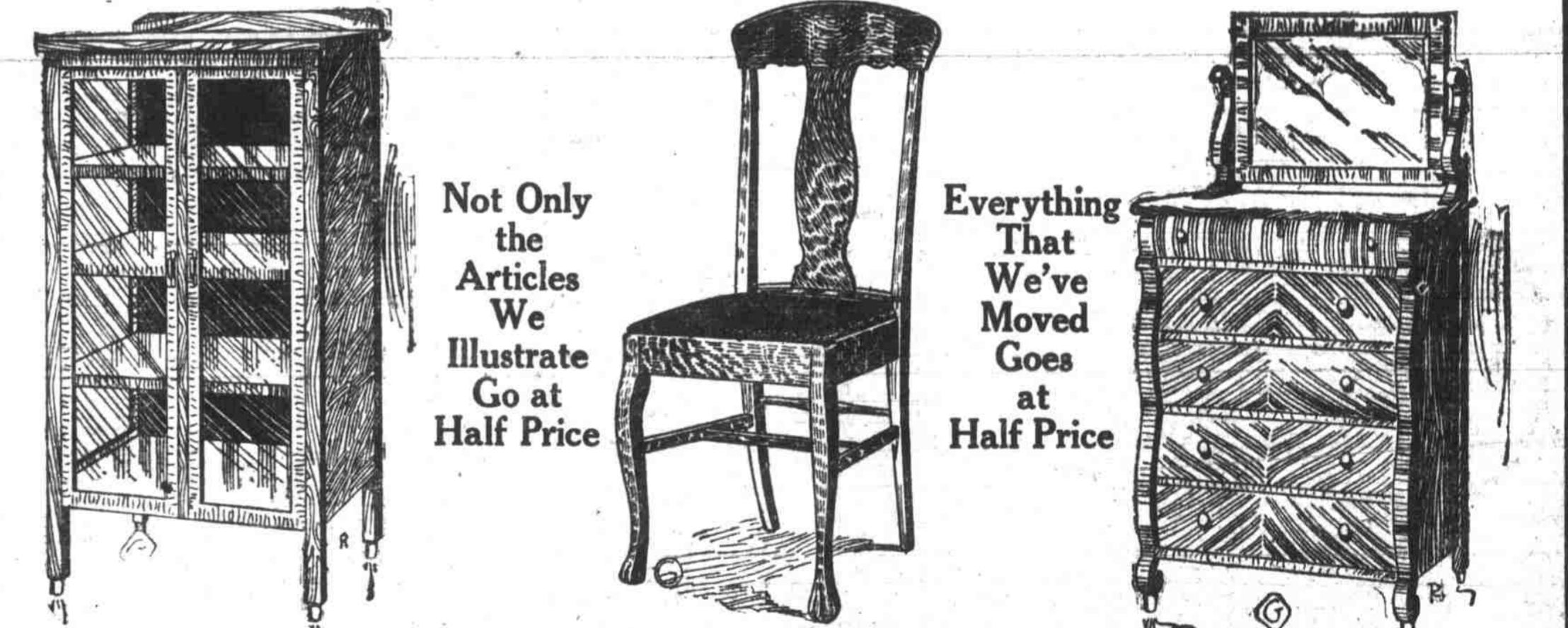
