

FIGHT IS BREWING —DEPOSED BULL —MOOSE CHAIRMAN

Meeting of Progressive State Committee to Be Called on January 20 Promises to Be Lively Occasion.

The state conference of the Progressive party, when the state central committee will meet to talk over the situation and plan for the future, probably will be called for January 20 by State Chairman George Arthur Brown. January 17 was the day originally set by the executive committee in directing the call for the meeting.

A lively meeting is forecasted by the talk of an attempt to be made to depose Chairman Brown on the part of those dissatisfied with the conduct of the last campaign. Brown's friends assert that he will have more than a majority of the state committee to sustain him, and that he will not retire unless the entire executive committee retires with him. He is reported to be willing to quit if his chief critics on the committee quit at the same time.

If Brown's conduct is attacked he promises to be ready to meet his accusers at all angles, and the innermost stories of party travail will be laid bare for the entertainment of the committee. Peace-makers are trying to head off a possible washing out of the party lines, and are demanding peace, even if they have to fight for it.

The rank and file of the new party seem to be in doubt as to what the trouble is all about. It is said to largely concern the differences between Brown and other members of the executive committee, which managed the campaign. These were troubles over finance and over the nomination for United States senator. They finally became so acute that Brown's authority as chairman was out to a minimum.

One of the leading spirits in the executive committee is L. H. McMahon of Salem. Brown favored the nomination of Bourne by the Progressives, and McMahon is bitterly opposed to Bourne. McMahon, who is said to nurse an ambition to go to the United States senate, is expected to come on hand for the conference fully primed for battle.

Local Bull Mooers are still discussing the nomination of a candidate for mayor, and a strong sentiment is appearing in favor of naming a candidate to oppose the Democratic and Republican nominees. Probably nothing definite will be determined until after the state meeting. So far most of the gossip of a possible candidate has centered around F. W. Muttley, head of the dock commission and former United States senator.

AUTOIST TAKES CHANCE TO AVOID HITTING WOMAN

While attempting to avoid a collision with a woman who had become confused while crossing Salmon at Seventh street this afternoon, L. L. Collins, a representative of the Pacific Motor company, ran his car into a private yard at the northeast intersection of the streets. The woman escaped with a slight bruise. She was bumped by the car and knocked to the street, but got to her feet and walked away without assistance. She refused to give her name and declared her injuries were of no consequence.

Collins was demonstrating a new Oakland car and was coming down Salmon street when he saw the woman, who turned at the hook of the horn. She jumped forward and back, until Collins was forced to run his car onto the sidewalk and into this yard. The machine was not damaged. A small holly tree was partially demolished.

JAN. 1 BRINGS NEW CASES OF INSANITY

January 1 is apparently a day for insane people to be brought to the county jail, according to the records, for the first person to be registered in the commitment book yesterday was a woman whom the police brought in to be examined for insanity. Another woman on the same charge was sent in by the police, but was released. A man was also brought from the Multnomah county hospital to the county jail. These were the only incarcerations made yesterday.

A year ago yesterday the first man to have his name entered in the big book was a doctor whose mind had weakened. The county jail has held, during the last year, 2743 prisoners, 347 being prisoners who were brought to the county jail by the police and for officers passing through the city. The remaining 2396 were city and county prisoners.

REJECT TURKEY'S ADRIANOPLE PLAN

Balkan Allies Insist All Questions at Point Must Be Settled in Peace Terms.

(United Press Leased Wire.)—London, Jan. 2.—Final rejection of the Turkish proposal that the status of Adrianople shall be settled between Turkey and Bulgaria alone is expected when the envoys trying to arrange a peaceful settlement of the Balkan war convene. Ambassadors' conversations on the Balkan deadlock were resumed at the foreign office today. It is understood that Bulgaria has informed the ambassadors of the powers that the Balkan allies made war on black, and that peace also will be concluded on black.

Dr. Dageff, it is said, has declared that Bulgaria will undertake no separate negotiations with Turkey on any point, but that the terms of peace when arranged must cover all questions between Turkey and all of the Balkan states.

Sir Edward Grey, British foreign minister, presided at the conference of ambassadors on the Balkan-Turkish question this afternoon.

Austrians Are Depressed.

(United Press Leased Wire.)—Vienna, Jan. 2.—It is a depressing new year for Austria and Hungary. Somehow New Year's joy will not come to the usually happy and vivacious Viennese and Budapesters, while throughout the dual monarchy thousands of homes are cheerless by the absence of father, husband or son, who is somewhere near the Serbian or Russian frontier, wishing he were with his loved ones.

It is difficult to obtain any reliable military information, but it is a safe estimate to say that 300,000 men are under arms ready for war. Special arrangements have been made by the government for the transportation of thousands of New Year's boxes and gifts to the soldiers. The newspapers have gathered subscriptions for the buying of holiday cheer for the troops in the field.

Greeks Repulse Turks, 172 Killed.

(United Press Leased Wire.)—London, Jan. 2.—A dispatch received from Athens says a detachment of Turks attacked a Greek force at Besani, near Janina, but were repulsed. The dispatch states that 172 Turks were killed and wounded.

INSANE MAN FLEES IN NIGHT CLOTHES

At Farm Houses Between Salem and Silverton He Begs Necessary Garb.

(Salem Bureau of The Journal.)—Salem, Or., Jan. 2.—By removing boards in the floor, where repairs had been made some years ago in the old farm house, he had walked to the distance barefooted and without clothes. He left in his night clothes and today he has been traced to near Silverton, where he begged for clothing at various farm houses. He had walked the distance barefooted and without clothes.

By means of a hole in the floor Bentley was able to drop into the basement and from there make his getaway without being detected. His absence was discovered soon after his departure, and attendants were sent out in search. Bentley is not considered dangerous. He was committed originally from Malheur county, where his relatives live, but about two months ago his father took him to a sanitarium in California and returned him to the asylum here only a few weeks ago.

ORDER MAIL CONTRACT WITH SUMPTER VALLEY

(Washington Bureau of The Journal.)—Washington, Jan. 2.—The request of Senator Bourne, the postoffice department telegraphed the superintendent of the Thirteenth district instructions to endeavor to secure a contract with the Sumpter Valley railway for transportation of mail between Austin and Prairie City. The mail is now carried by stage. The railroad company has so far refused to make the contract. The petition filed with the postoffice department is signed by several thousand residents of Grant and Harney counties for establishment of this service.

METOLIUS, OR., WINDOWS CAVED BY GREAT STORM

(Special to The Journal.)—Metolius, Or., Jan. 2.—One of the most severe wind storms central Oregon has had raged for about seven hours. Although a straight wind from the southwest, it nearly attained the velocity of a hurricane. Plate glass windows were blown in and several small buildings were demolished. Old settlers have never witnessed so severe a wind storm.

GLAVIS ADMITTED HE WAS IN PAID OF WEED LUMBER CO.

Kingsbury Says Secretary of Commission, Once Battering's Accuser, Told of His Connection.

(United Press Leased Wire.)—Sacramento, Cal., Jan. 2.—That Louis R. Glavis, who has resigned as secretary of the state conservation and water commission, close on the heels of an investigation of the Kingsbury charges by Governor Johnson, admitted that he had been in the employ of the Weed Lumber company, for which he secured preferential lieu land listings at Washington, D. C., while there on state business, is the statement made here today by Surveyor General W. S. Kingsbury.

Kingsbury, who was present at the hearing in the governor's private office, where Glavis was given a chance to present his defense, was loath to discuss matters taken up in that connection, but finally declared that the public had a right to know more than has heretofore been divulged.

"Glavis freely stated that while he was secretary of the state conservation commission he had been employed by the Weed Lumber company, a California concern, to secure the listings they wanted at Washington," declared Kingsbury today. "He stated also that he had employed Attorney Milton U'Ren to assist in securing the listings desired. Glavis, while admitting this, said he did not regard such action as unethical, inasmuch as it did not interfere with his duties as secretary of the commission. He said he felt he had a perfect right to accept employment as attorney for the lumber people on the side, and that he had made no effort to conceal this connection."

April 12 U'Ren wrote a letter to Secretary of the Interior Fisher asking that the special listings for the Weed concern be allowed, states Kingsbury.

It is declared by several officials close to the administration that the terms under which Glavis was employed by the lumber people provided that he was to receive \$1.50 an acre for all the lands he could get listed specially, and that he in turn was to pay U'Ren 25 cents an acre for all lands which the latter counted as his own.

Although it was stated that this was part of the testimony given at Governor Johnson's hearing, none of the officials would be quoted. It is understood that the governor asked Chairman Farde of the conservation commission to look into Glavis' resignation, but the governor could not be seen today to confirm this. No further inquiry is expected.

SOUNDS SENATE AS TO NAMING GOETHALS

(United Press Leased Wire.)—Washington, Jan. 2.—Before President Taft nominates Colonel Goethals as civil governor of the Panama canal zone he intends to assure himself that the senate will confirm the nomination. With this end in view, the president started today a personal investigation of the report that Democratic senators regarded the possible nomination of Goethals as a political move and intended to reject it.

President Taft is angry over the report, believing that this recognition is due Colonel Goethals, and that for the senate to act adversely would be subjecting Goethals to unjustifiable humiliation. The president insists there is no politics in this plan, and that it would merely be honoring Colonel Goethals for his work on the canal.

When asked today concerning a report that he intended to resign before the canal is opened, Colonel Goethals said: "It is probable. I am not a cavalier, but an engineer. I do not care for the blare of trumpets and the tinsel shows that will be connected with the opening ceremonies. I only desire to finish the work, and when the canal is completed, I will be ready to let someone else take the part of master of ceremonies."

HUNGARIAN LEADER WOUNDS OPPONENT

(United Press Leased Wire.)—Budapest, Jan. 2.—The outcome of a bitter personal quarrel which resulted in a deadlock in parliament, Stephen Tisza, president of the Hungarian lower house, and Count Karolyi, opposition leader, fought a saber duel today. Karolyi was dangerously wounded. The duel was fought in a thicket on the outskirts of the city.

Government Farmer Dies.

(Special to The Journal.)—Milton, Or., Jan. 2.—Jan Birdsell, a prominent farmer and fruit rancher, owning a large farm on Government mountain, died at his home in Milton Tuesday morning from an acute attack of indigestion. He has been in this country for 15 years, coming from Iowa and Illinois. He was born in Ontario, Canada, about 70 years ago, and is survived by his wife, three sons, William Birdsell, Samuel Birdsell and Robert Birdsell, all of this locality, and three daughters, Mrs. Harvey Demaris of Milton, Mrs. J. Crooks of South Dakota, and Mrs. C. A. Norman.

SHAW CELEBRATES GETTING REAL JOB BY BUYING A HOBO SHOES

(Special to The Journal.)—Oregon City, Or., Jan. 2.—Chief of Police Shaw felt so good when he realized that no longer he was "chief in name only" following Mayor-elect Jones' appointment to that office that he bought a new pair of shoes for a barefooted tramp who blew into Oregon City yesterday, shoeless and gloriously drunk. The hobo's name is Pete Larson, he says, and he has promised Chief Shaw a nice cigar the next time he "hits" Oregon City. The newly appointed night force got busy last night and rounded up 10 hoboes, all of whom were given lodging and breakfast in the city jail.

ADVISES URGED TO COPY FRENCH HIGHWAY PLANS

French Engineers Make Improvements by Districts and Politics Don't Affect Them, Says Noted Visitor.

Jean De Pulligny, a member of the chief staff of government engineers for France, and at present stationed in New York to study the industrial and commercial methods of this country in relation to public works, is in Portland today, a guest of Samuel Hill.

Mr. De Pulligny, who is one of the best known authorities on good road building in Europe, arrived in the city last night and was met at the station by Mr. Hill, who has just returned from a 40 day trip throughout the east. This evening the noted Frenchman will attend a dinner at the Arlington club, which will be given in his honor by Mr. Hill. He leaves for Medford late tonight and after a day's visit in the orchard country will continue to San Francisco, his destination. There he will study and report to the French government on the Panama-Pacific Exposition, and make recommendations as to what extent France should participate in the fair.

"I met Mr. Hill at Cincinnati at the road congress recently," said Mr. De Pulligny today, "and he was so loud in his praise of the northwest that I decided to make my trip to San Francisco via the northwest."

"And here I am," he added with a characteristic French shrug of the shoulders which was accompanied by a brilliant smile. "I understand the Oregon people are clamoring for good roads, and I am glad. Good roads mean good business, for with better transportation facilities, development of a country is intensified."

"In the United States I find that the people are liberal spenders for roads. Here you have the road before the house. In France we are what you call more prudent with money, and for this reason we have the house before we build the road."

"Activity in the northwest is enormous, development is going forward at a rapid pace and still it is hampered because you lack adequate roads. But it must not be forgotten that this is the land of the future, and highways are not built in a day."

French System Fraided.

"The principal trouble in building roads is not the knowledge of how to build them, but it is a question of administration and finance. In this country I believe it would be a good plan for the people of Oregon, for instance, to copy the French system. There the country is divided into districts and the government engineers map out the work that is to be done in each of them and decides which bit of construction should be completed first. These engineers are not in position where politics can touch them. They do their work as they think best and are in no danger of discharge save for incompetency. As a result they look to the best interests of all people and not any particular clique."

"There are 86 districts in France and each district finances its own road work. The central government keeps up about 24,000 miles of national highways, which formerly were the only main roads, and the districts have built and operate about 400,000 miles of highways."

"In the farming communities and less thickly settled areas, the roads are for the most part raised dirt roads with a central core of macadam, where the heavy traffic strikes it. On each side is a ditch, which at all times keeps the roads from becoming waterlogged. In fact, the ditches are the most important part of a road. Highways of this kind can be constructed economically, and the upkeep cost is slight comparatively speaking."

Afternoon Mr. De Pulligny was taken for a sight-seeing automobile trip by Mr. Hill, who, it might be added, was the recipient of a big silver loving cup at the hands of friends while attending the road congress at Cincinnati.

THEATRICAL HEADS DO SOME RAPID CHANGING SQUINTS

Orpheum to Take Heilig; Heilig Shows to Baker; Baker Attractions Will Move Into Old Orpheum Building.

A big game of checkers in which local playhouses are the checkers, is about ready to begin. Preliminary arrangements are just about completed. When a corner of the old Marquam block drops, not long ago the Orpheum began to stir. It was the Orpheum's first move. John Considine, who controls it, moved into the Bungalow and leased the Heilig for 10 years. The Heilig in turn leased the Baker theatre. Then the Baker arranged to move into the Bungalow as soon as the Orpheum vacated. The Empress is standing pat at its old location pending the completion of its new home at Seventh and Yamhill.

But not content with one move, Manager George Baker has announced that he has taken a five-year lease on the old Orpheum theatre and will move the Baker players to that playhouse, opening Sunday night, January 12, with "The Virginian." Nor is this all. Today he stated that the Bungalow theatre would be permanently closed after April 1. Whether the building will be dismantled or renovated for a business house he did not say.

As things now stand, the Orpheum, which is holding its shows in the Bungalow, will move a second time at the end of this week, and Monday night will open in the Heilig building.

The Baker players will then take possession of the Bungalow for a week, and then remove, bag and baggage, to the old Orpheum, while the Heilig will take the Baker. The last move in the game will be made by the Empress and Portlanders who play favorites will have time to figure out just where they want to go when they are looking for some certain show.

Manager George Baker seemed happy today over the proposed change. This morning he started a large force of workmen to work building a temporary arcade stretching from Sixth to Seventh street, thus giving him two entrances into the old Orpheum. As soon as the new building is constructed on the Marquam block site, the arcade will be replaced by one of steel and stained glass. In addition another entrance will be made through the proposed new structure, giving three entrances from Sixth, Seventh and Morrison streets.

BULLETS SPEED FUGITIVE ON WAY

Alleged Warm Springs Rustler Dragged From Under Building.

Edey, a wealthy retired Wall street broker, shot and killed his young wife in their home on Great South Bay early today, and then blew out his brains. Mrs. Edey, who was 12 years younger than her husband, left him last summer.

Mrs. Fleming resided with her parents at 1923 Clackamas street, and Fleming is from Vancouver, B. C. Miss Ruby Scott and Raymond Snyder played the roles of bridesmaid and best man.

Fleming went to Vancouver Monday to secure a license but did not have a witness, so was obliged to return without one. The woman who assists Clarke county's clerk in issuing licenses of all kinds gave him her address and issued the license late Tuesday at her own home. Mrs. Fleming's parents knew nothing of the wedding until this morning and had no objection to the union. The witnesses were Raymond Snyder and Ruby Scott.

TIBETANS IN ATTACK ON CHINESE KILL 300

(United Press Leased Wire.)—Shanghai, Jan. 2.—Dispatches from Chenctu, province of Sze Chuen, received here today, say that 300 Chinese soldiers met death last night in an attack of Tibetans near Heiang Cheng, on the Tibet border.

The Tibetans, who also captured six machine guns, made their attack in the darkness while a near-mutiny convulsed the Chinese camp.

Keene Near Death.

(United Press Leased Wire.)—New York, Jan. 2.—James R. Keene, noted financier and turfman, is at the point of death here today. A delicate and dangerous abdominal operation was performed this morning, but owing to his age, chances for recovery are against the patient. Keene has been an invalid for two years.

NATAL NEARS NEW YORK WITH BODY

British Cruiser Bearing Remains of Ambassador Reid to Enter Tomorrow.

(United Press Leased Wire.)—Newport, R. I., Jan. 2.—The British cruiser Natal, bearing the body of the late United States Ambassador Whitehead Reid, who died in London, is steaming slowly up the Atlantic coast today toward New York.

Owing to a new law prohibiting the publication of wireless messages, the only information published stated that the Natal was on time and was proceeding according to schedule.

The Natal's commander will get in touch with the American squadron. It was first stated that the Natal would anchor in the Hudson river tonight, but later it was decided that the original program would be followed. The Natal, escorted by the American squadron, will steam at half speed until reaching Ambrose Channel lightship at daylight, and immediately proceed up the river.

Dayton Windows Yield to Gale.

(Special to The Journal.)—Dayton, Wash., Jan. 2.—For four days in this vicinity the chief object of interest and concern has been an unusually high wind. At periods the wind assumed the dimensions of a gale with a velocity of from 50 to 60 miles per hour. ROBBERS STEAL IN TWO TOWNS

Springfield News Office Alone Fails to Provide Plunder for Thieves.
