

PROPOSED SALARY RAISES WOULD ADD \$25,000 A YEAR

Recommendations for 203 Increases Made by the Ways and Means Committee; New Positions Are Created.

If the recommendations already made by the ways and means committee of the city council are adopted by the council a week from today, the payrolls of the city will be increased more than \$25,000 a year. Exactly 203 salary increases have been recommended, the total amount of these being \$24,960 a year. In addition to these, several new positions will be created if the council passes favorably on the action of the committee. This will bring the total increase for salaries alone up to more than \$25,000, in fact, nearer to \$30,000.

Besides the raises already passed upon by the committee it is probable that the majority of the committee will ask the council to increase the wages of the night workers in the street cleaning department from \$2.75 a day to \$3.00. There are 105 men on the night force of the department and the total of the raise contemplated for them would be approximately \$8000 annually.

Council May Make Out. However, it is altogether likely that the council will cut down a great many of the projected wage additions. If indeed, not the greater number of them. Some of the raises are deserving, in the opinion of a good many of the councilmen, while others are not.

Before the matter of increasing salaries is finally settled this year, it may be that Mayor Rusk will carry out a plan he has long had in mind, that of appointing a special committee to investigate the various salary schedules with a view to revising these and establishing something approaching uniformity in the payment of stipends.

This plan was followed to some extent in the recommendations made for increases in the fire department. Councilman John H. Burgard made these recommendations after he had scrutinized the salary schedules of other cities in the state of Oregon. He says that even if the raises in the fire department are all granted the men will not be getting as much as men who hold similar positions elsewhere.

List of Increases Given. Following is a list of the salary increases recommended by the ways and means committee to date this year:

Three foremen in the sewer department, from \$85 to \$90 a month.

Three traction engineers in the street repair department, from 45 cents an hour to \$1.00 a month.

One clerk in the street repair department, from \$100 to \$110 a month.

Twenty-five laborers in the street repair department, from \$2.75 a day to \$3.00.

Four watchmen in the park department, from \$17.50 a day to \$20 a month.

One night foreman in the street cleaning department, from \$100 to \$125 a month.

One clerk in the same department, from \$90 a month to \$100.

Eleven chauffeurs in various departments, from \$3 a day to \$10 a month.

One stenographer clerk in the city auditor's office, from \$100 to \$110.

In the city engineer's office three clerks were recommended for raises of \$10 over their present wage of \$100 a month.

Eight computers in the same department, from \$100 to \$105. Five computers from \$90 to \$95. Two traction engineers from 45 cents an hour to \$1.00 a month.

One stenographer in the city attorney's office, from \$105 to \$110; one stenographer from \$90 to \$95; and one from \$80 to \$85.

One assistant clerk to the municipal judge from \$80 to \$100.

Laborers Get Boost. One stenographer in the city building inspector's office, from \$15 to \$25 a month.

One clerk in the health office, from \$85 to \$100. One school nurse, from \$75 to \$90.

One stenographer in the civil service department, from \$85 to \$95.

One poundmaster, from \$135 to \$150. Seventeen laborers in the city incinerator department, from \$75 to \$80.

Head janitor of the city hall, from \$100 to \$110.

O-W MEN INSPECT OREGON EASTERN

Report That New Road Has Been Taken Over From Short Line Affirmed.

Vale, Or., Jan. 15.—No question now remains, as previously reported, the O-W. R. & N. company on January 1, 1913, took over the Oregon Eastern railroad, now building westward across interior Oregon to Crescent, on the Nelson cut-off, from the management and control of the Oregon Short Line.

Verification of the report, which has repeatedly in the past two weeks been affirmed by events, comes with the visit here this week of George W. Boschke, general manager of the O-W. R. & N. at Portland, who has never inspected the property of the Oregon Eastern before.

An Oregon Short Line special train left Huntington January 13 with the following high officials of the two roads abroad: George W. Boschke, of Portland; Carl Stradley, his predecessor, chief engineer, O. S. L., Salt Lake City; E. C. Manson, general superintendent, of Salt Lake City; W. H. Wattis, general superintendent Utah Construction company, of Ogden, Utah.

Other local officials picked up at Vale, and who accompanied the eminent visitors on their trip of inspection over the new line, were: O. S. Osborn, assistant chief engineer, in charge at Vale; W. H. Wattis, local manager Utah Construction company; E. E. Iverson, of Nampa, Idaho; L. P. Tolman, of Seattle, Wash.; L. J. Seckels and Lewis Deppie, of Salt Lake City, Utah; R. E. Gurley, of Chicago, Ill., and Glen H. Trout, bridge engineer, of Pocatello, Idaho.

Recommendations made by the high officials, if any, could not be learned, but Mr. Boschke expressed himself as well pleased with the manner in which construction work has been conducted, and the present working force from O. GOVERNOR ASKS THAT S. P. TITLE BE REVOKED

Salem, Or., Jan. 15.—When the house convened this afternoon a special message was received from Governor West with recommendations for the settlement of the contest with the Southern Pacific railroad for possession of the Pacific coast property, foot of Jefferson street in Portland.

The governor recommended that the legislature revoke all rights to the property claimed by the railroad and that the property be turned over to the city of Portland.

Under this arrangement the city would be left free to negotiate with the railroad company for any adjustment advantageous to the city.

DIMICK'S 8-HOUR BILL REAPPEARS

Measure Which Caused Such a Fight Two Years Ago Is Introduced Again.

(Staff Correspondence.)
Salem, Or., Jan. 15.—An eight hour bill for labor in factories where the working day is 23 hours or more, which caused one of the big fights of the session two years ago, made its appearance in the senate this morning. The author, then and now, is W. C. Dimick, the angular senator from Clackamas.

While the bill will apply in many spots in the state, its chief object is to enforce an eight hour day in the mills at Oregon City. It has been drawn to eliminate outside opposition as far as possible by providing it shall apply only in factories and mills where the ordinary working day includes 23 hours out of 24, and then only to such persons as are employed in and about machinery operating for that number of hours.

Dimick says he expects to face the same bitter fight that was made two years ago, when the bill was up and down by turns, and was finally defeated in the house after a successful battle in the senate. At that time the Oregon City factories threatened to move out of the state if the bill were enacted. This, Dimick has always asserted, was a bluff.

Dimick is the author of another bill requiring each applicant for a marriage license to present a physician's certificate to the county clerk. Any physician may give a certificate of examination, and may not charge more than \$2.50 for it.

Senator Ragdale of Sherman county has a bill for extensive regulation of the business of commission merchants. He proposes to make it unlawful to sell on consignment more than \$5000. Books must be kept to show the amount and condition of all fruit and produce received and the merchant is made liable on his bond for failure to observe the provisions of the law.

WANT FISHING LAWS LEFT ALONE WHILE

Salem, Or., Jan. 15.—Headed by George H. George of Astoria, a group of representatives of the canning and fishing industries from Astoria and Portland, here today urged the legislature to leave West and members of the legislature their request that the fishing laws be left alone.

"We don't want any changes whatever," declared Mr. George. "We want the laws left just as they are. In the past there has always been a fight between various interests over fish legislation, and we would like to avoid that by leaving the present laws alone."

He said the fishing laws were amended two years ago, and that so far as propagation of fish is concerned it would require four or five years to determine whether the present laws needed to be changed.

and unity in the completed composition. The library will be enlarged through authority given yesterday to buy several hundred dollars' worth of new books.

The faculty will be strengthened by increasing the salary schedule to a point where it will attract the services of the most eminent teachers of the United States. This strengthening plan, says President Homan, will particularly relate to the chairs of philosophy, literature, sociology, history and science in Willamette university. The big endowment will furnish financial aid to this plan of faculty strengthening.

The auditing committee was authorized to obtain the services of an expert accountant who will install a perfect accounting system, so that every item of disbursement or collection may be immediately available when needed for reference.

A special committee was appointed, consisting of T. E. McDaniel, chairman of the board of trustees, President Homan of the university, and R. A. Booth of Eugene, to consider the affiliated schools of medicine, law and theology, the purpose being to find where they do not meet the most modern standards and conditions, to determine if it is advisable to keep and maintain these schools, and, if so, to strengthen their courses so that they shall be on a par with the best schools of the kind, east or west.

TRIAL OF MEDFORD TRAIN ROBBER BEGINS

Witnesses have been brought from Oregon to testify as to Lounsbury's sanity. In the courtroom were also his father and mother. The former, Colonel E. A. Lounsbury, was once a candidate for United States senator in North Dakota, and is now in the land office at Washington.

WOMAN CALLS SPEAKER TO TIME

Member of Washington Legislature Makes Taylor Eat His Joke on Her Bill.

Olympia, Wash., Jan. 15.—Speaker Howard Taylor of the house drew a hot call-down at the second session of the legislature this morning when he attempted to poke fun at Mrs. Francis Astell, one of the two women members who are introducing a bill regulating morals at the request of the W. C. T. U.

Mrs. Astell offered three bills which had been submitted to her by the temperance workers. One intended to curb "white slavery" was referred by Taylor to the committee on commerce and manufacturers as a joke.

Many members of the house took kindly to the intended humor and a roar of laughter went up. But Mrs. Astell was angry. Rising from her seat, she waited until the noise subsided, then demanded in firm tones that the speaker retract his action and refer the bill to the committee on morals.

Taylor complied at once.

Hay Sends Message.

Olympia, Wash., Jan. 15.—Governor Hay, in his last official message to the legislature, put great emphasis on the wonderful prosperity of the state.

He recommended to the present legislative session that the presidential primaries be changed from September to May; removing of the party circle from the head of party columns on the ballot; ratification of the bill submitting to the people an amendment to the federal constitution for the direct election of senators; a law ending mixed marriages; an investigation of the banking system; law providing for the use of public schools as social centers; and a first act for the workingmen's compensation act, but he did not say who should provide for the first aid, the employee or employer.

CLAIMS SHE CANNOT CLEAR TORGERSO

Roosevelt, Or., Jan. 15.—The criminal record of John Torgerson, who was arrested here Monday for robbing several postoffices and stores in the Rogue river valley and later was recognized as a murderer wanted in California, becomes more and more interesting as the case is thought to have robbed several postoffices in California and together with the husband of the woman, who accompanied him here, to have drugged and robbed a man at Vina, California. The woman has confessed that she is the wife of A. E. Dietz of Vina, and that she left California with Torgerson after he shot and killed Jim Miller at Vina one night during a drunken frenzy.

The woman, 22 years old, and slender and comely, said she was acquainted with Torgerson for some time before he committed the murder and that Torgerson and her husband were close friends. She said her husband is now under arrest there as an accomplice in the murder, which Torgerson is charged. She accuses her husband of numerous acts of cruelty toward her, and this she declared, was the reason she deserted him and ran away with Torgerson. In some of her various confessions, she said she would tell her husband as "a good, kind-hearted fellow," and is anxious, she says, to get in communication with him because she feels sure he will take her back.

"I want to go back to California," said Mrs. Dietz. "I could dinner clear Torgerson of the murder charges or I could at least show up the true facts in such a way that he would not be hung. My husband gave him so much liquor on the night of the killing that he didn't know what he was doing. Torgerson fired two wild shots at the station, coming out of a store, and one of them hit this man Miller and kill him. Torgerson didn't know what he had done until my husband told him the next morning in our cabin at the fish camp."

CONSERVATION PLANS FOR NEW CHURCH

First M. E. Edifice to Cost \$150,000 If Report Is Approved.

Work will be started on the plans for the new home of the First Methodist Episcopal church immediately after the meeting of the quarterly conference to be held Thursday, January 23, if the report of the committee on the new church, which was agreed upon last night by the trustees of the church, meets with approval at the conference. The church will cost \$150,000, and will be located on the site of the present Grace church, Twelfth and Taylor streets.

The meeting of the board of trustees was held last night in the church immediately after the adjournment of the Men's Brotherhood, which met at a banquet and heard an address by Bishop R. J. Cooke on "John Wesley as a Social Reformer." In his talk Bishop Cooke traced the growth of the Methodist church in this country following the work of John Wesley.

Members of the organization to the number of 130 heard Bishop Cooke. G. F. Johnson submitted the majority report of the trustees on the new structure. In it they asked to be given power to act as they saw fit concerning the property of the church, which is located at Third and Taylor streets and Eleventh and Salmon streets.

The trustees asked that they be allowed to either sell it, lease it, improve it or raise a mortgage upon it, with the proviso that half the total value of the property, whether sold or retained, be used toward building a new home or adding to the Grace church and make it adequate to suit the needs of the work, and the other half be used for a city extension fund or missionary work, as seemed necessary.

Judge Worden of Klamath county thereupon moved that a committee be appointed to draft a resolution favoring the plan, with instructions to report at this afternoon's session. It was carried unanimously.

Judge Cleaton, as president, then appointed Maloney, Judge Hall of Coos, and Peter from Polk to act as the committee. Maloney begged off on the grounds that the resolution would carry more weight if drafted by a Multnomah county man and on a motion Cleaton was elected to replace him as chairman.

To Change Code.
Other resolutions adopted by the association included recommendations to the legislature that the probate code be changed to allow the closing of estates in 90 days instead of six months and the repeal of the law which makes county officers personally responsible for monies left in their charge for the care of graveyards.

The big vote which downed a resolution calling on the legislature not to elect or appoint a state highway commissioner or engineer, introduced by O. H. Russell of Linn today, indicated that the association may repeal its adverse action of yesterday.
