

HOUSE DEVOTES MORNING TO BILL ON STERILIZATION

Measure Is Finally Sent Back to Committee for Revision, as Many Members Regard It Too Severe.

(Staff Correspondence.)
Salem, Or., Jan. 23.—A debate on the merits of sterilization for habitual criminals and moral perverts occupied the house for nearly an hour this morning. The house sent the bill back for committee revision, some of its provisions being regarded as too severe. This was done over the protest of Representative Lowelling of Linn county, a former guard at the penitentiary. "Realizing that it is only a step from the legislature to the penitentiary," said Lowelling dryly, "there hasn't been the opposition to this bill that I expected."

"But I think the bill should pass now, just as it is. From my own experience with criminals I am convinced that criminal instincts cannot be eradicated by environment, and we should make it impossible for these men to reproduce descendants who will inherit their qualities."

Urges Opposing Arguments.
The bill, which has been strongly urged on the legislature by Dr. Owens Adair, of Portland, makes third conviction for a felony constitute a man an habitual criminal. This clause was objected to by Chapman of Washington county.

"It's the man who's loose you want to sterilize, not the man that is locked up in the penitentiary," he said.

Murnane of Multnomah opposed the bill on the ground that it constituted an infringement on personal liberty.

"If this bill came up with regard to livestock," declared Bonebrake of Benson, championing the measure, "you would all vote for it. Why should you hesitate when men are involved? Why should you treat the human race worse than the lower animals?"

Near Clash Over Bill.
Speaker of Multnomah said the bill was dangerous. A man might be convicted of attacking a woman as a result of a conspiracy, and would be an innocent victim of sterilization, he said. For a short time it looked as if a fight might be precipitated on the passage of one of Governor Wood's resolutions. The bill requiring property owners to cut all weeds in roads through their property was reported adversely by the committee on roads and highways.

Representative Polce, chairman, asserted that it would work great hardship on farmers, in which he was seconded by Schueler of Clackamas, and Blanchard of Josephine, who declared the weed problem should be delegated to the county. Confusion was averted for the time being at least when the bill was referred to the judiciary committee.

FARM EDUCATION BILL ENDORSED

Oregon Development League Favors Passage of Measure.

Senate bill No. 72, providing for extension of farm education to all parts of the state, was given the strongest kind of endorsement at a luncheon held today at the Portland Commercial club under the auspices of the Oregon Development League. A. C. Callan was named as temporary chairman, Phil S. Bates, as temporary secretary. A committee was appointed to call on the state legislature to pass the measure. The committee is composed of A. C. Callan, H. P. Miller, J. Fred Larson, G. M. Hyland and J. D. Lee.

It was also the sense of the meeting that when the bill is introduced, a large delegation of Portland business men go to Salem and thereby indicate the keen interest taken in Portland in the development of the agricultural resources of the state.

Briefly the bill provides for the establishment of experimental stations in various parts of the state, farm education in the public schools, and farm education among the settlers in the various counties through the field secretaries and demonstration farms.

It is said that in spite of the tremendous importance of the bill, some opposition has been voiced from some farming districts on the ground that it would increase taxation to the extent of the annual appropriations for the work, approximately \$25,000, a very small amount compared with the results it is claimed to produce.

H. P. Miller in addressing the meeting said today that millions of dollars are being wasted annually in this state because of the lack of understanding on the part of settlers how to obtain the best results. He said, too, that a tremendous percentage of work has to be done two or three times because of lack of farm education.

TO SUBMIT CASE TO GRAND JURY TODAY

As the next step in the campaign of Sheriff Tom Ward to break up the alleged bootlegging system of traffic in girls and women for immoral purposes, Deputy District Attorney Robert Maguire is prepared to submit one case to the grand jury this afternoon. The case is that of B. H. Baruh, a Turk shoe dealer, arrested last night at 130 Third street, and Nellie Belle, mistress of a house to which Baruh took one of the sheriff's men who was laying a trap for the suspect.

PREPARES WARRANT FOR JOSSELYN'S ARREST

Deputy District Attorney Maguire has prepared warrants for the arrest of President B. S. Josselyn of the Portland and Hallway Light & Power company, and P. J. Fuller, vice president of the company. These warrants will be submitted this afternoon to be served. The warrants charge that the streetcar company has violated the law in not equipping the cars with proper fenders as required by the state law.

AILSHIE GOES OUT IN IDAHO RACE; 31 IS BRADY'S MARK

Only Three Ballots Are Taken, Boise Legislators Realizing No Verdict Is Yet Possible; James H. Hawley Scored.

Boise, Idaho, Jan. 23.—Denouncing ex-Governor James H. Hawley as a "reactionary Democrat," Senator Dow Dunning, one of three Democratic members of the upper house, fought bitterly today against the adoption of a resolution endorsing Hawley for secretary of interior in the Wilson cabinet. The resolution was of Republican origin and was adopted by a vote of 20 to 1, two Republicans and two Democrats voting against it.

Today's balloting for short term senator was marked by the disappearance of Chief Justice James F. Ailshie as a candidate. He did not receive a single vote. Ex-Governor H. B. Brady dropped from his mark yesterday, from 39 to 31. Many of the Brady supporters voted for ex-Governor John T. Morrison. Only three ballots were taken, members of the assembly realizing that the contest was in such condition that no election was possible today.

PERMITS BONDING FOR RECLAMATION

Removal of Constitutional Limitation on State's Debt-Making Power Provided.

Salem, Or., Jan. 23.—Removal of the constitutional limitations on state indebtedness for the purpose of state aid in the reclamation of arid lands by irrigation and the development of the water power of the streams of the state, is proposed in a resolution presented in the senate today by Thompson of Lake. If the resolution passes, the people of the state at the next election will vote on the question of amending the constitution in this way. As the law now stands, the state is limited to a debt of \$50,000 unless for the purpose of repelling invasion or building permanent highways.

In the form in which it was introduced, the Thompson amendment would repeal the amendment adopted by the people in 1910 authorizing state aid for good roads. Thompson says this was an oversight, and he will have the good roads provision included by the judiciary committee, to which the resolution was referred.

J. F. LOGAN HAS BILL FOR LEGAL REVISION

Salem, Or., Jan. 23.—Drawn up by Attorney John F. Logan, of Portland, a bill designed to sweep away much of the present technicality of the courts and to protect the interests of the client from the ignorance or error of his lawyer, was presented in the house this afternoon by Representative Latourrette, of Multnomah county.

While it will not be a panacea for all the ills complained of in the present code, says Mr. Logan, this bill would do away with a great proportion of them. Incorporated in it are the new equity rules adopted by the United States supreme court.

FALLING FIR TREE KILLS TWO AT ENRIGHT, OR.

Tillamook, Or., Jan. 23.—T. Monett, Japanese member of a section crew, and L. M. Dudley, an American track-walker, were killed and several others were injured at Enright, a station on the P. & N. Tuesday night. The accident was caused by a falling fir tree, which struck the locomotive, demolishing it. A special car with a doctor and nurses was sent to Enright. William Conley, the section foreman, whose family lives in Beaverton, was also injured.

STATE FAIR BOARD REELECTS J. H. BOOTH

Salem, Or., Jan. 23.—The storm that threatened at the last meeting of the state fair board over the election of officers, was blown away in evidence when the board met today and reelected J. H. Booth president and Frank Meredith secretary. H. W. Hatch was elected vice president and A. Bush, treasurer. The board is in session this afternoon.

Non-Resident Poor.

A bill for \$1,877.88 was sent to Secretary of State Olcott this morning by County Auditor Martin for the care of non-resident poor in this county for the past 10 years. The bill is based on the expenditure of \$12.50 a month and the number of months which the county claims is secured by taking the total of 28,697 days for which the poor were cared and dividing them into months, making a total of 956.23 months. The number of poor cared for is approximately 600 in the 10 years. The bill is to be submitted to the legislature for an appropriation, as the state has no fund from which to pay it.

Bank Clearings Show Gain.

An increase of \$1,783,412.05 in the Portland bank clearings for the week just passed, over the same week in January, 1912, is shown by the figures compiled today. For the past week, clearings have aggregated \$10,446,428.41, and for the same week in 1912, the aggregate amount was \$8,663,016.36. The clearings for every week this year have shown a substantial increase over corresponding periods in 1912.

ASSERTS PARCEL POST SYSTEM IS HERE TO REMAIN

Plan Gives Small Merchant a Weapon With Which to Fight Large Mail Order House; Hardware Men.

"Parcel post has come to stay. It is a good thing, and places in the hands of the small merchant and dealer a weapon to fight the big eastern mail order houses. The new system will bring changes in trade conditions and will bring the consumer in closer touch with the progressive dealer."

These are a few of the things told the delegates attending the Oregon Retail Hardware and Implement Dealers convention this afternoon by Arthur E. Sugdon, manager of the Pacific Hardware and Steel company, in his address, "How Can a Jobber and Retail Dealer Succeed Under Parcel Post, Best Cooperative?"

Others who addressed the convention today were N. D. Cool, of Drain, who spoke on "Cash or Credit Business," and Theodore P. Cramer, of Grants Pass, who chose for his subject, "Keeping Down the Costs in the Hardware Store."

To Hold Banquet Tonight.

At the annual election held yesterday afternoon, President Glen A. Goodman, of Roseburg, and J. Riley Craven, of Dallas, were reelected. N. D. Cool, of Drain, was chosen as executive committee man.

This afternoon the executive committee expects to choose a secretary-treasurer, and it is believed H. J. Altman, incumbent, will be selected.

Tonight a banquet will be given the retail dealers at the Multnomah hotel. Local wholesalers and jobbers will act as hosts.

In his address this afternoon Mr. Sugdon went deeply into the parcel post system, and declared the present zone rate system is the most feasible of all plans considered.

"With proper stock and progressive management," said Mr. Sugdon, "there is no reason why you can not hold your own, but rather increase your business in outlying districts. Many more progressive merchants doubtless are suffering to issue price letters or small catalogues. They recognize in parcel post an opportunity to compete with the mail order houses with their own weapons, and while the struggle will not be easy by any means, and I feel that large distributors by mail from prominent points will always be existent, they can, under the present system, do no more harm to you, who are prepared to fight them, than was possible under the express system."

This is an age of specialization. Your strongest competitors, the mail order houses, are actively engaged in figuring out what they can do to take your business away from you, and if you avail yourself of the facilities at your command under the present conditions, they have a hard proposition to overcome."

placed in the deed as a condition subsequent.

State Absolutely Unprotected.
Carson thought the land board might require a bond to be given before the state enters into contract, but this is challenged as probably unenforceable. Stanning, however, in the discussion in the fact that the Thompson bill does not contain anything whatever on the manner in which reclaimed lands are to be sold, whereby the state may be assured of sale in small tracts, to real settlers, or at reasonable prices, these are the things the governor is contending for, and the defects that are manifest.

Another bill urged by Thompson two years ago and passed over the veto is one providing for a fish hatchery at Spring Creek, in Klamath county, fathered by Senator Merriman. This was vetoed by the governor on the ground that the state fish and game commission could provide the funds needed.

Now it is charged that something akin to trickery secured the passage of this bill over the veto. It was stated before the judiciary committee of the senate that the fish and game commission has not the funds to protect the fishery, for which the bill made an appropriation of \$5000.

Near-Trickery in Senate.
Since then W. L. Finley, the fish and game warden, has appeared and says the statement was made without his authority, and that in fact the fish and game fund has \$30,000 available for such uses. He is only waiting the quieting of title to the land on which the hatchery is to be located, which is within an Indian reservation.

So this bill may be given rough sledding in the house, on the ground that it is a useless appropriation from the general fund. In the senate the facts were not brought out, so the bill went through with practically no opposition.

WEST MAKES CLEAR INTENTION TO CARRY FIGHT DOWN LINE

Salem, Or., Jan. 23.—Governor West is standing firm in his declaration that he intends to fight clear down the line if the antagonistic attitude of the legislature is maintained.

After Representatives Hughes and Helzel of Marion voted in the house yesterday against the administration measure placing the responsibility for immoral houses upon the property owner, the governor called the members of the state fair board and told them if the Marion county delegation was going to fight him they need not look to him for any support in behalf of the fair. He told them to let Hughes and Helzel do it.

Members of the board endeavored to get a meeting with the Marion delegation last night, but did not succeed. However, today they say that they believe the two members of the Marion delegation have seen the matter in a new light, and that there will be no further friction.

Governor West advised the fair board to cut the \$100,000 appropriation for which it was asking for a new agricultural building in half. He told them they would have a better show of getting what they wanted if they asked for only \$50,000.

BAILIFF OBSERVES HIS EIGHTIETH BIRTHDAY



George Humphrey.

George Humphrey, veteran bailiff and clerk of the United States District court, was wearing a red carnation and receiving hundreds of congratulations today, for this is the eightieth anniversary of his birth. Perfect in health and vigorous, he admitted this morning that he had never been confined to a bed a day on account of illness.

"Uncle George," his federal court title, was born in 1833 in Jefferson county, Ohio, but his parents took him to Iowa a year later. In 1845 he crossed the plains, as captain of an immigrant train of 52 wagons and 72 men. He settled in Albany, where he resided for 28 years, and of this time he was sheriff of Linn county for two years and deputy for 12. For a number of years he was the Albany representative of the United States marshal, and in 1892, he came to Portland as deputy United States marshal. Under H. C. Brady, Joe Houser and Jack Matthews, he served as deputy in the field until 1904, when he became court bailiff. It is said of George Humphrey that he has made more important arrests than any man in Oregon or the northwest.

MYSTERY IN DEATH OF MAN

Body Found Hanging From a Tree in Back Yard of Upshur Street Home.

Mystery surrounds the death of John Stroica a Roumanian, 28 years old, whose body was found hanging from a tree in the back yard of his boarding house at 940 Upshur street, at 8:30 o'clock this morning by the landlady, Mrs. Danil Gordon.

The body was found hanging about 10 feet above the ground with a hangman's noose around the neck. The rope was about eight feet long and was tied to a branch about 15 feet above the ground.

Mrs. Florea saw him for the last time at 10 o'clock last night, when he told her that he was going to die.

A ladder, which may have been used in tying the rope to the branch, was found lying several feet away from the base of the tree. It is said that it would have been impossible for Stroica to have kicked the ladder so that it would fall such a distance. The rope was badly burned on one side where it had passed over the branch, and the bark was cut about a half an inch deep.

Stroica had paid his board for two weeks in advance, although he had not been working for some time. He had always seemed in the best of spirits and Mrs. Florea knows of no reason why he should have committed suicide.

Although the body was discovered by Mrs. Florea, the police were not summoned until Mrs. John Holmes of 929 Thurman street notified them. Her attention was called to the body when she went to the back porch of her home, and saw several boys around the place.

Detective Swanson went to the scene, and later the coroner was notified. The body was cut down and is now at Dunning & McEntee's.

PROFESSOR GLEN GOES TO U. OF WASHINGTON

Seattle, Wash., Jan. 23.—Important changes in the faculty of the University of Washington, and also in its educational departments, were announced today.

Professor I. M. Glen has been named director of the department of fine arts. Mr. Glen was head of the department of music at the University of Oregon.

Professor Frederick E. Bolton was appointed director of the new college of education. Bolton formerly was head of the department of education at the University of Iowa.

Professor Henry Landes has become head of the new college of science, which includes both the sciences and liberal arts. Landes has been a member of the state university for 18 years.

SALOON MAN LIABLE IF HE CREATES DRUNK

Salem, Or., Jan. 23.—Without opposition, the senate today passed the bill of Senator Calkins, senate bill number 80, making a saloon man liable for damages in civil action brought by the mother, wife or child of an habitual drunkard or intoxicated person.

Another bill passed makes it mandatory upon county courts to pay \$1 per day to the families of rockpile prisoners convicted of non-support. Under the present law \$1.50 may be paid in such cases, but is not required to be paid.

SCHOOL SURVEY PLAN IS HALTED; OPINIONS DIFFER

Technical Quibbling Blocks Actual Progress; Question of Expending \$7500 Fund Is Discussed at Length.

Despite the fact that the school board at a special meeting last night passed a resolution appointing the same committee selected December 27 at the taxpayers' meeting to carry on a survey of the Portland public schools, the survey is held up apparently by technical quibbles.

Members of the board and the survey committee met last night for more than two hours. They discussed the question whether the survey would be given full rein to expend the \$7500 survey appropriation voted at the taxpayers' meeting, and carry on the investigation in its own way or whether the inquiry would be technically under the board's thumb.

The recent opinion on the matter, given by Attorney General Crawford, formed the basis of argument. The opinion is so expressed that it is open to two interpretations, one—that the board shall have control over all expenditures and the other to the effect that the board can empower the committee to go ahead with the investigation and vote \$7500 to carry it on.

Opinions Are at Variance.
J. V. Beach, who adopted an ultra-conservative stand on the question, said he feared to give the committee full powers for the reason that there was a possibility of doing something not exactly legal. He was backed by M. G. Munly, a fellow board member, while R. L. Sabin and I. N. Felschner were giving the committee the fullest possible power in whatever inquiry they set about.

"All I want is a proper auditing of the committee's books," said Mr. Felschner.

Mr. Sabin, who presided at the meeting, took the attitude that the board should follow the wishes of the taxpayers as expressed at the meeting when the appropriation was voted and committee to investigate appointed.

Members of the committee strongly inferred that they wanted full power to go ahead in their own way, appoint their own experts and conduct the investigation independent of the board. It was intimated that one or two board members do not look with any particular favor on the investigation for the reason that it might result in recommendations, which if adopted, would change the present system of education for technical reasons.

The stand taken by the committee was set forth by Chairman R. W. Montague, in his address to the board.

"The entire purpose of this survey is destroyed unless we are allowed to act independently of the board. It seems to me that that was the object of the meeting that appointed us. It is not a question of whether the committee has the power to but whether this is to be a committee survey or a board survey."

Now that the resolution has been passed, the committee will go ahead.
