

S. P. REFUSES AID TO INJURED MAN SINCE HE TALKED

Lawrence Kuppy is Neglected Because He Refused to Make 772 Mile Trip in Day Coach With His Leg Broken.

How publicity worked a hardship on one man is evidenced by the case of Lawrence Kuppy of 647 East Fourteenth street, an employee of the Southern Pacific railroad, who sustained a broken leg, December 22, while at work in the company's shops in Brooklyn.

Treatment at his home is denied Kuppy by the railroad, according to information given out from the office of Division Superintendent Fields, just because the injured man discussed the case for publication.

Although Dr. George Wilson, local physician for the company, stated this morning that while he would not visit Kuppy at his home, the man was at liberty to come to his office, inquiry at Kuppy's home shows that the injured man is unable to leave the house.

Kuppy is the sole support of his wife and four children, and as he is now unable to work, Mrs. Kuppy is wondering how the family is going to make both ends meet. Kuppy, according to his story, has been employed by the company for six years as an assistant painter.

"My leg was broken when a heavy axle fell on it," he said today. "I was removed to the Good Samaritan hospital, where I remained until last Tuesday. Then the company ordered me out of the hospital and said that I would be taken to the company hospital at San Francisco. The evening before I left, Kelly was also an employee of the company who had been injured—left the place. They would not even give us wheel chairs so we could wheel ourselves to the 'W' car. They said at the hospital that the chairs could not be taken out of the building."

Kelly Thrown to Floor.
"Well, Kelly and I had to hobble to the car. I don't know how we ever got there, as I did not know how to handle the crutches given me. The conductor helped us on the car and off when we reached the depot."

At this point Mrs. Kuppy took up the story.
"My son and I heard that Mr. Kuppy was to be taken to San Francisco," she said, "so we went to the hospital with some clothes and shoes for him. When we got there we were told that he had gone to the depot, so we went as fast as we could to take him."

"After a search we found him and managed to get him aboard the train. When I showed the conductor the pass which had been given for his passage, I was told that it was only good for a seat in the day coach. Mr. Kuppy said that he could not stand riding for two days and a night without lying down, so I decided to take him home."

"When the engine coupled to the train, the jar was so severe that Kelly, who was standing in the vestibule, tumbled to the floor. We had to help him to his feet. Kelly had been at the hospital for six weeks and I know his injuries still pained him. Before leaving the train, however, I again asked that Kelly and my husband be given a berth, which both had asked for, but again I was told that the pass was only good for a seat in the day coach."

Buses Forget Taxi, Says Doctor.
"Some kind people who were at the depot and saw the whole thing, called up the police station for us and an ambulance came. Then we brought Mr. Kuppy home and Kelly went to San Francisco."

"No doctor or representative of the company has been out here to see my husband, or have we heard anything of the pay check which I believe is coming to my husband. It may be a number of months before he will be able to work."

An official representing Division Superintendent Fields said yesterday that Kuppy's case had been investigated.
"We investigated his case upon learning of it," he said, "and as far as we are concerned we are through with it. We offered to take him to the company hospital at San Francisco, but he refused to go. Now, after the case has been given a lot of unnecessary publicity, we don't feel like doing anything more for the man."

"We did the best we could for him, however. If a man asks for a berth and we think it is necessary, we allow them a berth check good for sleeping accommodations."

Dr. George Wilson made the following statement this morning:
"The case has been given a lot of publicity which was not warranted. Even though Kuppy had been at the hospital only a month, he was convalescent. He would have been taken to the San Francisco hospital where special care is given convalescents."

"I do not know why a taxicab was not ordered to take the two men from the Good Samaritan hospital to the depot. I told the nurse to order one, but I suppose she overlooked it."
"I shall not go out to the house to attend Kuppy, but if he wants to come to my office for further treatment he can do so."

UNION MEN SOLID BEHIND RUSHLIGHT FOR SECOND TERM

Workingmen's Political Club Surprises Wiseacres by Indorsing Mayor by Decisive Vote Over Maguire.

Political circles are still rippling with the big surprise caused by the action of the Workingmen's Political club last night when the Rushlight forces joined in open battle with the supposedly strong array of union men that have followed the banner of Councilman James Maguire in his campaign for the mayoralty. The club by a decisive vote indorsed Mayor Rushlight for another term, although Maguire men have for weeks past been making the boast that the strong political organization controlled by the workingmen's club was always a unit for the big councilman from the tenth ward.

No sooner had the vote in favor of Rushlight been announced than Maguire, it is said, jumped to his feet in a fit of pique, and threatened to resign from the council.

Mayor's Friends Happy.

Friends of Mayor Rushlight are exultant over what they regard as a sure indication that the rank and file of the labor union forces are in favor of continuing the present city administration for another period of two years. The report has been circulated freely for several months that organized labor has been split into factions and that Maguire had the largest following of union men of any of the announced candidates for mayor. Former Councilman Lombard was conceded to have some strength with a few of the labor unions, but the wiseacres predicted that Rushlight would be abandoned by the great majority of organized labor men who supported him in 1911.

Advocates of another Rushlight regime say that the fact that the representative political club of the unions endorsed the present mayor even before he has announced whether he will again be a candidate, is a great victory and they do not take any pains to conceal their jubilation.

Rushlight Makes Talk.

The meeting of the club last night had been called for the special object of choosing a candidate on whom to center the support of the union labor forces in the coming majority contest. It was reported that the result would be a walkover for Maguire. But close friends of Mayor Rushlight induced the mayor to appear before the club to answer some of the many attacks that have been made upon him by the Maguire men.

The mayor was on the job. He spoke for half an hour, during which he engaged in a sharp verbal tilt with Maguire, it is reported. That his address was given in a confident manner, the result of the balloting that followed. Only two names, those of Maguire and Rushlight, were placed in nomination.

SEATTLE NATIONAL COULD CLOSE HIS BANK AT ANY TIME

penitentiary sentence for receiving deposits, knowing his bank was insolvent. The defendants in the present trial are accused of having aided and abetted him.

Hughes argued that Corrigan was attempting to put words into the witness' mouth.

Judge Hardin overruled the defense, saying:

"I think with five or six of you attorneys on guard all the time we will be able to get the real facts."

This was strenuously objected to by Fulton, and the court explained that he referred to counsel on both sides and not to the attorneys for the defendants alone.

Schriker, while recollecting having made such a statement before March 31, as well as on that date, could not tell the jury this morning when or where or to whom he had said he "was in the hands of the Seattle National, which could close his bank down any time." For that reason Judge Hardin ordered this testimony stricken out.

In going over the conversation of March 31, 1912, the state emphasized the fact that Schriker spoke of giving the Seattle National "preference."

Word "Preference" Obnoxious.
"Kelleher insisted I should send the Seattle National my best notes for discount," Schriker said. "I told him I would be giving them a preference by so doing. Kelleher replied it was not a preference; that banks were doing that all the time. I mentioned this 'preference' several times, and Kelleher insisted I should not speak of any 'preferences.'"

Better to Close Him Up.
Schriker then related a visit to the Lacombe bank made by Kelleher on April 2, when he was told he must come through with the "bills receivable" as collateral security for his overdrafts, within the next two or three days. It was on April 12 that Schriker wrote to Andrews, president of the Seattle National, that he was unable to meet the situation and it "may be better to close up the bank."

"When Kelleher was here today," wrote Schriker, "I was under the impression that he had come to close the bank then."

Three days later R. V. Ankeny was sent down to Lacombe to look over the situation.

The next day the bank was closed. Schriker's cross-examination will probably begin late this afternoon.

ANTI-PISTOL BILL PASSES SENATE AT OLYMPIA, WN.

New County of Cook Will Be Carved From Klickitat if the House Assents; Ed Koors Is Put on Tax Commission.

Olympia, Wash., Jan. 20.—The senate this morning confirmed the appointment of Ed J. Koors on the tax commission to take the place of Commissioner Carlgren, summarily removed Saturday by Governor Lister. Several senators before the final vote was taken expressed willingness to vote for Koors, but gave notice that they would endeavor to abolish the tax commission entirely before the session adjourned, making Koors' appointment merely a temporary affair.

A joint memorial was passed unanimously, asking congress to pass Congressmen Lister's bill providing for the erection of suitable monuments to mark the old Oregon trail from the Missouri river to Puget sound. This measure is backed by the Washington State Historical society.

The senate passed the bill making it a misdemeanor for any dealer to sell or offer for sale a pocket pistol or revolver, after amending the bill to permit purchase of the same by persons who can present certificates of peaceable and good character.

The house spent the morning listening to committee reports and second reading bills.

The bill to create the new county of Cook from a part of Klickitat county has been passed by the senate and is up to the house. Last session an endeavor to create this county under the name of White Salmon failed of passage this time. The name of Cook county was substituted in compliment to Captain H. C. Cook, a pioneer of the northwest.

Ready to Compromise Now.

Olympia, Wash., Jan. 20.—Outlets of second class land fronting on Lake Washington were driven into a corner when they appeared before the committee which is considering the Wray and Houser bills today, and now they are willing to compromise. They demanded, as is set forth in the Wray bill, all land adjacent uncovered when Lake Washington is lowered by the opening of the dam. The Houser bill provides that all land uncovered be reserved by the state; that on street ends and docks to be held, and the balance to be offered for sale, adjacent property owners to have first call. It is probable that this bill will be reported favorably with slight changes.

Investigate Seattle Waterfront.

(United Press Leased Wire.)

Olympia, Wash., Jan. 20.—Representative Houser will probably win his fight to have the title of Seattle's waterfront investigated by the legislature. The bill calling for this investigation is being considered by a special committee, before which a whole carload of attorneys representing railroads and

wharf companies appeared today and did their best to kill off the preliminary move to recover for the state two and a half miles of waterfront property. But at the close of the session members of the committee stated they would probably report in favor of an investigation.

Representative Houser appeared before the committee Monday and reiterated his charges that the first harbor lines had been changed and that the wharf owners' combine was charging 50 cents per ton for the use of their wharves, where the law allowed only 20 cents, because the state officials were either too cowardly or in too close collusion with the combine to cancel its leases.

held that the rights we took there were subject to the rights of the dedication of the tract to public use. But we hold that the two are not in conflict. We are the state's trustee, and were made so by that act." (referring to the act of 1882.)

But the discussion soon revealed that the two sides were not in accord as to the law. Attorney Fenton argued that as there had never been a public demand for a public wharf on the levee, the railroad company had not violated the terms of the grant. On the other hand, both Attorney Jayne and Senator McCulloch contended that the state had no authority to grant even the use of the property except to an agent that would put the property to the uses for which the original Stephen Coffin dedication was made. To sustain this view, decisions of both the supreme court and the federal court of Oregon were cited bearing on this specific subject.

Time to Break the License.
"These courts have held that the title to this property rests in the people of the state," declared Senator McCulloch. "The legislature made the railroad company the agent of the people to establish a public wharf. The legislature picked the railroad company up, so to speak, and set it down there for this specific purpose. By its own confession, the company has failed to carry out its part. Now, then, it is right that this legislature should revoke the license, take the railroad company out of there and put the city of Portland in its place."

He added that he thought the railroad company should be recompensed for its investment on the property.

S. P. Wants Rights, Not Money.

Attorney Fenton suggested a compromise. He said the railroad company did not want any money from the state, if it was conceded to have railroad rights on the property. He suggested that a member of the committee be appointed to cooperate with him in drafting such an amendment, but the suggestion apparently did not meet with favor.

City the One to Deal With.

Senator McCulloch said he wanted the legislature to do as the bill provided—to oust the railroad company, turn the property over to the city of Portland as trustee for the public to carry out the conditions of the grant, and then let the railroad company deal with Portland.

"Then, if the city of Portland wants to let the railroad company use its tracks for private uses all right," he said.
