

## SENATE DEFEATS DIRECT ELECTION

Owen Amendment Abolishing  
Electoral College Is Lost  
by One Vote.

(United Press Leased Wire.)  
Washington, Jan. 31.—Debate on the resolution introduced by Senator Owen, providing for a single presidential term of six years, was resumed in the senate today. The progressive, led by Senator Underwood of Washington, and Senator Bristow of Kansas, are fighting the measure, declaring it was designed to make Colonel Theodore Roosevelt ineligible for election.

By a vote of 27 to 37, the senate defeated the Hittchcock amendment to the Works resolution, proposing that no president elected after March 4, 1917, or who had acted as president for two years after that date, be eligible to election. The Owen amendment to the same one was rejected without discussion.

During the debate Senator Root argued that the personal element be eliminated from remarks, but the members refused to stop wrangling over whether such an amendment would bar Taft, Wilson and Roosevelt. Senator Cummins then warned the senate that it must not eliminate the presidential candidacy of anyone.

"You will never have any plan ratified," said Senator John Sharp Williams, of Missouri, "as long as anyone can raise a cry of persecution against it."

Turning to the progressive element, Williams continued:  
"I do not want that man you have in mind to do believing he could have been elected president again. I want him to run and to be beaten again. Maybe he will be satisfied then. Let's fight him fairly, but not let him say he was singled out and shot at."

The Owen amendment to the Works resolution, providing for direct election of the president, elimination of the electoral college and the substitution of direct nominating primaries, was defeated by one vote. The count stood 21 for to 22 against. The Owen amendment also proposed a six-year term.

## LORDS REJECT HOME RULE BY 326 TO 69

London, Jan. 31.—After four days' discussion, the house of lords late last night rejected the Irish home rule bill by a vote of 326 to 69. Demonstrations are feared.

The bill brought out the greatest number of peers assembled in parliament in many years. Several bejeweled peeresses sat in the galleries.

Lord Lansdowne concluded the debate for the opposition and Lord Morley for the government.

## THIRTEEN UNCONTESTED DIVORCE CASES HEARD

The indictment against Moore charged him with assault with a deadly weapon, but the jury found that it was only a case of simple assault, which lessens the crime from felony to a simple misdemeanor, punishable only with a jail sentence. He will be sentenced next Wednesday. Assistant United States Attorney Hindman handled the case.

## SUFFRAGETTES HURL 'VOTES FOR WOMEN' BY USING SLINGSHOTS

From Top of Motor Busses  
They Shoot Little Lead  
Discs Stamped With Motto.

(United Press Leased Wire.)  
London, Jan. 31.—Varying their tactics of annoyance of the powers that be, suffragettes today resorted to the slingshot and the small boy and from the tops of motor omnibuses hurled leaden discs stamped "votes for women," at houses and store windows along the route. Owing to their bad aim, little damage was done, and only one succeeded in hitting a magistrate.

The Westminster police court magistrate fined Jane McLeod \$5 on the charge of operating the motor bus from which the leaden missiles containing the "votes for women" legend were discharged. She refused to pay, choosing a jail sentence, but her father met the fine. Still protesting, she was released from custody.

Mrs. Emmaline Pankhurst, the suffragette leader, declared today that the release of Mrs. Drummond and Mrs. Despard showed that men clubbed together to pay their fines, being unable to endure the sight of women being subjected to the horrors of a hunger strike. Defiance of British laws, its officials and police, was voiced by "General" Mrs. Drummond, militant suffragette leader, when she was released. An unknown sympathizer paid the \$25 fine imposed by the magistrate.

"I am far from being through with fighting," Mrs. Drummond told the police. "It is now war to the knife. There is all kinds of trouble ahead."

The suffragettes have induced a firm of publishers to issue a series of "votes for women" novels, the first in the list being "The Poodle Woman," by Miss Annesley Kenney, one of the leaders in the movement.

The books will not be mere suffrage arguments, sugar-coated with a story. Of her own novel, Miss Kenney says: "It is not designed for forcible political reading, yet it does demonstrate how the injustice of present man-made laws affect women in courtship, marriage, motherhood and industry."

duced jointly by President Malarkey and Senator Butler, fixing severe penalties upon officers of banks who accept deposits of money or securities from such sources, and upon officers who offer to pay for such favors. This is intended to reach such cases as those of Louis J. Wilde and W. Cooper Morris in the Oregon Trust & Savings bank. Joseph and Kellaher alone voted against it.

Seventeen bills in all were passed by the senate today, when it adjourned for the week. To make this record it remained in continuous session until 1:35 o'clock.

Among the bills favorably acted upon by the senate were the following:  
Amended S. R. 11, by Perkins—Regulating the practice of dentistry, under which the field of practitioners is broadened and additional power is given to the state board. By the terms of the bill, a diploma may not be required from the National Association of Dental Faculties, as under the present law, if the state board deem the applicant to have equivalent qualifications.

S. B. 109, by Smith of Josephine, by which \$1500 is appropriated for a crematory at the asylum for the cremation of bodies of inmates of state institutions at Salem.

S. B. 138, by Moser, at the request of the Credit Men's association, placing collection agencies under bond and prescribing regulations to prevent abuses by irresponsible agencies.

S. B. 46, by Dimick, requiring all male candidates for matrimony, when they appear before a county clerk, to present satisfactory medical certificate showing they are free from contagious and communicable diseases.

S. B. 30, by Kellaher—To expedite the appropriation of land under eminent domain by authorizing cities to set aside a security fund subject to court supervision, whenever property may be taken for public use before a jury passes on the amount to be paid to the owner.

S. B. 110, by the committee on judiciary—Relinquishing \$14,648 escheated to the state in the case of John Morrison of Union county, so this money may be paid over to the heirs. This is a substitute bill for one voted by Governor West.

## ESTATE OF WILLIAM FRAZIER, \$170,927

Appraisement of the estate of William Frazier shows that the former sheriff of Multnomah county left property valued at \$170,927. Of this but \$96,216.66 is involved in the partnership of Frazier & McLean which operated the stable at Fifth and Taylor streets. Among the assets of the estate are a note for \$50,000 signed by John Mathieson and smaller notes, real estate valued at about \$100,000 and a bank account of \$7640.44.

Probate Judge Cleton this morning appointed Edith McLean, Mr. Frazier's partner in the livery stable, administrator of the partnership. Charles R. Frazier, son, was appointed administrator of the remainder of the estate when it was admitted to probate last week.

## RICE'S BODY ON WAY EAST FOR INTERMENT

The body of Edward R. Rice, general sales manager of the United States Rubber company and an official of the New York Life Insurance company, who died Wednesday afternoon at the St. Vincent's hospital, while under an anesthetic, during an operation, is now on its way to his home at Buffalo, New York, where burial will take place. Mr. Rice had a tooth extracted 10 days ago before leaving New York, and it left an ulcerous formation in the jawbone. After his arrival here Tuesday, he consulted a physician, who decided it would be necessary to operate on the jawbone. While the operation was being performed, he died.

## O. & C. LAND GRANT CASE SET MARCH 10

Judge Wolcott of the United States district court yesterday set April 8 as the date for the arguments in the case of the government against the Oregon & California Railroad company involving the land grants. Judge Wolcott leaves tomorrow night for San Francisco to sit on the bench of the United States circuit court of appeals until August.

## DARROW TRIAL ON; CASE IS OUTLINED

Prosecution Charges Lawyer  
Bribed McManigal's Wife  
and Uncle.

Los Angeles, Jan. 31.—The trial proper of Clarence Darrow, on a charge of bribing Robert F. Bain, a McNamara juror, began today with the taking of testimony. The jury was completed late yesterday after four regular and one special venire had been utilized.

Echoes of the first Darrow trial, when the labor attorney was acquitted of a charge of bribing George N. Lockwood, a prospective juror in the McNamara trial were heard today when Assistant District Attorney Joseph Ford outlined his case against Darrow.

In spite of a running fire by Chief Counsel Earl Rogers for the defense, Ford calmly announced that Lockwood would be called to testify that he had been bribed by Darrow.

Ford explained that he will endeavor to prove that Darrow bribed Mrs. Orlie McManigal and George Behm, McManigal's uncle, to urge McManigal to retract confessions to dynamiting.

That Darrow had fought to corrupt important witnesses for the prosecution and employees of the prosecution in the McNamara case.

That Darrow had instigated a scheme to defeat justice during the McNamara trial.

## MILLION DOLLAR BOND ELECTION TOMORROW

Taxpayers to the number of 32,315 are expected to vote tomorrow afternoon in one small room on the fourth floor of the Tifford building, Tenth and Morrison streets, on a \$1,000,000 bond issue. All of the voting is to be done between 1 and 4 o'clock—only three hours.

Owing to the lack of interest the majority are taking in the bond issue election, those at the school headquarters expect not more than 300 people to appear and cast their votes. Never before has there been a bond issue before the people in which so little interest has been taken.

Those who reach the office of School Clerk Thomas first tomorrow afternoon will select the judges and clerks, and to prevent delay arrangements have been made to have those present serve in this capacity.

## RESCUE MINER FROM UNDER TONS OF SNOW

(Special to The Journal.)  
Cottage Grove, Or., Jan. 31.—Buried under several tons of snow for three hours and rescued at the moment life was almost extinct, is the experience of Edward Lewis, who is employed at the Clampton mine in the Bohemia district, according to word which has reached here.

Superintendent Henry Landess, who was working with him, also had a narrow escape, and but for the ability of Landess to extricate himself, both would have perished. There were no other persons at the mine, and the nearest help was a mile and a half away.

The men were at work Friday afternoon shoveling the snow off the building. It was some six feet deep and was thought to be endangering the safety of the building.

They were working at the lower edge of the roof when the avalanche gave way and carried the men with it to the ground. Lewis was completely buried, but Landess was buried 50 feet or more out of danger.

He put on his snowshoes and hurried to the Crymlyn mine for assistance. Edward Lily went to his aid and the two succeeded in extricating the buried man in the nick of time.

He was unconscious and almost frozen to death but uninjured and soon fully recovered.

The snow is 18 to 20 feet deep in the district, said to be the deepest ever known at this time of the year.

## UNSIGHTLY CONDITIONS FOUND BY CHIEF SLOVER

Unsightly, instead of unsanitary, conditions are what Chief of Police Slover found yesterday while making an inspection of the city, giving particular attention to conditions criticised by the Sanitary commission Wednesday afternoon. Only a few places were found, says the chief, that could be called unsanitary.

One place was found on the river front where chickens have been killed, the feathers and heads being thrown under the docks. At many of the alleys back from the river to street ends rubbish has accumulated and is unsightly.

Such a place is at the foot of Stark street. In a few other places owners of docks have failed to extend boards to the water edge, thereby keeping refuse from the river in high water periods.

J. H. Barde, junk and second-hand buyer of metals, at the foot of Madison street, was arrested for obstructing a street. He has a large amount of such material at the foot of the street. Barde did not appear in the municipal court this morning, sending word that he was called out of the city on important business. The case went over until Saturday.

Patrolman McCarthy reported a pile of rubbish on Eleventh street, between Washington and Alder streets. This rubbish was thrown there two nights ago, when a fire occurred in that vicinity. The owners of the restaurant in which the fire occurred have been notified to clean this up.

## FIRE AT BURLEY, IDAHO, BURNS BANK AND HOTEL

Boise, Idaho, Jan. 31.—Loss of \$75,000 was caused at Burley, Idaho, early this morning by fire, which completely destroyed the Burley hotel and six business houses, which occupied rooms in the building. The hotel was filled with guests, but all were warned in ample time to escape. Business concerns in the building were: The Bank of Commerce, the Burley Realty & Abstract Co., the Rosecrans meat market, a pool hall, ladies' furnishing goods establishment and a barber shop.

All the money and papers of the Bank of Commerce were in a vault and were saved. About half of the loss is said to be covered by insurance.

## PADDY MAHER WILL NOT GET LITTLE JOB

Salem, Or., Jan. 31.—"Paddy" Maher will no doubt be saddened to learn that the bill that was to create a nice job for him in the office of the coroner of Multnomah county has been withdrawn from the legislature. Not that his name has at any time officially appeared before the legislature in connection with the job provided by H. B. 121, the title to which fitted smoothly to the tongue, as follows: "Authorizing the county coroner to employ a special investigator," but it has been very well known that the "special investigator" authorized by the act would be none other than Maher.

The bill was withdrawn yesterday by Representative Jay Upton of Multnomah, its introducer. He asked unanimous consent to make the withdrawal, and got it.

Mr. Upton declares that he introduced the bill by request and in perfect good faith, and that when he learned it was intended to provide a place for a specific person he withdrew it. Dr. Sam C. Slocum, the coroner, was here yesterday.

## GARDNER INVESTIGATION ORDERED ALSO BY SENATE

Salem, Or., Jan. 31.—Although the law has never been used, and the house committee on revision of laws for that reason sought its repeal, the senate has rejected H. B. No. 201, which permits counties to levy a tax for the support of tubercular institutions. Many of the senators thought the act does not come under the head of "dead wood" merely because it has not been used.

The senate has adopted the joint resolution coming from the house for an investigation of the affairs of the Boys' and Girls' Aid society, under the management of W. T. Gardner, Senator Farrell, who is one of the trustees, said he approved the investigation.

House memorials to congress were approved by the senate, asking the government to complete reclamation work to prevent the Willamette river from overflowing and damaging low lands at Independence and pleading for extension of time for payment for irrigated lands under the reclamation act.

## POLICE RESCUE SCORES IN APARTMENT FIRE

Seattle, Wash., Jan. 31.—Scores were rescued by police and firemen, and several hundred persons made their escape through the smoke filled halls when fire broke out in the basement of the Manhattan apartment house, the largest in the city, at 2 o'clock this morning. Several suffered minor injuries and a few had their hair scorched.

The alarm was given by Beatrice Risswald, who stuck to her post until she was sure that every person had left their rooms. The building, which covers the entire block, filled with smoke so rapidly that many were unable to find their way out and all available police were called to aid in the rescue. On the floor above the one on which the fire started about 20 persons were hurried through the flames to safety. Some held back fearing to run the fiery gauntlet and had to be dragged to the elevators. The actual damage caused by the fire is nominal.
