

STATE OFFICIALS ARE EXECUTED BY ORDER OF HUERTA

Inspector of Police of Chihuahua Among Victims; Part of Cananea Captured by Maderista Forces.

(United Press Leased Wire.)
El Paso, Texas, March 1.—Augustin Labaneta, inspector of police in Chihuahua, and other Mexican state officials, were executed by federal authorities after a hasty court martial, according to reports which arrived here today. They decided the execution of former Governor Abraham Gonzalez of Chihuahua is momentarily expected.

Followers of the Maderistas have captured Cananea, and federal reinforcements are hurrying to that town. A battle is expected today. Numerous Americans reside in Cananea.

Federal forces are pursuing General Maytorena south of Nogales, following reports that he confiscated all the Sonora state funds, amounting to nearly \$300,000 pesos.

Douglas, Ariz., March 1.—Startling information of rebel activities at Cananea, Sonora, was brought here today by refugees. According to their statement the Maderistas have captured the city hall and jail, while 300 loyal federalists under Colonel Romero are holding the barracks and have trained machine guns on the business section of the city.

Nearly 60 refugees, nearly all Americans, arrived from Cananea during the night. They declared the situation there is critical and predicted bloodshed within 48 hours.

Alarming conditions exist throughout the country between Cananea Springs, 20 miles southeast of Douglas, and the border. Copies of a proclamation, headed, "A Call to War," and signed, "The Second Volunteer Corps of the North," have been posted throughout that section. The manifesto declares:

"Our country is one vast jail; it soon will be a vast cemetery if we do not join together."
It further claims that several hundred rebels are under arms at Cananea Springs and calls upon all patriotic Mexicans to join the movement.

Further defections in the Agua Prieta garrison threaten today to decimate the already small federal force there. There is much dissatisfaction among the Yaqui Indians among the troops, and 30 of their number are held by the federal commander as hostages to prevent the desertion of their comrades.

Diaz Sentiment Grows in South.

Mexico City, Mex., March 1.—The last serious revolt against Provisional President Huerta, except that in Sonora, is believed here to have ended today with the surrender of Alberto de Fuentes, the governor of Aguascalientes.

Sentiment throughout Mexico is rapidly turning to Porfirio Diaz as the coming savior of the nation. His return is eagerly awaited and it is predicted that he will again be president. The conservative faction, however, is declaring in favor of General Felix Diaz for president, and assert that it will be so arranged and that the former dictator will be chief adviser to his nephew in the regeneration of the country.

The liberal-democratic party was formally launched today with the avowed object of electing Felix Diaz as president and Francisco de la Barra as vice-president of the Mexican republic.

MULTNOMAH ANGLERS
CONDEMN CLANTON

At a mass meeting called by the Multnomah Anglers' club, which was held at the Commercial club last night, strong resolutions were adopted, condemning the action of Master Fish Warden R. E. Clanton in giving his support to the recent passage of house bill 128, introduced by Representative Schubei of Oregon City. The bill takes away the power of the fish and game commission to establish a line at the falls at Oregon City, above which gillnet fishing cannot be used.

The anglers decided to initiate a bill that will entirely close the Willamette River in opposition to the Schubei measure.

COUNTY REINSTATES OLD BRIDGE EMPLOYEES

Multnomah county is now in full charge of all bridges spanning the Willamette river in the city, the transfer of the new Harrison bridge being made at midnight in accordance with the law passed by the people last November and the enabling act just passed by the legislature. Four members of the bridge crew were let out once and the four men who were employed on the old steel bridge under the county administration were reinstated.

According to the enabling act the city must pay the cost of the bridge until the contract between the U. W. E. & N. company and the city of Portland expires a year from next October. The law leaves a renewal of the contract at the option of the county and arrangements for use after October, 1915, will be made by the county.

O. J. Laird, for 11 years a familiar sight on the old steel bridge, was reinstated as foreman of the new bridge. During the 11 years of his administration it was his boast that no accident occurred as the result of carelessness or negligence on the part of himself or his men. The three other men reinstated were Ed Caffee, D. C. Hoyt and H. C. Proudfoot.

Three cents will be paid into the city treasury by the Portland Railway, Light & Power company every time one of their streetcars crosses a bridge across the Willamette. This applies to all the bridges except the U. W. E. & N. structure. This ordinance was passed by the people at the special election November 5, but the company maintained that previous contracts applied to the Burnside and Hawthorne bridges. A decision was obtained against the company by City Attorney Grant and the company appealed, agreeing later to withdraw their appeal.

LEGISLATURE OF 1868
FAILED TO ADJOURN
SINE DIE; LAWS STAND

to adjourn sine die. A precedent was set.

"There is absolutely no question," said Representative Reames, "that if the legislature should fail to adjourn or convene on Tuesday, March 4, every act passed by the 1913 legislative session would be a valid law. Section 28, article 4 of the constitution reads as follows: 'No act shall become effective until 90 days from the end of the session at which the same shall have been passed, except in the case of emergency, which emergency shall be declared in the preamble or in the body of the law.'"

Circumstances in Case of '68.
"If the legislature should fail to convene on next Tuesday we will not be without precedent to guide us in determining the validity of the laws passed at the 1913 session."

An examination of the house journal of the session of 1868 disclosed that on October 28 of that year the legislature took a recess until the fourth day of March, 1869. The only difference between the action of the legislature in 1868 and the action of the present legislature is that the session of 1868 took a recess until March 4, 1869, and the 1913 legislature has taken a recess until March 4, 1913.

The journal shows that in 1868 there was a bitter fight between the legislature and Governor George L. Woods and that the legislature at that time was trying to put Governor Woods in the hole.

"That the machine makers made the same claim as to that session as have now been made to session of 1913 is shown by the following paragraph of the report of the special committee appointed by the house and the senate to investigate the validity of the final adjournment, which paragraph is as follows:

"In conclusion your committee can but express regret that the harmony and apparent good faith that characterized this house should have ended in the total overthrow of legislation."

On October 29, 1868, as shown above, the legislature adjourned to meet again under joint resolution on March 4, 1869. On March 4, 1869, it was impossible to get a quorum and after several days' wrangling between the legislators and the governor, the members of the legislature finally went home.

Some of the Bills Then Passed.
"An examination of the statutes of our state shows that some of the most important legislation now upon our statute books was passed at this session of 1868 and none have questioned the validity of any of these laws. They remain upon our statute books today in full force, operation and effect."

For instance, the statute regulating appeals from courts of the state, which was passed at this legislative session and for years remained upon the statute books without any person questioning its validity or claiming that it had never taken effect. When it was amended in 1909, the only purpose of the amendment was to change the manner of perfecting an appeal in cases of forcible entry and detainer.

"Section 2105 of Lord's Oregon laws, which still remains upon our statutes, was passed at the session of 1868. This is the law defining gambling and it remained upon our books until the year 1876. It will be noted that in the meantime there were many convictions had under this law and it was only changed in 1876 for the purpose of raising the maximum penalty from \$200 to \$500."

"The session of 1913 has now adjourned to meet on Tuesday, March 4, 1913. If there should be on that day no quorum present the legislature will simply come to an end as provided for in section 28 of the constitution and every law against which the referendum is not ordered by the people will go into full force, operation and effect 90 days from that date, just as it did after the session of 1868."

Why Reames Won't Go Back.

"In refusing to return on Tuesday, March 4, I do not want to be misunderstood as shirking my duty as a legislator. In my particular, the adjournment at this time it was absolutely useless and unnecessary. The governor's vetoes were then upon the desk and the legislature could have acted upon them just as well at that time as they could one week hence."

"Believing, therefore, that every act passed by the session of 1913 is valid whether we have more legislation or not and that the best interests of all will be subserved if a sufficient number of legislators take the position that at some time there should come an end to legislation, I do not believe it my duty to return to Salem next Tuesday, will refuse to do so and will test the matter in the courts if I am forced."

VETO SESSION EDICT

glad to "patriotically" contribute for the purpose of having such bills passed over the veto.

Apparently the principal "duty" of the veto session will be to pass a mass of salary bills that the governor has vetoed. The number of vetoes, it appears, is around 40, and the salary or new job bills amount to about 30. From the standpoint of the taxpayers, this veto session promises to be a hummer.

The responsibility for it will rest wholly upon the shoulders of the Malarkey-McArthur-Thompson-Upton combination. It was this combination that forced through the veto session plan. In the senate a resolution for sine die adjournment last Wednesday, offered by Miller, was defeated by the "roller," and the house roller, on Thursday night, turned down an effort by Hagood to provide for sine die adjournment that night.

Hagood was declared out of order when he made a motion to this effect, amending another motion to adjourn until next Tuesday. He appealed from the decision of the speaker and the appeal was lost.

While most of the constitutionalists agree, there are some who contend that, without a vote for sine die adjournment the session will be automatically ended by failure to secure a quorum for continuing the work. This view of the matter was expressed by one lawyer as follows:

Legal Points Raised.
"There can be no question that the end of the session will be the adjournment in fact, whether it is a sine die adjournment or not."

"The present session adjourned Wednesday to 11 o'clock Tuesday morning. If there is no quorum Tuesday, the legislature is not in session. The session will have ended in fact when Tuesday's adjournment was taken."

"No further formal adjournment would be necessary. The session would be ended, and the end of the session, as referred to in this section, would date from Tuesday."

"This point has been raised probably to frighten legislators into believing they will have to return to legalize their legislation."

Promoters Are Worried.
The Malarkey-McArthur-Thompson-Upton combination is now playing the quorum panic idea for all it is worth. They are so much alarmed by fears of the mess and litigation that may grow out of a salary raising carnival, that they are appealing to those they were lately denouncing to come back and help extricate them from their predicament.

If it develops that it is necessary to have a quorum to adjourn sine die next week it is not unlikely that friends of the governor will chieftainly come to their rescue. Governor West has said that he does not care what the legislature does next week, as the legislature's responsibility is not his. If the legislature deems that a great public exigency requires it to return to Salem for a salary raising carnival, the governor's friends are not expected to put any large boulders in the way.

TO HOLD FUNERAL OF W. A. CLELAND SUNDAY

Under the auspices of the Grand Lodge Free and Accepted Masons, the funeral of W. A. Cleland, who was killed by an automobile at East Fifteenth and East Morrison streets Thursday evening, will be held tomorrow afternoon at 2 o'clock in the auditorium of the Masonic temple, West Park and Yamhill streets. Interment will be made at Riverview cemetery.

Ceremonies at the grave will be conducted by the Grand Commander, Knights Templar, and members will appear in uniform.

In addition to Masons and personal friends, members of the Portland bar will attend the funeral in a body. At a special meeting of the bar, held this forenoon in Judge McGinn's court, it was decided that attorneys would meet in the lobby of the Portland hotel shortly before the time set for the services and march in a body to the Masonic temple.

The meeting, which was presided over by Judge McGinn, was attended by approximately 50 lawyers. A committee consisting of W. D. Fenton, E. E. Heckbert, Cyrus Dolph, J. C. Morrow and Wert Minor, was appointed to draft resolutions of condolence and report back two weeks hence. The Multnomah Bar association, it is expected, will make an ardent plea in this regard at its next regular meeting.

Investigation of the tragedy shows that Dr. P. J. Wiley, who was driving the machine which struck down the attorney, was not violating the traffic rules. In accordance with the law, Dr. Wiley swung from the north side of the street, veering toward the center, with the intention of passing the west-bound street car on the "blind side." When he struck Mr. Cleland, who darted across the street, bent on buying a hat, it was the inquest was held this afternoon.

TWENTY-FIVE BOYS CONFESS TO THEFTS

Larceny proved the most general charge against youths brought before the juvenile court this morning. 25 boys under 16 years of age pleading guilty to thefts of various magnitude. 25 were sent to the reform school of a gang of five South Portland boys, who formed the habit of entering stores and restaurants, from which they would run with eatables without paying. They also were charged for carrying small amounts and knock the money from the man making change and run away with the money. Another of the youths was sent to the Frazier home for 30 days, and two were paroled on account of good previous records.

The dock today was the largest ever known. 40 cases being disposed of by Judge Gates. Dorothy Louisgoun, held as a witness against a man named Rollins, was taken from the county jail, where she has been held, and sent to the Home of the Good Shepherd as a delinquent. She is but 15 years of age, but has been held as a state's witness until this morning.

Two large South Portland boys were sent to the Frazier Home for 30 days for stealing sacks from the Oregon Box Manufacturing company. Three more from the same vicinity were given sentences to the State Training School and paroled for breaking into the store of J. H. Havelly, 269 Taylor street, while the ringleader of this gang was sent to the Frazier Home for three months.

Three East Side boys were given a severe lecture for stealing a lifeboat. Three oars and oarlocks from the steamer Elkader. They were paroled. Three more boys from the Montaville district were up for theft from a store and a house in their neighborhood. One was allowed to go because of his good record; another was placed on probation, and a third was sent to the Frazier Home. Nine Lower Albina boys were lectured for stealing wheat from the Albina docks. Three who had shot pigeons were told they would not be sentenced if they returned to court for any reason.

JEWELER ACCUSED OF WITHHOLDING ASSETS

Alfred P. Knox, a jeweler of The Dalles, was arrested at his home there yesterday morning by Deputy United States Marshal Will Griffith on a charge of withholding assets from a bankruptcy receiver. The complaint was made by A. S. Butterfield, the referee in the case. Knox was taken to Hood River before United States Commissioner Bishop and bound over to await the action of the federal grand jury in the sum of \$2,000. This he was unable to furnish at the time and spent last night in the Multnomah county jail. This morning, however, surety was furnished and he was released.

Griffith went after his man Thursday morning, but did not make the arrest immediately as he was endeavoring to take him with some of the withheld assets on him as he had been instructed to do. When he was taken into custody yesterday morning nothing of much value, beyond personal effects, was found.

The trouble arose over Knox continuing in the jewelry selling business after he had taken up the bankruptcy law. He told Griffith, however, that he had secured new credit since becoming bankrupt and that all of his purchases of goods to sell had been made since that time. He said that if Griffith had waited ten days to make the arrest, he would have caught him with \$20,000 worth of diamonds in his possession, as he now has that amount ordered.

HERMAN TRENKMAN DIES THIS MORNING

Henry Trenkman, 70 years old, one of Portland's pioneer contractors, died suddenly this morning at his home, 434 Market street. Heart disease was the cause of death, the fatal attack following a long illness from which Mr. Trenkman was thought to be recovering. Mr. Trenkman is survived by a widow and one son, Ben Trenkman.

Cup Presented by President Taft.

OLD OREGON, NOW MERE PIGMY, GOES ON NEW DRYDOCK

Washington Legislators and Governor Lister Attend the Opening of One of Greatest Drydocks in World.

Bremerton, Wash., March 1.—Amid the booming of guns, one of the world's greatest drydocks was dedicated at the navy yard here today, with the docking of the famous battleship Oregon, which will be given a thorough overhauling and made ready to lead the great naval parade through the Panama canal, on completion of the big ditch.

Governor Lister, Admiral Reynolds and staff, Mayor Cottrell, of Seattle, and most of the members of the legislature took part.

The governor was given a salute and made a brief address in behalf of the state.

The Oregon, once the pride of the navy, which made such a record for herself in the Spanish-American war, going into action at Santiago after completing a 16,000-mile voyage around the Horn, appeared but a pigmy as she steamed in past the big cruisers of the Pacific fleet.

Charles Doby, or Derby, brought here from San Francisco at the order of the police, issued an emphatic denial today that he knows of the existence of such a ring, or ever heard of Lee Rial, against whom a grand larceny charge is pending here, or E. C. (Poker) Davis, mentioned in connection with the affair.

John Scott, retired farmer of Mitchell, S. D., is the latest known victim to complain to the police. He declared that he was mugged of more than \$500 on a fake race at the Santa Anita track two years ago.

The tracing to Hoboken, N. J., of two alleged members of the gang whom the police are trying to locate has given rise to speculation that the Atlantic coast connections of the organization may have enjoyed police protection under Police Lieutenant Becker, headliner in the recent New York police scandals. The police here refuse to discuss this angle of the affair.

Lays Egg 2 1/2 Inches Long.

OREGON FOREST FIRE ASSOCIATION MEETING

A general review of the work of the Oregon Forest Fire association for the past year is being made at the annual meeting of the association today at the Hotel Oregon. The members also will outline a plan of work for the ensuing year before they adjourn tonight.

The Forest Fire association is comprised of the leading timber owners of the state, banded together for mutual protection and protection of the general timber of the state from fire. Reduction of fire losses since the association began its activities has been so marked as to fully justify the annual expenditure of from \$100,000 to \$200,000, which the association and its individual members spend for protective work.

The efforts of the association are directed not only towards actual fighting

of fires, but as well in the making of trails and building of telephone lines as a part of the work. The Oregon Forest Fire association has been largely instrumental in systematizing the general forest protection work in Oregon.

Arthur P. Sprague, president of the association, is presiding at today's session. A banquet at the Hotel Oregon will conclude the meeting.

The association has the distinction of being the first organization to meet in the convention hall of the new Oregon.

CITY WATER LABORERS ASK FOR MORE PAY

At a short meeting this morning the city water board wanted only long enough to audit pay rolls for the month and to approve routine claims. A request filed by 143 laborers in the water department asking for increases in salary was referred to the special salary revision committee of the board.
