

WILSON GOES TO NEW JERSEY TO FIGHT FOR JURY REFORM

President Will Stump State to Prevent Referendum Upon Measure Proposed by Senator Smith's Machine.

(United Press Special Wire.)
Washington, May 1.—President Woodrow Wilson, in the role of a fighting man, will be presented to residents of New Jersey tonight and tomorrow. Answered by the opposition, his plan for jury reforms, formulated while he was governor of the state, is meeting in New Jersey, the president left for Newark at 3 o'clock this afternoon to lock horns with the opponents of the measure.

The president is due in Newark at 7 o'clock and will make his first speech there. He made it plain before leaving Washington that his speeches will be virile in character and that he intends to fight the so-called non-partisan machine which he alleges has combined with the Smith machine to prevent enactment by the legislature of a law reforming the jury system. The machine combination which expects to control the special session of the legislature next week wants the jury reform bill submitted to a referendum vote. The president believes that this would defeat the bill's purpose. He also believes that if the question is left to a referendum the machine will be able to defeat the plan in the counties where in Jersey City, Newark and Hoboken are located.

The president plans to speak at Elizabeth City tonight. On Friday, he will speak at Jersey City and confer with leaders of the legislature. He expects to return to Washington at midnight Friday.

President Wilson admits his wishes regarding a referendum vote probably would be disregarded, but he told friends that he "stands during his entire term to carry every subject belonging to the people before them, and that he will see that no man opposing a real jury system is permitted to remain in public life."

TWO KILLED IN BATTLE WITH COLORED FIEND

Hampton, S. C., May 1.—Frank Bowers, a planter, and Magistrate F. H. Ed. Enfield of Allendale, S. C., were killed in a pitched battle between a posse and Richard Austin, a negro, who attempted to assault a white woman in Luray, near here. The negro escaped. Bloodhounds are on the negro's trail and the governor is considering a request to send troops out after him. Several members of the posse were severely wounded in the fight.

BRIDE FEARS HUSBAND IS INSANE AUTOIST

Los Angeles, May 1.—Police of southern California cities were asked today to search for J. C. Delaney, manager of the Randolph Fruit company, at Pleasanton, Cal., who has been charged with believing in a conspiracy to kill the president in an automobile, his mind temporarily deranged. Delaney left his home early Tuesday in an automobile. He was injured in a runaway some time ago, and surgeons removed a portion of his skull. His wife fears his memory has been affected.

CITIZENS KNOW JUST WHERE TO TURN WITH "KICKS" FOR RESULTS

It is something against the wishes of the people, they know whom to recall. A public official's record is open at all times.

To say nothing of the vastly increased business efficiency of the city government, due to the fact that the officials now are elected to devote their entire time to the city's business and to nothing else, it has resulted in great savings in the cost of the city and the municipal establishment. In many instances, one employee is now able to do the work that previously was handled by three or four.

"Just an example of the greater efficiency in law enforcement to the great advantage of the city, resulting from the commission form of government, let me cite one instance. We had a law requiring banks to pay 3 per cent interest on daily business of the city, but under the old form of government it was never enforced because there wasn't anybody who took enough interest in the city's affairs to enforce it. But since commission government went into effect, that law has been enforced and the city gets the interest. There is somebody always on the job to see that the city gets what is coming to it."

Mayor Gillis spoke at a luncheon of the East Side Business Men's association at the Multnomah hotel at noon. Tonight he will make an address on commission government as it has worked in Walla Walla, at the Central Christian church on the east side.

SALT LAKE FIREMEN STRIKE FOR MORE PAY

Salt Lake City, Utah, May 1.—Following the refusal of the city commission to grant their demand for increased wages, every active member of the Salt Lake City fire department, with the exception of Chief W. H. Bywater, has resigned from his position. The resignations go into effect next Monday.

The men demand a wage increase ranging from \$5 to \$15 a month.

Nangle Held for Grand Jury.
George Nangle, accused of setting fire to the bank apartments, was held in the grand jury this morning for the municipal court on a charge of arson. Mrs. E. M. Downing, part owner of the apartments, testified that she met Nangle at the time of the fire, his conversation at that time indicating that he was intoxicated.

SETS TOP VALUE ON WATER FRONT LAD

W. B. Ayer, president of the Eastern & Western Lumber company, struck high water in estimating the value of the waterfront property which the city is seeking to condemn for a public dock and which is claimed by the Pacific Milling & Elevator company. Mr. Ayer declared he considered a fair price for the property would be \$750,000. His estimate exceeds that of any witness so far on the stand by \$200,000. Mr. Ayer's estimate was reached by considering the property in units and not as a whole as others have considered it.

Ralph W. Hoyt, Samuel Connel, F. P. Kendall, of the American Can company, W. H. Chapin, R. L. Ryan, R. N. Telford, and A. C. Callan, all estimated the property to be worth from \$100,000 to \$150,000 a front foot or from \$365,000 to \$550,000. Experts called by the city were ex-county Assessor Sigler, Deputy Assessor Pank and Joseph Paquet and their estimates ranged from \$250,000 to \$327,000.

M. W. Hunt testified that he and associates attempted to purchase the property in question three years ago but that when \$100,000 a front foot was asked for the owners the deal was declined. R. Paltich declared he could give no estimate on the land. The property has a frontage of about 365 feet, and is located at the west landing of the Alameda ferry. It extends to Front street and is considered one of the best pieces of property on the river owing to its location with respect to the railroad yards. The city has offered \$185,500 and the company wants \$455,500 for it. None of the witnesses has been able to show any activity in property in that section of the city or to recall any recent sales. The witnesses have indicated throughout that their estimates are largely made with the consideration of future activities in that section. Several admitted offers but the amounts offered were not given out.

RABBI WISE BACKS COMMISSION FORM

"You don't know now whether five men or fifteen men have charge of your city government, and furthermore, you don't know who they are," declared Rabbi Jonah B. Wise in an address before a large audience in the Baker theatre at noon today. "If you adopt the charter amendments, you will know exactly who has charge."

Today's noon hour was divided between Rabbi Wise and Professor W. F. Ogburn of Reed college. The latter praised highly the work of the municipal research bureau.

Rabbi Wise told in his explanations of the objections to the new charter provisions.

"I believe in political parties," he said, "but not in city government. Party politics in a city have always tended to build up machines. They have debauched every city in which they have been played. They gave one man complete control of the government of Cincinnati, and they have perpetuated Tammany Hall in New York. The preferential voting system contained in the charter amendments will do away with party politics in municipal government."

JEFFERSON MEMORIAL DEDICATED IN ST. LOUIS

St. Louis, Mo., May 1.—The magnificent Jefferson memorial, erected in commemoration of Thomas Jefferson and of the acquisition of the Louisiana territory during Jefferson's administration, president of the United States, was yesterday formally dedicated in the presence of a distinguished company. The dedication ceremonies were impressive and elaborate.

The day's program was divided into two parts. The first part, which was held at the actual ceremonies attending the formal dedication, when speeches were made by eminent officials and individuals. The ceremonies were initiated with the unveiling of the Thomas Jefferson statue, which occupies a conspicuous position in the rotunda of the memorial hall. Former Governor David R. Francis, as president of the Louisiana Purchase Exposition company, made an address, presenting the memorial to the city of St. Louis, and Henry W. Kiel, as mayor, responded. These were followed by several orations on the life and services of Thomas Jefferson and the importance of the purchase of the Louisiana territory.

The second part of the program consisted of a musical program, which started immediately after the literary exercises were concluded.

The memorial is in the form of a great hall, more than 300 feet in length and constructed entirely of stone and marble. It occupies a conspicuous site near the entrance to Forest park. The building will be used to house a library and relics, interesting from an historical standpoint, of the Louisiana purchase and of the history of the great section of country embraced in the Louisiana territory. The memorial was built with a fund of about \$500,000, which was left from the receipts of the Louisiana Purchase exposition held in St. Louis in 1904.

CHAMPOEG OBSERVANCE TO BE HELD TOMORROW

Salem, Or., May 1.—Tomorrow the Oregon Pioneer association will celebrate at Champeog, Marion county, the 70th anniversary of the founding of American civil government west of the Rocky mountains. F. X. Matthieu, the only living survivor of that historical meeting, is expected to be present.

Pioneers from many cities and towns in the Willamette valley are expected to attend. Judge P. H. D'Arcy of Salem, ex-president of the association, will be the presiding officer of the day. Short addresses will be delivered by Judge G. B. Dimick of Oregon City, ex-Governor T. I. Geer, Colonel Robert A. Miller and C. E. Moores of Portland. Vocal music will be given by the veteran quartet, the members of which are Professor Z. M. Parvin, A. W. Mills, W. N. Moore and Dr. J. E. Hall.

People going from Salem expect to leave on the 8 o'clock Oregon Electric car. At Wilsonville they will take a boat up the river to Champeog.

Many Shots; One Wounded.
As the result of a quarrel between Antonio Mortello and Luigi Patreco, members of the local Italian colony, Mortello is suffering from a bullet wound in the shoulder. Patreco is being sought by the local detectives on a charge of assault with intent to kill. The shooting occurred last night near 266 Sheridan street. Several shots were fired, and a number of persons barely escaped injury. Detectives Hyde, Vaughn, Litherland and Hill are on the case.

LETTERS CABLES Lombard Makes Open Challenge in Speech and Then Backs Water.

A meeting strangely punctuated, with long interrupted sentences and highly colored claims, was the luncheon meeting of the Progressive Business Men's club in the Multnomah hotel this afternoon. All the candidates had been invited to come and tell in two minutes, each why they should be elected. The meeting was enlivened by a sharp pass between Gay Lombard, one of the candidates for mayor, and R. W. Montague, member of the official charter revision committee, who answered in a witty story Lombard's attack on the commission charter.

During his speech Mr. Lombard challenged anyone, whoever, to debate the charter with him. Mr. Montague challenged Mr. Lombard immediately after the meeting. Mr. Lombard immediately refused, saying his meeting dates would prevent. He refused to set any of his arrangements aside. A. L. Stephens presided.

The clubmen heard from A. L. Barbun, candidate for reelection as city auditor; H. R. Albee, candidate for mayor; K. K. Hubil, candidate for councilman; William Adams, candidate for city treasurer; C. L. McKenna, candidate for mayor; Day Lombard, candidate for mayor; Mrs. M. T. Hilden, candidate at large for a seat in the city council; James Maguire, candidate for mayor; Fred L. Olson, candidate for municipal judge; W. C. Campbell, candidate for municipal judge; C. L. Daggett, candidate for councilman.

J. E. Werlein introduced Mayor A. J. Gillis of Walla Walla, who in a brief but pointed address urged the support of the commission charter proposed for Portland, saying that it has no essential differences from the Walla Walla commission charter that has proven such a great success, and concluding with this significant sentence:

"Oregon has had her glory because courage made her progress; fear never held her back. Let us have courage on the commission charter, remember it is a step of progress. Look to courage and not to your fears for future action."

Only one of the candidates, Mr. Hilden, insisted on disregarding the gong. She claimed that Walla Walla was the woman's privilege of speaking two minutes longer.

PLANS READY FOR NEW GLISAN MARKET

City Engineer T. M. Hurlburt today completed a sketch of a tentative public market which may be constructed on Glisan street alongside the new railroad bridge. An estimate prepared by the city engineer fixes the cost of such a proposed structure at something like \$20,000.

The proposed market would be built on steel pilings on a floor on a level with the sidewalk of the bridge, from which would be the entrance. The building shown in the plan is 120 feet long by 28 feet wide.

Ample room would be left beneath the supporting arches for traffic along the street.

The plan has been prepared at the suggestion of Mayor Rushlight, who was asked by the Women's Republic to select a site for a small public market, which the women want to see established in Portland.

U. S. FILES ACTIONS AGAINST CORPORATIONS

For failing to file with the internal revenue department of the government by March 1 statements of business for the year ending December 31, information against the Mist Publishing company and the St. Helens Transfer company were filed today in the United States district court. These are the first cases of this kind ever brought up in the Oregon federal court.

The federal act which is alleged to have been violated by these companies, was adopted in 1905. The act provides for a tax on the net income of corporations exceeding \$50,000, and in order to assess that tax an annual return from the corporations is required. The two St. Helens companies, it is said, have been warned repeatedly by the government. Failure to obey brings a fine of \$1000 to \$10,000 against the offending corporation.

Chung Shuet Out of Danger.
Chung Shuet, the Chinese who tried to hang himself in the city jail yesterday, is reported out of danger at the hospital and will be returned to the county jail Friday. He is held for the murder of a Japanese woman Monday in the grocery at Fourth and Flinders streets.

CHARTER IS PORTLAND'S CHANCE, SAYS MCGINN

Judge Henry E. McGinn says the commission charter is Portland's best chance to get good government. He believes the charter should be adopted Saturday.

"It will be our's, the people's, fault if the commission charter doesn't pass," said Judge McGinn. "It will show that we didn't recognize the best thing yet presented for the good of this community."

"I believe the charter will be adopted next Saturday because I believe in the intelligence of Portland voters, men and women alike."

"I believe in the charter because it definitely fixes responsibility on a few men instead of scattering it about a crowd of office holders."

"I believe in the charter because it provides for the preferential ballot and the preferential ballot will wipe out politics from our city elections. It will put into office the men whom the people want to elect."

"I have no fear of the civil service provisions in the charter. I believe civil service will be unchanged except the efficiency will be required. No one who has a job under civil service and merits will be affected."

"I believe in the charter generally because it furnishes a better method of handling the city's business than we have had before. This is Portland's chance to get good government."

SURVEYING LINE IN GRAYS HARBOR SECTION

O. W. R. & N. surveyors are in the field running lines for a tentative line from some point on the Grays Harbor line to Willapa Harbor, and it is believed that the company plans to proceed at an early date with the construction. The Willapa Harbor country is rich in timber and enough lumber is cut in the mills on the bay and river to furnish tonnage for a great number of years. In addition the section has a large area of agricultural land that, when opened by a railroad, will rapidly be developed.

The line will, in all probability, be run from Cedarville, on the Grays Harbor line, in a westerly direction to South Bend or Raymond, on the bay. The company also expects to build a line from the North Branch, running from the Grays Harbor line near Cosmopolis to the town of Primo, about midway between Grays Harbor and Willapa Harbor. While this road could be extended, it is held that the route would be a roundabout in giving an outlet for the Willapa traffic and hence there is said to be greatly more probable that the connection with the Grays Harbor line will be made at Cedarville or some point in that vicinity.

SUSPECT MAY FACE A FEDERAL CHARGE

When C. H. Duffy, alias Joseph Ellis, who is on his way from Sacramento to this city, in the custody of Sheriff Word, reaches here, he will find another charge awaiting him besides the one on which he was brought back from California. He is wanted by the federal authorities on a charge of using the mails in an attempt to defraud. Already the woman, with whom he lives in a city, who is said to be his wife, is under arrest at San Francisco, where she is being held as a witness for the government. As soon as the charge of swindling against Duffy is heard, she will be brought to Portland and will be a witness against him in the federal court.

Duffy is being brought back here to answer charges instigated by Anne Bock, who alleges that she married Ellis or Duffy in Macon, Ga., several weeks ago, then Duffy swindled her out of \$2500, it is charged.

Sheriff Word is expected to arrive in Portland with Duffy late this afternoon.

PHIL GEVURTZ SUED FOR RENT FOR HOTEL

Fallure of Philip Gevurtz to pay R. Koehler \$570 still due on the rent for the Carlton hotel for April and to pay a part of one note overdue and another note payable on demand without grace resulted this morning in the filing of a suit in the circuit court for \$1504.45 and the attachment of the property of Gevurtz and of L. Gevurtz & Sons, who had guaranteed the payments. The notes were for money expended by Mr. Koehler for taxes on the property. One for \$1383.85 was for six months and was due last 1912; \$215.60 was for rent on that note. The other was for \$1218.32 and nothing had been paid. It was dated April 23, 1913. Attorneys' fees amounting to \$100 are asked.

WOMEN TO WORK WITH COMMITTEE OF 100

Dr. S. Leah Baker, Mrs. Mary Sayer and Mrs. Sarah A. Short have been appointed a committee from the Political Science club to cooperate with the committee of 100 of the World's Christian conference, in reply to a request from Professor W. F. Ogburn, Reed college, chairman of the cooperation committee of the committee of 100. Resolutions indorsing the conference were also passed by the club. A request for contributions and donations has been sent by Professor Ogburn to 200 organizations of the city, enlisting their cooperation in preparing for the big gathering to be held here June 29 to July 6.

COMMISSION CHARTER WILL BE DISCUSSED

At a mass meeting to be held tonight at the North Portland branch library, Killingsworth avenue and Commercial street, W. C. Benbow and Dan Kellahan will discuss the proposed commission form of government, the questions of municipal ownership, the Houser franchise and the proposed interstate bridge will also be discussed. The plan is to give the voter of North Portland an opportunity to get reliable information on questions in which all good citizens are interested at this time.

AMENDMENT TITLES READY FOR BALLOT

Ballot titles for the proposed charter amendments to go before the voters at the June election have been prepared by City Attorney Frank S. Grant and filed with the city auditor.

Any one dissatisfied with these titles may appeal to the city council to have them amended. All such appeals must be made at the next session of the council.

CAESAR TALKS AT MIDNIGHT SESSION

As Result 8 Frisco Detectives Are Charged With Taking Bribes in Coast Cafe.

(United Press Special Wire.)
San Francisco, May 1.—Charges of unofficerlike conduct and accepting bribes were lodged today against eight detectives, recently suspended by the San Francisco board of police commissioners in executive session. The men affected are Frank Eola, Louis Drolette, Jack Sullivan, William McHugh, James McGowan, Charles Taylor, Arthur MacPhee and Charles Joseph.

The charges preferred by the police commissioners today are independent of any action the grand jury now investigating the charges may take. The charges against the detectives were dictated by Police Commissioners Roche and Kuhn, and their trial was set for next Thursday morning.

A meeting of the commissioners continued until 2 o'clock this morning and Caesar Ronchi, owner of a widely known Barbary Coast cafe, is alleged to have admitted that detectives and bunco men frequented his place and that he personally had passed "buling envelopes" to detectives at the request of members of the bunco ring.

Sensational developments are expected before night, the police commissioners taking the stand that the evidence already at hand "shows that the accused detectives consorted with thieves and bunco men" and this is sufficient grounds for their removal from the service without proving the bribery charges.

The inability of the grand jury to force Ronchi to talk led to the action of the commissioners. The commissioners, it was said, threatened to take away his saloon license if he again refused to divulge the facts concerning the alleged passing of money to police officers in his restaurant. The cafe man was nervous and tired when he finished. Caesar, it is said, also told of all the transactions between bunco men and the police in a saloon at 544 Broadway when he was its proprietor. Caesar named particularly Detectives Frank Eola, W. E. McHugh, Jack Sullivan, James McGowan and J. L. Drolette as men who consorted with the bunco men and who received envelopes.

COOS BAY ROAD LAND ALSO IS FORFEITED

B. D. Townsend, prosecutor for the government, and John M. Geary, attorney for the Southern Oregon company, appeared before Judge Wolverton in the federal court today and announced that they would submit to the court without argument the demurrer, made by the defendants to the suit of the government, instituted in 1910, to declare the lands of the Coos Bay Military Road grant forfeited. This suit, ordered by congress at the same time that the Oregon & California railroad case was authorized, asked that the land parcels of the Coos Bay grant, made in 1859, be forfeited because the companies that had accepted the grants had refused to comply with conditions.

Mr. Townsend announced this morning that the formal demurrer would be presented to the court Monday.

Mr. Geary will leave for New York early next week to spend some time in that city in connection with the land grant suit decided in favor of the government Tuesday. He represented the defendant Union Trust company, which has a \$20,000,000 mortgage on the lands that have been declared forfeited.

W. D. Fenton will leave with his wife for New York Sunday morning, from whence they will sail next Saturday for Europe. They are to be gone until early in September. Judge Fenton goes to rest after his activities as chief counsel for the Oregon & California Railroad company in the big suit.

INSTALLED DICTATOR OF ORDER OF MOOSE

Oscar W. Horne was last night installed as dictator of the Portland lodge, Loyal Order of Moose, for the coming year. He succeeds Judge Robert G. Morrow, who in turn becomes past dictator.

Besides the dictator, the following officers were chosen and installed: Vice dictator, Andy Weinberger; prelate, George R. Funk; secretary, T. R. Ratcliffe; treasurer, Paul M. Long; sergeant at arms, John Cassidy; inner guard, H. B. Glidden; outer guard, William Reed; physician, Dr. Banner R. Brooks; trustees, William H. Fitzgerald, Ralph C. Clyde and R. H. Bigham.

Mr. Horne, the new dictator, has lived in Portland 20 years. He is well known in fraternal and labor circles, and was once president of the State Federation of Labor.

Murdered Man's Wife Cleared.

Seattle, Wash., May 1.—The murder of Carl Axel Westman, watchman at the Hill Brothers' shipyards at Winslow, is still a mystery. The coroner's jury, after a few minutes' deliberation, practically exonerated Mrs. Westman, when they returned a verdict that the man died from a gunshot wound inflicted by some unknown person. Three witnesses testified that Mrs. Westman was at home at the time of the killing.

Cleaning Day at Goldendale.

Goldendale, Wash., May 1.—The annual clean-up day was observed by business men and citizens of Goldendale Tuesday. The work was done under the direction of Mayor N. L. Vard and several carloads of trash were removed from the streets, alleys and private premises.

He is a native-born American, and has been a resident of Portland for many years. He is well known in the community, and has a record of public service. He is a member of the local chapter of the Knights of Pythias, and has been active in the work of the organization. He is a man of high character and ability, and is well qualified to represent the tenth ward in the city council.

JACK REED, AUTHOR OF "JUSTICE," SEEKING IT

New York, May 1.—With his influential New York friends doing their utmost to secure his release on bail John Reed, the magazine writer, and son of Mrs. C. J. Reed, of Portland, Or., is still in jail in Paterson, N. J., as an instigator of the silk mill strikers there. Reed's friends hope to secure his release this afternoon.

"Jack" Reed is on the staff of the American Magazine, and went to Paterson to secure "copy" for an article on the silk mill strike. He ran in with a policeman, didn't "move on" and went to jail.

Reed has been actively interested in socialism since his undergraduate days at Harvard and in a recent issue of The Masses, the Socialist monthly, he had a story entitled "Justice". In it he told how he was arrested for failing to move on, taken to night court and there saw a friendless girl sent to jail for soliciting. When his case was called the judge looked at him and recognized him. He was taken to the bench with him and reprimanded the policeman for arresting a friend of his.

And now Reed's friends are wondering whether the Paterson police judge read "Justice" and was peeved by its irony or whether he just considered Jack one of the friendless ones. In either case the arrest has aroused a stir here, especially among the literary and Socialist sets, and the release of Reed seems but a matter of a short time.

WILLAMETTE STUDENTS SPEND HAPPY MAY DAY

Salem, Or., May 1.—In a bower of apple blossoms and on a throne almost concealed beneath the fragrant blooms, Miss Ada Mark was crowned queen of the May by the students of Willamette university this afternoon.

Preceding the coronation ceremonies a number of folk dances were given by the girls of the university. Following the coronation the queen reviewed the May-pole dance. The May-pole was garlanded with apple blossoms, adding to the pretty effect of winding the pole.
