Voters of Portland will have an opportunity at the election June 2 to pick from a list of 90 candidates, four commissioners, one mayor and one auditor to inaugurate the new commission government regime for this city.

When the time for filing nomination petitions expired yesterday afternoon it was found that just 80 candidates had filed for commissionships, four for the office of city auditor and six for mayor.

Considering the fact that early predictions were made by opponents of the commission charter to the effect that between 200 and 300 office seekers would file for the different positions, the citizens of Portland have been quite moderate in seeking places. Though Portland is twice as large as Spokane, the number of candidates to file here is less than the number that found places on the ballot when Spokane adopted commission rule recently.

Sample Ballots to Be Printed.

City Auditor A. L. Barbur is now anxiously awaiting the return of City Attorney Grant before ordering the ballots printed. All is in readiness now at the auditor's office for the city attorney's approval of the tentative forms prepared, and as soon as the city attorney gives the word the ballots will be printed. Mr. Barbur expects to have 100,000 sample ballots ready for distribution within the next two or three days, although he has until 10 days before the election to put these in circulation.

Under the provisions of the new charter, candidates for office must deposit their names for recognition at the polls, as Sec. 23b states, "No ballot shall have printed thereon any party or political designation or mark and there shall not be appended to the name of any candidate any party or political designation or mark (but words not exceeding 12 indicating his views on strictly municipal questions or issues may be)."

Three Choices for Candidates.
 Each voter will have a first, a second and a third choice vote for each office to be filled for the reason that there are more than three times as many candidates as there are offices to be filled in each case.

Under Sec. 23 there can be no numbering on the ballot. Each name will therefore have to stand on its own merits, except for the slogan of 12 words or fewer that each candidate is allowed.

In the published list of candidates yesterday the names of E. Helms and W. J. Smith appeared under the list of those seeking commissionships. In checking over the lists today the city auditor found that Helms had filed for the office of auditor and that Smith had filed for mayor.

William R. McGarry's name will not go on the ballot because he reached the auditor's office a minute or two late.

CANADA TO REVISE HER TARIFF SCHEDULE

 Ottawa, Canada, May 13.—Consideration of a new budget, including a revised tariff schedule, was begun today in the Canadian parliament. W. T. White, in presenting the measure, said that the government proposed waiting to see what the American congress does before changing the present tariff policy. The measure extends the free list to include typewriting and typesetting machines, certain traction ditching machinery, miners' rescue supplies, glassware and scientific apparatus used in hospitals.

Under its provisions the duty on cement is cut to 35 cents a barrel.



UNION PACIFIC LIFE GETS A PERMIT BUT KADY IS FORCED OUT

Members of Company Promise Insurance Commissioner He Won't Get Presidency.

 Salem, Or., May 13.—The long fight of the Union Pacific Life Insurance company of Portland for a license to transact business in this state ended happily today, when State Insurance Commissioner J. W. Ferguson issued the desired permit, and the officials of the company signed a stipulation dismissing the mandamus suit pending in the supreme court. The company has complied with the state insurance laws. Half a dozen of the officials and stockholders of the company visited the state insurance department today and personally went over the affairs of the company with Commissioner Ferguson. Mark T. Kady, who was president of the company and was personally objectionable to Mr. Ferguson, was forced to resign, and yesterday the board of directors met in Portland and elected new officers. F. H. Wiechen, the heaviest stockholder of the company, was elected president; I. M. Walker, first vice president; N. W. Merrifield, second vice president; C. E. Feldmann, third vice president; C. F. Hendrickson, treasurer, and J. S. MacCallan, secretary. The members of the company here today gave Commissioner Ferguson assurance there was no possible chance for Kady to again head the company. The company has over \$106,000 paid up capital stock, which is invested as required by the insurance laws. This point was ruled on by the supreme court when Commissioner Ferguson opposed the conversion of a surplus into capital by resolution of the stockholders. "This is a happy solution of the matter," said Commissioner Ferguson, and the insurance men indorsed the sentiment.

GIRL ART STUDENT IS GUILTY OF BURGLARY

 San Francisco, May 13.—Miss Jessie Clifton, the young Riverdale, Cal., art student, today was found guilty of burglary in the second degree by a jury in Judge Trabucco's court. She will be sentenced Saturday.

Miss Clifton was arrested two months ago as one of the Shea gang of young men and women burglars. When the verdict was pronounced the girl's mother collapsed and Miss Clifton became hysterical.

DR. LOEB BLACKBALLED BECAUSE OF HIS RACE

 New York, May 13.—The blackbarring of Dr. Jacques Loeb of Rockefeller institute, distinguished investigator in biological research, to membership in the conservative old Century association today threatens a serious rift within the ranks of the organization. The feeling is particularly acute because some of the sponsors of Dr. Loeb openly charge that he was denied membership because of racial prejudice, the biologist being a Jew.

BABE TUMBLES OVER 1000 FOOT CLIFF INTO TREE AND IS UNHURT

Jolted From Auto, It Falls Down Mount Wilson; Father Lowered by Rope Rescues It

 Los Angeles, May 13.—The 11 months' old infant of Mrs. Willard Spruce is no worse today for a tumble from an automobile today that shot it down the side of a mountain to lodge in the upper branches of a great tree, from which it was rescued by its father, who was lowered by means of a long rope.

While Spruce and his wife were motoring over the Mount Wilson road, late yesterday, the baby slipped from Mrs. Spruce's arms and fell over a 1000 foot precipice. Its clothing caught in the branches of a tree, where it hung, while Spruce sped to a ranch house a mile away for a rope. Ranch hands, who returned with him, lowered him to the rescue. The baby was found to be unhurt.

POWERS GIVEN WHIP HAND IN SETTLEMENT OF WAR IN BALKANS

Turkey to Abandon Territory West of Enos-Media Line—Greece to Get Crete.

 London, May 13.—The terms of the treaty by which the Balkan allies and the Turks are to lay down their arms were published here today. The peace pact is composed of seven sections. Turkey, according to the terms, is to abandon all territory in Europe west of a line running from Enos, on the Aegean sea, to Media, on the Black sea, except Albania. The frontier lines and the disposition of Albania are left to a commission, which the rulers of France, Russia, Germany and England will jointly appoint.

Greece is to get Crete, but the powers' commission is to decide the disposition of the Gallipoli peninsula, the Turkish islands in the Aegean sea, the cash indemnity to be paid and other financial matters.

BRITAIN SENDS CRUISER TO IMPRESS GUATEMALA

 Kingston, Jamaica, May 13.—Sailing ostensibly for Balise, British Honduras, the British cruiser Aeolus today is en route to Puerto Barrios, Guatemala, to enforce a settlement, it is believed, of long standing claims of British subjects against Guatemala. Great Britain recently placed a time limit on this settlement and it expires May 15.

Vale Flood of 1913.

 New Orleans, La., May 13.—With falling stages recorded at all points except New Orleans, the crest of the 1913 flood today has passed out of the Mississippi river into the gulf of Mexico.

CASUALTY CONCERNS WARNED TO CALL OFF MEN ON REFERENDUM

"They're Behind It," Declares Governor; "I Happen to Know"; Club Is Used.

(Salem, Or., May 13.—"The head office of every company writing liability insurance in Oregon will be immediately advised of the activity of its Oregon agents in connection with this referendum and each company will be told in plain English that if the referendum is not called off, a bill to put the state into the general insurance business will be offered to the people next year and fought through to the final vote today."

Some time ago Governor West also made the statement that if the agents of the casualty insurance companies were instrumental in referring the workmen's compensation act, he would personally go before the people of the state and campaign in behalf of a state insurance law.

"As I expected the casualty people deny all knowledge of the referendum in the workmen's compensation act. As a matter of fact, however, I happen to know that they are back of the referendum and that Lou Gifford has been employed to stand out in the limelight and be the goat."

"The most charitable construction that can be placed on their plan of soliciting subscriptions to defray the expense of referring the bill, is to say that it is a bluff, pure and simple, and done for the purpose of making the referendum appear a popular movement. As a matter of fact, the money for getting the names has been appropriated and will be paid over to Gifford as fast as he delivers the goods. As to what will become of the money raised by solicitation from house to house, one man's guess is as good as another's. The insurance agents admit that the bill will carry before the people by an overwhelming majority and that they are trying to hold it up for the sole purpose of keeping a fat thing for five months longer."

LISTER MAKES MAY 24 STATE GOOD ROADS DAY

 Olympia, Wash., May 13.—In response to a general request Governor Lister today issued the following proclamation:
 "I, Ernest Lister, governor of the state of Washington, do hereby declare and designate Saturday, May 24, as 'Good Roads Day' and request that all commercial organizations, automobile associations, school districts, farmers' organizations and all citizens of the state assist in the work of improving and bettering road conditions in their respective localities by assisting in the building and repairing of roads on that day fixed."
 "I would also further request that all school districts in the state set aside a part of the school hours on Friday, May 23, for a discussion of and education in relation to highway construction to the end that teachers and pupils will take an active interest in the 'Good Roads' movement and assist with the work on the following day, the one herein designated as 'Good Roads Day.'"

REPUBLICANS ARE ACCUSED OF PLAN TO BRING ON PANIC

Democratic Leaders in Senate Claim Reactionaries Plan to Delay Action on Underwood Tariff Bill and Kill It.

PENROSE FILIBUSTER IS PART OF GENERAL PLAN

Resolution Would Have Finance Committee Conduct Open Hearings on Bill.

(United Press Leased Wire.)
 Washington, May 13.—Charges that Republican members of the senate seek to delay action on the Underwood tariff bill until an artificial protest is raised in order to bring about a panic, were voiced today by Democratic leaders. The senate was scheduled to vote this afternoon on Senator Penrose's resolution providing that the senate finance committee conduct open tariff hearings before consideration of the measure is begun. The Democrats expect to reject the plan.

The Democrats say the business world wants the uncertainty regarding the tariff bill ended, asserting that if tariff hearings are eliminated the bill will go at once to the finance committee and be reported out within two or three weeks.

Senator Penrose is determined to conduct a filibuster. The Democrats expect Senators Borah, Cummins and Kenyon to oppose the Pennsylvaniaan. "If you can't be true and loyal to your own state and its vital sugar and wool industries, don't come back to Colorado."

This was the sentiment expressed on labels attached to several letters from his constituents received here today by Senator Thomas of Colorado. Thomas indicates that he will yield to the pressure, and that his vote will be cast against the Underwood tariff bill.

By a vote of 48 to 24, the senate this afternoon went into executive session, thereby automatically delaying action on Senator Penrose's motion for public hearings on the Underwood bill, and preventing any action on the tariff until the next regular meeting.

BEEF GOES TO 14 1-2 CTS. WHOLESALE AND CONTINUES TO CLIMB

Price Goes Full Cent Over the Record; Mutton, However, Is Cheaper.

The extreme scarcity of cattle all over the Pacific coast is reflected today by the announcement of a leading packer of an advance in the price of fresh beef at wholesale to 14 1/2 a pound. This is the highest price ever known in the history of the Pacific coast markets.

The previous high record attained here was 13 1/2 cents. It was for a time believed to be the extreme limit to which beef prices would climb. Now it is asserted that it is quite possible that a still further advance will be made in the price of beef before the first of the coming month.

Then relief, to a small extent, will be in sight. A slight falling of prices is expected when the big movement of grassed cattle starts for the city. The grass is now in good condition. Usually at this time of the season the movement of grass cattle has begun. The present season is fully a month later than normal, which accounts for the present shortage of cattle here.

For the first time in years the price of beef has soared beyond that asked for pork. No changes were made in the price of pork for the day. One real good sign of the present meat situation is that mutton will be cheap. Market prices are dropping constantly and it is believed that this will relieve to some extent the famine in beef.

FLEET WILL CARRY POWDER TO PACIFIC
 (United Press Leased Wire.)
 Philadelphia, Pa., May 13.—Precaution against any possible invasion of the Pacific coast is seen by shipping men in the announcement that the E. I. DuPont de Nemours Powder company of Wilmington, Del., has chartered 12 vessels to carry explosives to the Pacific coast. The charters for the vessels, seven of which were chartered in this country and five abroad, provide "for the carrying of the explosives from north of Cape Hatteras to the north Pacific or Australian ports." The words "Australian ports," shipping men say, were put in simply as a blind and that the explosives are to go to north Pacific ports alone.

It is also declared that the government is prepared to transport 30,000 tons of explosives from the DuPont works as fast as the explosives can be manufactured.

CHIEF PEACE DELEGATE FROM GREAT BRITAIN

BRYAN'S TOAST AT PEACE BREAKFAST EVOKES APPLAUSE

"To the New Battleship—a Ship of Friendship," He Said; "No Target Can Withstand Shots It Sends Forth"

(United Press Leased Wire.)
 Washington, May 13.—Secretary of State Bryan was one of the speakers today at a farewell breakfast given to foreign peace delegates by John Stewart, founder of the peace centenary conference.

Bryan proposed a toast "to the new battleship—a ship of friendship."

"No target," he said, "can withstand the shots it sends abroad." His toast was received with cheers.

Calls were received yesterday by the president, vice president, secretary of state and speaker of the house from the international peace delegates. A banquet was held in the evening, at which speeches were made by leaders in the peace movement and in the proposed celebration of the one hundredth anniversary of the treaty of Ghent and the establishment of peace among English-speaking peoples.

Secretary Bryan declared to the delegates that a lesson for all nations was exemplified in the long-continued peace between the United States and Great Britain.

Vice President Marshall said he was convinced that practically all differences between nations are possible of settlement if submitted to the arbitration of fair-minded men. His remarks were received with many evidences of approval.

Lord Weardale briefly responded to each of these addresses, in behalf of the assembled delegates.

The speakers at the banquet were Senator Elihu Root, Secretary Bryan, Ambassador Spring-Rice, Lord Weardale, Sir Charles Reid of Australia, Charles A. Magrath, member of the Canadian parliament, Eugene Gutierrez of Newfoundland, C. De Bruyn of the municipality of Ghent, and Andrew Carnegie.

The delegates left for Philadelphia today. From there they will go to Chicago where they are due on May 15, then to Detroit, arriving May 17, then to Niagara Falls, arriving May 18 and then to New York, arriving May 20.

That Christmas eve, December 24, 1914, the anniversary of the signing of the treaty of Ghent, there shall be held in all the churches of Washington a service of praise and thanksgiving, in commemoration of the anniversary of the signing of 100 in Washington. It is also planned to have the celebration last a week and to erect suitable memorials in the United States and England. The establishment of chairs of American-British history in both countries with an interchange of professors is another of the plans proposed.

JAPANESE TREATY TO BE NEGOTIATED DESPITE JOHNSON

Present Loose "Gentlemen's Agreement," Negotiated by T. R., Will Be Replaced by Definite Arrangement.

WILL BE INDEPENDENT OF CALIFORNIA ACTION

Japanese Protest Said to Be General in Character; No Citizenship Demands.

 Washington, May 13.—A new Japanese treaty to settle the status of Japanese as residents and land holders in the United States is soon to be negotiated, according to information today at the state department.

This treaty, it is said, will be conducted independent of what action Governor Johnson of California takes on the new alien law of that state. It is admitted by attaches of the department that Secretary Bryan and Ambassador Chinda believe that the time has arrived finally to settle all possible points of controversy and have determined that there is common ground on which they can meet to draw up such a convention.

The result of this, it is expected, will be a definitely worded treaty which will replace the present loose understanding of "gentlemen's agreement" made by President Roosevelt with the Nipponese. No definite indication of what the Japanese are eligible to citizenship.

Persons familiar with the situation state that the protest is based on a feeling that there is an effort everywhere in the United States to discriminate against the Japanese because they are ineligible to citizenship. The protest asks the president to remedy this discrimination.

Diplomats here, as a whole, think that a new treaty between Japan and the United States is imperative.

JOHNSON KEEPING QUIET

 Sacramento, Cal., May 13.—"Nothing yet" was Governor Johnson's terse reply to questions as to when he would reply to Secretary of State Bryan's telegraphic plea to withhold action on anti-alien land legislation for the present through veto.

"The reply may be ready later in the day," he added, "but for the present there is nothing to be made public."

It is stated by those closest to the governor that the reply to the national administration's request will be but a reiteration of his already declared stand that California has a right to enact such legislation, that the state demands it and that he will not put his veto upon the Webb-Birdsall bill.

100,000 WOMEN WILL MARCH IN ENGLAND TO PLEAD FOR SUFFRAGE

If Pleading Doesn't Succeed Army May Try Militant Tactics; Medals for Strikers.

(United Press Leased Wire.)
 London, May 13.—When the trial of militant suffragettes, charged with disturbing the peace, was resumed here today, a physician testified that "General" Mrs. Flora Drummond had completely collapsed and was unable to appear.

Ramsay MacDonald, a labor member of parliament, announced here this afternoon that he was willing to publish the Suffragette, the militants' official publication, despite the police. Kier Hardie, the labor leader, is said to be backing MacDonald. They allege that the police are infringing on the rights of free speech in attempting to stop the publication.

The suffragettes plan to have 100,000 women march from London in all directions to spread their propaganda. Starting from Trafalgar Square, they will leave by companies for Scotland, Wales and the east and south coasts. The missionaries will be mostly working women, who will appeal to the men of their class for work for suffrage.

Scotland Yard men who raised the suffragette headquarters testified today that the suffragettes had a system of awarding medals to hunger strikers. As other witnesses needed in the case were absent, the hearing of the suffragettes went over to tomorrow.

BRIDE OF 50 WALKS 20 MILES TO GROOM OF 82

WOMEN FAINT WHEN DUMMY AVIATOR FALLS
