Suspected of Stealing Auto.—For stealing the automobile of B. S. Josselyn, president of the Portland Railway, Light & Power company, C. R. Cunningham was arrested last night by Patrolmen Evans and Holland. A charge of larceny was filed against him this morning in the municipal court. James Turner, driver for Josselyn, saw Cunningham take the car on the night of May 7 from in front of the Orpheum theatre, drive it a couple of blocks, when the machine broke down. Cunningham left the auto and ran. Turner chased him but was unable to overtake the man. Last evening Turner saw Cunningham on the street and called the police. The patrolman followed Cunningham, Earl Chaplin and E. J. Bradstreet for several blocks, finally taking them into custody. The two latter are charged with vagrancy.

Wife Beater Promises to Be Good.—After Fred Brooks, waiter at the Louvre, had whipped his wife last night at their home, 887 Thurman street, she came into the municipal court this morning and asked the judge to give him another chance. Brooks cried and pleaded for leniency, saying that he was drunk and would never strike his wife again. Assistant City Attorney Sullivan suggested that he be given 30 days on the rocks. Mrs. Brooks further pleaded that she is destitute and would be unable to get along without him. A sentence of 180 days on the rocks was given, but this was suspended during Brooks' good behavior. He was ordered by Judge Tazewell to turn over his money hereafter to his wife and treat her properly.

Striker Recovers from Deputy.—For a beating at the hands of W. A. Mack, a former special deputy sheriff employed as a guard by the O-W-R & N. company at the east side cannery, Walter Seibor was given \$2,000 damages by a jury in Circuit Judge McGinnis' court last night. Seibor sued for \$25,000 on account of the beating and \$25,000 for false arrest. The first jury in the case disagreed. The row came in February, 1912, when Mack went to arrest Seibor's brother for stealing wheat. In the altercation Seibor threw hot water on Mack and was in turn beaten.

Chase Boy Over Lawns.—Lawn and fences in the Nob Hill district bear evidence this morning of a wild chase made by Deputy Juvenile Officer Jelfers after 12-year-old Meyer Silverstein. The boy has become so difficult to manage that his parents in despair gave up and Judge Gatens determined last Saturday in juvenile court to give him a taste of the state training school. For a week he has been sought. He was caught once and put in the Fraser home but escaped by a basement window. His main failing is larceny at which he has become an adept.

Woman Hurt by Bicycle.—While passing Third street at Morrison street yesterday afternoon on his bicycle, J. M. Farlow, 1538 East Eleventh street, ran into Mrs. B. Swanson, living at the Imperial hotel, from which collision the woman sustained a sprained ankle. The bicycle rider was going slowly at the time, other pedestrians reporting the accident practically unavoidable. Farlow reported the matter to the police.

Complain Against Saloon Men.—Mrs. E. W. Quirk, 546 Gilman street, yesterday complained to the police that two saloon men have been selling her husband liquor, allowing him to come home intoxicated. Chief Siver directed Patrolmen Miller and Wellbrock to notify the two men of the woman's complaint. Both saloon men said they hardly knew Quirk, but would refuse him liquor should he ask for it.

Gander Causes Fine.—Peter Albright, living in Dover addition near Woodstock, was fined \$10 this morning in the municipal court for allowing his

gense to run at large. Mrs. William Haylor signed the complaint against him. Albright testified the woman chased his gander off her property, trying to hit it with her clothesline pole, whereupon the trouble between them started.

Dies After Being Found Unconscious.—Chester Weiler was found unconscious yesterday afternoon in the Woolley rooming house at Grand and Hawthorne avenues, and died last night at the St. Vincent's hospital. Dr. C. H. Wheeler had the man sent to the hospital. The body was turned over to the coroner. Natural causes are thought to have been the cause of death, although an investigation is being carried on today. The deceased was about 50 years old.

Assessed \$1 Fine.—For violation of the federal prohibition act, J. R. Keep, a young man of this city, was fined \$1 in the United States district court this morning. Keep said that he had just purchased his boat and had not had time to equip it yet. The violation, which Judge Bean regarded as entirely technical, was for failing to have equipment necessary for extinguishing burning gasoline. Keep was arraigned by Assistant United States Attorney Sumrall.

Bequests \$2475 Estate.—According to the will of Alice May Thompson, whose death occurred May 4, Volney E. Thompson, her widower, is the sole heir to her estate, valued at \$2475. He was named executor. The estate of Albertus C. Armstrong was also admitted to probate yesterday, and Justice P. Armstrong, the widower, was named administrator. The estate is valued at \$1000. Ehrman Armstrong, a son two years old, is the only other heir.

NATIONAL CASTER TAKES TO GRANGE

First Day of State Session to Conclude With a Large Reception.

(Special to The Journal.) Albany, Or., May 12.—With over 200 delegates from all parts of the state in attendance, the fortieth annual session of the Oregon State Grange was convened at 9:30 o'clock this morning in the Moose lodge hall at the corner of Second and Lyon streets. The session was opened with the ritualistic work, and was presided over by C. E. Spence of Oregon City, master of the Oregon Grange. Mr. Spence made a brief address of welcome to the visiting delegates, after which he introduced Oliver Wilson of Peoria, Ill., national master of the Grange, who presided at the convention for over an hour. Mr. Wilson stated that he came to Oregon for the express purpose of attending the annual session of the state grange and nothing else, and will return home immediately after the close of the convention. Mr. Wilson's address was along the lines of grange work, what it had accomplished and what it planned to do in the future. He was given an ovation at the close of his speech.

Horace Parsons of Portland, a fraternal delegate to the convention from the Oregon Federation of Labor, addressed the meeting and made an encouraging address that was received with applause by the delegates. The credentials committee, consisting of Mary S. Howe, Multnomah; W. L. Whitby, Clatsop; H. R. Findley, Clatsop; Mrs. Nellie Peterson, Multnomah; J. G. Jarvia, Hood River, and Mrs. F. E. Butler, Knappa, reported shortly before noon, and the delegates were adjourned. The program of the afternoon is confined to the reports of committees. This evening a public reception will be held at the Armory, and Mayor Gilbert will deliver an address of welcome.

PORTLAND EDUCATOR GOES TO THE DALLES

Principal Guy W. Henderson of Oakley Green school received notice yesterday that he had been elected superintendent of the public schools at The Dalles. Mr. Henderson said this morning that he had concluded to accept the appointment. He will begin his work at The Dalles in August.

Principal Henderson has been teaching in Portland eight years. He came to Portland from Ohio. He had taught both in Ohio and Indiana. For three years he taught Latin and mathematics in the Portland—now Lincoln—High school. He was then elected principal of Oakley Green school, and has served there five years. For five years he had charge of the night schools in Portland, and in that direction the enrollment of students grew from 200 to over 1000, the list of teachers from 4 to 22.

His special ability has been in school organization. He established the "honor system" of discipline at Oakley Green school. It is a boast of the district that disorder and profane language are unknown on the school playground. Plans were discussed today for a public gathering at the school as an expression of regret that he is to leave. The school at The Dalles employ 30 teachers and include grade and high school organization. A high school to cost \$100,000 is about to be built.

WILL TELL HOW THIS CITY CAN GET SHIPS

Putting into effect its recently adopted slogan for Portland—"Where Water Grade Meets Ocean Trade"—the Ad club will consider ways and means for increasing the shipping of Portland at its meeting in the Hotel Portland tomorrow. The principal address will be given by Captain Richard Chilcott, whose subject will be "Shipping and Shipping Facilities of Portland." He will show why the geographical situation of Portland should be an aid to developing a great commerce, why Portland is not of the commercial importance he contemplates, and how the lack of ocean transportation facilities and the consequent disadvantages under which this city labors.

IN EARLIER DAYS

"My father's name is W. H. Willson," said Mrs. J. K. Gill. "Be sure to spell it with two 's.' Willson avenue in Salem was given to that city by my father, yet you frequently spell it with only one 's'."

"When my father was a young man he used to sail out of New Bedford with the whaling fleet. He was a ship's carpenter and his work was keeping the barrels in which the whale oil was stored in good order."

"On July 28, 1838, he sailed with others from Boston for the foreign mission field, as Oregon was then termed. They left Boston on board the Hamilton for the Sandwich Islands."

"The party consisted of Dr. Elijah White and wife, Alanson Beers and wife, with their three children; my father, W. H. Willson; Anna Maria Pitman, Susan Downing and Elvira Johnson."

"Mr. Beers was from Connecticut. He came out to be a carpenter, and Dr. White came out, as Mr. Lee had written that they were badly in need of a physician. Miss Pitman had been selected by the missionary board as a wife for Jason Lee. They had never seen each other. Miss Downing was going out to be married to Cyrus Shepard, Jason Lee's fellow-worker."

"A few months after this party arrived in Oregon, several additional workers were sent out by the board, among them Rev. H. K. W. Perkins, who married Miss Elvira Johnson. "After arriving at the Sandwich Islands, the party that my father was entertained by the natives until the spring. They left in April of 1837 in the big Diana for the Columbia river. They arrived in the latter part of May at Fort Vancouver, where Dr. McLaughlin gave them a hearty welcome."

"After a few days Jason Lee arrived and they all started for the mission. Jason Lee and Miss Pitman were assigned to one canoe, with an Indian crew. They camped the first night out at what in those days was the regular camping place, which, as you know, later became the site of Portland. "They left the boats at Champoug and from there they traveled on horseback to the mission on French prairie. The mission building was 18 feet wide and 40 long and, with the Indian pupils, there were 54 persons sleeping in it. "The following spring Jason Lee, accompanied by P. L. Edwards and Mr. Ewing, started on a trip overland to the eastern states to stimulate interest in the work and raise money. While he was gone his bride, Anna Maria Pitman Lee, gave birth to a son. The babe and his mother both died and were buried together. "Father had his hands full, as there was great need for buildings. He was sent up to Puget sound to build a mis-

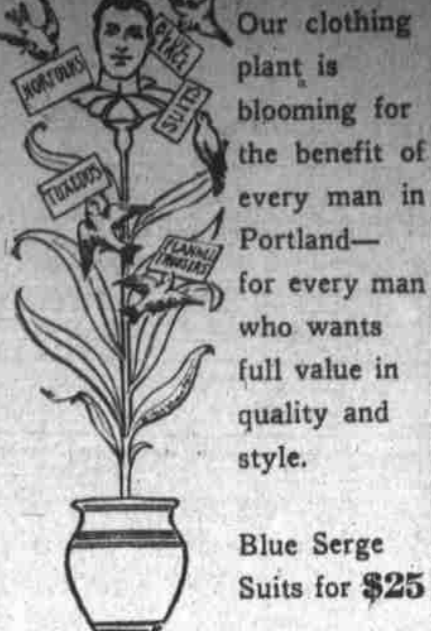
