

DUNWAY BEGINS LEGAL FIGHT ON COMMISSION PLAN

Supreme Court Will Be Asked
today to Issue Mandamus
Writ and Demanding Election
on Primary Nominees.

Asserting the charter election May 3 was unconstitutional and the nominations made at the city primaries on the same day are illegal, Ralph Dunway, an attorney who has been fighting the fight against the Broadway bridge, will this afternoon apply to the state supreme court for an alternative writ of mandamus on the city of Portland and its auditor to show cause why the primary nominees should not be voted on June 3.

Dunway asserts that the people in voting the commission charter under took election powers and privileges not granted them under the state constitution or the state election laws, and for this reason among others the commission charter is null and void. He further declares the charter is not yet in effect because the vote has not been canvassed and the results not proclaimed by the mayor and that all the nominations for mayor, commissioners and auditor under the new charter are premature and no legal right exists for electing them June 3.

Acting as "Dummies."

The application for the writ is brought in the names of Mrs. Abigail Scott Dunway, Mrs. Mary Reynolds and Robert M. Alstrop, each as a representative of the Republican, Democratic and Progressive parties respectively. It is admitted that they are acting only as "dummies."

In the action Dunway today declined to disclose the names of persons or corporations who are backing him in the attack upon the newly adopted charter.

Asked whether the same interests that behind the unsuccessful "Portland Taxpayers' Association" in its fight against the charter are backing him, Dunway refused to say.

"I take the stand that this is a matter which should be settled now," he said. "If the so-called commission charter is defective and void, I think it best that the supreme court pass upon the question now. If it is all right, then we want to know that, too."

For this reason, he said, he wants to have the matter argued before the supreme court on Friday of next week, to the end that a decision can be made by the court before election day.

Prior to departing for Salem this afternoon to file the writ, Dunway served a written demand on Auditor Barbur demanding that the names of the primary nominees be placed on the official ballot. He was verbally refused. This constituted the first legal step of his attack upon the charter.

In applying for the writ he alleges the following "infringements and violations of law" occurred, among other things:

That the primary election and special charter election were inconsistent because 28,000 voters in casting ballots for primary candidates in effect voted against the charter, while only 17,900 voted for it;

That the voters had no right under the constitution of Oregon to repeal the old charter or any sections thereof.

Other Defects Alleged.

That they undertook to repeal the general election laws of the state by passing the charter amendments.

That no right exists whereby voters can change sections of their charter into perambulating ordinances, as was done.

That the state constitution provides that the initiative and referendum powers shall be reserved to the electors of the city, and the so-called charter undertakes to provide that on a large number of ordinances there shall be no referendum by virtue of the commission's right to lack on an emergency clause.

That the preferential system of voting should be no part of a commission charter and is not legal because it deprives voters of absolute freedom in voting.

That the charter is not in effect, and the nominations for mayor, commissioners and auditor made under its provisions are null and void, and only the nominations made at the primary are official and can be voted on June 3.

LAST CHANCE TODAY TO REGISTER BOOKS CLOSE AT 9 O'CLOCK

Registration books, on which your name must appear if you vote at the election on June 3, will close tonight at 9 o'clock sharp. Though today has shown the heaviest registration of the week, it has been comparatively light, indications being that not more than 600 or 700 will register all day. About 200 registered this morning. It is doubtful, from present indications, if half of the women vote of 50,000 will be registered for the June election. It will be too late to register after 9 o'clock tonight.

EMBEZZLEMENT CHARGE FOLLOWS MAN 6 YEARS

Everett, Wash., May 17.—Charged with embezzlement, which is alleged to have occurred six years ago, H. T. Fowler, president of the Pacific Wholesale Grocery company, and one of the most prominent business men in this city, is under arrest here today. The warrant was served by an officer from Douglas county, Wisconsin, and charges Fowler with taking money from the firm of Fess, Freeman & Fowler, of Superior, Wis. Fowler says that it is an outgrowth of a business deal when the business in Superior was dissolved, and that he will fight extradition. The case will be heard by Governor Lister next Monday morning.

FRIENDLY DRINKS COST LONDERA \$280, WATCH

AUSTRALIAN BEEF CUTS LIVING COST

First Shipment to Frisco
Saves From 2 to 5 Cents
Per Pound Retail.

San Francisco, May 17.—A nationwide fight on the beef trust through the importation of Australian beef, which has lowered the price of meat here from 20 to 25 per cent, is believed a certainty today. The first big shipment from the south sea, 200 tons arrived here yesterday and immediately found its way into nearly 200 butcher shops. The foreign beef has met the requirements of the United States inspection laws and is in great demand by San Francisco housewives. A comparison of meat costs follows:

BOY OFFENDERS TELL THEIR TALES IN COURT

Leander and Byron, of different grades of color but the same race, and two white boys, all between 12 and 14 years old, appeared to answer charges of larceny before the juvenile court this morning. All admitted guilt as far as the theft of 500 cigars, 1000 cigarettes and a jar of gum from a restaurant owned by F. W. Fletcher is concerned, but denied they stole \$4.75 from the same place.

The two colored boys will be sent to the Boys and Girls Aid society, where they will be for adoption. The two white boys have been in trouble before frequently and were given reform school sentences but were paroled during good behavior.

They told how one boy would stand watch while the other did the stealing and on sign of danger would yell "Jiggers." That was the signal for a general scramble for escape.

Three of the four boys who took the automobile of E. E. Coover, arrested May 6, were given severe lectures by Judge Gatens and paroled on their pleas of guilt. They will be required to report once a week for six weeks to the court and the records against them will be wiped out at the end of a year.

Three brothers between nine and 14 years of age and a girl were given reform school sentences for being extremely cruel to animals. The boys were charged with chopping the legs from cats to see them hop about and with throwing a cat in the furnace, extricating it before it was consumed.

Parents were said to have no control over them. They will be held here until next Saturday when their mother may appear in court and tell her story.

NEWPORT-SILETZ ROAD WILL COST \$2500 A MILE

Newport, Ore., May 17.—Engineers E. M. Derrick, M. Wygant and B. F. Zezler, appointed by the county court to survey the route for a coast road north from Newport to Siletz, have completed their work. The purpose was to survey the best practicable route, with the idea of making the road a section of the coast highway. The engineers report they have ascertained 35 per cent grade, and that the road can be constructed at around \$2500 per mile. The road, when built, will be from a scenic standpoint unsurpassed in Oregon, and important not only to Newport and Lincoln county, but to the state. It will be the route for automobiles touring from the valley and Portland.

Plans are on foot to construct a tramway on the south side of the bay here so automobiles can negotiate the sand spit and get to the fine beach on the south of here. This will enable members of the Beaver Lake Gun club to get to their resort at any time of the year in an automobile from this city.

IMPORTERS ASK THAT LEMONS BE FREE LISTED

Washington, May 17.—The free listing of lemons today was strongly urged on the Senate finance sub-committee, considering the agricultural schedule of the Underwood tariff bill, by importers in North Atlantic states. California's representation in congress assume this fight is being agitated by New York importers. Because of this new situation, it was stated that California and Florida representatives would fight now for the duty originally provided in the Underwood bill as against free lemons.

A compensation to cotton manufacturers for cuts in manufactured cotton rates, Senator Smith, of Georgia, intimated today that the sub-committee on cotton and chemical schedules, of which he is a member, would recommend that two dyes used in the manufacture of cotton be restored to the free list.

NEWPORT COUNCIL MAKES SHARP SALOON MEASURE

Newport, Ore., May 17.—The Prohibition city council has passed an ordinance prohibiting minors, females, vagrants, habitual drunkards, habitual loafers, Indians and persons without visible means of support from entering and loitering in any saloon or place where spirituous, vinous or malt liquors are sold, and providing a penalty for any such proprietor of a saloon or barroom and for his employees and for minors or other persons for violating the ordinance.

ASKS \$15,000 FOR INJURIES.

Suit has been started by O. M. Bjorklund in the federal court against the S. P. & S. railroad asking \$15,000 for injuries received in 1910. The complaint alleges that Bjorklund was employed as a common laborer at the tunnel six miles west of Rainier. He was engaged in prying some boards off the east mouth of the tunnel when one on which he was standing broke and he was precipitated thirty feet to the ground. A broken shoulder, breast bone and three ribs were the result. Injuries to the breast bone caused tuberculosis to develop. It is claimed.

PLEDGE RENEWED; FARM IN PORTLAND

Commercial Club Men Consider Development Fund
for 1913-14-15.

Subscribers to the promotion fund of the Portland Commercial Club met last night at dinner at the club and considered ways and means of providing a fund of \$50,000 a year for 1913, 1914 and 1915, to be used in development work for Portland and Oregon and attracting a desirable class of agricultural settlers.

Every one of the 85 men present, all representative of large business interests, indicated strong faith in the position of Portland and its immense tributary country, and the speakers struck a most optimistic chord from the very beginning. G. E. Johnson, chairman of the club's executive committee, pointing to Portland's remarkably favorable geographical position and the possibilities of development of the immense surrounding territory. Development of this territory, he indicated, will make Portland one of the large commercial centers in the world and one of the main links in the principal gateways to the Pacific.

Mr. Johnson outlined the plan by which it is proposed to bring the best results through the expenditure of the money subscribed and gave statistics showing Portland's wonderful growth and improvement during the past year. Other speakers were S. C. Pier, C. C. Colt, B. S. Josselyn, C. C. Chapman, L. Samuel and William Gadsby. All spoke highly of the work accomplished and gave many reasons why it should be continued under the plans that have been steadily improved.

PLANT WILL SWELL WINLOCK PAYROLL

Winlock, Wash., May 17.—It has been announced definitely that a large clay factory is soon to be added to the industries of Winlock. J. A. Vonesse, lumberman and capitalist, is to finance the project to the extent of \$20,000 to \$30,000, stipulating that \$5000 worth of stock must be subscribed by other persons.

Associated with Mr. Vonesse in this enterprise will be O. W. Daniels, who will be manager. Mr. Daniels was manager of the Little Falls clay works that was destroyed by fire recently. A crew will be put to work Monday to prepare the ground for the factory. At the beginning, only preserver of clay, drainage and partition tile will be manufactured.

The capital of the company has been fixed at \$30,000. The articles of incorporation will be filed early next week.

SIX TO GRADUATE MAY 23.

The third annual commencement exercises will be held in Mutties hall Friday evening, May 23. The class of 1913 is composed of six members. They are Cyril Colbath, Russell Hall, Martha Johanson, Emma Viste, Myrtle Davis and Edgar Bryanes. Professor Edmond S. Meany of the state university will deliver the address.

SECOND MARKET DAY SET.

Winlock's second bargain and sale day will be held on Tuesday, June 2. At this time the merchants will again offer inducements to buyers in the way of bargains in various wares and the sale will again be featured. E. J. Vonesse, mill, is nursing a fractured rib and a slight cut over the eye, received from a fall caused by stepping on a piece of green bark.

FOUR TEACHERS WILL BE GIVEN HEARING

Four teachers who have been notified they will not be re-elected to positions in the Portland schools next year, have secured permission to appear before an executive meeting of the school board Monday night.

At the meeting of the board Thursday a five year lease on quarters formerly occupied by the county clerk in the county court house was taken by the board. The present quarters in the Tilford building demand a rental of \$40 monthly and under the new lease more commodious rooms will be secured for \$120 monthly. The board will remove its offices and the city school clerks to the new quarters in August.

TODDLING CHILD MOVES OFFICIAL TO CLEMENCY

An 18-month-old baby-toddlng around the room while the hearing was in progress, influenced United States Commissioner A. M. Cannon this morning to order the parents married instead of binding the father over to the federal grand jury on a charge of interference with slavery.

The mother of the child, Lizzie Holton, was arrested in the north and Thursday morning and on her confession, was implicated. It developed at the hearing yesterday that there had been a well established violation of the white slavery statute, but the case was not aggravated. Way had been making good wages and had been supplying the girl with money.

This morning Commissioner Cannon got the two together and told them that if they were married they would release Way. Both were eager to do this, and at noon in the custody of a United States marshal the ceremony was performed by Judge Gatens.

ST. JAMES VS. POST, SUNDAY.

Vancouver, Wash., May 17.—The St. James' Athletic club baseball team will play the post team on the Vancouver barracks baseball field on Sunday afternoon, commencing at 2 o'clock. These teams are said to be about evenly matched and a good game is expected. This will be the first game of the season between the teams in Vancouver for the championship of the city.

MADMAN SHOTS THREE IN OAKLAND

Oakland, Cal., May 17.—Running amok in the crowd at Eighth and Franklin streets here shortly after noon today, an insane Italian, believed to be Oreste Cirincio, shot two girls, a man who tried to protect them and then, overpowered, fired a bullet into his own head from which he probably will die.

Daniel Donovan, the man wounded by the lunatic's gun, was shot in the jugular vein when he leaped between the madman and the two wounded girls. But for the prompt action of a physician who witnessed the shooting, Donovan would have died on the spot. This physician, Dr. Leard, grasped Donovan's throat and held the spouting vein closed until he reached the hospital. Letters on Cirincio showed that he came from Dorna, Italy, and more recently from El Paso, Texas.

ANNUITY'S CASE ABOUT READY FOR THE JURY

New York, May 17.—Both sides in the case against Attorney John Annuity of New York, accused of trying to free Harry K. Thaw from Matteawan by bribing Dr. John Russell, superintendent of that institution, are making their closing arguments here this afternoon. It is possible that the case may reach the jury before night.

STAND COLLAPSES AT WHITE SOX BALL PARK

Chicago, May 17.—A small, temporary stand at the White Sox ball park collapsed today just before the game between the New York Highlanders and the White Sox started. Several persons were injured, the accident causing a panic among other spectators.

NEW JAIL MAY BE BUILT IF IT ISN'T A PALACE

Astoria, Ore., May 17.—In the circuit court, Judge Campbell has denied a motion for a temporary injunction to restrain the county court of Clatsop county from awarding a contract for a new county jail based on the ground that the indebtedness limit would be exceeded. The judge ruled that it is the duty of the county court to provide a safe and sanitary jail, and that an indebtedness so incurred is not an inhibition of the state constitution so long as no attempt is made to build a "palace."

In the matter of an injunction restraining the county court from proceeding with a contract with the Neuge Timber company to have the timber lands cruised in Clatsop county, Judge Campbell postponed his decision until May 28.

G. Wingate is plaintiff in the action brought against the county court and the timber company.

ARREST FOLLOWS RUSH BUSINESS IN COOK BOOKS

F. B. Smithson, who for several weeks has been at the Portland hotel, was arrested at noon today by Detectives Royle and Goltz, on a charge of obtaining money under false pretenses. Smithson has been doing a rushing business in selling books for which he collected \$5, but for which he failed to deliver the book. It is charged. He has been advertising for women to accept remunerative positions and in the way has names of people to whom he attempted to sell the books. He has been taken to the office of the district attorney who is making an investigation.

The man claims he represents a Los Angeles firm which publishes literature for children, and that the money he has collected is in the nature of a deposit until a certain amount of sales are made.

H. SHOGREN, PIONEER, DIES AT HIS HOME

Henry Shogren, who for 40 years has been a resident of Portland, died at his home, 98 East Sixty-third street north, this morning from an attack of heart failure following a serious illness of several weeks duration. He was 77 years of age. He retired from active business life 20 years ago. He was a native of Sweden, but came to this country when a very small boy. Four daughters survive him. His wife died six years ago. The funeral will be held Monday from the East Side Baptist church. Rev. O. A. Shank, his pastor, will officiate. Interment will be at Riverview cemetery.

ATHENA TEACHER CHASES PRINCIPAL

Prevented From Chastising
Him, Brings Suit for \$5000
Damages.

(Special to The Journal.)

Pendleton, Ore., May 17.—The town of Athena is having troubles of its own. Two of its school teachers, the principal and the instructor in the commercial department in the high school, have become involved in an imbroglio which bids fair to be aired in the courts.

Hubert C. Starr, the commercial instructor, yesterday filed suit against Howard W. Drew, principal, for \$5000 damages for alleged defamation of character. Drew, he claims, circulated false, slanderous and scandalous reports about him to the effect that on May 5 he was "soused." Drew did have the school board call the teacher instructor before it to answer certain charges and as a result Starr chased the principal about the school building the next day in an effort to settle the grievance by physical force.

Falling because of an intervention, he has appealed to the courts, claiming his professional reputation has been damaged \$5000 and his private reputation \$2000.

Historian Is Inverted.

Libel proceedings on the steamer Historian, which arrived in harbor here last week, were served Friday afternoon by local attorneys against the steamer for Rubeen W. Hillis and Austin H. Hillis, merchants of San Francisco. The complaint alleges that a shipment of 2000 bags of coffee carried on the vessel from Santos, Brazil, was damaged by being loaded in close proximity with a consignment of goods that smelt of a strong odor which the coffee absorbed. Bond was given in San Francisco and the vessel was not seized.

WENIX'S BAD LUCK TAKES GOOD TURN

Captain McKay's Due From
Cayuse War Will Fall
Largely to Her.

(Special to The Journal.)

Pendleton, Ore., May 17.—Wenix, the old squaw whose land was condemned by the city in order to secure the springs upon it as a source of water supply and who refused to decamp until the sheriff put her off, has had a stroke of good fortune which will serve as a balm to her ruffled spirits.

As the only surviving child of Captain Thomas McKay, she will probably receive 150 acres of soldier's scrip valued at \$15 per acre and a small sum of cash due the captain for services in the Cayuse war of 1855. Major Lee Moorhouse of this city is in receipt of a letter from a pension attorney of Washington, D. C., asking for information regarding the descendants of Captain Thomas McKay, who played such a prominent part in early Oregon history. Wenix is a daughter of McKay by his second wife, a Cayuse maiden, and her full brother, Donald McKay, is dead. Her half brother, Dr. William McKay, is also dead, but he has three children living, Thomas and Lella McKay of Portland and James McKay of Pendleton.

Inasmuch as Wenix is the only direct descendant, it is the opinion of Major Moorhouse that she will receive half of the money due from the government and the full quarter section of soldier's scrip in view of the fact that she was alive at the time of the war, being 2 years old then.
