Miss Elizabeth Butler Becomes Bride of Charles Yates, a Portland Attorney, After Settlement of \$50,000 Suit.

Within a few days after securing a settlement in a \$50,000 breach of promise suit which she had brought against Mr. A. B. Starbuck of Dallas, Or., Miss Elizabeth Butler, daughter of N. L. Butler of Portland, married Charles Yates, a young attorney, at Vancouver, Wash., Saturday. It was not until today that the facts concerning the marriage became public, although Mr. Yates had been handing out cigars among his close friends since Saturday.

Just what amount the young woman secured by the settlement is not known, but it is said it ran into the thousands of dollars. She had the suit filed in the circuit court at The Dalles, Tuesday afternoon, April 29, 1912, but it was not until several days ago that a satisfactory settlement was effected. She resided in the complaint that the alleged promise of marriage had been made by Mr. Starbuck in 1907.

Miss Elizabeth Yates, nee Butler, is the grand daughter of the original Butler who settled in Polk county a great number of years ago. The family is one of the oldest in the county and is very well known. She is quite talented and is said to be a singer of ability.

Mrs. Yates has been in Portland for about three years and has known Mr. Yates about two years of this time. Some weeks ago she was one of the entertainers in a local grill for a short time.

ALBEE TO BE "FAIR BUT FIRM" WITH SALOONS

Addressing the Women's American Republic club in a committee room at the city hall yesterday afternoon, H. R. Albee, candidate for mayor, explained his attitude toward the liquor business when he was asked by a woman regarding that question. He declared that, if elected, he would administer the laws on that subject fairly, but firmly.

"No officer acting under the provisions of the law," said Mr. Albee, "can do more than to enforce those laws with regard to the liquor business, just the same as with regard to all other interests. I am personally opposed to the liquor business; would favor its abolition, but you must remember that a mayor or a commissioner, under the charter, can go no further than the law allows him to go and, no matter what my personal views may be, I could not rush in and close up all of the saloons. I pledge myself, however, unequivocally, to enforce the laws with relation to the liquor traffic fairly, but firmly. I will make them all obey the law."

Mr. Albee also, upon being asked as to whether he would advise the complete use of the ballot, as to the three choices, replied that he does favor that procedure. "These could be but one thing," he said, "that would cause him not to exercise his complete three-choice vote and that is principle."

"Should it ever occur," explained Mr. Albee, "that there are not three men representing my principles on a moral issue, for instance, I should not cast a vote for a man who did not represent my principles. For instance, I would not vote for a man who is engaged in the liquor business, for he does not represent my principles."

Mr. Albee also pledged himself, if elected to construct at once public markets, to install a free garbage collection system and to work out, with all possible speed, some solution for the conditions with regard to the social evil, especially as to providing women could go and be helped to redeem themselves. He said he favored a home or a farm, where vocational training may be had, so that these women may learn to help themselves by honorable means and not be made worse through the machinations of the laws of the land.

AD MEN DISGUISE AS JAPS AND TAKE JOHNSON CAPTIVE

California Governor Surrenders to Miss Mildred Tucker, Portland's Mascot, When She Demands Kiss.

Sacramento, Cal., May 19.—Governor Hiram W. Johnson was taken completely by surprise when the visiting advertising men of California, Oregon and Washington, in convention here, invaded the capitol and took possession of the executive offices, staging a burlesque on the Japanese alien-land situation about the desk where the governor was working on bills passed by the recent legislature.

"At first embarrassed and then still further confused when little four-year-old Mildred Tucker, mascot for the Portland delegation, presented her pink check for a gubernatorial kiss, Governor Johnson quickly rallied by saying: 'That's the kind of people we are going to keep California for.'"

This brought a cheer that rattled the windows.

"If I wasn't a Webfoot, I'd surely be a Bear," piped little Miss Portland, standing on the big desk and shaking her curls at the governor. This brought the kiss.

The governor joined in the general laugh when the spokesman exclaimed: "Now that you have signed the bill, we are sure that California will never have a Japanese governor."

ence were made. Following the chief's machine came a second machine filled with detectives. As the chief raced up the street such a howl went up as has not been heard in San Diego since the I. W. W. day. The chief's car was jumped into every available vehicle and started in pursuit.

The police firmly believe violence would have been done at the jail door but for Chief Wilson's warning speech of a few minutes before.

"I am glad to hear you from here," were Reitman's last words.

The last time they were in San Diego, during the I. W. W. troubles, Miss Goldman was escorted out of town and Reitman was taken out of the desert, tarred and feathered, and turned loose.

After a conference with Chief of Police Wilson, Admiral Manney, superintendent of police, gave out the following statement:

Arrested to Protect Them.
"We arrested Emma Goldman and her two companions solely for their own protection. They would have been lynched within an hour had we not taken them into custody. What we will do with them will depend entirely upon what they do and on the way the citizens act. I understand that the Goldman woman has attorneys here."

When Miss Goldman and Dr. Reitman stepped from the train the police were waiting.

"You are under arrest," said Sergeant W. W. Johnson, as Miss Goldman's feet touched the ground.

The same greeting was given Reitman.

Asks for Warrant.
"I would like to see your warrant," said Miss Goldman.

"I'll show you my warrant," said one of the officers. Roundsmen George Williams and Officer Threlkeld were with Johnson. The officers surrounded the trio and all started for the station. Just before the start was made, Gerke, the advance man, was picked up. According to Sergeant Johnson, Gerke was seen distributing Goldman literature in a city park near the police station. He was chased then, but eluded the officers.

When the trio, mild as new milk, arrived at the station, they stood quietly while the formality of searching them was gone through. They were then escorted across the alley between the station and the jail and given into the care of the keeper. Reitman and Gerke were placed in cells in the main portion of the jail and Miss Goldman was given into the care of the matron.

Immediately after issuing the statement, Manney went to police headquarters where several hundred men had gathered. The street in front of the station was filled with automobiles and men. Most of the men carried tin horns which they were blowing. In the crowd were a number of so-called "vigilantes" who were active in the I. W. W. troubles more than a year ago. The automobiles, most of which were decorated with American flags, were driven to the station by some of the vigilantes and remained there, apparently ready for a parade or demonstration.

FORMAL DECREE IN S. P. SUIT RECEIVED

The formal decree of the United States supreme court affirming Judge Bean's decision in the injunction suit of the Southern Pacific against the city of Portland to prevent the operation of the ordinance forbidding the operation of steam locomotives on Fourth street, was received this morning and ordered made a part of the record of the local federal court in the case. The decision was announced February 24. The injunction suit was started by the railroad company in 1909 and the case was heard by Judge Bean in December of that year. Shortly afterward he gave a decision adverse to the company.

The damage to the house and furniture will aggregate about \$700, but the entire house would have been destroyed had it not been for his presence of mind and quick action.

Annual Report Shows Company Has Adopted Minimum Wage for Women.

Chicago, May 20.—In the annual report of the International Harvester company for the year 1912, just issued, President Cyrus H. McCormick says:

"The year 1912 was one of exceptional prosperity for the farming community throughout the world. The production of the principal grains increased almost 20 per cent over the preceding year, and yielded a crop value considerably larger than any previous record. This created an increased demand for harvesting machinery, tillage implements and other farm appliances, and enabled the company to make a substantial gain in the gross volume of sales. The expansion of the foreign trade continues. The sales of harvesting machinery abroad increased 23 per cent, and the sales of other farm implements, engines and tractors increased 10 per cent over 1911. The foreign trade now exceeds 40 per cent of the total business of the company, and contributes more than proportionately of the net earnings; while the domestic sales of harvesting machinery and tractors in 1912 were less than one-third of the total business.

"In pursuance of the welfare policy of the company, it has recently made the following changes for the benefit of its employees: It has abolished night work for women in all its works, and hereafter, whenever night shifts are required, only men will be employed; it has established for its women workers a minimum wage of eight dollars per week at all the company's domestic works, with corresponding adjustments in piece work prices and for more expert labor; it has adopted the Saturday half-holiday through the year at all the
