

NATION'S DEAD TO BE REMEMBERED IN FITTING MANNER

For First Time, G. A. R. Will Not March, But Will Ride in Motors and Have Place of Honor.

Veterans of the war will honor the memory of dead comrades on next Friday, Memorial day, by a parade and the strewing of flowers on soldiers' graves in the cemeteries.

The procession will start at 2 o'clock from Fourth street, in front of the court house. It will move through the principal streets and disband at the Armory, where fitting Memorial day exercises will take place. W. G. Copley will be grand marshal.

No Grand Army men will march in line this year, though they will be in the parade. Automobiles will be provided for them, and they will occupy the place of honor in the parade. The Third Regiment, O. N. G., Battery A, Coast Artillery and Naval Militia will act as military escort.

Special details will go to the cemeteries to see that graves of soldiers there are not forgotten. A flag and flowers will be placed over the resting place of each old soldier.

At Woodman hall, East Sixth and East Alder streets, there will be a general camp fire in the evening. The public and friends are invited. The camp fire will begin at 7:30 o'clock.

Parade in Afternoon.

Here is the complete program for the day:

At 8:00 a. m.—Details made from posts, corps and Spanish War Veterans will go informally to the various cemeteries of the city and decorate graves of departed soldiers and sailors of the war, inviting all interested to join in this service of loving remembrance.

At 9:30 a. m.—Comrades not otherwise detailed will assemble at Lone Fir cemetery for the decoration of graves. During this service the North Portland band will be present and between the hours of 10 a. m. and 12 noon, will give a sacred concert.

After decoration of graves comrades, wives and friends will meet for refreshments at Woodman hall, corner East Sixth and East Alder streets. The ladies of the Women's Relief Corps will furnish noon lunch at the court house.

At 10 a. m. the memorial service for the dead sailors of the war will be observed by the Oregon Naval militia, opposite the moorings of the U. S. S. Boston, by strewing flowers on the waters, music and addresses, all under the direction of the executive officer, J. A. Beckwith, and a joint committee of comrades and the Women's Relief Corps.

Assemble at Courthouse.

At 1:30 p. m.—Comrades will assemble at the courthouse and prepare for parade. Comrade Cicero Newell, chairman of the transportation committee, will have charge of the autos for the comrades at Main and Fourth streets, where they will take seats in autos before 2 p. m. The Spanish war veterans will form on the east side of Fourth street, south of Salmon. The details of the formation of the parade will be under the direction of the marshal of the day.

The Third regiment, Oregon National Guard, Major L. A. Bowman; medical corps, Oregon National Guard, Captain A. N. Creadick; Coast Artillery, Captain Charles O. Brown; Battery A, Lieutenant Frank I. Randall, and Oregon Naval Militia, Lieutenant J. A. Beckwith, will march as escort.

The procession will move promptly at 2 p. m. The following is the line of march: North on Fourth street to Morrison, east on Morrison to Grand avenue, north on Grand avenue to Burnside, west on Burnside across bridge to Fourth, south on Fourth to Washington, west on Washington to Tenth, north on Tenth to the Armory. The Women's Relief Corps and Ladies of the G. A. R. and those not in the procession will be given reserved seats at the Armory.

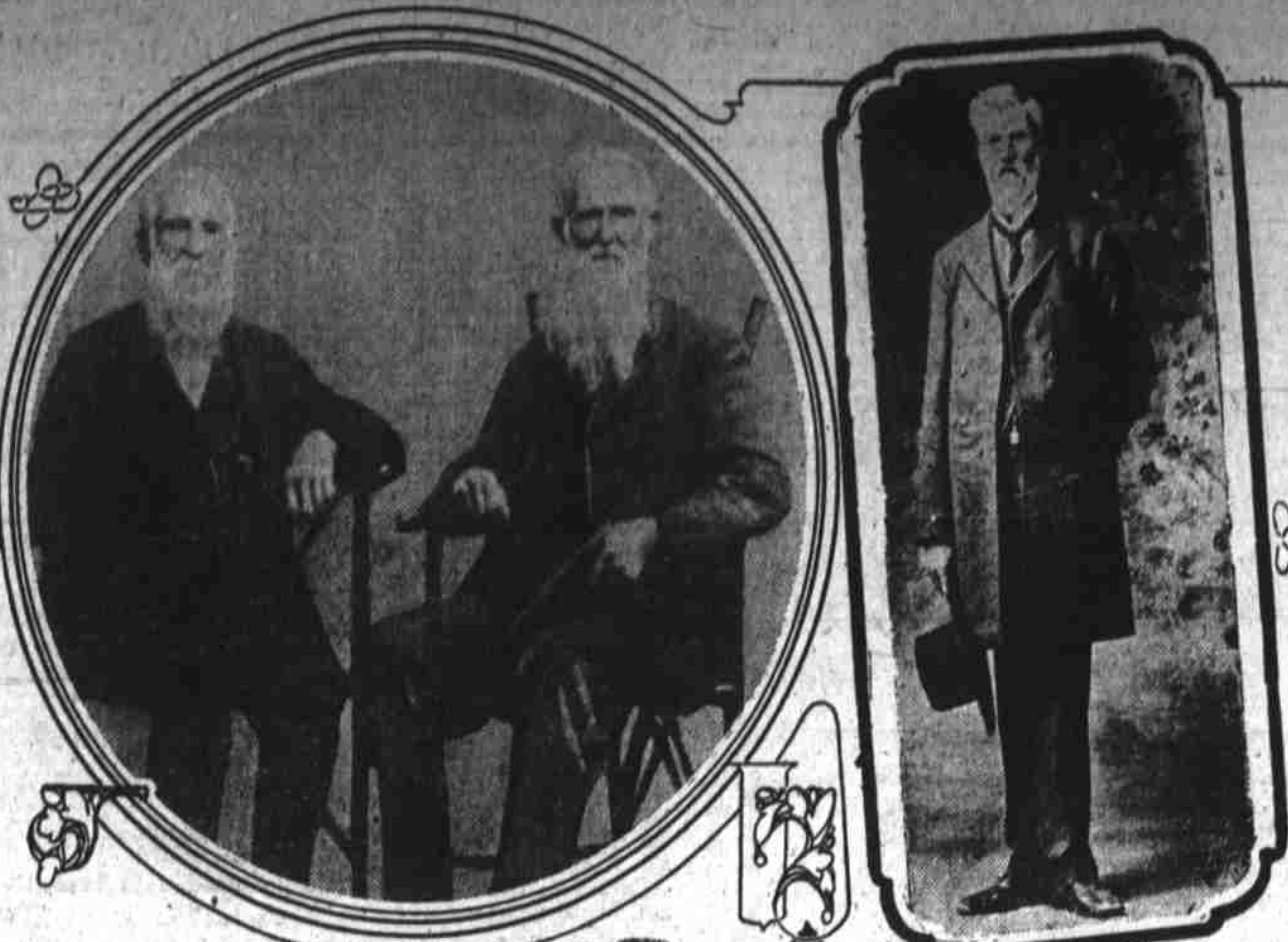

Independence, Or., May 23.—After a long period of 57 years, during which time has removed many of the men, the only eight survivors of the North Yakima Indian war of 1855-1856 of Polk county have filed with attorneys affidavits to certify that they had served in the war, and have received pay for the horses and mules which they lost while on duty.

In the minds of some it is doubtful if Polk's remaining survivors realize the inattention that has been given them by the state in not having the bills paid at an earlier date. They have made no complaint and have waited to receive or not to receive their pay.

Three of the men have clear mental pictures of the battles in which they fought and can tell exactly the privations under which they labored, re-

membering all the parts of the country around North Yakima.

BLIND GIRL MEN'S VICTIM IS CLAIM

Two Arrested in San Francisco for Attempting to Sell Her; Continuance Denied.

(United Press Leased Wire.) San Francisco, Cal., May 23.—Bitter denunciation of an alleged white slavery plot of which Camille Meining, a blind Los Angeles girl, was the intended victim, was voiced from the bench by Police Judge Shortall. The court's outburst came when attorneys sought a long continuance of the case in which Sam Grubb and Rose Marks are held here under \$10,000 bail on a charge of pandering.

"This is one of the most pathetic cases that has ever come to my notice," said Judge Shortall. "I will not tolerate a long continuance in the matter."

Prosecuting Attorney Becsey also took a hand in the matter when Attorney Barrett and Summerfield, representing the accused couple, sought to delay the case.

"This blind girl," he shouted, "has been intimidated. An officer reports that a woman offered to pay Miss Meining's transportation either to Los Angeles or Alaska if she would drop the case."

This allegation brought another outburst from Judge Shortall, who ordered that the blind girl be cared for in a dormitory in the Hall of Justice. Miss Meining, who feared some complaint would be registered against the woman, voiced a plea in her behalf.

"Please, please," she cried, "don't punish the girl who offered to take me away. I don't want her to suffer. She was so good to me."

Judge Shortall continued the case until tomorrow.

DIES FROM BLOW ON HEAD BY AUTO CRANK

The injuries did not bother him until yesterday when he complained of a headache. He died shortly after a widow and four children survive him.

LANDS OF SILVIES TO RECEIVE WATER

Harney Valley Reclamation Company's Applications Are Approved.

(Salem Bureau of The Journal.) Salem, Or., May 23.—The state engineer has approved the several applications of the Harney Valley Reclamation company for water for its 54,000 acre project in Harney valley.

"For the reclamation of this project, four or six reservoirs will be required," said State Engineer Lewis. "The two large reservoirs will be located on Silvie river, which together with reservoirs located on Poison and perhaps one on Emigrant creek, will serve to irrigate the Silvie river unit of the project."

"The project is naturally divided into two units of about equal size, and a reservoir only slightly smaller than the Silvie river reservoir will be constructed on Silver creek, which flows directly into Harney lake."

"The reservoirs contemplated for the Silvie river unit are the Upper Silvie reservoir with a capacity of 96,000 acre feet; Lower Silvie reservoir, capacity 105,000 acre feet; Poison Creek reservoir, 23,500 acre feet; Emigrant Creek reservoir, 67,500 acre feet and for the Silver Creek unit reservoir No. 1 for the storage of 97,700 acre feet of the waters of Silver Creek; and reservoir No. 2 for the storage of 2215 acre feet of the waters of Nichols Creek."

"The site of the proposed Upper Silvie reservoir is one of the most remarkable in the state, as it requires only a 46 foot dam to inundate 5200 acres and store 96,000 acre feet of water. The dam for the Silver Creek reservoir No. 1 is the highest proposed, being 118 feet in height; the lowest, that on Emigrant Creek, being 44 feet in height."

"The railroad now under construction from Vale to Harney valley will pass through this project and solves the transportation problem, which has long held back the development of this section."

WARRANT IS OBTAINED BY MOTHER-IN-LAW

August Phillip, championing the cause of his young bride, struck his mother-in-law, Mrs. Helen Klontropoulos, of 244 Park street, during an altercation Monday. Monday night Phillip and his bride were detained at the city jail. A charge of assault and battery was preferred by the girl's mother.

Phillip and his wife are now trying to convince Judge Gatens and County Clerk Coffey that the girl is of legal age. The trouble started when Mrs. Klontropoulos attempted to force the daughter to marry a man whom she did not like, it is asserted. May 23, Phillip and the girl armed themselves with documents to prove her legal age and were married by Judge Gatens.

Monday evening the girl attempted to leave the home at 244 Park street. The mother objected, whereupon Phillip is alleged to have struck her. The couple was about to board a train for Tacoma when arrested. Soon after they had left the station, Mrs. Klontropoulos swore to a warrant against her son-in-law.

Warm Weather Helps Hops.

PEACH TREE CURL CUTS 1913 YIELD

Washington County Trees Are Seriously Affected by This Blight.

(Special to The Journal.) Orenco, Or., May 23.—A fruit tree disease known as peach leaf curl has seriously affected the peach crop throughout the county. It is reported that thousands of peach trees throughout Washington county have been affected and that the trees thus blighted will yield nothing this season. These trees had all the appearance of yielding heavily early in the spring, the trees being full of blossoms, but as the spring advanced the leaves shriveled and dried up, then turned black and fell off, leaving in numerous cases nothing but bare limbs. It is also observed that not only peaches are affected by this disease, but that numerous pear, cherry and apple trees are also so afflicted.
