

JAMES IS WRONG IN HIS STATEMENTS CONCERNING ALBEE

Candidate Did Not Fight Initiative, Referendum and Statement No. 1; Not One of "Solid Ten."

A letter published in The Journal yesterday, which was written by one signing himself Martin T. James, relative to the candidacy of H. Russell Albee, contained statements that were not correct. The Journal on investigation has found that they were not true, and in fairness to Mr. Albee publishes the facts.

Mr. Albee did not fight the initiative, referendum and statement No. 1. He was one of the statement No. 1 senators who refused to consider voting their pledge in the legislative session of 1909 when the Oregonian administration was defeated. George Chamberlain, who had received the people's vote for United States senator. The letter stated that Mr. Albee voted against the indorsement of the Oregon system in the legislature. This is a perversion of the truth on the part of the letter writer. Mr. Albee voted against a resolution introduced by Dan Kellaher, lauding the Oregon system, because it contained a phrase stating that the Oregon system, including the initiative and referendum, the recall and the corrupt practices act, was "the best system of government in the world." Mr. Albee objected to this phrase, and on the floor of the senate asked Mr. Kellaher to remove it, saying he could not support the resolution containing it because it was too broad a statement to make. He said that New Zealand and other places might have a better system than the Oregon system, and that the phrase was unnecessary and out of place.

Mr. Kellaher refused, and the resolution was defeated. Albee voted against it. Mr. Albee then introduced the same resolution commending the Oregon system, with the phrase to which he objected omitted. It did not carry.

Mr. Albee was not a member of the "solid ten" in the city council that opposed Mayor Lane. He was in the council from 1902 to 1905, before Lane was mayor.

as plaintiff, is expected to be completed today.

Didn't Drink a Drop.

Andrew Abele of Ironton, Ohio, followed Thompson. He testified that he accompanied Colonel Roosevelt from Ironton to Chillicothe, Jackson, Athens and other Ohio towns, at some of which the defense asserts, Roosevelt was drunk. He asserted that Roosevelt did not drink a drop at any of the towns mentioned.

Abele was closely cross-examined but stuck fast to his testimony. He was followed on the stand by former Judge W. Z. Blair of Portsmouth, Ohio, who barred half of Adams county from the right to vote on account of election bribery.

Blair testified that he accompanied Roosevelt through southern Ohio last year. He said:

"There was nothing to indicate that Colonel Roosevelt was drinking or had been intoxicated. He was sober and in good physical shape."

Colonel's Cousin Knows Him.

Philip Roosevelt, 21 years old, and 6 feet 7 inches tall, the colonel's cousin, then took the stand. He said:

"I know the colonel so well that I have been swimming with him when he had on no clothes at all. Young Roosevelt said he had been a newspaper man since March. He had known the colonel always and accompanied him on his trip through the northern peninsula of Michigan. He said: 'The colonel hardly ever drinks anything except at night a teaspoonful of brandy in milk.'"

Asked if he ever saw the slightest indication that Colonel Roosevelt was intoxicated, he shouted: "Of course not."

Young Roosevelt admitted that before

the trial the testimony of Colonel Roosevelt of himself, and of a number of other witnesses had been written out as a guide to Attorney Pound.

Edwin Emerson, Roosevelt's field secretary in Cuba, who is now a New York newspaper man, testified that the colonel drank only black coffee during the Spanish war.

Gifford Pinchot testified this afternoon that he had known Colonel Roosevelt intimately for 14 years. He said he always had watched Roosevelt carefully, adding:

"I always have been interested in questions of efficiency and how efficient men worked. I never knew a man so efficient as he."

Pinchot declared he never saw Colonel Roosevelt intoxicated.

Pound Waives Technicalities.

The court room was packed during yesterday afternoon's session and the courtroom doors were locked. Attorney Pound resumed his argument, asking the court to decide how far Newett may go in presenting testimony regarding Colonel Roosevelt's sobriety. Pound finally announced he would waive all technicalities, and said that Newett could go as far as he liked.

A girl in the balcony created a diversion by falling asleep and cracking her nose on the balcony railing. She let out a yell that startled the spectators.

The court decided, in substance, that Newett may testify regarding Roosevelt's general reputation as to the use of liquor. He is barred, however, from introducing clippings from other papers bearing on the same points. The ruling, however, does not bar defense depositions bearing on specific occasions.

Bacon Defends His Friend.

Gilson Gardner was subjected to a brief cross-examination, after which Robert Bacon, former United States ambassador to France, reviewed his acquaintance with Colonel Roosevelt since he met him at Harvard university in 1876.

During my lifelong association with Colonel Roosevelt, I did not know him, and especially during the four years I was in the closest personal contact with him in Washington, it would have been impossible for him to have been a drinking man without my knowledge. His whole life, both public and private, has been clean and decent. Any statement, thought, speech or suggestion that he has ever been anything but temperate to the highest degree, is unqualifiedly false."

L. F. Curtis, a New York newspaper man, also testified that the colonel was a temperate man.

Herman Newberry, former secretary of the navy, followed with testimony that Colonel Roosevelt was most abstemious.

Judge Is a Speeder.

Marquette, May 29.—Judge Flannigan arrived at the courthouse today an hour before the opening of the Roosevelt trial, and immediately shut himself up in his chamber while a bailiff shooed all visitors away. But one enterprising reporter broke in, and discovered his honor reading a bloodthirsty dime novel with tremendous interest. Caught in the act, the judge explained:

"All I read is law books and dime novels. I like the wild kind, but it seems to me that dime novels have degenerated lately. Maybe I've got a dime novel blood in me. I have wanted an aeroplane ever since they were invented, and I hate to go slow in my automobile."

LIFE INSURANCE MEN WILL BANQUET TONIGHT

In honor of N. D. Sills of Richmond, Va., president of the National Association of Life Underwriters, members of the Oregon Association of Life Underwriters, will give a banquet at the Hotel Oregon at 6:30 o'clock tonight. Covers will be laid for about 65 persons.

Mr. Sills is in Portland in the course of a tour of inspection of western underwriting agencies. He will be in Seattle next week on the occasion of the convention of the Puget sound association.

H. H. Ward of the Pacific Mutual Life, president of the local association, will preside tonight as toastmaster.

Criminal Cases Bunched.

All criminal cases now on the trial docket of the five circuit judges will be transferred to Circuit Judge Kavanaugh, who will begin hearing them Monday morning and will clear them from the docket as rapidly as possible. It is thought many of the cases will be disposed of without trial and that not over two weeks will be needed to get all cared for. As soon as he completes this work Judge Kavanaugh will resume the hearing of civil cases.

THEME FOR PEOPLE TO TAKE CONTROL OF CITY AFFAIRS

Public Interest Aroused Will Be Perpetuated for Good If Votes Are Carefully Cast, Declares B. F. Irvine.

The issues of public good are more prominently before the people and more nearly within their grasp than ever before in Portland's history, said B. F. Irvine, in a stirring address before a mass meeting in the auditorium of the Albina branch library last night.

The good people of the city have been stirred as never before, said he. They are more aggressively asserting their right to have a controlling voice in the affairs of the city. They are more practically and strongly organized against sinister influence and corrupt plan.

But, continued the speaker, the victory is not won. If indifference should settle upon the better element of the voting population, if they fail to register their determination for sustained good government at the polls next week, and third choices in every instance, then the spirit and intent of the commission charter will be defeated.

Describes Milk Fight.

Mr. Irvine described some of the fights made in behalf of the people against vested interests that fatten on misfortune and hold the dollar before the health and happiness of little children, even. He described the pure milk crusade that was waged in Portland three years ago. No one, he said, could tell all that was selfish and sinister encountered in that campaign.

There were those who in the name of the invested dollar sold dirty milk because they could make a few extra cents though at the cost of the lives of innocent babies. There were those who fought in the darkness against improvident in production and distribution of the milk supply because they loved the invested dollar more than human life. The invested dollar, declared the speaker with strong feeling, is responsible for more murders, more human misery, more destruction of innocent life than any other one thing, and to fight for improvement against it requires courage of the highest order.

Should Scrutinize Records.

Mr. Irvine described the part that Marshall N. Dana, now a candidate for commissioner, had in the pure milk crusade and declared that he had demonstrated his fitness to serve the people in this and other public services.

Judge W. N. Gatens said that under the old administration of municipal affairs the darkness that enshrouded everything that should be public business had allowed the social evil to flourish and officials have not been compelled to give an accounting to the people for their lack of law enforcement. Now comes the commission charter, a method of handling the city's business with business efficiency, and the light and the interests of the people. If the people next Monday elect men who skulk in the shadows, whose ways are the ways of darkness, they will not have as public officials men who are a part of the progressive movement toward better things, and evil and vice may flourish and disaster come upon the city. He urged that the people elect to office only men whose records show that they are honest and mind with the people, who are honest as well as efficient.

Advice to Single Shoot Selfish.

In a brief preliminary address, Marshall N. Dana declared that the big issue of the campaign is the election of men who will genuinely serve public welfare and that the people will demonstrate the quality of their citizenship by their vote at the polls next Tuesday. During his address Mr. Irvine had commented on the records of the Denver election as an argument against "single shooting" candidates, or voting only first choices. At Denver no one was found to have been elected until the third choice votes had been added to the first and second choice votes, thus showing the importance of the second and third choice votes.

During an address before a meeting at East Seventeenth and Alberta streets later in the evening, Dana said, "I am told that a few candidates are urging their friends to vote only their first choices. For this reason such candidates should be defeated. They are selfishly seeking jobs and they don't have the first intention of serving Portland's people if they are elected. As to indorsements, while I have been indorsed by the Committee of One Hundred, the Public Welfare League, and the People's Progressive League, and while these organizations have performed a public service in investigating the records of candidates, voters should not be satisfied with anything told them by any individual or organization but should look up and weigh the qualifications of candidates for themselves."

Big Improvement Saving.

"Neither do they tell you that I have saved you \$2,000,000 in the cost of sewer and paving improvements. On the contrary, they say that paying prices are excessive, knowing as they do that these prices are lower from 12 to 25 per cent than they have ever been."

"They misrepresent and they criticize and grasp at straws, but they know in their hearts and they surely must know that the public know they are trying to bolster up their losing fight against me with a string of misleading generalities and not a single sound fact upon which to base the whole rignmarole."

"My enemies are circulating unheard of lies about my private life. One of these villainous falsehoods that cannot be traced to its source is the effect that I used to beat my wife, that I made her commit suicide, that I beat my little children, and other calumnies of a despicable nature have been put into circulation to injure my character. I challenge any one to show where my home life has not been one of happiness and felicity. Any one who knows me can vouch for what I say."

"It has been said that prices paid for supplies by different departments are not uniform. That is true as it has always been in Portland under the present charter. I have been criticized because I did not personally investigate every purchase made for a \$300,000.00 corporation."

"To show you how absurd such a criticism is, I will tell you what I did

today. The council met this morning, and it was nearly 3 o'clock before it adjourned and I was able to go out to lunch. The council passed on 203 separate items of business. I will have every one of these on my desk to scrutinize before they can go to the executive board, which would meet Friday were that not a legal holiday.

Stops to Answer Questions.

"When I came back from my lunch I was handed a package of check books amounting to \$1,350,000 and one of improvement bonds amounting to \$300,000. Working without intermission until 5:30 o'clock, I was able only to sign \$900,000 of these bonds. By the time I finished I had a dozen people waiting in my office to meet me on important matters. It was 7 o'clock before I got home."

"This is only a sample of the routine at the city hall. As chairman of the park board, the health board, the water board and special commissions, I must preside, and I have to take up individual complaints by the hundreds and will all parts of the city to watch over public improvements and check up contractors. The details of the mayor's office routine are well nigh innumerable and a man who would not make some mistakes would have to be superhuman."

Mayor Russell had to leave the hall early last night on account of being indisposed. As he was leaving an old man in the audience arose and said he would like to ask a question.

Chairman Kerkheim of the meeting rapped with his gavel for order and told the inquirer he would have to write his question on paper.

"No, let him ask me; I'll answer him," quickly interposed the mayor.

"Have you," asked the old man, "administered the affairs of this city for the masses and not for the few?"

"I have," was the mayor's earnest reply, which was hailed with another ovation of cheers and handclappings as he left the hall.

FIRE DEVASTATES COPPERFIELD, OR.

Loss Is \$50,000 in Mining Town in Snake River Canyon.

Halfway, Or., May 29.—Fire at 1 o'clock this morning destroyed \$50,000 worth of business property in Copperfield, Or.

The fire originated from an unknown cause in the Mountain-Kenebirtwhic saloon. A strong wind made it impossible to fight the flames successfully. The saloon and the Copperfield hotel adjoining, owned by Gus Aistead, and the general merchandise store of M. T. Griffith and the contents of that building were destroyed, also several small buildings and residences adjoining. Several hundred dollars damage was done to the Sam Aikin general merchandise store across the street. Little insurance was carried on the saloon. The Griffith property and hotel were a total loss with no insurance.

LEAVES TODAY TO FILE U. OF O. REFERENDUM

H. J. Parkinson, secretary of the Oregon Higher Educational Institutions Betterment League, left this afternoon for Salem to file a referendum on the act of the last legislature appropriating a fund for new buildings at the University of Oregon and for improving the heating plant of the university.

The demand is made by the petition that the matter be referred to the people at a special election in November of this year or in November, 1914. Two bills attached were the ones that provide \$100,000 for new buildings and \$75,000 for repairs.

The object of the O. H. E. I. B. L. is to bring about the consolidation of the University of Oregon and the Oregon Agricultural college. Parkinson, before leaving, refused to make any statement about the proposed plans of the league, declaring that it would take much time and study to prepare a statement due to the fact that there are five important elements in the consolidation measure which he intends to submit in the near future. The referendum does not stop the regular biennial maintenance appropriation to the university of \$425,000.

RICHARD WILSON TO BE BURIED SATURDAY

The funeral of Richard Wilson, prominent club member, president of the Eubank Electric Transmission company and vice president of the Title & Trust company, will be held Saturday morning at St. Mary's Cathedral, at Fifteenth and Couch streets. Burial will be at Mount Calvary cemetery.

Mr. Wilson, in addition to his connections with the electric concern and the trust company, was a director of the Columbia Title & Trust company, and was a member of the Arlington, Multnomah and Waverly Golf clubs. He was also a member of the Knights of Columbus. During the administration of Mayor Simon he was a member of the executive board.

CRUISER CANNOT GO TO ASTORIA'S REGATTA

Washington, May 29.—The navy department has informed Senator Chamberlain that because of a reduced complement of officers and men on the cruiser St. Louis and assignment for the coast cruise of the Oregon naval militia immediately following the Rose Festival, it is inadvisable to assign it to Astoria for the regatta. There is no other vessel that can be assigned for the regatta.

JULIAN STORY'S BABES
AND NURSE ARE BURNED

London, May 29.—The babies of Julian Story, the American portrait painter, are suffering from severe burns today, sustained in the explosion of an oil stove. Their nurse is in a hospital and the children are being nursed by their mother.

MRS. C. A. COBURN IS LAID TO REST

Many Send Floral Tributes and Funeral Is Largely Attended.

With many of the leading citizens of the state present to pay their last respects, the funeral of Mrs. C. A. Coburn, a member of one of Oregon's best known families of pioneers and for years an editorial writer on the Oregonian, was held this afternoon at the First Unitarian church. The body was laid to rest in the Riverside cemetery.

Rev. W. G. Elliot, pastor of the church, conducted the services. His father, Rev. T. L. Elliot, pastor emeritus, was to assist, but was unable to return to Portland in time from Hood River, where he is visiting.

The ceremonies at the church were simple and impressive. Rev. Mr. Elliot read a few selections from the scriptures made a brief address, in which he reviewed the life of Mrs. Coburn and her achievements. John Claire Montell sang Tennyson's "Crossing the Bar," and a prayer and benediction ended the services. At the grave the committal service was held, and the body lowered into the grave.

At the church the casket was covered with flowers, tributes from friends.

The active pallbearers were John H. and Leslie M. Scott, sons of the late Harvey Scott, who was Mrs. Coburn's brother; Ralph Dunaway, Paul R. Kelly, James S. McCord, Kenneth Latourette, Wallace Eastham and Frank P. Young, all of whom were related to her.

Honorary pallbearers were H. L. Pitcock, Edgar B. Piper, Ben Selling, Judge Henry McGinn, F. V. Holman, George H. Himes and ex-governors J. T. Gear.

With the passing of Mrs. Coburn, who had been ill for several months, Oregon loses one of its leading women. She was 73 years of age, and during her active life spent much of her time working for the betterment of the living conditions of people as a whole.

She was an active member of her church, and at one time was president of the Portland Woman's union, and also a director of the Baby Home. She was born in Tazewell county, Illinois, November 30, 1839, and crossed the plains with her parents in 1852. She was married to John Coburn and settled at Canemah, Or., and on the death of her husband, in 1888, successfully supported her four daughters by teaching school. Later she went into newspaper work, and remained in it actively until her last illness.

Alleged Rioters' Preliminary Trial.

Oregon City, Or., May 29.—Two hundred union men came from Portland to attend the preliminary trial of the 12 Home Telephone company strikers accused of rioting at Oswego recently, and as the sympathizers with the company were not unconsiderable, an adjournment was forced from justice court to the circuit court room for more room. The 12 men are: Burnett Bralliar, J. W. Lash, Clyde Akeley, B. Westcott, J. Olson, E. E. Hies, G. L'Heuallen, E. Miles, Fred Reams, George Egler, C. E. Swallow and F. Trabur.

Red McKim was principal witness this forenoon. His evidence tended to show the strikers had gone to Oswego with belligerent intent. Cross-examination endeavored to bring out that the strikebreakers were wearing guns. The preliminary may last a day and a half. W. M. Davis, McDougall and Senator Dimick are defending the alleged rioters and Deputy District Attorney Lavy Sipp and Gilbert Hedges are prosecuting.

Accused of Vagrancy.

Marceline Devlet and A. Mayer were arrested last night at Kenton by deputy sheriffs. The men are accused by Sheriff Word of meeting young girls downtown and luring them out to Kenton, where the two men live in a tent.

MAYOR VINTON IS UP FOR CONTEMPT

McMinnville Official's Case Is Result of Bitter Paving Row.

Salem, Or., May 29.—The controversy over paving contracts which has been stirring McMinnville for some time took a turn bordering on the sensational here last night when Mayor William T. Vinton, who was declared to be in contempt of the circuit court, evaded the process servers and returned home. But he was served with the writ this morning and Judge Galloway will go to McMinnville this afternoon, where at 4 o'clock the mayor will be given an opportunity to show cause, if any, why he should not be punished for his refusal to obey the orders of the court.

The McMinnville city council approved paving contracts in favor of the Montague O'Reilly Paving company aggregating about \$150,000, and Mayor Vinton refused to sign them. W. S. Link brought mandamus proceedings to compel him to sign them. Judge Galloway issued an order citing Mayor Vinton to appear at 4 o'clock tomorrow to show cause why he should not be punished for contempt. But the mayor got away before the papers were served on him.

The maximum punishment for contempt is six months in jail and \$300 fine.

OVERHEAD WIRE
CONFERENCE HELD

A committee of representatives from the various telephone, power and electric companies of the state, together with a committee from the railroad commission, are meeting today in the office of the railroad commission, to adopt a satisfactory system for the arrangement of all overhead wires.

This is the final meeting of this committee and the results of their meeting will be turned over to the railroad commission for its approval or rejection. It is the purpose of the commission to have the various companies come to a satisfactory agreement as to the proper placement of power, telephone and electric lines overhead so that the line men will be protected from injuries.

SUPPLY-HOUSE FILES
INCORPORATION ARTICLES

According to the articles of incorporation of the Farmers' Supply House, Inc., which were filed with County Clerk Coffey yesterday, the company will have its principal place of business in Portland and branches wherever business warrants.
