Boy Gets \$6750 Verdict.—Balfie Robertson, just 21 years old, who lost his arm, shoulder and collarbone as the result of a blow from a crank on a gravel auto truck, received a settlement of \$6750 from the Columbia Contract company, which he was suing for \$25,000 damages in Circuit Judge Morrow's court. Young Robertson was unloading the truck with the windlass when his hand slipped from the crank. The safety dog which should have caught the crank ratchet did not work and the crank struck his arm, bruising it badly. Amputation was finally necessary to save the boy's life. The accident occurred in the night. The testimony for the boy was exceptionally strong.

Take Poison During Dependency.—In a mood of dependency over continued illness from rheumatism, Mrs. Frances Cunningham, 700 East Twenty-first street, north, committed suicide yesterday at her home by taking carbolic acid. She was formerly of Battalion Chief John Young of the fire department. She had suffered from rheumatism for two years, being confined to her room the greater part of the time. She was formerly the wife of Battalion pioneer family. Dr. E. E. Spurr, who attended her, and was called when friends discovered she had taken the acid, but the physician was unable to give relief. No inquest will be held.

THRILLING ESCAPE OF BOYS IS RECOUNTED

The escape of Wilbur Dean, 17 years old, and Cavoni Helmer, 15 years old, from the county jail several weeks ago was more thrilling than had been supposed, according to the story told by Dean to Sheriff Word, who brought the lad back from Tacoma. Dean stated that after they had opened a way through the screen at the window of the "bull pen," they managed to climb to the top of the high wall which surrounds the jail on top of the courthouse. Crawling around to the Salmon street side of the building, they found a rope left by the men who are cleaning the outside of the building. Dean started to descend this rope to the ground, six stories below. Half way down he observed two policemen standing directly underneath him. Afraid to descend farther and unable to climb, he hung there for several minutes. The policemen at last walked on and he slid to the ground. The two boys went to Vancouver, Wash., on the night of their escape, crossing the railroad bridge over the Columbia. Then they separated and Dean went to Tacoma. Helmer is not being sought, as he was merely held here for the juvenile authorities of Marshallfield. Dean is under indictment for passing bad checks.

IN EARLIER DAYS

"Shortly after I entered the commissary department of Bombay," said Captain William Gadaby, "the Russians approached Constantinople, and Dieralli, our prime minister at that time, ordered an army corps from India to embark for Cyprus and Malta. This, by the way, was the first occasion upon which native troops were taken away from India to fight the battles of the British empire. I had been appointed staff sergeant, and I had my hands full in preparing for the embarkation of the native troops. There were 25,000 native troops sent, consisting of Sikh infantry, Bengal cavalry and Ghorakas. All of the ships in Bombay harbor were commandeered for use in transporting the troops.

"The muleteers, teamsters and all of the other men experienced with horses had embarked or were absent securing mounts for the cavalry. The cavalry used small ponies from northern India, most of which were pintos. They looked like circus ponies. The ponies were received in the plaza near the Bund. Sir Richard Temple, a small man, but a perfect human dynamo, had charge of one of the three military divisions of India, with headquarters at Bombay. The commissary department was trying to make a record in dispatching the native troops. Another sergeant and myself had charge of getting the horses aboard. We put them in scows and took them out to the boats where they were put in slings and brought aboard. The ponies were unbroken, and the natives were afraid to handle them. The other sergeant and myself, to expedite matters, finally stripped down to our undershirts and trousers, and as the natives lead the ponies to the side of the lighter we would clasp hands in front and back of the pony to keep it quiet and push it into the scow. Neither myself nor the other sergeant happened to notice a small scow who was watching our work. It turned out, however, that it was Sir Richard Temple. He recommended to the commanding general of the department that for our initiative and industry in expediting the shipment of horses we be given commissions. The matter was brought to the attention of the government of India, and it was decided that the regulations would not allow his recommendation to be put into effect, as there were no vacancies on the commissioned staff and that new positions could not be created. The governor of Bombay that a cash bonus be given us in lieu of a commission. We were called before the commanding officer and told of Sir Richard Temple's recommendation. We were asked if we would not accept, in lieu of a commission, 1000 rupees. I rather hesitated, and said, 'Well, 2000 rupees would be so bad,' and so the officer said, 'Very well, I'll recommend that you each be given 2000 rupees.'

"It so happened that I had contracted fever, and had to go to the Bombay hospital, where I stayed for three months. Later I was sent as a convalescent to Deolali, a hill station, where I spent three months more in regaining my strength. Those at the head of the government affairs had amicably settled up their national troubles, so the troops were recalled, and I was ordered back to Bombay to help unload the native troops who were returning from Malta and Cyprus. "Ever since I had been away from England I had been corresponding with my sweetheart, urging her to come to India to be married. She finally notified me that she was coming and would take the next steamer for India. You can imagine how slow the time dragged while the steamer was on its way. While helping unload the troops some one told me the steamer had come in ahead of time and was in the harbor. I secured a leave of absence and hired some native boatmen to take me out to the steamer. I never in my life saw a boat go so slowly. I first threatened, and finally bribed the boatmen to hurry. We finally arrived at the boat, and I went up the rope ladder in a rush. The girl I had left in England was a slender little mite of a girl, 16 years old with wavy brown hair and blue eyes. I went into

the ladies' cabin, and, seeing her, I could not restrain my impatience. Catching her up in my arms I pressed her close to me, and in spite of those who were standing around I kissed her with all of the ardor you can imagine. I would have waited for several years. Enthusiastic as was my greeting, she seemed to lack just a little in cordiality. Finally she withdrew from my clasp, and said, 'would you mind telling me who you are?'

"I looked at her in astonishment and said, 'Aren't you Nelly?'

"She said, 'I certainly am not. There's a young lady by that name out on the deck looking for her lover.'

"I never had the wind so completely taken out of my sails in my life. I went out on the deck and bashfully and timidly shook hands with Nelly. "Aren't you glad to see me, Will?" she asked.

"I told her I was so overcome that I couldn't express how glad I was. To tell you the truth, I was overcome, for I had left a little bit of a fragile girl in England, and this plump, well-developed woman seemed like a perfect stranger. I had forgotten that four years was going to make a difference with both of us. I expected to find the same girl I had left. As we went back in the boat I heard the boatmen talking in Hindustani. One of them said, 'Why, this man isn't as crazy as we thought he was. He don't seem in such a terrible hurry as he did. He don't seem to care whether we get to shore in a hurry or not. I am afraid he won't give us the extra money he promised.'

"It took me a week or two to get reacquainted with my wife, but I finally discovered she was the same, sweet girl I left England."

PORTLAND BUSINESS MEN WATCH TARIFF

The tariff bill pending in the United States senate will go into effect immediately upon its passage unless the bill is amended to the contrary. The bill passed the house May 1, and the senate fight centers on the wool and sugar subsidies. The bill as it now stands provides for free raw wool and wool waste, but imposes a reduced duty on woolen manufactures. Sugar and various products of sugar will be subject to a reduced duty until May 1, 1916, after which time they will be placed on the free list.

Portland business men are keeping close watch on the bill, for the reason that uncertain schedules interfere with future contracts. Reports from Washington are to the effect that should the senate materially change the house bill and refuse to recede in conference, President Wilson will veto the bill. In that event tariff legislation would go over until the next regular session of congress and tariff makers under the president should call a special session for the summer months.
