Saloon Man Acquitted.—Because Mose Alverado is a Spaniard and Ruby Metcalf is a citizen Indian, Gus Olson, a saloon owner of Toledo, who was indicted for selling liquor to the two, has been found not guilty by a jury in the federal court. The fact was definitely established that Olson sold the two the liquor, and the question for the jury to decide was whether the citizenship and naturalization qualifications of the men forbid their purchasing it. Alverado and Metcalf are residents of the Siletz reservation. The government rewarded its two witnesses, Alverado and Metcalf, by informing them to come into federal court tomorrow morning and enter a plea to the indictments against them, charging introduction of the booze on the reservation. As both have expressed a desire to plead guilty, they will probably be obliged to spend most of the summer in the county jail.

Says Road Had Incompetent Doctor.—Claiming that the United Railways had an inexperienced and incompetent physician care for Tudor Moché, and that in administering the anesthetic the physician did not use proper care, Nick Evanoff, administrator of the Tudor estate, is suing the railway for \$7500 damages. Evanoff claims that the anesthetic caused Moché's death.

Portland Art Association.—The annual meeting of the Portland Art association will be held Monday afternoon, June 9, at 4 o'clock, in the Museum of Art, Fifth and Taylor streets. A new loan collection of paintings will be shown and, in the downstairs galleries, the Pennell lithographs of the Panama canal, and etchings by Piranesi. Tea will be served at 5 o'clock.

Dr. McGaw in Albany.—Dr. James S. McGaw, national field secretary of the World's Christian Citizenship conference, to meet in this city Sunday in July 6, will speak at Albany Sunday in the interests of the conference. In the morning he will preach in one of the local churches and in the afternoon will address a mass meeting of all the churches in the armory.

Saloon Wins Over Protesters.—Over the vehement protest of residents in the neighborhood of the east approach of the Broadway bridge, the liquor license committee of the city council yesterday afternoon recommended the granting of a transfer of a license to permit Doane Ruhnke to conduct a saloon on East Broadway, near the bridge approach.

Basements Flooded.—Scores of firms have had to vacate their basements on account of high water. Many are now installing motor driven pumps, rented from the Standard Machinery Co., at 46 Second st. In so doing they have saved themselves from much trouble, damage and loss of money.

Judge Morrow to Judge Parade.—Circuit Judge Morrow has accepted the invitation of C. J. Cook, marshal of the Automobile club's parade next Wednesday, to act as one of the judges of the divisions of clubs and organizations of the parade.

Sues Vetsch for \$20,000.—A suit for \$20,000 damages and the reformation of

a contract was filed yesterday by W. J. Patterson against Andreas and Peter Vetsch. Patterson alleges that after the Vetschs had bargained to sell him the butter and milk business of the Damascus creamery, including the trade name, routes, milk stations and wholesale and retail business, and he had paid \$2500 on an option to bind the deal the Vetschs advertised that they had given him an option on only the retail business. He says that this advertising spoiled his efforts to organize the Portland Milk company, which was to take over the business. He asks the monetary damages and that the contract be made to include the entire business.

Spit Settled for \$3,000.—A settlement was reached this morning in the suit of Williams and Rasmussen against Philip Gevurtz by which Gevurtz is to pay the firm \$3,000 for plans and specifications which they prepared for the building, which he proposed to erect at Twentieth and Everett streets. The building was to be a \$275,000 apartment house and they were to receive three per cent as commission they claimed. Gevurtz claimed they submitted the plans of their own record and not on order. They asked for \$8,250 for their commission.

Portland Art Association.—Beginning with Rose Festival week, the special summer exhibitions at the museum of art are open to visitors. These consist of a gallery of paintings lent by Portland owners, the large Pennell lithographs of the work at the Panama canal and etchings of antique architecture by Piranesi. The museum hours are: weekdays, 9 to 5 o'clock; Sundays, 2 to 5; free the afternoons of Sunday, Tuesday, Thursday, Friday and Saturday. Corner Fifth and Taylor streets.

Chambers Now Sued for Divorce.—A divorce suit against Charles Chambers, who pleaded guilty Thursday to assault on his 15-year-old step-daughter and was sentenced to from one to 10 years in the penitentiary by Circuit Judge Kavanaugh, was filed yesterday by Lena J. Chambers. The felony statute was taken as the basis. Mrs. Chambers asks the return of her maiden name, Lena J. Eaton. They were married in Oregon City, May 17, 1911.

Sentenced for Fast Driving.—Five days on the rockpile was the sentence given Harry Warren, driver for the City Taxicab company, this morning in the municipal court for reckless driving Wednesday evening. Evidence submitted showed Warren was going at an unlawful rate of speed at Sixth and Couch streets, where he struck an automobile of the taxi company, knocking out the driver and a passenger.

Passes Cigars to Friends.—Chief Engineer of Construction R. E. Kremers of the department of city building inspection, spent the morning receiving congratulations and passing around a box of cigars to his friends at the city hall. The occasion was a visit of the stork to the Kremers residence on E. Salmon street, the long legged bird having brought a baby girl weighing 7½ pounds.

Arrested for Trespass.—J. J. Finn was arrested for trespassing yesterday afternoon in the home of Mrs. E. B. Hawes, 175 Twelfth street. The man was seen in a room there, but ran away when detected. A roomer at the place caught him and called the police. Hearing will be given Finn Monday morning in the municipal court.

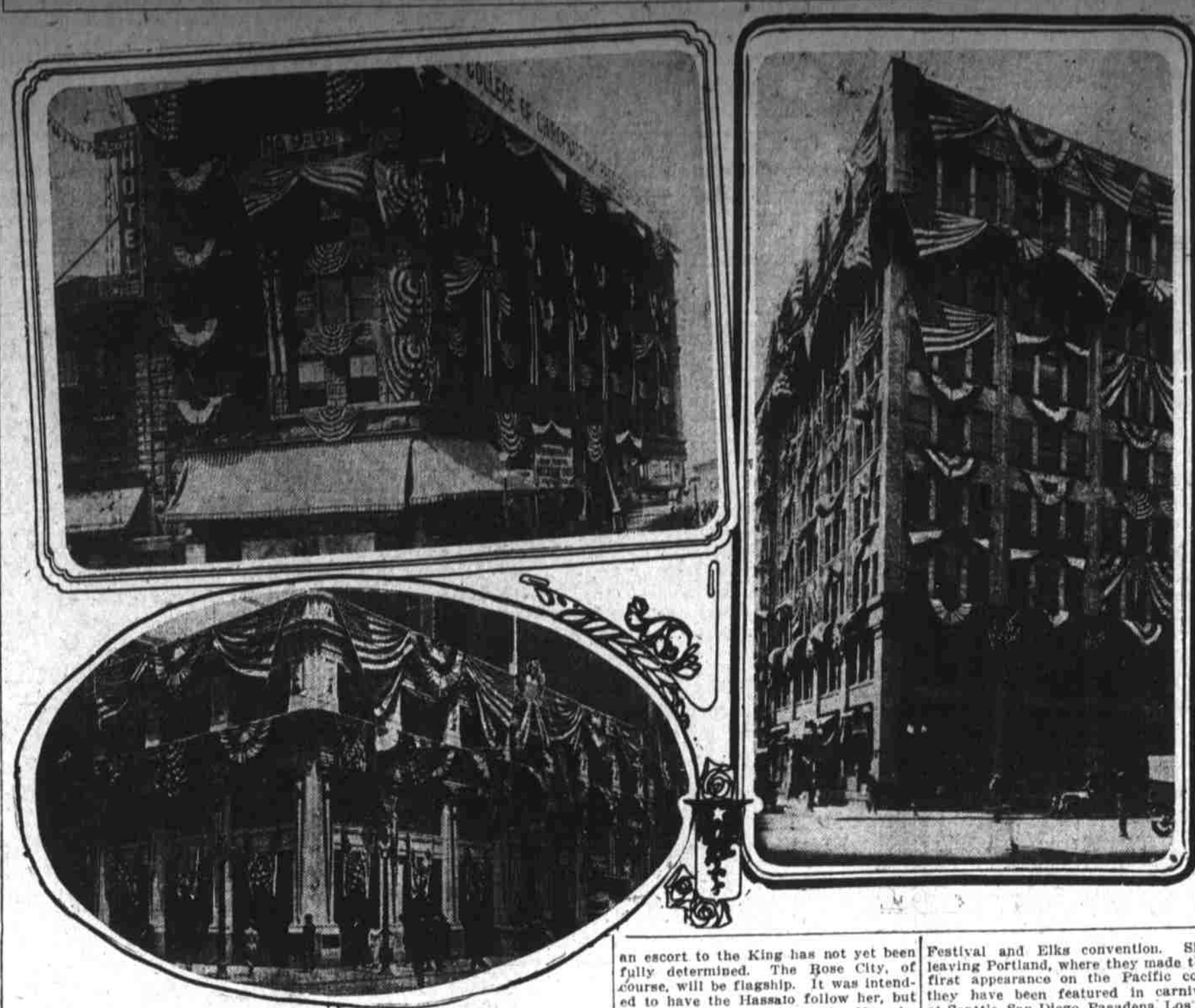

IN EARLIER DAYS

"At about the time I began raising sheep I sent to Texas for some Angora goats," said J. B. Stump of Monmouth, who is an Oregon native son and one of the pioneer stock raisers. "Of course, you know that Polk county is recognized as the Angora goat center of the United States, no finer Angoras being raised anywhere than here in the Willamette valley. The story of the Angora goat industry is wonderfully interesting. Way back in the dawn of history we read of the Angora goats. The early pastoral people whose wealth consisted entirely of flocks and herds raised goats and Moses had the Israelite craftsmen spin Angora goat hair for the curtains in the Temple. The name 'Angora' comes from the village of Angora in Asia Minor, a district about 220 miles southeast of Constantinople.

"In the year of the California gold discovery, 1849, the United States had a southerly by the name of Dr. Davis as representative in Turkey. He gave the sultan information about the growth of cotton and in return the sultan presented him with nine Angora goats. These Angora goats were the first ever brought to the United States and for many years nothing was heard of them. They finally fell into the hands of a man who took an interest in them and eventually some were sent to Texas and others to southern California. A good many years ago Cecil Rhodes secured a permit from the sultan of Turkey and brought over a shipment of Angora goats to South Africa. From these two strains I secured my best bucks. I sent to South Africa and secured one or two of the best bucks from the Cecil Rhodes importation, paying \$200 apiece for them. I still have some of the bucks that I purchased 15 years ago. They are wonderfully strong and hardy. It is impossible now to get any of the Angoras from Turkey or Asia. Minor importation, the sultan has forbidden the exportation of any Angora goats from that country. South Africa put a duty of \$500 per animal on the exportation of their Angoras to other countries which, of course, made it prohibitive and they are now planning to forbid exportation entirely.

"When you remember that the Angoras averaged this year five pounds and that the mohair sells for an average of about 32 cents you can readily understand why it will pay to import Angora bucks that will shear as high as 15 pounds. The increased quantity as well as quality of the fleece and its offspring will more than pay the high price paid for the bucks. I received 44 cents a pound for all of my mohair on account of its grading highest quality. 'I usually keep from 500 to 600 Angoras. They do better on hill land where they can climb over rocks and brush. By nature they are like deer and love to live in a wild country. For a man who is taking a place in the mountains they are a godsend as they will browse down the brush, furnish him meat, and the milk of the young kids is greatly esteemed by many people. By putting blue-stone between their hoofs occasionally, to keep their feet healthy they do well here. Most of the Willamette valley bucks are shipped to Utah, New Mexico, Arizona or Texas, where they bring, as you know, from \$25 to \$100 apiece.

"Mohair cannot be manufactured where the climate is dry or where there is alkali in the water. Bradford, England, has always been considered the center of the mohair industry on account of the pureness of its water and its moist climate. The climate of England and the Willamette valley are very similar. We have an abundance of pure water and the moisture of our climate makes this an ideal district for the manufacture of mohair or wool. The time will come when we will utilize to greater advantage, our water power and be able to produce power at a price that will make the Willamette valley the center of the wool manufacturing industry. A through sleeping car service between Portland and Lewiston, Ida., will be established by the Spokane, Portland & Seattle and Northern Pacific Railway for the Rose Festival period. In addition to this the Oregon Electric management are preparing to add extra equipment to all of their regular trains and to also run special trains if necessary.

Success of Commission Depends on Cooperation of All Good Citizens, Declares the Mayor-Elect to Retailers.

The promises of the commission charter campaign were repeated as pledges by the mayor and commissioners-elect at the dinner of the Retail Merchants association in the Commercial Club last night.

It had been said that under commission government the city's business would be done in the light. Mayor-elect Albee said this should be the policy and rule. It had been promised that mayor and commissioners would meet the people and hear their complaints and suggestions. Commissioners-elect Daly, Brewster and Bigelow declared this would indeed be the case.

Mayor-elect Albee predicted an administration of entire harmony and added that it was his belief that under the administration the city will prosper.

On one point all were agreed. They said that without the support of good people definitely directed the administration will be a failure no matter how good its intentions.

"We greatly desire good government, but the people not the officials will be responsible for it. The support of the people is vital," said Mayor-elect Albee.

G. F. Johnson, chairman of the executive committee of the Commercial club, and William Young, Portland manager for R. G. Dun & Co., delivered addresses on "Optimism." Both took occasion to condemn the foolish gossip that has been apparently systematically circulated intimating that Portland's business is not in good condition. Mr. Johnson showed how gas and water users, telephone subscribers, postal receipts, population, have all greatly increased during the past year. He said that the prospects for an excellent wheat crop are good, and that the agricultural prospects of the state generally, are brighter than ever before.

President E. J. Jaeger of the association presided. Nearly two hundred of the retail merchants attended. A feature of the meeting was the report of the secretary, W. B. Shively, on the success of efforts to detect "bad check artists."

Robert G. Dieck, one of the four commissioners-elect, was unable to attend the dinner as he had left the city to rest before assuming the duties of his office, July 1.

Some time ago the association sent letters to all candidates inviting them to attend the meeting last night in the event that they should be elected. The invitations were quite generally accepted. The mayor and commissioners-elect were received with great enthusiasm.
