Found Guilty of Embezzlement.—Conflicting statements of Percy J. Wood practically convicted him of embezzlement and the jury in Circuit Judge Morrow's court, which heard the evidence in the case, brought in a verdict of guilty. He was charged with having taken \$190 and some tools from J. E. Williams, to whom he had sold a butcher shop and for whom he was working at the time. He admitted taking part of the money and became so confused in his statements that he lost all chance of winning his case. He fled to Vancouver, B. C., after the theft, and was brought back after his arrest there.

Woman Stenographer Arrested.—Katherine Walker, a public stenographer in the Yeon building, was arrested this morning in room 905 of that building, on a charge of creating a disturbance. Marion Drummond, also a stenographer at the office, filed the complaint. Patrolman Cason made the arrest. Miss Drummond complained that Miss Walker had purchased one-half interest in the public stenographic business, making a part payment. This morning the question of paying the balance was under consideration, when the trouble took place. The case will be heard Friday morning in the municipal court.

Dr. Morrison Files Answer.—A motion to compel Mrs. Marcella Clark to make points in her \$25,000 damage suit more definite and certain was filed yesterday by Dr. A. A. Morrison, rector of Trinity Episcopal church. He demands that she name those who overheard alleged insulting remarks by him to her and that she answer some technical questions. This is the first action taken by Dr. Morrison in the suit.

To Speak at Chautauqua.—Several distinguished foreigners who have come to America to take part in the World's Christian Citizenship conference, to be held at Portland from June 29 to July 6,

will fill engagements at the Chautauqua assembly at Boise, Idaho. Among these will be: Rev. Robert J. ("Catch-My-Pal") Patterson of Belfast, Ireland; Rev. John Lamond, B. D., Edinburgh, Scotland; Dr. Charles Marie d'Aubigne, Paris; and Ng Poon Chew, Canton, China. Dr. James S. McGraw, national field secretary of the conference, spoke at Boise today.

Hidden Diamond in Cream Pot.—A pot of face cream was what Mrs. Mary McNaughton used in which to hide a diamond she found in the room of L. M. Star at the Cadillac hotel. Star lost the jewel several days ago from his ring. The woman, who is the chambermaid at the place, found the diamond on the floor. Detectives Hyde and Vaughn secured a search warrant this morning, but the woman produced the diamond before they had time to search for it. The diamond is valued at \$200.

"Sheriff Word" Bloodhound.—Sheriff Tom is the latest acquisition to Sheriff Word's office. He is a young thoroughbred bloodhound, recently purchased by Word. His name was given by William Mack, superintendent of Kelly Butte rockpile, who will have charge of training the animal so he can be used in tracing criminals. This is the first time in several years that a sheriff of Multnomah county has owned a bloodhound for use.

Man's Finger Nearly Pulled Off.—While trying to arrest Fred Peterson last evening at 105 Third street, Patrolman Manning pulled Peterson's little finger almost off. Peterson held on to a rail while the officer attempted to pull him away. At the hospital, 14 stitches were required to repair the injured finger.

Given Heavy Sentence.—Louis Zimelli was sentenced to serve six months on the rockpile and pay a fine of \$100, by Judge Jones of the district court yesterday afternoon. Zimelli was arrested several days ago on a vagrancy charge by Deputy Sheriffs Tennant and Aldrich, who in charge of the work of arresting vagrants. This is the third man to receive a sentence this heavy. The sentence given by Judge Jones is the maximum penalty.

Gets Judgment for \$2500.—James January was given judgment for \$2500 against the Alameda Consolidated Mines company by a jury in Circuit Judge McGinn's court yesterday. He brought suit to recover because of alleged failure of the company to transfer 500 shares of stock to him. The company expressed willingness to transfer the stock but wanted legal orders to whom it should be transferred.

Solicitor Found Guilty.—Arthur Levine, a newspaper solicitor and alleged short-change artist, was found guilty this morning in the municipal court for attempting to short change T. C. Peterson at the latter's cigar store, 53 Third street. Levine was also identified by the proprietor of a restaurant, who said he attempted the same game on him. Sentence will be passed Monday.

Hatfield. Mrs. Hatfield is the only heir. The estate consists of 150 shares of stock in the Brown Shoe company of St. Louis, Mo., valued at \$15,000, and property in Irvington worth \$8500.

IN-EARLIER DAYS

By Fred Lockley.

"My father's name was Meyer Rosenblatt," said Louis Rosenblatt. "He came from Bavaria in 1853. He was a poor emigrant and all the capital he had when he came to America was pluck and a determination to succeed. He borrowed money in New York and in the spring of 1854 he came to Portland. Or. His brother had preceded him six months to New York city and had also come to Portland six months before."

"When my father came to Portland there was a firm here that used to outfit peddlers, trusting them for their goods. The young German Jews were honest and were hard workers. If you will track back the history of many of the wealthy families in Portland, you will find they started just as my father did, with a pack on his back, traveling on foot through the country selling goods. My father traveled out of Portland carrying the ordinary general merchandise carried by peddlers. He convinced the store that he could build up a profitable trade by going by wharboat up and down the Willamette river, stopping at each farmhouse."

"In his trips he visited Eugene and as it supplied a wide territory, he decided to open a general merchandise store there. His brother Simon went in with him and they soon had established a profitable business. The store was on Willamette street in Eugene and our family lived over the store. I was born there 44 years ago. I'll tell you an interesting thing about it. When father sold this place to the Matlock brothers he bought the northwest corner of Fourth and Morrison streets. That \$3500 investment is now worth \$40,000."

"Some men value one thing and some another. My father's great pride was in the confidence and trust of the people. The fact that they called him Honest Meyer was always a source of great satisfaction to him. When we were boys he was always telling us that he wanted to hand down a good name and wanted us to maintain it. The fact that we have been in Oregon since 1854 and never had a fire sale nor an assignee sale nor even been sued for the goods that we are trying to maintain the reputation that father built up."

"Here is just one little instance of how a thing of that kind works out. When my brother Sam went to Henry Taylor, of Astoria, he paid \$100,000 to put up a brick building on the corner of Fourth and Morrison streets. Henry Taylor asked him what his name was. He told him. Mr. Taylor then said: 'Are you a son of Meyer Rosenblatt, who used to be a peddler?' Sam told him that he was. Mr. Taylor said: 'When I used to be a traveling man and would go to Eugene, I used to stay at your father's place. He had a room over the store that I used to occupy. All I want from you for a \$20,000 is to let me have the room over the store. That's all the security necessary. I know what kind of stock you come from.'"

"In the early days in Eugene a great deal of the trade was done by barter. The people would trade their hogs into bacon, bring the bacon in and exchange it for groceries and dry goods. We shipped the bacon to Allen & Lewis. 'My mother had friends in Portland and came down here and heard of a tract of land and had counted for \$4000 dollars. She told my father about it and suggested that he sell the bacon on hand, which amounted to a little over \$4000, and buy the property. My father's brother Simon said: 'No merchant should take his capital and put it in real estate. We need it to turn over in the business.' Jacob Kamm bought it and it is now known as the Kamm property and is immensely valuable. Meanwhile the bacon moulded and most of it spoiled."

"In the latter part of the Civil war and for some time thereafter greenbacks were at a discount. The merchants would pay their debts in greenbacks. My father used to do a very peculiar thing. He would get greenbacks in trade, take them to the bank, pay the difference to get gold and pay all of his bills in gold. He said he had a reputation for integrity to maintain and it was worth paying a little premium to do so."

"That reminds me of a peculiar incident that happened to him in the Civil war times. They raised a revenue stamp to be attached to all canned goods. A deputy sheriff from the United States marshal's office came down to Eugene and represented himself to be a camper who wanted to get a supply of canned goods to go out camping on the McKenzie river. He asked my father to let him get greenbacks in trade, take them to the bank, pay the difference to get gold and pay all of his bills in gold. He said he had a reputation for integrity to maintain and it was worth paying a little premium to do so."

"In 1879 we moved to Portland. My father had a store on Front street, between Stark and Washington. In those days Front street was the principal business district. A little later he moved to 107 Front street, between Alder and Morrison, where he bought a two story brick building. My brother Sam was born in a little cottage on the Fourth street side of where the Chamber of Commerce building now stands. My mother had come up to Portland shortly before his birth and returned to Eugene a little later."

"My father and my sister Carrie were passengers on the first east bound train that ever left Portland. My father went to New York to visit his sister. That must have been about 1884."

"I never forgot one thing my father said. He said that leaving money was a very little value to one's children unless the home training had been such that they knew how to use it wisely. They must have, not only an education, but good character, or the money would do them no good."

RUNAWAYS ON STEEP GRADE LEAP OVER LIGHT. RIG AHEAD; 2 BABES HAVE MARVELOUS ESCAPE

(Special to The Journal.) Goldendale, Wash., June 10.—A team of runaways drawing a heavy lumber wagon overtook a light open hack in which Sam Shell, an elderly farmer of Pleasant Valley, his wife, their daughter, Mrs. Hattie Lahey, of Castlerock, and her two small children were driving, on the steep down grade in the Columbia hills between Pleasant Valley and Chamberlain flat on the Columbia river, Tuesday.

The runaways plunged entirely over the back and the lumber wagon lodged on top of it, hurled to the road under the hoofs of the plunging horses. Mr. and Mrs. Shell and Mrs. Lahey were all knocked unconscious. They and the two little children escaped death by the merest chance.

The only warning the occupants of the light vehicle had of the approach of the runaways was the sudden clatter of hoofs and the rattle of the big wagon as the team appeared right behind them around a curve. Before Mr. Shell could

whip up his own team, the straining draft horses were upon them.

Mrs. Lahey was in the back seat with her children. She was made unconscious by the collision. When she regained her senses she was 40 feet down the road in front of the vehicle, where she had been thrown. The first thing she saw was her baby under the feet of the runaway team, which had come to a stop in front of the hack, almost as if it had been there in the place of the hack team, which had bolted. She rescued the infant, which was unhurt, and the other child, 3 years old, crawled out from under the team.

Then Mrs. Lahey turned her attention to her father and mother. They were jammed under the wreck, both unconscious. The physician who attended Mr. Shell said that there was hardly a square inch of skin on his body that had not been bruised. His right leg and his head were also severely cut. His hurts are not dangerous.

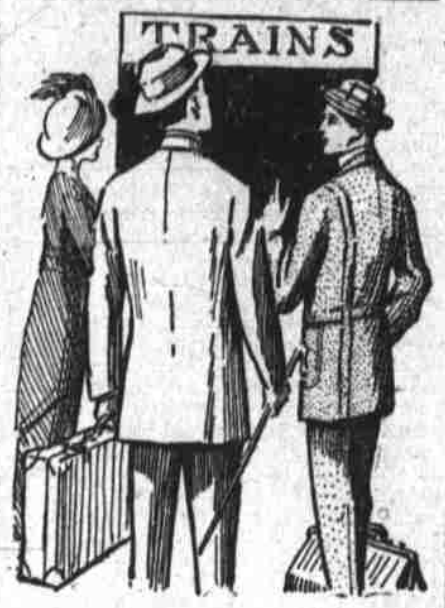
Mrs. Shell and Mrs. Lahey were badly bruised but there was not so much as a scratch on the children.

MATTHIEU INVITED AS ROTARIANS' GUEST

F. X. Matthieu, the only survivor of the historic group that signed the agreement for Oregon's first provisional government, has been asked by the Rotary club to be guest of honor at the picnic to be held at Champego next Saturday. Mr. Matthieu will accept if weather conditions permit. Mayor-elect Albee and Commissioners-elect Brewster, Bigelow, Daly and Dick are also to be among the guests of honor, according to announcement today by the committee on arrangements. The day is to be given up to rymaking and a fine is to be imposed on the Rotarian who mentions business.

Leaving on the Grahamona from Taylor street dock at 8:45 o'clock Saturday morning the picnic party will arrive at the grounds about the middle of the forenoon. There will be old fashioned games and contests. A prize will be awarded to the winner of a sack race that is open to all. Boys and girls under 7 are eligible to enter for a 50 yard dash for which the prizes will be awarded. Boys under 14 will compete for the bat and ball and other prizes offered the winners of a potato race. A Turkish bath and a shaving cup are offered the winners of a 100 yard dash. To be eligible to enter the races must weigh 200 pounds or more. A Victrola and a pair of gloves are the prizes to be awarded the winners of a 50 yard dash open to the wives of Rotarians. A silver spoon and a doll will be given as first and second prizes to girls under 14 who enter for a 50 yard dash. Young women who win a 50 yard dash will receive a box of stationery and an order for flowers as prizes. But one prize—the applause of the multitude—is to be awarded the winner of a 100 yard dash open only to trustees of the club. A big box of candy is to be awarded the Rotarian who brings the biggest family.
