Death Waits Petition.—The formality of dismissing the application of Joseph Isidor Schaeffer, a German butcher of 577 Bybee street, was made necessary yesterday at the naturalization hearing before Circuit Judge Gatens because of the death of the applicant on April 22 last. Schaeffer died two and a half months after making application for his final citizenship papers. Two applications were denied yesterday because the applicants deserted ships and applied during the time they were subject to deportation. Both applicants must begin over and cannot complete the process now before 1916. In all, 27 were admitted yesterday to citizenship and four were denied.

Robbers Enter Store.—The store of J. L. Smith, 1651 East Thirteenth street, was entered last night by burglars, who stole several pieces of cutlery and clothing. Entrance was gained by forcing a rear window. The room of L. H. Gray, 94 North Fourteenth street, was entered yesterday and a suit of clothes stolen. This is the second week in a row that burglars have been successful in stealing property from the store. In case of burglaries the police can be reached by calling Main 212 or A-2121.

Rev. de Lance Wallace Re-elected.—The Rev. de Lance Wallace was re-elected district superintendent for Oregon and Washington by the assembly of the Church of the Nazarene, East Seventh and Couch streets, yesterday. There was a rally in the afternoon, and last night Professor E. T. Ellison preached. About 215 delegates were present. It was said that membership has largely increased in the last year.

Barn Must Be Sanitary.—Peter Lehr, 330 Grand avenue, has one week in which to tear down his barn or place it in sanitary condition. The order came from the municipal court, where Lehr has been charged with maintaining a nuisance in his garbage wagon and barn. 1200 boys. From these they were to pick out 20. My boy was one of the 20 selected from the 1200. His name is Jay Yu Tin, and he is at the Tsing Hun college at Peking. He is my second son. My third son is named Jay Chow. He took the first prize in competition with 250 of the students, so you see I am very proud of my children.

We see the Chinamen on our streets, going along with their impassive faces, and we haven't the faintest conception of what is going on back of that placid countenance. The old Chinese gods are losing their hold upon the people. Kwan Ti, the God of War, is losing his power. Chee Kung Tong, or put it in English, "The Most Just Hall," no longer exercises its old-time influence. After centuries of inertia, the Chinese, like the Japanese, are taking up western civilization, and the world is going to be surprised at the progress they will make.

Most of the Chinese we have in the United States come from a single province, the province of which Canton is the capital. In the early days, when the Chinese first came to the United States, they had as their destination California. This was in the days when gold mining was California's principal occupation, and so the United States became known in China as "the land of the golden hills," and they still speak of coming to "the land of the golden hills."

There is much in the Chinese character that is childish. For example, a mother in giving her boy a "milk name" often gives him a rather silly name to fool the evil spirits into thinking that the boy is of little consequence, and that she does not care for him. She is afraid if she shows her affection for him by giving him a name that she values, the evil spirits will think that he is valuable, and take him.

If next New Year you get from your Chinese friend a slip of red paper with a lot of intricate characters winding up and down the page, just hand it to your stenographer and she will translate it something like this: "May the Chinese be at peace and the foreigners in harmony, and may the five blessings descend upon your door."

JUDGE GATENS FILLS TWO ROLES AT ONCE Circuit Judge Gatens filled two judicial roles yesterday at the same time. An application for a writ of habeas corpus by Mrs. Georgia Holman for the custody of her 5-year-old son was before him as circuit judge and a petition by Mr. and Mrs. Shannon, uncle and aunt of Mrs. Holman, to have the mother declared an improper person to care for the boy, was before him as juvenile judge.

Testimony was taken in the two cases at the same time and Judge Gatens decided that for the best interests of the boy he should be left with the Shannons. The testimony of the Shannons and others was directed at the character of Mrs. Holman. She had retained a lawyer by declaring that the witnesses against her told "a pack of lies."

The testimony showed that Mrs. Holman was with the boy only until he was 13 months old and that he has been with Mr. and Mrs. Shannon since. Mrs. Holman said she wished to take him to New York, where she goes soon to live. She became hysterical when denied the custody of the boy. To legalize his action Judge Gatens dismissed the case against Mrs. Holman, made the boy a ward of the juvenile court and turned him over to the Shannons temporarily. The Holmans are separated and the father will have an opportunity to make known his wishes before the Shannons are permitted to adopt him.

Contract Canceled by School Board Satisfied that the firm of Foster & Co. is in no position to complete its contract for the construction of the new Ainsworth school building, the school board at a special meeting last night finally decided to stand by its action, taken 29 days ago, and terminated the contract.

The district will now go ahead and finish the structure itself. The building is about one half completed. When the matter came up for settlement last night neither partner of the Foster concern was present, although it was understood a representative was to attend.

Although the district will undertake the completion of the work and pay for all materials and labor put into the building, the board of trustees of Foster & Co. will have to look either to the concern itself or its bondsmen for their pay.

The board decided to terminate the contract the 29th of last month, but postponed action to give the contractors full opportunity to get their affairs in shape to finish the job. Several meetings in regard to the matter have been held, but nothing was achieved beyond the securing an excellent collection of reasons why the work was delayed.

Foster & Co. repeatedly demanded that the work be allowed to proceed, but subcontractors and the concern's financial agents informed the board that they would not advance any more materials or money until they were paid for materials already used.

The ride over the nursery grounds and to the adjoining farms was a revelation to the visitors, who saw the Willamette valley at its best, and opened their eyes to the horticultural and farming possibilities of Oregon.

The efforts of Mr. McDonald, Mr. Small, Mr. Perry and others connected with the nursery to show everything of interest was greatly appreciated by the guests, who said they would remember their visit to this garden spot of the Willamette valley.
