

BODY IDENTIFIED AS THAT OF FORT STEVENS SOLDIER

Sergeant Murphy and Private
Bingo Certain Man Drowned
Near North Jetty Is Wit-
ness Who Disappeared.

(Special to The Journal.)
Aberdeen, Wash., June 26.—The body of the soldier found on the north jetty June 19 was positively identified yesterday as that of J. C. Crawford, the private who disappeared from Fort Stevens, Oregon, June 2.

Sergeant Murphy and J. W. Bingo, a private, who were sent to Hogue Island to make an investigation, found that the number of a key which was in one of the pockets of the dead man corresponded with that of the locker Crawford used at the fort. Not only did the general description of the body tally with that of Crawford, but the initials, "J. C. C." found in the shoes corroborated other evidence. The initials "F. H." found in the leggings are accounted for by the fact that a short time before his disappearance Crawford had traded with a comrade named Frank Holbrook.

Sergeant Murphy and Bingo have returned from San Francisco, where they were detailed to search for another missing man, also wanted as a witness against private Coffman, accused of circulating seditious literature in the fort. He was ill in a hospital, where he had been taken just prior to the time for his departure for Fort Stevens. Both men and a third, still unaccounted for, were material witnesses against Coffman and all mysteriously disappeared just before the date of the trial.

Private Crawford was last seen alive about 11 o'clock the night of June 2, when he left a saloon at Hammond, a small town near Fort Stevens, and started for the fort after purchasing a flask of whiskey. He was then intoxicated. The broken flask was found in his trousers pocket, and the body was brought to Hogue Island for interment.

Bingo and Crawford were old friends, having served in the same company together before they went to Fort Stevens, but Bingo does not know the whereabouts of the dead man's relatives.

NAVY MILITIAMAN KEPT ISOLATED

Portland Youth Kept Isolated
on Cruiser; Suspected of
Smallpox.

The most novel experience of the cruise of the Oregon Naval Militiaman to San Francisco bay on the steamer St. Louis, befell William Healy, 436 Sixteenth street, North Portland, who made the voyage in sick bay, meaning in isolation. Young Healy was separated from the rest of the boys on the cruise by three watertight compartments and air tight doors. Early in the cruise Healy showed suspicious symptoms of a mild case of smallpox. He was kept in isolation and by the time the St. Louis reached Frisco, his case had developed to such an extent that there was no question about it.

Regular marines on the St. Louis and Oregon militiamen who could not show signs of large vaccination scars of recent vaccination were kept in isolation. No further cases developed.

The Oregon boys, except Healy, arrived home last night aboard the "Hawaii." Healy was left at the quarantine station off Astoria, where he will be given every care until completely recovered.

The boys report a splendid trip, crammed with interesting experience and adventure, to say nothing of hard work. The militia boys were subjected to all the drills, exercises and labors of the regular enlisted men, and they did their part with commendable dispatch and vigor. The drills included everything from "man overboard" to "abandon ship," and nothing happened aboard but what served to teach the militia boys something or to make them more confident in tactics with which they were already familiar.

"The trip was one of the best we ever had," said Louis J. Wolf, physician aboard the St. Louis. "We were treated splendidly by officers and men aboard the cruiser, and everything went along very well and smoothly. The boys had a chance to learn a good deal and I believe they did. It was certainly good experience. The local boys made a splendid showing in the various boat drills and the like, and gave a good account of themselves in general. Two more can't be said for the courtesy of Captain Whitehead and other officers of the St. Louis."

The St. Louis has gone to Bremerton and will later go to Tacoma as a feature of the Montanara Fests there.

PRACTICALLY FINISHES STRAW BOND CASES

Deputy City Attorney Ray Sullivan practically cleaned up the "straw bond" cases when he secured judgment against M. Goldberg and N. J. Wade this morning for \$250. The two went bonds for Lena Dunbar, who was convicted in the municipal court of vagrancy and sentenced to 60 days in jail on her appeal. Judge Gantenbein found her guilty last winter when her appeal case was heard. Today Circuit Judge Parker gave judgment for the amount of the bonds against Goldberg and the Wade woman.

In another case of the same nature against John Parker and H. Harris, who went the bonds for Meyer Caplan a year ago, a stipulation was made by Sullivan with Attorney Moore and Wolfe, representing the bondsmen, to allow the bond case to abide by the outcome of an appeal in the Caplan case to the supreme court. Caplan was convicted on vagrancy and given 90 days in municipal court. On appeal he was again convicted and the same sentence imposed by Judge Gantenbein. An attack was made on the constitutionality of the vagrancy ordinance and this is on appeal to the supreme court. The bonds in this case were \$250.

Judge Parker reduced the sentence of B. Schlonke, a South Portland butcher, from \$50 to \$25 on appeal, as Schlonke apologized to Mrs. Mary J. Wade for impudence and impertinence. He was convicted of having an unsanitary meat market. He pleaded guilty before Judge Parker. The 30 day sentence of Bertha Livingston for vagrancy in the municipal court was reduced to 20 days by Judge Morrow when her appeal case was brought before him this morning.

BIDS PARENTS GOODBYE; DIES UNDER OPERATION

Spokane, Wash., June 26.—After kissing his mother goodby, and telling his father not to worry, Vern Alexander, age 8 years, the only son of Mr. and Mrs. J. D. Alexander, of Spokane, leaped unaided to the operating table in Dr. R. A. Greene's office yesterday afternoon to undergo an operation for enlarged tonsils. Two hours later he was dead from loss of blood without regaining consciousness after the anesthetic was applied.

He was attended by four physicians, but all attempts to stop the blood after the operation failed, presenting a rare case to surgical science, in which the peculiar operations of lymphatics prevent blood clotting.

Suit for Damages.
The trial of a suit of Ida Decker against R. J. and Ada Williams for \$5000 damages for assault and battery, and the counter claim of the Williamses for \$10,000 damages on the same grounds against Mrs. Decker is being heard by a jury in Circuit Judge Kavanaugh's court. Mrs. Decker alleges that the Williamses beat her up when they came into her apartment to take away a sewing machine. The Williamses allege that she beat them with her fists and used a dog whip on them.

Von Klein Answers.
A demurrer has been filed by E. C. Von Klein to each of the indictments against him. One charge of larceny of \$3500 worth of jewelry from Ethel Newcomb and the other charge polygamy. He is accused of living with Miss Newcomb as her husband, though already married. Both cases will be set for hearing in the near future.

Speakers Discuss Situation.

Talks were made by A. L. Barbur, city auditor; C. S. Jackson, vice president of the Commercial club; John P. Carroll, of the Telegram; B. S. Josselyn, of the Portland Railway, Light & Power company; Ralph W. Hoyt, president, resigned, of the Rose Festival; Tom Richardson and Charles Barker.

Mr. Barbur said a tax of 25 cents on each \$1000 of assessed valuation—\$308,000,000 for 1913—should produce \$75,000 a year if the festival is to be put on a taxation basis. He said to hold a special election for the purpose of dividing into 450 or 460 precincts would cost \$20,000, unless the election service was nearly all contributed.

Mr. Jackson declared that a "piker" is one who knows within \$20 of what he has in his pocket, and added that lists of contributors to public causes should be published while the contributions are being made, instead of saving the feelings of those who don't give because of fear or other reason. Mr. Carroll warmly spoke in favor of perpetuating the Rose Festival.

Mr. Josselyn said the street car company is the largest contributor to the festival and complained that none of the papers complimented the service or mentioned the contribution of the last Rose Festival. Mr. Hoyt said the festival needed reorganization and better support.

Statement Is Seconded.

Mr. Richardson seconded a statement of Mr. Jackson that enthusiasm is more important than money and inquired why the festival cannot be made more of a social event like Mardi Gras. Mr. Baker said the speakers were very good, but would the representatives of clubs please proceed to do what they came to the meeting for—organize. FIELD CORN WILL BE NEW CROP IN OREGON

Several thousand acres of field corn will be sown along the O-W. R. & N. this summer, according to Traffic Manager R. B. Miller, who early in the year distributed among the farmers some 10,000 pounds of seed corn. This was about all that the company could get hold of.

"We sent out 10,000 pounds of seed corn to farmers in our territory," said Mr. Miller this morning, "and all of it has been planted, but that is only a comparatively small percentage of the total planted this year, for many farmers bought corn for planting."

"I should say that the area of corn planted this year will aggregate several thousand acres. Experiments have proven that field corn can be grown very successfully on the wheat lands, and the company is anxious to have it cultivated as it will mean a greater diversification of products."

RICH GIRL DROPS FROM SIGHT IN GOTHAM; HER FATHER FEARS SLAYERS

Helen McCarty, 16-Year-Old
Daughter of Broker, Disap-
pears as Did Dorothy Arnold

New York, June 26.—The Helen McCarty, 16-year-old daughter of John McCarty, a wealthy newspaper broker, may have fallen a victim of white slavers, increased today when the girl's absence was still unexplained. She disappeared Tuesday from the Hotel Langrave, where her parents reside, and vanished as utterly as did Dorothy Arnold, whose fate is still a mystery.

Miss McCarty returned recently from a convent at Torredale, Pa., where she had been a pupil. Her father sent telegrams to all her girl chums. All replied that they had not seen her.

Mrs. McCarty sent Helen on Tuesday to a nearby store on an errand, since when she has not been seen. Every hospital in New York has been visited without finding a trace of the missing girl. Miss McCarty when last seen wore her hair in two braids. She is five feet four inches tall, weighs 125 pounds and has dark brown hair. Her mother is prostrated with grief and apprehension.

COMMISSION TO MAKE SELECTIONS TOMORROW

The city commission will hold tomorrow morning one of the most important meetings since the election of a purchasing agent, municipal judge and city engineer are to be appointed. Conference will be had with representatives of the bureau of municipal research who are formulating the administrative code required under the commission charter.

A number of ordinances that it will be necessary to enact in aid of commission government will likely be discussed.

Mayor-elect Albee and Commissioner-elect Robert C. Dick have been out of the city, but they have arranged to return in time for the meeting.

The mayor-elect will nominate the municipal judge. W. L. Brewster, as commissioner of public affairs, will nominate the purchasing agent. No important office has been created by the commission charter than this. Commissioner-elect Brewster declared this morning his intention to submit the names of five selected by him as probably competent from among the number of applicants, asking the commission as a whole to vote on the five by preferential ballot.

Apparently not realizing that the position of purchasing agent will be very hard to fill many have sought the place, a number with no regard to fitness. A very quiet but earnest campaign has been waged in behalf of at least three candidates. The meeting tomorrow may be the last one before July 1, when the mayor and commissioners will assume office.

HEAT AND HUMIDITY FELL SCORE IN CHICAGO

FINDS COUNTY FINANCES IN GOOD CONDITION

The finances of Multnomah county as controlled directly by the county court are shown to be in pretty good shape, according to some figures compiled by County Auditor Martin today. There is a balance on hand up to date of \$698,033.18 in the general county fund and a balance of \$199,921.89 in the road fund, making a grand total of \$897,955.07 on hand.

On June 1 there was a balance of the county fund on hand amounting to \$746,407.44 and since then the present date \$34,415.52 has been received, making a total balance of \$780,822.96. Out of this \$81,742.78 was paid on county warrants to date, leaving a balance of \$699,080.18 on hand. In the road fund on hand June 1 was a balance of \$306,845.64 and since then \$2,615.90 has been received, making a total of \$309,461.54. There has been paid out on road warrants to date \$9,538.56, leaving a balance of \$199,921.89 in the road fund.

POLICE CATCH WHITE GIRL IN OPIUM DEN

In a raid on one of the most notorious and well protected opium dens of the city at 53 North Fourth street the police last night arrested Miss Marie Davis, a 21-year-old girl from Seattle, who was fashionably dressed. She said she had become addicted to the opium habit within the past few weeks. Police, detectives and customs inspectors have been trying for weeks to get a case against the place, the arrest last night being the first one in which a white person has been caught.

The opium den has been operated by Ah Hong, who is under indictment by the federal court for handling opium. The Chinaman's 16-year-old son, Lee Hong, was caught operating the den last night. The case against the girl will be taken before Juvenile Judge Gatens, while the Davis girl has been turned over to the department of public safety for girls until the case in the municipal court can be heard.

Customs Inspector McGrath this morning in court declared: "The federal officers have been watching this place for months. Officers from the customs office have followed white girls after white girls to the den, only to lose them in the intricate network of small rooms and hallways. Alleyways and passages criss-cross throughout the big building, making it practically impossible for a man to arrest persons in the opium den. We know the den is the oldest and worst in Portland. There appears to be some organized system of sending white girls to the den. How this is done, we have been unable to solve."

The Davis girl was caught in the smoking room. She had been using a genuine opium pipe, which was still warm when the officers broke into the place. In court this morning she pleaded illness.

WHEAT, SILK DUTIES TAKEN UP, WOOL FREE

Washington, June 26.—Rapid progress is expected to be made from now on by the Democratic senate caucus which is considering the tariff bill. It is probable that a resolution binding all senators except the two members from Louisiana, who are opposed to free sugar, to support the bill finally approved by the caucus will be adopted.

The caucus took up today the countervailing duties on wheat and specific duties on silk. A provision to exclude all products of child and convict labor in foreign countries also was considered. The income tax section of the bill will be considered tomorrow and Saturday.

By an overwhelming majority the Democratic house caucus voted to abolish the United States court of commerce.

The senate caucus also upheld the provision for free wool. The only Democrats who voted in favor of placing a duty on sugar were Thornton, Randall, Walsh, Newlands, Shaffroth and Thompson.
