

GET IMPROVEMENT OF WAGE SCALE

Industrial Welfare Commission's Report Shows Good Results Accomplished.

The results of the first work done by the recently created industrial welfare commission are found in a public statement given out this morning by the commission. The members of the body are Edwin V. O'Hara, Bertha Moore, Amelia M. Smith and Carolyn J. Gleason. The statement in part follows: "June 27, this commission has issued its report on the investigation of the wages of women employees with a view to establishing a minimum wage rate for such employees, as provided by the act creating the commission. A few days later a report of dissatisfaction among the employees at the Oregon Packing company determined the commission to make a thorough investigation of the plant.

The commission finally secured from the company a written agreement, to go into effect immediately and continue during the present fruit packing season, fixing \$1 a day as the minimum to be paid to any worker and a piece rate to be regulated for each kind of fruit so that fast workers can earn more according to their efficiency. (Aged and crippled workers may receive permits to work from the commission.) The following considerations led the commission to accept this agreement unanimously:

"One—It offers immediate relief where any regulation the commission might seek to enforce by law would require to do so by that time the fruit packing season would be nearly over.

"Two—The improvement in wage conditions is notable. Before the new schedule went into effect many girls got only 40c and 50c a day. Now none will receive less than \$1 and the more capable workers can earn more. The rate for assorting cherries is advanced from 10c a box to at least 10c a box and the workers are assured that with each change in the kind of fruit handled the rate will be maintained at a satisfactory standard.

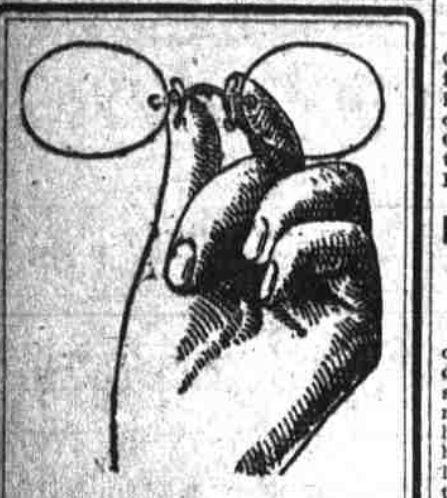
"Three—Many other factories in Portland are paying women workers only \$2.50, \$3.00 and \$4.00 a week. The commission considers that \$1 a week may be considered not unreasonable as a minimum rate for an individual factory until the whole question of wages, with which it is now engaged, is thoroughly sifted and all factories (and other establishments employing women) are brought to reasonable standards.

"Four—Fruit packing being a seasonal occupation attracts a number of workers who vary to an extreme degree in efficiency. The commission has found girls working side by side one of whom made \$1.50 a day and the other at precisely the same work only 40c a day. To fix a high minimum would simply be to throw a number out of employment."

CONVICT, CHILD LABOR PROVISIONS CUT OUT

Washington July 2.—The majority members of the senate finance committee today practically emasculated the convict labor and child labor amendment to the Underwood tariff bill suggested by Senator Hughes of New Jersey. The amendments prohibit the entry into America of goods made in countries where the laws do not prohibit the employment of children in factories or where convicts compete with free labor. Senator Simmons of North Carolina, chairman of the committee, insists that the amendments would affect most of the important nations. California house Democrats, headed by Representative Baker, this afternoon appealed to the senate finance committee in behalf of California sweet wine growers, who urge that the existing duties on wines be retained.

Preparing Motion for Rehearing. Deputy City Attorney Tomlinson is preparing a motion for a rehearing of the suit of Robert Wakefield against the city for \$400,000 he alleged to be due him for work on the new water reservoirs in Mount Tabor. A jury gave Wakefield a verdict for \$16,000. Neither side was satisfied. Recent efforts to compromise the case have failed, and the motion for a rehearing will be heard on Monday.

WAR VETERANS ARE GUESTS AT HOME

Old Union and Confederate Soldiers Meet at Luncheon Today.

Veterans of the Union and Confederate armies who fought in the battle of Gettysburg and who were unable to attend the reunion now being held on the old battlefield, were the guests of the Pennsylvania club of Portland at a luncheon held this noon at the Portland hotel. Thirty-five old soldiers from all parts of Oregon were present and listened to the addresses regarding the part the soldiers of Pennsylvania played in the important battle.

Wallace McCann of the executive committee of the club gave the address of welcome, telling of the results accomplished by the men and commanders of the Pennsylvania club in the battle of Gettysburg. He said that more than 26,000 men of the 80,000 Union soldiers in the engagement were from that state. Colonel James Jackson responded on behalf of the Union veterans. He reviewed briefly the battles in which he had participated and told of the hardships of both armies as he had witnessed them. He stated that for the first two years of the civil war the time was wasted, as the men who were first in command were merely politicians, who knew nothing of warfare, but gradually, however, these men were weeded out and those who were really soldiers came to the front.

Judge David T. Johnston responded on behalf of the Confederates. J. A. Curry, first vice president of the club presided and introduced the various speakers. Stewart Young, steward for the Sacramento baseball club, formerly of Philadelphia, was an interested listener at the luncheon.

deprived by the Balkan victories. The Turkish entry into the field would be regarded as ominous of possible complications between the powers themselves.

Bulgars Are Retreating. Sofia, Bulgaria, July 2.—After two days of the most stubborn fighting, the Bulgarian forces to which Servians have been opposed, are retreating along the whole line, according to dispatches from the front which were received this afternoon by the war department. It is stated that the Servians have been almost uniformly successful in the various engagements and that yesterday they captured 200 Bulgars after a battle in which the losses were heavy on both sides.

Greek Losses Are Heavy. Athens, Greece, July 2.—Official advices from the front to Greece today declare that the Greeks, aiding the Servians, continue their advance, inflicting heavy losses on the Bulgarians and capturing several important positions. The Greek losses, the dispatches say, have been considerable. No definite figures are announced.

3000 Wounded Cared For. Geneva, Switzerland, July 2.—Dispatches received here today by the Swiss Red Cross society from the Serbian front declare that the number of the Serb-Bulgarian battles have been most severe. The dispatches said that more than 3000 wounded have been brought from the front and they ask that doctors and nurses be immediately despatched to the scene of hostilities.

Roumania to Join Servia. Bucharest, Roumania, July 2.—King Charles today ordered a general mobilization of the Roumanian army. It is believed certain that Roumania has decided to fight beside Servia and Greece in the hope of gaining part of the territory taken from Turkey by the Bulgars.

BOY OF 5 PICKS UP CRACKER AS IT EXPLODES

Albany, Or., July 2.—The first Fourth of July accident happened here yesterday afternoon, when Teddy, 5-year-old son of Mr. and Mrs. Sam Gilbert, miraculously escaped losing the sight of his right eye, a firecracker exploding in his hand. After lighting the fuse, the little fellow threw the explosive into the street. It failed to explode, and believing the fuse had gone out he picked it up. The extent of his injuries is a badly hurt eyeball and a severely burned face.

The extension means ten miles of new road, through a thickly settled section, and the settlers along the line have agreed to furnish rights of way and to grade the road.

Two Day Celebration Likely to Bring in a Great Fourth-of July Crowd.

(Special to The Journal.) Baker, Or., July 2.—Baker will have a two day celebration on July 4 and 5. "Everything Free" was the slogan of the celebration last year, which was such a success that the same will again be in order, so a huge attendance is predicted.

The Goddess of Liberty parade on the Fourth and athletic sports will be features, and on the 5th a "Made in Baker" program will be the main event on the program. Over forty Baker firms engaged in manufacturing, will have floats representing their business, and it is believed this exhibit of home industry will show that Baker is as well or better off in this regard as any city the same size in the northwest.

A rock drilling contest is one of the big numbers on the program and miners from all over eastern Oregon will compete. Log rolling and loading contests will bring in practically all the employees of saw mills and logging camps in the county.

COST \$30,000 TO TRY "FAT" CASE; NO VERDICT

Denver, Colo., July 2.—Retrial of the celebrated "Fat and Lean" case here in which the government is prosecuting "Marjorie Hamilton" Cunningham for alleged misuse of the mails is expected to be ordered soon. The jury disagreed late yesterday and was dismissed. The trial cost the government \$30,000 and \$50,000 was the bill of the defense.

CALDWELL HORSE THIEF IS QUICKLY RUN DOWN

Caldwell, Idaho, July 2.—Sheriff Frank Broshers of this city left this morning for Baker, Or., where a young man named Jim Welsh has been located and is wanted for horse stealing. Young Welsh, whose home is at Baker, spent his last night here and was taken Monday evening hired a saddle horse at the Fashion livery stable. MAYOR ANGLES WITH STRIKERS

Pays Visit to Canning Factory, and Talks With Hands Unrecognized.

Strikers at the plant of the Oregon Packing company, at East Eighth and Belmont streets, did not know until afterwards that Mayor Albee was one of those who mixed in the crowd before the plant and listened to addresses by leaders of the strike, yesterday afternoon.

In fact, nobody knew that he was there until just as he was leaving, when a newspaperman recognized him. But by that time he had been seen by three-quarters of an hour, circulating among the strikers and hearing the stories of several of them who thought he was just an ordinary citizen and talked freely to him.

Someone rang up the mayor's office in the afternoon and said that there was disorder at the plant. Without telling anyone where he was going, the mayor went out and cranked up his automobile and drove over there, running the car himself. No one could ask for a more orderly crowd.

"I am a thorough believer in the right of free speech on the streets, and I shall never interfere with it as long as the speaking is peaceable and orderly," he said yesterday. "My policemen will not interfere except when there is abuse and indecent language, and that will not be tolerated at any time."

"I wanted to see conditions just as they were, and I am glad I went."

MORE GIVEN PENSIONS; TOTAL NOW IS 31

Six more widows' pensions have been granted by Judge Gates of the juvenile court, making 31 granted to date. These pensions represent \$193.80 a month and bring the total to \$440 a month at present. Several of the pensions were only temporary and others will be reduced when it is found the amount really needed in each case.

The 31 cases passed upon so far are the most worthy that have appeared and are all cases in which immediate action was necessary. Several of the pensions were granted to widows who had been receiving assistance from the Associated Charities and from the Board of Relief.

FRIENDSHIP LIVES LONG AFTER DEATH

Aged Portlander Cannot Die Until He Has Moved Long-Buried Body of Pal.

(Special to The Journal.) Dufur, Or., July 2.—"No, he was just my friend."

This was the answer given by E. Koshler of Portland when asked if William Holman, whose body he had moved from the trouble and expense of moving from one cemetery to another, was a relative of his.

Many, many years ago, when there was but a small handful of settlers in the Fifties, this valley, a location for a cemetery was selected on a hill overlooking the valley. The reason for its being thus located was that at that time there were many Indians in the neighborhood and those who had relatives or friends buried wanted to keep watch of the home of the dead, for one of the offenses of the red man was that of robbing graves.

Later, when there were more people here and the Indians were practically all gone or had been forced to submit, more desirable locations were chosen and the cemetery overlooking the valley was abandoned. Most of those buried there who had relatives living were removed to the new burying ground and the old place was allowed to become neglected and of late has been little more than a rendezvous for Jack rabbits and coyotes. There have been an interment in it for more than 50 years.

A few days ago Koshler, now a gray-haired man, came to look after the last resting place of his friend, Holman. He left here soon after Holman's death, 35 years ago.

"We were good friends—very good friends," he said. "I could not be happy if I knew he would be left out there in that cemetery with no one to care for his grave. I had intended to look after this long ago, but circumstances have prevented, and now I am growing old and I must do this one kind act for my friend. The old man closed his story."

"C" FOR "G" BRINGS PAVING CASE REVERSAL

(Special to The Journal.) Pendleton, Or., July 2.—Because the city engineer, in describing the assessment district, mistook a letter "C" for a figure 6, the street department has reversed the decision of Judge Phelps in the paving case of John vs. the City of Pendleton. In all the principal contentions the city was upheld, the supreme judge ruling there was no evidence to show that grave bitumuls was the best pavement to be had, and that the price charged was excessive, or that the fact that it was a patented article created a monopoly, and the point upon which reversal was made was one upon which no one, not even the counsel for the plaintiff, expected to be considered. In his opinion, Judge Phelps did not even mention the point in view of the fact that the plat filed with the description showed the property included in the district, no mistake could have been made by the mistake.

In view of the fact that the case was reversed only upon a little technicality, it is not thought the case will have any bearing upon the other cases now pending up the improvement of Webb and Riley streets.

DECLARES HE HAD NO INTEREST IN THE BANK

Answering the suit of Thomas C. Devlin, receiver of the Oregon Trust & Savings bank, to recover property for the benefit of the creditors, Walter H. Moore, one of the defendants, declares that he conveyed the property in question to Laura and America Moore for the purpose of reimbursing Henry A. Moore. He says that Henry A. Moore and himself owned 640 acres of land in eastern Oregon and Washington and a 160,000 parcel of ground at Water and Montgomery streets, valued at \$118,900 in all.

Henry A. Moore, he says, had no interest in the bank but agreed to transfer this property to the receiver if Walter H. Moore would deed to the two women the residue of his property. This was done with the understanding that Henry A. Moore was to receive through his wife, America Moore, \$87,950, the value of his half of the property. What ever was left of the residue was to be kept by Laura Moore, wife of Walter H. Moore, to reimburse her for \$6400 which she owned in her own right when she married in 1882.

This residue is the property which Devlin seeks to have returned to Moore's possession that he may secure judgment against it. Moore alleges that he was liable for but \$15,000, the amount of stock which he owned in the defunct bank, of which he was president. Judgment was secured against Walter H. Moore for \$46,014.70 in a civil suit following the failure of the bank, and it is to collect this judgment that Devlin filed the present suit.

MRS. FRANK MOTTER BRINGS DIVORCE SUIT

Alleging that the strident tones of Frank Motter's voice could be heard by the entire neighborhood whenever they had a row, Adah Motter has brought suit for a divorce charging cruelty. Motter is an attorney and has for years held the position of reading clerk of the state senate. Mrs. Motter said his voice was so loud that she was unable to sleep and he was otherwise cruel and inhuman. She asks for the household effects which she claims and for a one-third interest in his real estate. They were married in 1901.

AUTO QUITS CURVE; 1 KILLED, 5 HURT

Driver of Wrecked Car Is Out of Sight but Not Out of Mind.

(United Press Leased Wire.) Tacoma, Wash., July 2.—Rounding a sharp curve in the southern part of the city at a high rate of speed early today, Morris E. Newton, 31 years old, was instantly killed and five other persons were painfully injured, when the automobile in which they were riding overturned.

Newton was thrown out of the machine and dashed against the hub of one of the rear wheels. The other occupants landed in a pile of dirt, which probably saved them from serious injury. Those hurt are Helen Smith, Mrs. J. Bennett of Aberdeen, George Olson, Edward Brown of Darringer, a woman, name not given.

The driver of the machine, which is owned by Charles Lewis, manager of the Savor Auto-obile company of Seattle, disappeared following the accident, and has not yet been located.

MANAGER'S SALARY START OF HOTEL PORTLAND SUIT

From the testimony brought out in the trial of the suit of Sidney Norman against Robert H. Ellis, Edward Boyce, Eugene Day and Jerome Day to recover \$18,750 commission for securing the transfer of the interests of the Normans in the Portland hotel to the Days, trouble between the two factions began because the Days objected to having Norman made manager of the hotel at a salary of \$5000 a year. After the trouble had started the Days offered to sell for \$300,000 their half interest. The Normans refused, and then the Days offered to buy the interests of the Normans.

Sidney Norman claims that he engineered the deal by which the Days bought out the Normans for \$375,000, and was to get 5 per cent, or \$18,750, commission. The Days claim he had nothing to do with the transfer.

After hearing the case Circuit Judge Hamilton left for his home in Medford, and will announce his decision from that place.

The tag bore a drawing of a baby and they claimed the money was to go to the baby home.
