Attachment Suit Answered.—The attachment suit of the Sweeney Investment company against the First Trust company for \$700 rent on the second floor premises of the Dekum building was answered by the trust company yesterday with a counter-claim of \$23,000 damages. The trust company claims it has suffered through breach of contract. It alleges that the investment company refused to allow a large safe to be placed in the offices, thus depriving it of a large source of revenue in its trust business. It also alleges that the investment company failed to repair and rehabilitate the premises after a fire and thus prevented the trust company from earning money with which to pay the rent. The place is closed now under attachment.

Mrs. J. D. Lee Estate.—Elizabeth A. Lee, wife of J. D. Lee, former member of the state legislature and warden of the penitentiary, who died June 27 at the age of 65 years, left an estate valued at \$9500. The property consists of real estate in Multnomah, Umatilla, Clackamas and Tillamook counties. Mr. Lee is named executor of the will. The other heirs are Althea E. Lee, a daughter; J. Roscoe Lee and Lyman M. Lee, sons; and Charles Lee, grandson.

New East Side Terminal.—The work of raising the frame buildings at the southeast corner of Union avenue and East Morrison street, preparatory to the erection of the new freight depot of the North Bank lines, was commenced yesterday. It is stated that the construction of the new depot will proceed immediately after the ground has been cleared. The company has already commenced the laying of tracks in the new terminal yard between Union avenue and East Third street, from Belmont to East Main street.

Large Probate Bond Filed.—One of the largest probate bonds filed for some time was filed this morning in behalf of Augustus R. F. Orr, husband of Mary A. Orr, who died June 19, and administrator of the estate. The estate is valued at \$62,500, and the bond is for twice the sum, as required. Mr. Orr is the only heir. The bond was signed by Louis and Della Orr, who qualified for \$30,000, and Charles and Lizzie Bernard, who qualified for \$27,000.

Neither Side Wins Suit.—Neither the Portland Taxicab company nor J. F. Shea won the suit of the company, which was heard in Circuit Judge Davis' court yesterday. Though the jury returned a verdict in favor of Shea, it failed to give him any part of the \$25 damages he asked because of damages to his car received when it met a taxicab in collision at Twenty-third and Glisan streets, November 4, 1912. The company asked for \$171.75 for damages to its taxicab.

Emblems for Winners.—Emblems to be worn by winners in athletic contests at the public playgrounds have been designed as added incentive to interest in sports on the part of the children of Portland. The park officials will award one to each victor, and stars later sewn upon it will indicate further prowess. The emblems are of cloth, circular in shape, with a suitable design in the center. The stars may be placed in a space inside the rim.

Want Sewer Service.—Spurred by a recent order of the board of health ordering them to remove their sanitary cesspools at their homes, residents of the Peninsula district will appeal to the commission to secure sewer service. Mr. Woodward, C. Spies, Dr. S. M. Strohecker and L. C. Wilkinson of the North Portland Commercial club compose a committee to make the representations to the municipal body.

Addresses G. E. Kelly.—At a rally of the Christian Endeavorers last night at the Central Christian church on East Twentieth street, Rev. Claude E. Hill of Valparaiso, Ind., national president of the society, delivered an address. The music was in charge of W. F. M. Heckleman of Indianapolis, a singing evangelist. IN EARLIER DAYS

By Fred Lockley.

W. I. R. Beach was what my parents named me, but when I joined the army they turned the "I" into a "J" so I have been W. J. R. Beach ever since. I have followed railroading. I have held down a job as fireman, engineer, brakeman, conductor, train dispatcher and superintendent, so I know something of railroading.

In the days before the war the end of my run was at Bloomington, Ill. Lincoln used to come over from Springfield for court week at Bloomington. In those days we only knew him as a general, kindly man with a wonderfully persuasive way with him. He used to win his cases because he had the jury with him. He never talked down to them. They felt that he was one of them—a plain every day American, wanting to see justice done. In the evening I would come in from my run, wash up and eat a quick supper, so I could sit in the hotel office of the Pike House and listen to Lincoln and the other lawyers tell stories. If I was late I would often miss my supper rather than miss the discussion of politics and Lincoln's apt and laughable stories.

"He could settle an argument, or explain a case or make an unenviable position ridiculous by telling a story. His stories were never unkindly. You will sometimes hear people claim that Lincoln told questionable stories, stories that were witty but coarse. That statement is absolutely untrue. I was a young man and looked up to Lincoln as more or less of an oracle. I have heard him tell hundreds of stories but never one that left a bad taste in your mouth. After his death people got into the habit of telling stories, some of them coarse and unclean, and attributing them to Lincoln.

"When the war started a wealthy man in Chicago, named Sturgis, organized the Sturgis Rifles. They acted as a body guard for General McClellan. Sturgis outfitted us with Sharps rifles, gave us two uniforms each, provided tents and all necessary supplies and turned us over to the government. There were 84 in the company of which I was a member.

"We were quartered in Washington, D. C., during the winter of '61. One day while I was on duty Lincoln passed. He was talking very seriously with a gentleman walking by his side. He looked up and saw me. His serious face lit up and with a smile, he stepped toward me with outstretched hand and saying: 'Here's one of my Illinois boys.' He turned to the man with him and said 'This is Will Beach. We used to know each other out in Illinois.' He took my hand in his lean and powerful one, gave me a hearty hand clasp and walked on.

"When McClellan was relieved of his command the Sturgis Rifles were mustered out and most of the boys joined other regiments. I joined the secret service department of the army. ice was exciting and had plenty of risk in it.

"The most dangerous work I had to do was to help rid Missouri of bushwhackers. They burned, looted, and murdered either aide indiscriminately. I was the means of putting a stop to the activities of scores and hundreds of them.

"Once I was working on the Hannibal and St. Joe line, where the bushwhackers had been burning bridges and holding up trains. Once we pulled into a small town and as I swung off I heard one of the bushwhackers say they were going to burn this 'blankety' blank town. I said 'What's the use of doing that. I wouldn't if I was you fellows,' and a big fellow stepped up and with an oath told me that if I didn't keep my mouth shut they would shoot it for me for good. I recognized the speaker as being LeFevre, the notorious leader of a gang of cut-throats and bushwhackers that had been operating around Hannibal.

"The next day with two men, one of them a fearless fellow named Crompton, I went to the terror LeFevre's home and pressing his ribs with our revolver barrels we took him prisoner. "We rode him back to Hannibal and from there started him on his way to St. Joe on the train. He never reached his intended destination. He had murdered more than one railroad boy in his time, and at Windy Clark Hill, two miles from Brockfield, he was taken from the train and strung up.

"Other passengers didn't know who the big red-whiskered man was, and in fact LeFevre's disappearance was never satisfactorily explained to the military authorities."

NEW SAWMILL WILL BE IN OPERATION SOON

The new sawmill being built at Seaside, three miles from Suxton, on the line of the Pacific Railway & Navigation company, is expected to be ready to cut lumber the latter part of next month. The output will be about 100,000 feet in 10 hours.

The Standard Box & Lumber company, of which Isaac Gratton is president, S. B. Cobb secretary and C. C. Woodcock vice president, operates a large sawmill here on the east side of the river, and the new mill will probably be known as No. 2. The company bought 3500 acres of timber back of Suxton a few months ago for \$450,000 from John Pearson and associates, and this body will furnish material for the mill for many years. The timber is on Dairy creek.
