

KITCHEN CABINET SESSION INSULATED BY COMMISSION

First of Informal Friday Meetings Discusses Important Matters Relating to City Affairs.

The city commission held its first "kitchen cabinet" this morning. Seated about a long table, Mayor Albino, the four commissioners, and a city attorney, La Roche, discussed in an informal way matters and measures affecting the city's interests, and agreed on the best course to pursue.

No legislative action was taken, and none will be taken at future "kitchen cabinet" sessions, which are to be held each week on Friday morning. That does not mean that the chief value of which lies in the opportunity it affords for informal and friendly discussion of pending affairs.

The nearest approach to legislation at these meetings will be recommendations for action at regular meetings. As the same men make the recommendation who later will pass on it, of course it is about equivalent, except in legal form, to taking the action contemplated.

Important Decision Reached.
One of the most important decisions reached today was that a street improvement code is necessary. This view was unanimous, after City Attorney La Roche had pointed out some of the difficulties barring the extension of East Broadway, said to be a very much needed improvement, by the intricacies and absurdities of the present code.

Mr. La Roche pointed out how one lone remonstrator can hold up a whole street improvement, even though \$500 property owners are affected, and all but the one wanted the work done. With the filing of a remonstrance, he said, the only course open to the city government at present is either to stop the work and abandon it, or to direct the city attorney to begin expensive condemnation proceedings. And in these proceedings, it is further necessary to summon every property owner affected into court at great expense and delay. Although many property owners wish East Broadway extended, and the need is great, Mr. La Roche said, as there are certain to be some remonstrators it would not do much good to go ahead under the present code, because work would be sure to be held up. He said that save in one minor respect, the old improvement code was infinitely better than the present one.

New Code Outlined.
Mr. La Roche outlined a new code under which the commission would be the judge of whether the improvement should be made, but reserving to remonstrators the right to appeal from its decision to the courts. He was directed to prepare it as soon as he can.

At the next regular meeting of the commission, the old health board and water board will be duly and officially abolished. The new charter provided for these boards of what was said, until the commission desired to dispense with them, but when Mayor Rushlight retired the members of the boards all resigned. Consequently, the boards still exist in theory but not in fact, and Mr. La Roche said serious legal complications could be averted by formally abolishing them.

Commissioner Brewster recommended that the plan adopted by the school board in dividing insurance be followed by the city. Each department now insures the property under its direction, and it was agreed this was unsatisfactory. The matter will be discussed with insurance men next Friday.

It was decided to amend the street sign ordinance to permit the American Lens sign company to enter this field. A discussion of what should be done should not go on the official calendar took up the rest of the session.

ATHLETIC CONTESTS AT FIREMEN'S PICNIC

Considerable interest will be added to the athletic events that are to be pulled off at the picnic of the Portland fire department held at Estacada next Sunday by the amusement tent that will be set up there for the purpose of awarding cash prizes to the winners in the contest.

Many contests are being planned for the day and it is believed that the competition will be very lively. The band playing at the picnic will be the Portland fire department band, which is giving this picnic to help raise funds for the trip to New York to be taken late in August, when the organization will attend the annual convention of fire chiefs.

Every available car has been chartered by the firemen from the Portland Railway, Light & Power company, which is making a substantial division of the day's receipts to the firemen. That a splendid crowd will attend is the belief of the committee.

Many attractions have been planned for the day, including a band concert in the afternoon. An orchestra will furnish music at the pavilion for those who wish to dance.

ACCUSED MAN'S BONDS RAISED TO \$10,000

Circuit Judge Gatens this morning ordered that the bonds of Vi Radich, held for the shooting of John Corcoran, be raised to \$10,000, as Corcoran is said to be in a very precarious condition. Radich is held under \$1000 bail in the county jail on a charge of assault with a dangerous weapon. He shot Corcoran, an innocent bystander, during a row in the White House saloon, Grand avenue and Delany street, at midnight June 23. Corcoran was shot in the stomach. Attorney M. O. Wilkins, representing Radich, said his client will plead self-defense.

SUIT FOR \$25,000 HEART BALM IS BEGUN

A \$25,000 allegation of affection suit by Robert L. Sparrow against A. F. McKay was taken up this morning in Circuit Judge Cleator's court. Sparrow and his wife were married August 23, 1904, and he alleges that February 23, 1913, McKay stole his wife's affections from him.

McKay denies the charge that the wife was divorced from Sparrow April 18, 1912; Judge Morrow granted the decree on the ground of cruelty. He denies that he assisted in the divorce or that he perjured any of Mrs. Sparrow's allegations.

870 LBS. AVOIDUPOIS DIVIDED AMONG THREE GETS GAME LICENSE

Albany, Or., July 11.—With their aggregate weights making 870 pounds, but considering that it should be even 900, Grant Pirtle, C. L. Thrasher and Peter Reuter, arm in arm sauntered into County Clerk W. L. Marks' office yesterday afternoon and the former two procured fishing licenses, while the last secured a hunting license. Notwithstanding his 290 pounds, Mr. Pirtle said that he was a little off feed for the present and that he was going on a fishing jaunt to gain back his slackened appetite. Mr. Reuter, although weighing 380 pounds, agreed that he was a little below average and said he deserved 20 more pounds. Mr. Thrasher, with 300 avoidupois, said he was in the pink of condition and intended to have a fine outing. The three are Albany's biggest men.

CITY WILL ENTER THE AUCTION BUSINESS FOR A BRIEF PERIOD

Has Large Lot of Slabwood No Longer Needed Which Will Go to High Bidder.

The city is going into the fuel business. Not as a permanent venture, however, but merely to dispose of between 350 and 400 cords of dry slabwood which have been on its hands more than two years, and which Commissioner Will H. Daly has decided to auction off to the highest bidder.

The slabwood is piled up at the city garbage incinerator. Twenty-four cords of the wood have been there ever since Dave Otis, the present superintendent of the incinerator, took charge. At that time, the city was paying a big monthly wood bill trying to make a fire hot enough to burn the garbage, but Otis quickly had things working so he didn't have to use the wood. A month's supply out in the yard has never been used.

The wood will be sold to the highest bidder for the whole lot, or in small lots of a few cords, or even one cord. The buyer must deliver it for himself.

Mr. Daly has made no announcement of his intentions in this regard, but it is believed that he will soon name Mr. Otis, who has successfully managed the incinerator which the city once decided to reject, to superintend construction of the new incinerator authorized by the people. After the city garbage collection system is put into effect, Mr. Otis will probably manage that, too.

WOMAN FINDS SHE HAS TWO HUSBANDS LIVING

A woman dressed in Salvation Army clothes and accompanied by an applied yesterday at the county clerk's office for a copy of her divorce decree. Search was made of the records and the case was found. February 10, 1910, Martha Hartford sued George Hartford for divorce, charging drunkenness and cruelty. He answered with a cross-complaint, charging cruelty. Circuit Judge Bronough denied both prayers and dismissed the case. This information was furnished the woman.

"But I paid my attorney, M. B. Keefe, \$50 and he told me that I was divorced," she said, perplexed. "I believed him and have married since."

It took some time to convince her that she had never been divorced, but she finally left, realizing that she had two husbands living. The license records show that June 3, 1913, a license was issued to James Rogers to wed Martha Hartford. It did not mean for the fact that Hartford returned to Portland and Mrs. Hartford feared he might do something unless she had proof of a divorce the deception would in all probability have gone undiscovered. The woman gave a hint as to what action she would take next.

News of County Board

The commissioners yesterday ordered that one mile of the Salmon road, beginning at the St. Helena road, be macadamized. Road Supervisor Chapman reported that the improvement of the four miles of the road would cost \$34,000. The mile to be improved will cost \$2,812. Mr. Chapman's estimates are: Macadamizing, \$4000; gravel dirt, 454 yards at 25c a yard, \$113.50; grading road, 645 yards at \$1.35 a yard, \$860.25; grubbing, \$75. The work he expects to complete in 10 weeks.

Provision was requested that grilles be placed behind the glass pane and openings on his counters for protection. His request is being considered.

Changes in the maps which accompanied the Hood River road contract were allowed that corrections might be made.

A report that the Boone's Ferry road bridge is in dangerous condition was referred to A. H. White, road supervisor, for investigation. Alex Sweek and Cecil Bauer appeared regarding the bridge.

The report of W. J. Clemens regarding insurance of the county, together with checks and cash collected in relation to policies, was considered and ordered turned over to County Treasurer Lewis.

A suggestion from the Portland Examiner that advertising of bids for materials for county use be let to papers covering the field of materials desired rather than by rotation was received. The Examiner suggested that it desired advertisements for building, bridge, road and plumbing work and the like.

Partner of W. G. Kerns, former partner of State Sealer of Weights and Measures, Fred G. Buchler, to do the work of the sealer of weights and measures for the county for \$50 a month and traveling and board expenses, was received. Mr. Kerns said he did not expect to devote over half his time to the work.

VICTIM OF RABIES LIES UNCONSCIOUS; DEATH EXPECTED

Frank Griffith Suffering From Hydrophobia as Result of Bite of His Pet Dog Five Weeks Ago.

Frank Griffith lies at the Good Samaritan hospital in an unconscious condition, suffering from an attack of hydrophobia. At 1 o'clock this afternoon word came from the hospital that his death was expected at any moment.

About five weeks ago Mr. Griffith was bitten in the left hand by his pet dog while he was treating it for an illness. Mr. Griffith paid no attention to the bite at the time.

Last Tuesday he felt ill, and consulted J. T. Walls, who found that he was suffering from cerebral hemorrhage. His left side was partially paralyzed. He also complained of a difficulty in swallowing.

Wednesday he returned to Dr. Walls' office, still complaining of his throat. Dr. Walls offered him some water and he went into a convulsion at the sight of it. After he had recovered Griffith told Dr. Walls he had been bitten by a dog five weeks ago, saying that he did not think the bite amounted to anything at the time.

He was then advised to go to a hospital but he refused to do so.

Yesterday he again called on Dr. Walls but was in no better condition. He was finally persuaded to go to the hospital last evening, with Dr. Walls. He continued to manifest symptoms of hydrophobia and it was with some difficulty that the hospital was reached.

Dr. Walls called in consultation Drs. O'Day, White and Williams. All agreed that nothing could be done to save the patient's life and that death was but a question of time.

REALTY BOARD HEARS DOCK PLAN OUTLINED

Ex-Senator Fred W. Mulkey, chairman of the public dock commission, addressed the Realty Board at noon today, outlining the work so far accomplished in providing for the city of this port. The speaker gave the details of the purchase by the commission of the site for dock No. 1, which cost approximately \$750,000.

Mr. Mulkey indicated that the dock commission will ask the voters to supply \$1,000,000 for extension of the public dock system of the city, between now and 1924. He said that the indicated growth of the business of the port will require 10 years hence berthing facilities for 43,000 foot ships.

The Realty Board voted at today's luncheon to discontinue the regular Friday luncheon until the first Friday in September.

A special luncheon will be given next Saturday noon, July 19, at the Commercial club, for the purpose of entertaining Los Angeles delegates en route to the National Real Estate convention at Winnipeg, Manitoba.

Marcella Bartlett was indicted for perjury in connection with the grand jury investigation of charges against Edward Picard, alias Boris, alias Coco. She denied knowing Picard and having seen certain postal cards, which is alleged to have been false testimony. George Emmett, alias Hill, was indicted for passing a forged check on Edward Uffer for \$16.75.

Not true bills were returned in the cases of G. H. Thompson, charged with contributing to the delinquency of an 8-year-old boy; George Kapala, with larceny by bail of \$100 from John Toole; Annie Schiff, with operating a disorderly house; and Charles Wilson, with larceny of a watch and chain from the person of C. F. Scott.

As the result of a fall through a glass sidewalk awning at the New Healy building, Morrison street and Park avenue, Wednesday, John Gustafson, a window washer, 27 years old, died of fractured skull and lacerations of the brain. Gustafson, who had no straps to prevent a fall, slipped from the ledge and crashed through the glass to the sidewalk. He came here only recently from the east. The funeral will be held tomorrow afternoon at Pearson's chapel.

LAND EXCHANGE BILL PLEASURES GOV. WEST

Governor West expressed pleasure this morning because of the passage by congress of the bill submitted by Senator Chamberlain. It provides for the exchange of 40,000 acres of school lands in forest reserves for about 50,000 acres in one body in the national reserve. The purpose is to utilize the tract for a forestry school. He flew across Lake Michigan from Chicago at the rate of a mile a minute. The lake was very calm and the flight was unhampered by wind. Twenty minutes later, Martin resumed his flight to Macatawa Bay, the next control station.

Martin arrived at Macatawa Bay at noon, four hours behind the others. He averaged 70 miles hourly.

CAUCUS BILL FOR CURRENCY NEEDED

House Banking Committee in Tangle and Caucus Action Is Believed Necessary.

Washington, July 11.—The tangle in the house banking committee over currency legislation reached a stage today where it was admitted by many congressmen that a caucus bill on currency reform is the only solution of the problem. Wide differences have arisen between factions of the Democratic members of the committee, and a dictum by the caucus, it is expected, will be forced.

A call for a caucus of house Democrats to meet next week will be requested. Representative Glass of Virginia, in charge of the currency bill, said today that he expected the bill approved by the Democratic caucus would be completed at next week's caucus. The differences among members of the committee are said to be sharply defined, and a bitter fight is expected before a final agreement is reached.

WESTON P. M. NOT MUCH TO TRAVEL

In Sixteen Years He Has Been Only Twice to County Seat.
