

DR. HODGE CONSENTS TO STAY YEAR WITH UNIVERSITY OF OREGON

Will Help Cities of State in
Sanitary Problems; Two
Portlanders on Staff.

(Special to The Journal.)
University of Oregon, Eugene, Or., Aug. 5.—Clifton Freeman Hodge, for 24 years biologist at Clark university, famous the nation over for his activity in problems of civic biology, has been elected a professor at the University of Oregon for a year, while on a leave of absence from his eastern institution.

Dr. Hodge was the first biologist to demonstrate that the housefly carries disease. He has since been employed by several American cities, including Baltimore and Washington, D. C., to direct anti-fly crusades, in which he has absolutely rid whole districts of the fly nuisance.

With the election of Dr. Hodge as professor at the university, comes the announcement of two others. Colin V. Dymont, at present northwest editor on The Oregon Journal, has been elected instructor in the school of journalism of the university. J. P. O'Hara of Portland has been elected instructor in the department of history.

University authorities are elated over securing the services of Dr. Hodge, even though for only a year. He will be connected with the extension department and will spend much of his time traveling about the state, assisting Oregon cities solve their problems in biology. He will also be used by the state game warden to carry on a study of Oregon bird conditions and to lecture in the interest of Oregon birds and game.

Dr. Hodge has made a life study of birds and is a national authority. He is an extreme believer in the protection of the birds, even to their domestication.

Colin V. Dymont, instructor in journalism, was selected over candidates from all parts of America and several in England. For four months the journalism department has been searching the east and has finally returned to Oregon for a selection. The new instructor is an honor graduate in classics from the University of Toronto, and since graduation has had 13 years' newspaper experience.

J. P. O'Hara, chosen instructor in history, was recently appointed by Governor West on the Oregon textbook commission. He attended and was later an instructor at Notre Dame, and afterward graduated with honors in the department of history at the University of Paris.

COIN TO BE REMOVED FROM BOY'S THROAT

Under the direction of Dr. E. DeWitt Cornell, 8-year-old Ronald Grassens, son of Mr. and Mrs. Joseph Grassens, 446 East Market street, will be put under the anesthetic tomorrow and a delicate operation performed to remove a silver quarter lodged in the youngster's throat. The operation will be performed at St. Vincent hospital.

The boy swallowed the coin several days ago, and since that time has suffered considerably. An X-ray picture was taken by Dr. Alex. Robb, which showed the coin lodged in the esophagus, but it was firmly lodged there so that it could not be removed with instruments.

There is no immediate danger from the coin, but ultimately a destructive abscess would be sure to form, the doctors say.

In order to get at the coin, it will be necessary to enter the chest cavity, pass the windpipe and make an incision in the esophagus large enough to remove the obstruction. Dr. Fred Gullette will assist in the operation.

OFFERS TO SELL SAND AT LOW PRICE POUR IN

Offers to sell the city sand and gravel at prices lower than those charged by the local sand companies still continue to pour in at the office of C. A. Bigelow, commissioner of finance. The latest offer came this morning when a man made a proposal to sell sand and gravel to the city for 50 cents a yard. This is 25 cents lower than the price made by the local sand companies to the city.

Other people who have had trouble with sand companies relative to prices charged are telling their troubles to Mr. Bigelow. This morning he received a letter from J. E. Martin of East Tenth and Sherman streets. Mr. Martin states that he ordered a yard and a sixth of sand from the Columbia Contract company and was charged \$2.50 for the small amount. He declares in his letter that when he took the matter up with the concern he was met with smiles, but he did not secure a rebate.

ALLIES WILL WITHDRAW DEMANDS FOR INDEMNITY

Bucharest, Aug. 5.—Representatives of Bulgaria, Greece, Serbia and Montenegro met unofficially here today before resuming their conference in an effort to arrive at a peace treaty. The announcement by Premier Majorevic of Roumania, president of the conference, that no further armistice will be asked indicates that an agreement is expected. The allies, it is said, have withdrawn indemnity demands.

Calumet, Mich., Aug. 5.—"Mother" Jones, the celebrated woman strike leader, was given an ovation upon her arrival here today to aid the copper strikers to victory. Despite a heavy rainstorm, hundreds of miners met her at the depot and escorted her to a hotel.

The militant speakers denounced the government and urged the suffragettes to start a demonstration at Albert hall tomorrow, where the International Congress of Medicine meets, as a protest to the methods employed by the doctors at Holloway prison.

MAXIMUM HOURS OF LABOR FOR ALL YOUNG GIRLS ESTABLISHED

Industrial Commission Fixes
8½ Hour Day and 50 Hour
Week; \$1 Minimum Wage.

The Oregon industrial commission made a ruling today which affects wages and working hours of women. Under the ruling, which becomes effective in 60 days, all girls under 18 may work but eight hours and 20 minutes a day or 50 hours per week. They may not work after 6 p. m. and all girls between the ages of 16 and 18 must receive a minimum of \$1 a day except where arrangements have been made with the commission for apprentices or learners. The law will affect girls employed in department stores, telephone exchanges, telegraph offices, hotels, restaurants, laundries, mechanical establishments and other retail business of like character. Male minors are not affected.

The ruling was made after a public hearing at the commission's headquarters in the Commercial block, at which were present representatives of department stores and telephone and telegraph companies.

Asks Increased Minimum.
W. P. Olds, representing department stores, asked that the minimum of eight hours be increased to eight and one quarter hours, in order that the service in the middle of the day during lunch time might be maintained at a standard that would be fair to the public.

On motion of Amadeus Smith, this change was made. F. H. Shea, representing the Pacific Telephone company, indicated that the new ruling would hit the telephone service severely, as one third of its girls were under 18. He implied that as a result of the ruling his company would refuse to employ girls under 18. He pointed out that it was a much harder problem for the telephone company to adjust than for the department store, as they had to take into consideration the night shifts and Sunday work.

Just what the department stores will do in reference to Saturday closing is to be determined. In many of the stores the percentage of employees under 18 is large and the observance of the law would practically be an order for Saturday closing.

WOMEN OF WOODCRAFT PLANNING MERRY TIMES

Consideration of legislative matters took up the time of the delegates in attendance at the grand circle meeting of the Women of Woodcraft, being held in the Woodcraft building, Tenth and Taylor streets.

Tomorrow the delegates, grand circle officers and local members of the organization to the number of 300 will take a trip up the Willamette river to Champagne. Thursday afternoon arrangements have been made for an auto ride around the city for the visiting delegates, and Mt. Hood circle will entertain the delegates at a reception in the Woodmen's hall, East Sixth and Alder streets, that evening.

Friday morning the drill teams will compete for a valuable trophy cup and a \$300 cash prize. This trophy has been won twice by the Fresno team and if it wins this year, the cup will become the permanent property of that circle.

Four teams of nine persons each have entered. They are Fresno, San Jose, Bellingham and Salem.

JUDGE ADVISES WOMAN TO KILL HER HUSBAND

Oakland, Cal., Aug. 5.—"I advise you to buy a shotgun, load it with buckshot, and then shoot your husband dead if he makes any more threats on your life," was the advice that Judge R. B. Tappan gave Mrs. Minnie A. Rowe today when she had her husband in court for threatening her life.

"If more women would kill their brutal husbands this country would be better off," continued Judge Tappan. "I do not favor murder, but when a big, hulking brute abuses a woman who is trying to make a home for him, it is time for strenuous measures."

Rowe was placed under bonds to keep the peace.

THOUGHT IT WAS JULY 4; HAD SLEPT ONE MONTH

Los Angeles, Aug. 5.—Frank Crawford is awake today after a nap of a month. He went to sleep in his room on the evening of July 3 and awakened a month later in a hospital.

According to the hospital physicians, Crawford was the victim of a kind of paralysis, which they have been treating. They do not believe he will suffer another lapse of consciousness.

Crawford experienced no distress from his long snooze and waked believing the date to be July 4.

MRS. OLSON ALLEGES LEONARD DUPED HER

Woman Says She Gave Good-
Paying Business for Worth-
less Land.

Charged with obtaining personal property by false pretenses, J. E. Leonard, or J. E. Reynolds, as he is introduced to the woman whom he is accused of duping, was arrested yesterday afternoon by Deputy Constable Hunter.

He was taken into custody in a tobacco and confectionery shop at Fourteenth and Washington streets. He was in charge of the place, which is reported to do a thriving business, and which he is charged with securing from a woman in return for 35 "town" lots, located in the timber and brush 18 miles from Tillamook, and which are of no value whatever.

Mrs. Nellie Olson is the complaining witness. She saved for seven years out of her earnings, she says, in order to open the store. She married last winter, and not wishing to remain in business, she and her husband recently arranged to sell it.

COMMERCIAL CHAMBER TRUSTEES TRANSACT ROUTINE BUSINESS

Hear Petition From Longshore-
men and Discuss Electric
Signs; Wants Free Road.

With the view of placing further safeguards against accidents to longshoremen in handling vessel cargoes a committee representing the Longshoremen's union appeared this morning before the trustees of the Portland chamber of commerce and presented arguments, asking the chamber's favorable action toward regulations along that line.

It was explained that while some precautions are taken by the employing stevedores, they are insufficient, and the result has been several fatal accidents of late. The trustees took the matter under advisement.

Another matter discussed at considerable length was whether or not the chamber should go on record in favor of a proposed amendment of the ordinance regulating the use of electric signs. A new company wants to install a new kind of electric signs, and in order to do so the change in the ordinance will have to be made. The trustees indicated that they will not oppose any electric signs that are not detrimental to health or safety.

The trustees authorized the publication of 5000 copies of the chamber's booklet on public lands in Oregon, including a colored map of the state. This will be the fourth edition of this booklet, which is meeting with a big demand.

Indorsement was given to the plan to make the Barlow road as extended across the Cascade mountains, a free road. It is suggested that the toll can be eliminated if the forest service and the agricultural department of the federal government will take charge of the maintenance of that section of the road which lies within the government forest reserve.

REBEL ARMY SAID TO HAVE BEEN BEATEN

Eagle Pass, Texas, Aug. 5.—Unconfirmed reports are current here today that the Constitutionalist army under General Carranza has been overwhelmingly defeated in an all day battle at Torreon on Sunday. It is reported that more than 2000 rebels were killed and that Carranza himself was killed or captured. Constitutionalist here discredit the reports.

WHEATLAND IS QUIET; MILITIA WILL LEAVE

Wheatland, Cal., Aug. 5.—"I can see no further need of the national guard in and about Wheatland. To all appearances the trouble in which four men lost their lives by rioting Sunday is at an end."

This was the statement here today of Adjutant General E. A. Forbes, who was sent here in command of six companies of the national guard by Governor Johnson, following the clash between striking hoppickers and the county officials.

This little town is quiet today following the bloody rioting of Sunday, and neither the national guardsmen nor the local officers anticipate further disorder.

STEPHENS WOULD REPEAL U. S. NEUTRALITY LAWS

Washington, Aug. 5.—An attempt to force President's Wilson's hand in dealing with the Mexican situation came in the house today, when Congressman Stephens of Texas introduced a resolution proposing a repeal of the neutrality laws in order that the Mexican rebels may procure arms. He denounced Huerta as a usurper.

Fantastic, Says General Diaz.
San Francisco, Aug. 5.—Senator Romero, private secretary to General Diaz, characterized a fantastic dispatch from Yokohama that Portirio Diaz, former president of Mexico, has sailed from Southampton for the orient on July 15, nephew and return with him to Mexico.

General Diaz is now here en route to Japan to carry the thanks of Mexico for participation in the independence centenary of 1910.

"The last word we had from General Portirio Diaz," said Romero, "was that he had gone to Switzerland to spend the summer, having suffered an attack of malaria."

He declared that so far as any of the party now here knows, General Portirio Diaz is still in Switzerland. General Felix Diaz and party expect to leave here tonight for the north to sail for Japan.

COMMISSION PLANS SALE OF CITY BONDS

Money Necessary for Contin-
ued Street Work Will Be
Thus Raised.

An ordinance will be submitted to the commission council tomorrow morning by C. A. Bigelow, commissioner of finance, authorizing the city to sell \$225,000 worth of street and sewer improvement bonds and \$950 worth of street extension bonds. Money to be raised by the sale of these bonds is necessary to carry on street work.

The improvement bonds will be in denominations of not more than \$500 and will pay six per cent interest. They are to be redeemable within 10 years. According to Commissioner Bigelow the city will bid on these bonds from the sinking fund. The denomination of the street extension bonds are to be determined.
