

NEW STATE PRINTER WANTS A CLOSED SHOP

State Treasurer Is Opposed,
Olcott Suggests Delay,
Governor Absent.

(Salem Bureau of The Journal.)
Salem, Or., Aug. 12.—The question of whether the state printing plant, when it is secured, shall be operated as a closed or open shop came before the state board today. It arose in the discussion of a statement issued by State Printer R. A. Harris in which he outlined his policy, and stated his intention of entering into a written contract with the Typographical union.
This was strongly opposed by State Treasurer Kay, who said that while he was friendly enough to the union, he did not believe in a state official entering into a contract with any private organization that would exclude any citizen not a member of the organization from obtaining employment.
State Printer Harris declared that only union men had been employed in doing the state printing for the last 20 years, although no contract had been made with the unions. He said, however, that the question of signing up would be put to him by the union, and he thought much trouble would be avoided by announcing his policy and entering into a written contract with the union at the start.
Secretary of State Olcott urged Harris to hold the matter in abeyance until the state had secured a plant and not try to cross the bridge before he reached it.
Governor West was not present.

assumed charge of his office, and Leslie M. Scott, after shaking hands around with his old force, left.
The new marshal practically completed his list of appointments. Two of the old men who are not under civil service, are retained. D. B. Fuller, jailer under Sheriff Stevens, and a member of the fire department with Mr. Montag, remains as a field deputy. He was appointed last fall by Leslie M. Scott. H. M. Dukes, appointed by Mr. Scott in 1911, remains as office deputy. Dukes was recommended to Mr. Montag and to the senators from this state by the Spanish-American war veterans.

Appoints Assistants.

New men appointed are S. C. Armitage, George Jackson and Tinnies De Boest. Armitage has been a traveling salesman and dealer in dry goods stocks. George Jackson has been a guard at Linnton. De Boest was chief of the fire department under the Pennoyer administration, and both Mr. Montag and Fuller served on the department under him.

These men succeed Joseph B. Marvin, W. B. Griffith and John Talley. All were field deputies, and the new men will also be on the road most of the time.

Chief Deputy W. S. MacSwain and Leonard Becker are office deputies who are under civil service. MacSwain has been in the office since 1907 and Becker came a year before then.

Old Bailiff Retained.
The question of bailiffs has not yet been settled up by the new official. George Humphreys, 80 years old, who has been bailiff and clerk of the United States district court for 20 years, will remain in that position, it is said. John Knight and James M. Conley are other bailiffs of the same court, and nothing has yet been said regarding their positions.

"My plans are immature at present," said Leslie M. Scott, whom Mr. Montag succeeded. "I shall not return to newspaper work."

With his wife and mother, Mrs. W. W. Scott, the former marshal left this afternoon for a trip through the Puget Sound country. They will probably go up into British Columbia for a while. Mr. Scott expects to be back here by September 1, when he will make some announcement of his business intentions.

People around the federal building and elsewhere are highly pleased with the new marshal and say that a better man could not have been selected. He has taken hold of things with the customary vigor and earnestness that he evinced when he was a member of the city council and in his business.

waiting for the opening of the doors, which would admit only 48, that being the seating capacity. The erection of the barricade following a warning by Judge Van Fleet that he would regard any loitering about the door or in the corridor as contempt of court, to be followed by arrest.

Many of those in the line had been waiting since 7:30 o'clock. Men familiar about the Barbary Coast resorts brushed elbows with club women and young girls.

Of all the hundreds about the courtroom door, just six women made their way in when court began. More than a score of others took their stand outside, eagerly awaiting a chance of entrance which might come should any seats be vacated.

Writing Expert Called.

The first witnesses called when court opened were Theodore Kytko, the handwriting expert, and R. J. Semin, postmaster at Sacramento. They briefly corrected evidence they had given at earlier sessions of the trial.

Chief of Police J. B. Hillhouse of

Reno was the first new witness. He told at length of the discovery of Diggs, Caminetti and the two girls in the bungalow at Reno, where all, he said, were in various stages of undress. One of the most significant portions of Hillhouse's testimony was his relation of a conversation which occurred when the quartet of elopers were being taken to the depot in Reno.

Diggs Threatens Girls.
"Well," Hillhouse declared Diggs said, "it's up to you girls whether we go to the penitentiary."

And to this the witness declared Miss Warrington replied: "We'll stay with you."

After a rather brief examination Chief Hillhouse was taken in hand by Attorney Devlin for the defense, who tried to show that the girls, after the Reno capture, were in a "happy" frame of mind and that they gave no signs of having been in any manner in duress. Hillhouse's answers along this line were largely affirmative.

Confirmed by Constable.

C. T. Read, a Reno constable, who was with Hillhouse when the elopers were discovered in Reno, followed his chief to the stand. His testimony was substantially the same.

Girls' Hair in Disorder.

Practically all the witnesses called today were interrogated closely as to the condition of the cabin after the arrest of the eloping quartet when routed from bed on the morning of March 14 by Chief of Police Hillhouse and other Reno officers.

"The girls came out of the bathroom with hair disordered and their dresses loosely donned when we appeared at the cottage," said Chief Hillhouse. He reiterated the statement ascribed to Diggs that "he hoped the Sacramento officers would place him in a strong box, as he feared being shot by Mr. Warrington."

Both men said "We've done nothing wrong," was the chief's further contribution. He was then cross-examined by Attorney Devlin for the defense and admitted he had heard Marsha Warrington state to her father over the long distance telephone that "the boys are not to blame."

"She said words to that effect," admitted Hillhouse, "asking her father not to do anything to the boys; to drop the case."

The next witness to be called was John L. McNab, former United States district attorney here who resigned his position following charges made by him that Attorney General McReynolds was delaying the prosecutions of Diggs and Caminetti under the excuse of "pull" exercised in Washington. McNab was expected to simply identify certain exhibits in the case.

Chief of Police Hillhouse of Reno in his testimony regarding the arrest of the Diggs-Caminetti party this morning, said he did not remember that Miss Warrington had said that if it came to a fight between the parents of the girls and the boys, she would cast her lot with the boys, as was intimated by Devlin.

Bearing on the state of mind of the

two girls, as to whether they were dejected or not, Hillhouse stated that the four, after having been arrested, asked if they might witness a performance by Chauncey Olcott. This was held material by Judge Van Fleet. The witness stated that he had persuaded the girls not to go.

Both Cried Bitterly.

To negative this testimony, Special Prosecutor Roche for the government brought out that when the girls were confronted by Martin Beasley, a close friend of both families, they broke down and wept bitterly. This was again followed by an assumption of bravado, he stated.

"It's too bad we were interfered with; we were having the time of our lives," is a declaration accredited to Miss Norris by Chief Hillhouse. "The girls seemed to be having a good time until in the evening, after the telephone conversation of Miss Warrington with her father," he continued.

Caminetti Very Gay.

That Caminetti had attired himself in a policeman's old uniform while waiting at the station and had not only contributed some impromptu vaudeville for the benefit of the other three, but had also posed for a picture—exhibited in court today—was Hillhouse's testimony.

T. A. Read, constable for the township of Reno, testified that he had discovered under the pillow of the bed alleged to have been occupied by Miss Warrington and Diggs evidence of the allegation made in the indictment as to the purpose for which the two girls were taken to Reno from Sacramento.

In the other room, alleged to have been shared by Caminetti and Miss Norris, Read found similar evidence, he stated.

BLIND STREET MUSICIAN IS AWARDED A DIVORCE

Oregon City, Or., Aug. 12.—After only four months of wedded life, Edward Joseph Emery Thompson, a blind street musician of Portland, applied for a divorce in the Clackamas county circuit court and was granted this divorce from Josephine B. Thompson, for cruelty.

They were married in San Francisco, January 27, 1913, and shortly afterwards Thompson alleges, his wife refused to help him about the house and finally left him and went to Everett, Wash. He sent her \$30 and when she wrote to him, acknowledging the receipt of the money, she said she "did not want him to ever write to her again as she did not want to hear any more from him and did not want to live with him" and for him not to come to Seattle or Everett as "it was no place for a blind man."

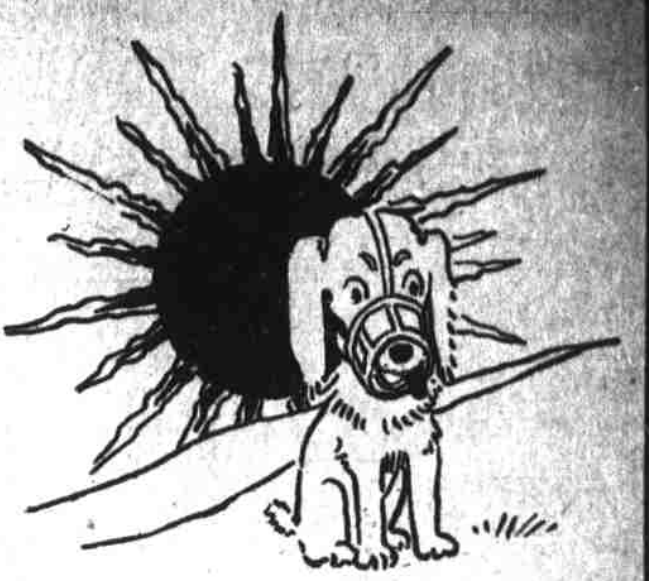
