FRANK JAGGAR'S HOME LIFE BARED BY WIFE IN SUIT FOR DIVORCE

Rich Clackamas County Man May Have to Give Up 1-3 of Loved Property.

(Special to The Journal.) Oregon City, Or., Aug. 12.—The tale of a life which to outward appearances was that of a successful, respected business man, but at home was that of a Mr. Hyde unmasked, is told in the divorce complaint filed in the Clackamas county circuit court yesterday by Mrs. Jeannette Jaggar, wife of Frank Jaggar, the wealthy Clackamas county farmer and former member of the state legislature.

Allegations of personal indignities too extreme to relate are made in the complaint. Mrs. Jaggar says her health was injured for life.

Although Jaggar's fortune is said to be \$200,000, Mrs. Jaggar alleges he did not buy her a new dress for four years and that it was only when his mother died and he had to supply her with mourning that he bought one then.

her husband permitted her to buy during the 20 years of their married life cost \$5.00; at the same time, she says, Jaggar, in order to present an appearance of poverty at home but affluence abroad, had a \$60 tailor made suit of clothes at his mother's house and changed there each time he left their farm for the city.

Carries Water 28 Years. Mrs. Jaggar further alleges her husband never made any repairs around their house and never supplied her with any of the modern conveniences even moderately wealthy people had, and that she has been obliged to carry house water from a spring to their house during the dry months all these years.

While she was sick with a malady for which she accuses Jaggar, she says their 17-year-old daughter Cora had to wait upon her so closely that she became seriously ill, which made Jaggar so angry on account of the expense that he drove his daughter from home. The daughter has been obliged to earn her own living since then, about eight years ago, the complaint says.

Mrs. Jaggar further alleges that her husband, instead of procuring medical aid for their eldest son, Lewis, who was weak mentally, had him committed to the state insane asylum at Salem, to save the expense of medical aid.

She avers she could not keep a woman servant about their home because of her husband's nature.

Asks One Third of Property and \$6000. Mrs. Jaggar asks for an undivided third interest in her husband's property, custody of the children, \$6000 permanent alimony, \$100 a month alimony, \$1200 attorney's fees and \$100 a month during the duration of the suit.

"Frank Jaggar is a well known business man of this county. He has extensive holdings in Clackamas county property and is interested in several business blocks in Oregon City. He also owns considerable property in Portland. He has been quite prominent in Clackamas county politics for a number of years. As well as being a member of the state legislature, he has been chairman of the Republican county central committee several times and at present has charge of the supervising of all county roads in this county. C. M. White and Farrington & Farrington, Portland lawyers, are the plaintiff's attorneys."
