

CIVIL SERVICE BOARD NOT READY TO DECIDE POLICE CASE TODAY

Hearing of Former Captain Slover's Case Postponed on Account of Examination

No decisions in the cases of the discharged members of the police department will be forthcoming today, according to an announcement made this morning by George W. Caldwell, chairman of the municipal civil service board, which recently heard the charges against the men.

Chairman Caldwell said that through mistake it was announced that decisions in the case of 11 of the men were to be rendered today, while the board had had hardly time to peruse the evidence. It had also been announced that the hearing of the charge against former Captain E. A. Slover was to be held on January 22, but according to Mr. Caldwell the hearing will not be on that date, as examinations for captains will be given then.

A date for the announcement of the decisions will be given probably at the next meeting of the board and a date for hearing ex-Captain Slover will be officially set at the same time.

PLAN TO OBLIVATE RED TAPE

City Officials Discuss Methods of Buying Supplies.

To obviate red tape and prevent employees from purchasing supplies on requisitions when there are no appropriations for the purchase was the purpose of a meeting held this morning by Commissioners Bigelow and Brewster, City Auditor Barker, Purchasing Agent Wood and the chief clerks of the city departments purchasing material and supplies.

Mistakes have been made in the past by having employees purchase goods on requisitions when no appropriation for the purchase of the goods existed. While all matters pertaining to the issuance of the requisitions and the handling of the orders by the purchasing bureau were discussed no final action was taken, it being decided to leave the matter in the hands of a committee. Questions pertaining to the administrative cost relative to purchases were also discussed.

The work is being done in excellent condition as a new steel bridge was built across the Klickitat river, two miles north of Lyle, last fall and a concrete bridge built to replace a wooden trestle in the upper canyon about the same time.

'MOTHER' ONES HELD PRISONER IN TRINIDAD BY GOVERNOR'S ORDER

Returned to Camp After Being Deported Once and Is Rearrested.

(United Press Leased Wire.) Trinidad, Colo., Jan. 12.—"Mother" Jones was arrested just before noon today. The arrest was made by Lieutenant Nichols and five privates of the Colorado National Guard. It occurred at the Municipal Hotel, where "Mother" Jones was arrested. Cavalry and infantry drove strikers off the nearby streets while Lieutenant Nichols and his squad took "Mother" Jones into an armored automobile and hurried to Camp San Rafael hospital, where she will be held until General Chase and Governor Emmons order otherwise. She was arrested on orders of Colonel W. A. Davis, who acted under instructions of General Chase, who was in conference with Governor Emmons in Denver. The prisoner offered no resistance. Before her arrest striking miners and others were previously several days ago, but was not allowed to remain. Adjutant General Chase, commanding the militia in the region, had a detachment of soldiers meet her at the railroad station, an officer accompanied her while she bought a ticket, and she was escorted past Walsenburg, beyond which point military rule does not extend.

John German, miner, was shot dead at Walsenburg last night by a sentry, according to the latter's account, because the miner disregarded a command to halt while he was crossing the line into the military camp.

FOREST OFFICIALS IN BIENNIAL CONFERENCE

Meeting Which Lasts Ten Days First of Three Gatherings.

Seven supervisors of national forests of Oregon and Washington are at the district offices of the United States forest service today in the beginning of a biennial meeting that is to last ten days. The last meeting was held during the winter of 1911 at the district offices of the forest service in Washington and Alaska were present at one time. At this meeting, however, the supervisors are coming in in pairs, one from each of the two states. The meeting is for the purpose of discussing the work of the supervisors and the instruction work may secure more intensive attention on the part of each individual. Another group of ten supervisors will come in on Wednesday, January 21, and after they have spent the same period of time a third and last group of nine supervisors will be at headquarters. The meeting on the national forests was the topic under discussion today, but during the time they are here, forest planting, timber sales, conduct of timber sales, fire protection, map making and telephone construction will be gone into.

Each supervisor has two or three papers to read on some one of these topics. Present today are Harry N. Hale, Okanogan, Wash., supervisor of Okanogan forest; George W. Millham, Chelan, Wash., supervisor of Chelan forest; A. H. Sylvester, Leavenworth, Wash., supervisor of Wenatchee forest; C. C. Reid, Republic, Wash., supervisor of Colville forest; M. L. Merritt, Bonanza, supervisor of Deschutes forest; M. C. Erickson, Medford, supervisor of Crater forest; N. F. Macduff, Grants Pass, supervisor of Siskiyou forest.

W. A. CARTER ENTERS RACE FOR GOVERNOR ON REPUBLICAN TICKET

Candidate in Platform Gives Many Measures of Progressive Laws Favored.

Forty-five hundred refugees, including the troops of the beaten Ojinaga garrison, were in the concentration camp here today. They were without food, shelter of clothing, except what they wore. There was much sickness among them, but there had been no deaths as yet. American pack trains were rushing supplies from Marfa, Texas, the nearest railroad point, 78 miles away.

The fugitive soldiers will be held prisoners here until the war is over. The other refugees will be transferred to Marfa as soon as possible. According to the rebel account, Saturday night's casualties were 27 rebels and 83 federalists killed, and 40 rebels and 120 federalists wounded. It was believed, however, that these figures were too low.

Each Ammunition Captured.

All the Ojinaga artillery was captured by the rebels with the exception of two cannon, which were brought off the river by the prompt action by the United States troops. At Major McNamee's order, Villa ridiculed the claim that lack of ammunition for the garrison forced the evacuation of Ojinaga. He said he captured several hundred thousand cartridges, 1000 horses, 1000 saddles and hundreds of rifles. In addition to this the fugitives surrendered to the United States troops 100,000 pounds of ammunition and 2100 rifles.

Four Members of I. W. W. in Court at Marysville for Killing District Attorney.

(United Press Leased Wire.) Marysville, Cal., Jan. 12.—The joint trial of Richard Ford, Herman Sobel, William Beck and Harry Bagan, charged with the murder of District Attorney E. T. Maxwell and Deputy Sheriff Eugene Reardon in the Wheatland hop ranch riot, was begun here today.

"I am impatient of delay in this matter. Now is the time to act. We have every natural advantage for the development of a great commerce, and but one natural disadvantage—the bar at the mouth of the river. Its removal must be accomplished. The action of the committee authorized, one completed and one under construction, will be of aid in narrowing the river current at its mouth from seven to two miles."

All Interested Are Invited.

President Averill said that his call for the meeting would include all interested in the commercial future of this port. He does not intend that any man who can contribute anything to the campaign should be excluded. He said that the Chamber of Commerce has already endorsed the movement and has committed itself to it, and that the public gathering for organization in support of the measure of accomplishment desirable and necessary. He has in mind to especially ask representatives of the various business organizations of the city, also the port and dock commission and the city commission.

Young Slover Better.

Walla Walla, Wash., Jan. 12.—Clark Slover, captain of the 1914 Walla Walla football team, who with Miss Edna Wilson, also of the college, was pinned beneath a wrecked automobile for two hours Saturday night, will recover. Miss Wilson was slightly bruised and Slover suffered temporary paralysis from the chest and abdomen.

TRAFFIC IS TIED UP BY AFRICAN R. R. STRIKE, FAMINE THREATENING

General Strike Favored by Unions at Johannesburg; Sunday Was Peaceful.

(United Press Leased Wire.) Cape Town, South Africa, Jan. 12.—Though Sunday was comparatively quiet so far as the railroad strike was concerned, the authorities were still on the alert today.

Traffic was still nearly at a standstill in the Transvaal and the Orange State, and if the tie-up continued it was agreed that it was only a question of time before a famine in foodstuffs would result. There was the threat, too, of a general strike of all industries at Johannesburg, where Sunday's mass meeting of the Trade Federation adopted resolutions in favor of a combined walkout.

John Langford and Frederick were considered the principal danger points and strong forces of militia were held ready at both points, though the soldiers were kept as much as possible in the background. Demonstrations against arousing needless antagonism.

The native situation continued critical. The blacks at Jaegersfontein were somewhat subdued, following the repression of the outbreak with cost several of their lives last week, but at Johannesburg and elsewhere throughout the country they were in an ugly frame of mind, and it was clear that if the strike should get out of hand, a native revolt will also have to be reckoned with.
