

WILLAMETTE TRUSTEES DISCUSS ADVISABILITY OF EXTENSION COURSE

Matter Considered at Semi-Annual Meeting of Trustees, Held in Portland.

A spirited discussion as to the advisability of establishing extension and correspondence courses at Willamette university featured the semi-annual meeting of the trustees of the Salem institution held at the First Methodist church, Third and Taylor streets, this morning.

Extension work was heartily advocated and endorsed by Dr. Fletcher Homan, president of the university. In his report to the trustees, the reading and discussion of which occupied most of the morning session, Dr. Homan urged the giving of extension lectures and courses by members of the faculty of Willamette university as a means of keeping pace with the other higher educational institutions of the state, notably the State university and Agricultural college and Pacific university.

Would Attract Students.

Drawing the attention of the people of the smaller towns and cities to Willamette, he pointed out, through extension lectures would prove a means of attracting students to the Salem school. He stated that the extension course could easily be arranged to the material benefit of the university.

"Willamette university," he said, "is suffering because it is not going out among the people." Several of the directors opposed extension work, on the ground that it was lowering the standards of higher education. It was stated that the universities of Wisconsin and Minnesota, where extension work has reached its highest form, are the greatest corruptors of higher education in the country.

Questions Are Referred.

The questions of the discontinuance of athletics, the law school and preparatory school at the university were referred to committees to be reported at the June meeting of the trustees. Questions of insurance on university buildings and dormitory locations and library funds were also referred.

BOY MURDERER MUST DIE UPON THE GALLOWS

Los Angeles, Feb. 10.—Lewis Bundy, the boy murderer of Harold Ziesche, was sentenced today by Judge Willis to be hanged at San Quentin April 24. Bundy, sitting sullenly among his relatives, was dumbfounded by the sentence. The belligerent, surly attitude that he assumed soon after his arrest was swept away in an instant, and his soba filled the courtroom.

Larceny Warrant Did Issue for "Major" Howard The Journal's Account of Affair Was Correct

Fac Simile of Warrant Charging "Major" James J. L. Howard With Larceny by Bailie, Which Was Issued by Judge Joseph H. Jones on January 3, 1914. The "Major" Has Sued The Journal for \$20,000, Disputing the Truth of This Statement.

WARRANT FOR ARREST FELONY.

IN THE NAME OF THE STATE OF OREGON.

To the Sheriff or any Constable of the County of Multnomah Greeting.

Information upon oath having been this day laid before me that the crime of Larceny by Bailie, James J. L. Howard, has been committed and accusing James J. L. Howard, thereof.

Now we therefore hereby command you to arrest the above named James J. L. Howard, and bring him before me at my office in said County, or in case of my absence or inability to act, before the nearest of most accessible magistrate in this County.

Man From Whom He Secured Money to Buy Cavalry Horses Caused Issuance of Document Which Is in Possession of District Attorney.

Because The Journal, on January 4, printed a news story stating that "Major" James J. Howard, formerly connected with a cavalry troop which was being organized here, was being sought by the district attorney, the Journal Publishing company for \$20,000 damages. He alleges the article was untrue.

The statement was true. Howard was being sought on a warrant charging larceny by bailie. A facsimile of the warrant is reproduced in this issue of The Journal. Barney McCarthy, a deputy constable, went to the union depot on the evening of Saturday, January 3, in an effort to arrest Howard. The warrant was issued by District Attorney Delch at the request of George T. Wilson, a young attorney in the Lumbermens building, and was signed by District Judge Joseph H. Jones.

Wilson secured the warrant only after consulting two other attorneys, Charles A. Robertson and M. G. Montreza, personal friends.

They, like Wilson, had given Howard money some time previously to buy some cavalry horses, which Howard had represented he could purchase from a man near Independence, cheaply because the man had got them on a mortgage. He had failed to secure the horses, had retained the money, and they sought his arrest on Saturday night, January 3, because he had said he was going to Reno to buy some horses he said he could secure, and they doubted his statement.

Howard was not at the depot at the time he said he would be there and the warrant was not served.

A few days later Montreza, Wilson, and several other young men who had given Howard money to buy horses, received postal cards postmarked "Reno" and signed by Howard. In them he said he would soon be back to Portland.

In addition Aaron Frank, of Meier & Frank, received a telegram from Howard requesting the loan of \$150. Frank ignored the wire.

When Howard returned he brought no horses with him. He collected the postcards he had sent and the original of the telegram he sent Frank. Among the men from whom Howard had secured money to buy horses were George T. Wilson, \$25; M. G. Montreza, \$15; Charles Robertson, \$20; and Roger Macveigh, \$30. When these men were seen yesterday they declared they had not been repaid. Moreover Howard, it is said, owes a bill at Meier & Frank's which likewise remains unpaid.

EXEMPTIONS UNDER DANCE ORDINANCE ASKED BY SOCIETIES

Question Discussed Pro and Con; Commissioner Will Consider Issue.

Since the new dance hall ordinance has been in effect there has not been one girl arrested whose delinquency was the result of attending public dances, according to a statement made by Mrs. Lola G. Baldwin, head of the municipal bureau for the protection of young women, this morning. The statement was made at a meeting held by C. A. Bigelow, commissioner of finance, to give those who were opposed to certain sections of the measure an opportunity to be heard.

A number of representatives of German speaking societies, benevolent and social organizations spoke against the regulations prescribed for them in the ordinance, although all stated that they were in favor of regulating the public dance halls. They asked that they be exempted from the regulations.

There were several members of the Women's Christian Temperance union present, including Mrs. Mary L. Maloney, Mrs. M. J. Maloney, and Mrs. E. J. Maloney. They spoke in favor of the ordinance and urged that all dances be regulated were Rev. B. J. Thoren, of the Swedish Tabernacle, Mrs. M. J. Maloney, of the W. C. T. U., Mrs. G. L. Buland, of the Parents' Teachers' association, Miss Helen Saxton, of the Y. W. C. A., and others.

Representatives of the Mothers' Congress, People's Institute and the Recreation League were also present.

J. E. Werlein, representing the American Order of United Workmen, asked that if any action was taken on the ordinance, that the section exempting the schools and the city be repealed. He stated that the ordinance would embrace every dance, no matter by whom it was held.

Commissioner Bigelow stated that he would take the matter under discussion and recommend to the council at its meeting next week.

YOSEMITE ROBBER CAUGHT IN SALT LAKE

"Gentleman Bandit" Who Held Up O.-W. R. & N. Again Arrested.

Salt Lake City, Utah, Feb. 10.—Milton Lee, in jail charged with counterfeiting, has confessed he served three terms in San Quentin for Yosemite stage robberies and one for an Oregon train robbery.

Lee was arrested January 31, with counterfeiting dies in his possession. In his confession he said he was well known in the sixties and seventies as the gentleman bandit of the Yosemite.

Lee said he received his first sentence to San Quentin in 1868 for horse stealing. He was pardoned after six months, but two years later received a second one to the same prison for the same offense, and this time served four years.

Then he took to the road, operating mainly in or near Yosemite National park, and estimated that between 1874 and 1884 he robbed 120 stage coaches.

Finally he was caught and this time put in 12½ years behind the bars.

Following his release, in 1897, he said he held up an Oregon Railroad & Navigation company train in the city of Portland, was caught directly afterward and stayed in prison again until 1907, when he was pardoned.

While he admitted that he had been counterfeiting gold coins he said he made them only for ornaments.

Even before that he considered his really criminal career began Lee said he operated during Civil war days as a highwayman in California, devoting his plunder to the aid of the federal cause.

He had, he added, a son and daughter in Fresno, a nephew in a San Francisco bank and a brother in San Jose.

Milton H. Lee, alias Charles Jackson, in company with Charles Williams, held up an O. R. & N. train at Corbett station September 25, 1897, compelling the engineer and fireman to leave the train, after stealing the engineer's watch. The two men were compelled to flee before the job of robbing the train was completed when the train crew opened fire on them.

Lee was sentenced to 30 years and seven months in the penitentiary at Salem and was paroled after 10 years.

THOMAS HARDY MARRIED

London, Feb. 10.—Thomas Hardy, the famous novelist and his typist, Miss Florence Dugdale, were married at 8 o'clock this morning in the parish church at Enfield. His first wife died in 1912. His bride is the author of several well known books for children.

BANDON ASKING \$250,000

The port of Bandon has taken steps to raise \$250,000 for that purpose and the government is asked to duplicate the amount in the resolution by the senator today.

POLES PROTEST AT EDUCATIONAL TEST

BASEMENTS FLOODED WHEN WATER BURSTS DAM UPON HILLSIDE

Streets and Private Lawns Damaged by Debris; Up-roots Shrubby.

With a roar that brought many householders out of their beds, 50,000 gallons of water impounded in King's gulch, by the Lewis-Wiley Hydraulic company for use in sluicing terraces above Summit avenue, broke through the bulkheads shortly before midnight and poured mud, water, stones and splintered lumber into the fashionable residence section below.

Nelanda and Summit avenues, Twenty-fifth street, Kearney, Johnson, Lovejoy, Marshall and Northrup streets were flooded for blocks, and today are covered with mud and sand while piles of debris ranging from a few inches to a foot encumber the street intersections.

Several lawns were badly damaged, shrubbery was uprooted and basements of houses were filled with the murky fluid. Although the streets were considerably messed up, the actual damage was comparatively slight.

President William H. Lewis of the Hydraulic company today estimated that it will not exceed \$2000.

Basements Are Flooded.

The principal damage done by the roadway of Melinda avenue. Shooting over the terraces above the main stream poured down this thoroughfare, which is macadamized. And great was its force that the curbing was torn from the street, and carried down the grade for blocks.

Melinda avenue winds down the hill and ends at the intersection of Twenty-fifth and Johnson. Immediately below the first curve stand the homes of Charles Warren and L. H. Turpley. These houses got the brunt of the torrent. The basements of both were flooded and the lawns damaged. The basement of the home of Adrian McCalmade on Melinda avenue, nearby, was flooded also.

Theatre-Goes Caught.

The downpour from the bulkheads lasted for about 15 exciting minutes, starting at 11:30 o'clock. The theatre-goers were caught in the stream and compelled to wade out and an auto bearing several persons is reported to have been swept down Lovejoy street by the torrent for half a block, no one was injured.

Damage Being Repaired.

It was the wreckage from the bulkheads and the curbing and macadam from Melinda avenue that were swept into the streets below.

Owing to the quantity of water released the sewers were unable to carry it off and the turgid streams started as far down as Seventeenth street on Kearney and Marshall, before the sewers absorbed them.

Streetcar service was delayed somewhat on Twenty-third street.

Work of cleaning up the streets and repairing damage is already under way and virtually every trace of the flood will be removed in a few days.

COLUMBIA HIGHWAY IS SURPRISE TO BUSINESS MEN WHO INSPECT IT

Beauty of Road and Scientific Construction Makes Impression.

Upon invitation of the county commissioners a party of Portland's representative business men inspected the work being done by the county on the Columbia river highway, yesterday. Included in the party were J. C. Ainsworth, H. C. Campbell, C. S. Jackson, A. S. Benson and Brookwell Statton. Under the chairmanship of County Commissioner Rufus C. Holman, Consulting Engineer Samuel C. Lancaster and Roadmaster John B. Yeon the party walked over the route from Onesta gorge to Latourelle Falls.

The beauties of the road and the scientific method of construction were a revelation to those who saw the work for the first time. A striking contrast between the new and the old way of making roads was observed just east of Bridal Veil, where two years ago a stretch of road was made at a cost of \$10,000.

Contrast With Old Road.

The grade is full of steep pitches and sharp turns and a great deal of it will have to be thrown away to conform with the new construction. In the vicinity of Multnomah Falls westward a great part of the grade has been completed. On its lower side it is bounded by artistic walls of rock.

The right-of-way is one mile long except in two cases, one at Onesta gorge and the other at Latourelle. In connection with the obtaining of the right-of-way a noticeable fact is that it has been given by those who could least afford it and withheld by those who could best afford it. This fact was commented by one member of the party who characterized the latter as "speculators on the natural glories of the country who instead of being damaged by the road will be greatly benefited by it."

Force to Be Increased.

It is the intention of Roadmaster Yeon to put two more crews at work in a few days, about 100 men in each crew.

It is desired to force the work of construction between now and June 1, when it is expected that it will be possible to travel to Multnomah Falls with the same ease and comfort that the road between Portland and Chanticleer inn can be traveled.

Butter Suit Continued.

Chicago, Feb. 10.—The trial of the government's suit against the Elgin and Chicago butter and egg boards was continued today until February 25 by Judge Landis. The boards are charged with violations of the Sherman law.
