State Railroad Commission  
Asked to Double Charges  
by Independent Company.

COMPETITOR IS INCLUDED

Asserts That Present Rate Is Not Sufficient to Pay Operating Expenses.

(Salem Bureau of The Journal.)  
Salem, Or., June 6.—To double the telephone rates in Corvallis is the request made of the state railroad commission by the Corvallis Independent Telephone company, which is a part of the Home Telephone system. Not only does the independent company ask for permit to increase its own rates 100 per cent, but it also asks the commission to order the Pacific Telephone and Telegraph company, whose rates are lower than the independent company, to raise its rates.

There has been a rate war on between the two companies at Corvallis, and at one time the independent company threatened to pull out of Corvallis. It now asks for increased rates as follows: Individual business line, from \$1.25 to \$2.50; two-party business line, from \$1.25 to \$2.50; two-party residence line, from \$1.25 to \$2.50; four-party residence line, from \$1.25 to \$2.50.
