

HARMONY IS FEATURE OF THE REPUBLICAN MEETING AT TACOMA

Delegates Work Together on Platform They Hope to Put Through.

POWELL IS IN THE CHAIR

Many Washington Women Are Among the Delegates and One Has Her Baby in Her Arms.

(United Press Leased Wire.) Tacoma, Wash., June 18.—Working harmoniously and eager to get down to the business of drafting a platform that they hope will carry them to victory in the fall campaign, nearly 500 delegates to the state Republican convention assembled here today and elected by acclamation John H. Powell of Seattle, temporary chairman, Sam R. Sumner of Wenatchee as elected temporary secretary and George J. Stewart of Okanogan county assistant temporary secretary.

Noticeable among the delegates were over a score of women, attending their first political convention, and one woman delegate was present with a baby in her arms.

The convention was called to order by Chairman Rupp, after an invocation by Rev. Bloomquist of Tacoma.

In his address Rupp said the convention had assembled "for the purpose of repledging faith, of defining Republicanism anew, of pointing out the path the Republicans are to tread, and providing a guide for all who desire efficient and stable government, based on the truths of experience and not purely progressive." This is a Republican year, he said.

"Possibly no action, however ill advised, can prevent a triumph at the polls this fall," he continued, "but it is the duty of this convention so to act that victory is here and now assured, so to act that confidence in the capacity of the Republican party to govern rightly will be firmer than ever."

Relatives Request Temporary Truce

District Attorney Evans Receives Telegram in Behalf of Miss Marie Greenwood, Under Arrest Here.

District Attorney Evans received a telegram from Pennsylvania relatives of Miss Marie Greenwood, the pretty young woman arrested on a charge of impersonating Mrs. F. P. Russell and charging purchases to Mrs. Russell's account, asking that communication be delayed until further communication can be had.

The telegram suggests that arrangements will be made if possible to straighten out Miss Greenwood's affairs and have her taken to her home in Pittsburgh, where relatives will take care of her that she may be kept out of trouble in the future. No action will be taken until further word is received from the east.

It is said that Miss Greenwood is a grandniece of former Congressman John Dalzell of Pennsylvania.

Trial of Herlow Case Is Started

Member of Realty Firm Is Charged With Converting Clients' Money to Own Use; Partner Convicted.

R. C. Herlow, jointly indicted with W. H. Chapin on a charge of larceny by baillee, was placed on trial in Circuit Judge Morrow's court this morning and a jury is being selected. Chapin was convicted of the charge and is under sentence of one to ten years in the penitentiary. Steps are being taken to appeal his case.

Chapin and Herlow are alleged to have taken \$1500 from Mr. and Mrs. William Grace for the purpose of investing the money for the Graces in first mortgage securities, and with using the money for their own interests instead. Chapin and Herlow operated the Chapin-Herlow Mortgage & Trust company.

Mrs. Davis Files Suit.

Vancouver, Wash., June 18.—Suit for divorce was filed in the superior court yesterday by Bessie M. Davis against Ernest Davis. Non-support and abandonment are the alleged grounds on which she asks the decree.

Woman Poisoner Not Responsible

Federal Grand Jury Returns Not True Bill Against Mrs. Hawley, Who Is Now in Asylum.

Because she has been adjudged insane and is now in the asylum, Mrs. Edith Edna Hawley, the woman who attempted to poison several of her stepchildren by sending them candy filled with bichloride of mercury through the mails was not held responsible for the offense. The United States grand jury and that body returned a not true bill in her case yesterday.

Thomas G. Smith, Klamath Indian, was indicted on a first degree murder charge. He is accused of fatally assaulting an Indian farmer, Link River, when the latter, on May 27, ordered Smith off his farm. William Matthews was indicted for white slavery, and today an old indictment against him charging counterfeiting, was dismissed. Several other secret bills were returned and several not true bills were made public on minor charges.

The grand jury, which has been grinding since April 27, and which has returned 40 bills, some indictments and some dismissals, was adjourned and a new inquisitorial body will not be called until September.

Try to Force Filing Of Recall Petitions

Mandamus Proceedings to Be Brought Against Rusk, Keith and Orledge To Compel Production of Documents.

Mandamus proceedings will be instituted against former Mayor Rusk, Keith and Orledge if the recall petitions against Mayor Albee and City Commissioners Dieck and Brewster are not filed with City Auditor Barbur by next Tuesday.

David Gross, unsuccessful candidate for the Progressive nomination for congress from the Third district at the recent primary election, is authority for this statement.

Gross believes that these men have in their possession or know the whereabouts of the petitions in question, and that they are withholding them, thereby making possible a recall election. He will go to the courts in an effort to make them produce the petitions.

He has retained Robert M. Alstrop and Frank E. McGinnis as his attorneys.

Man Gets Judgment Against Railroads

Passenger Injured in Accident Near Lakeview, Wash., Awarded \$9000 Damages in State Circuit Court.

Damages of \$9000 were assessed against the O.-W. R. & N. and Northern Pacific railroads in favor of Adolph Swanson by a jury in the court of Circuit Judge Anderson of Baker, who is assisting the local justice, in clearing their dockets. Swanson was a passenger on an O.-W. R. & N. train on the Northern Pacific tracks May 12, 1913, when the train struck the wrecking train near Lakeview, Wash. He alleged that the force of the wreck had wedged him between seats and he had been severely injured. The jury found that he did not disclaim liability, but alleged that Swanson became much worse after he had retained an attorney and that his injuries were not as serious as claimed. Swanson has a machine list. He sued for \$50,000.

FORMAL SCHOOL OPENING

Monday evening at 8 o'clock a formal opening of the new Alnsworth school will be given in the school assembly hall. Judge H. H. Northrup will deliver an address on the "Life of Captain Alnsworth," for whom the school was named and whose life helped to make history for Oregon. A splendid musical program will be rendered by Mrs. Pauline Miller-Chapman and John Claire Montello, also a reading will be given from the "Blue Bird," by Miss Edith Woodbury.

Goose Kills Bull Terrier.

Tulare, Cal., June 18.—C. E. Doffle-meyer, a rancher, is exhibiting today a goose that he avers killed his bull terrier in a fair fight. The goose, he declared, seized the dog by the neck and dragged it into an irrigation ditch and held it beneath the water until it drowned. The goose suffered a broken leg and wing in the battle.

Accused of Having Opium.

Ali Chung, Chinese, 107 1/2 Fourth street, arrested yesterday by Officers Westbrook and Miller with opium candies in his possession, was turned over today to the United States attorney, and will be given a preliminary hearing before United States Commissioner Frederick H. Drake Saturday morning.

FIRST ADMISSION IS MADE THAT MEXICAN PEACE IDEA MAY FAIL

Administration Has Not Yet Abandoned Hope, Things Look Dubious, However.

VILLA BREAK MAGNIFIED

Exertists Making Capital of Alleged Riots—Federalists Mourn Tampico Commander's Suicide.

(United Press Leased Wire.) Washington, June 18.—For the first time since American-Mexican mediation negotiations began, it was admitted in administration circles today that failure was possible.

Hope had not been abandoned, but the fact that the Mexican envoy had published their side of the case was deemed unfavorable.

It was not denied that the break between General Carranza and Villa, which it was generally admitted today actually had occurred, despite all statements to the contrary, had furnished the Hostetters with an argument against the selection of a constitutionalist civil and military departments.

General Villa was reported this afternoon to have sent three of his officers to General Carranza to demand the complete divorce of the constitutionalist civil and military departments.

In pleading contract to the barbarities which have marked so much of the fighting in Mexico, a report was received from Mazatlan saying the federal gunboat Guerrero, which sank the rebel gunboat Tampico at Topolobampo, had arrived at the former port with flag at half mast in honor of Captain Malpico, the Tampico's dead commander.

Malpico shot himself when he saw that defeat was inevitable. He was formerly a federal lieutenant and the Guerrero's officers, who knew him, mourned him seriously.

It was stated that they had also decided to spare the lives of the captured members of the Tampico's crew, and consequently they would not turn them over to the shore authorities, lest they be executed.

Contested Delegates Entitled to Seats

Modern Woodmen of America, in Toledo Convention, Sustain Ruling of Head Consul Talbot.

Toledo, June 18.—By a vote of 225 to 131 the Modern Woodmen of America, in convention here today, sustained the ruling of Head Consul Talbot that 15 contested delegates were entitled to seats. The entire morning session was devoted to a discussion of the contest over which set of delegates would represent Iowa. When the question came to a vote the delegates whose seats had been contested were seated.

Leaves Large Family.

The first post Mr. Hill gave Mr. Harder was the general agency of the freight department of the Great Northern at Helena, Mont. After several years there, he was transferred to Portland in 1894, coming on the first train to reach the city after the high water had put the O.-W. R. & N. temporarily out of business. He was a member of the Commercial club, the Transportation club, Clatsop and the First Presbyterian church. His family consisted of the widow, two sons, Stuart J. Harder, 679 Talbot avenue, and William A. Harder of Seattle; five daughters, Mrs. George C. Hazzard, Mrs. Henry Gunther and Mrs. W. L. Wern of Los Angeles, and Mrs. W. J. Sheppard and Mrs. C. S. Richardson of Winnipeg, and nine grandchildren.

was quite badly burned. Then I put the little boy in the stove." The father, who was charged with the body after getting a shovel at the mill, and that still later he dug it up again and put it in the mill furnace, where he thought all traces of it had been destroyed.

Coroner Poindexter, Sheriff Frank Eldkins and District Attorney W. H. Wirtz conducted the investigation after the mother had expressed the suspicion, and found many evidences of the crime.

PROSECUTION DISMISSED

On recommendation of J. H. McKenzie, an insurance man, the criminal case of Rev. John H. Hopp, pastor of the German Ebenezer Congregational church, has been dismissed. Hopp was found guilty by District Judge Johnson of appropriating \$24 paid by McKenzie to the church in return for insurance premiums, and \$5 which McKenzie donated to the church and not accounting to the church for the money. Hopp was sentenced to six months in the county jail. A letter from McKenzie states that the money Hopp was alleged to have retained has been paid back.

Former Sheriff Wins Case.

Former Sheriff Robert L. Stevens yesterday won a verdict in Circuit Judge Morrow's court in a suit against him by Samuel Strebin, in which Strebin asked for \$312 for boarding a horse from June 24, 1911, to Oct. 12, 1912. The horse was taken by Stevens on an attachment of bond in answer to the suit he alleged that all arrangements were made for the care of the horse by the owner and Strebin. Strebin asked for \$20 a month for the keep of the horse.

Court Fixes Taxes.

Inheritance taxes of \$265.82 and \$224.16 were fixed this morning by Circuit Judge Cleton in the estates of Henry Everding and Nannie Bowers, respectively. The Everding estate amounted to \$41,522.14, all of which was left to the widow, Theresia Everding. The Bowers estate totaled \$27,739.76, and goes to a sister in California and two relatives in Ireland.

Prominent Educator Dies.

San Diego, Cal., June 18.—James G. W. Cowles, for many years prominent in educational, religious and business circles of Cleveland, Ohio, died at home here last night. He was at one time a Congregational minister, leaving the ministry to become associate editor of the Cleveland Leader and later becoming president of the Cleveland Trust company.

CITY SAYS ABOUT \$4500 AS A RESULT OF COURT DECISION

How Money Is to Be Returned Is Question Puzzling Department Official.

AUDITOR MADE DISCOVERY

Police Department Certified Salaries of Men Not Working Owing to Illness; Rearrangement Planned.

The decision of the supreme court in declaring the police pension and relief fund act unconstitutional has brought to light the fact that the city is out \$1896.30, paid on conditional salary rolls for the police department. Just how this money is to be returned to the city's treasury is causing considerable worry to the department heads. It was due to the act of City Auditor Barbur that the payrolls were caught when they were and more money was not paid out.

When the act took effect June 1, 1913, a certain per cent of the salary of each member of the police department was held out each month and placed in the relief fund. When members of the department were taken ill and off duty those in charge of the payrolls at the police station certified them as being on leave. In a number of cases men were off 80 days yet the payrolls were certified that they had worked full time.

This kept up until late in April of this year, when City Auditor Barbur made the discovery. It was only an accident that the discovery was made, says Barbur. He immediately took charge of the matter and on investigation found that this had been going on for a number of months.

Those in charge of the payrolls explained that they had acted in accordance with the provisions of the relief fund act. The money, however, says Mr. Barbur, was not paid from the fund as the act provided, but instead came from the salary appropriations of the general fund.

The act provides that in case of illness a claim for salary could be made to the board of trustees of the fund, but this was never done, and on making the discovery Auditor Barbur refused to certify any payrolls containing the names of those who were off duty.

When the members of the police department learned that they were to receive no salary benefits in the way they immediately took steps to see why the relief fund act was not in operation. Later followed court action resulting in the supreme court deciding that the act was unconstitutional.

Auditor Barbur commenced this morning to make a check of all amounts paid into the relief fund by the policemen, who are having the city return it to the individual men. After this money is returned it is probable that steps will be taken to have the old city relief fund in operation again. Complications are expected when this work is started, as it is not known how the city is to get the \$1896.30 back in the general fund.

PRIZE WILL GO TO CHARITY

Department of Public Works Is Satisfied With Glory.

Instead of the department of public works receiving the \$75 cash prize for the best entry in class F of the floral parade, it is to get an inexpensive plate in lieu of cash, and the rest of the prize money is to go to the Visitation hospital fund. The department's modified milk station recently opened.

This is in accordance with the wishes of Commissioner Dieck and Howard Evans and A. K. Kippick, who assisted in building the prize winning float.

OLD BRIDGE PIER APPEARS

Government Wants Obstruction Removed Without Delay.

Demand has been made on the city by Assistant United States District Attorney Beckman to have the city remove the obstruction of the old bridge pier, which has been there ever since the old bridge was destroyed. In a letter to Mayor Albee, he said that the city is responsible for the removal of the obstruction, and the war department wants it removed as soon as possible.

In a note to the council, Mayor Albee says that the city is not responsible, which will be the bridge, is responsible and suggests that City Attorney La Roche require the company to do the necessary work.

Officials View Dairies.

Mayor Albee and the city commissioners were out of the city this morning viewing some of the dairies supplying milk to Portland.

Mrs. Vaughn Given Divorce.

On a cross complaint alleging desertion, Tena W. Vaughn was divorced this morning from Andrew D. Vaughn, better known as "Andy" Vaughn, city detective. They were married here April 12, 1899. Custody of a 7 year old daughter and \$40 a month support money were allowed Mrs. Vaughn. Circuit Judge Gates signed the decree of divorce. Judge Morrow granted a divorce to Elizabeth M. Nason from James A. Nason on grounds of cruelty, and Judge McGinnis signed a decree divorcing Grace Tindall from Thomas Tindall for desertion.

Arrested on Larceny Charge.

William Bonnerfield, an attorney, was arrested this morning by Deputy Constables Druhot and McCullough on a charge of larceny by Bailey of \$39 from Belle Brownell, who says she gave him the money to pay court costs in a suit and that he used the money for personal purposes. The Meier & Frank store made informal complaint that he has sold furniture purchased from them which was not entirely paid for and owes a balance of about \$70 on it.

Forecast Made of R. R. Rate Decision

New York American Prints Summary, Which It Claims Is Correct—Few Advances Sanctioned by Commission.

New York, June 18.—Forecasting the decision of the interstate commerce commission on the application of the eastern railroads for a 5 per cent increase in freight rates, the American prints the following summary of what it claims the decision will probably be.

First—Advances will be sanctioned on class rates in Central freight association territory, which is between Pittsburgh and Buffalo and the Mississippi river.

Second—No advance will be sanctioned on commodity rates in Central freight association territory.

Third—No advance will be sanctioned in trunk line territory, which is east of Buffalo and Pittsburgh.

Fourth—The commission will point out to the carriers in trunk line territory how they may conserve their revenues by discontinuing certain practices which now prevail.

Fifth—Pending the outcome of the efforts by carriers in trunk line territory to increase their revenues, the commission will hold open the question of an advance in rates for final disposition.

Sixth—No advance in lake and rail rates will be sanctioned. It is said that the additional revenues which the carriers will receive will be far below the amount they hoped for.

Bones Recall Old Cemetery in City

Water Department Employees Find Pieces of Human Skeleton While Digging Trench on Third Street.

Bones recently uncovered in trench excavation at Third and Pine streets by the city water department were found this morning to be those of a human being. According to City Bacteriologist Pernot the portions of the skeleton found had been in the ground for at least 40 years.

It is not thought that there is any mystery connected with the case, as it is said that a number of years ago a cemetery was located in that section of the city. These bones were the only ones uncovered, however.

The discovery was made by C. Albein, foreman for the water department, when his men a few days ago were digging a trench on Pine street. The bones were found about three feet below the surface of the street.

Professor Pernot, who is in charge of the examination, assisted by Chief Medical Inspector Wolf and Assistant Health Officer Beaman, says the bones have been in the ground for at least 40 years.

INVITE FORMER STUDENTS

The reunion dinner of the Portland Academy Alumni association, which will be held at the Hotel Multnomah at 8:30 o'clock June 25, will be made one of the most brilliant affairs in the history of the academy, as the alumni will serve as a farewell to Dr. J. R. Wilson, who will retire this year, after having served as principal of the academy for a quarter of a century.

All alumni and former students are expected to be present.

Von Klein Welcomes Change.

Salem, Or., June 18.—Smiling and in his usual genial spirit, E. H. Von Klein, convicted bigamist and alleged swindler of women, entered the state penitentiary last night to serve a term of from one to four years. He said he was glad to make the change from the Multnomah county jail to the penitentiary, as he was in poor health and thought he would get better medical attention at this state institution. He said he expected good treatment at the penitentiary. Prison officials said they had not decided what work Von Klein will be given to do.

Judge Benson at Capital.

Klamath Falls, Or., June 18.—In accordance with instructions from the secretary of state the official canvassing board will reconvene this afternoon to make a complete recheck of the Klamath county vote for all candidates for justice of the supreme court. Circuit Judge H. L. Benson who, for over a month, has been seeing-sawing with McNary for the fourth place nomination, left this morning for Salem, following telegrams from the capital. He will remain there until the race is settled.

French Defeat Tribesmen.

Oudja, Morocco, June 18.—With 64 killed and wounded, French troops under General Buge had today defeated the Riatas tribesmen, burned their village and killed and wounded several hundred.

Rate Increase Denied.

San Francisco, June 18.—The supervisors let the Pacific Telephone & Telegraph company abolish certain classes of service on which it claimed it was losing money, but refused to allow it to increase rates.

Cotton Records Broken.

El Centro, Cal., June 18.—All records for early cotton production were broken at Calexico today when Roy Tover, a planter, took the first bale of the season to the gin. Seed will be planted at once in an effort to establish another record by producing a second crop this year.

White Men Fighting With Chinese Bandit

Foreigners with "White Wolf" Would Be Severely Dealt With by Consuls if They Are Caught.

Shanghai, June 18.—That a number of white men are fighting under the banner of White Wolf, the bandit chieftain, was reported here today in messages from Hankow.

There was a fairly thick sprinkling of trained foreign soldiers in both the imperial and rebel armies during the recent revolution and since White Wolf has grown so strong, it was believed some of them had gravitated to his service.

In the rebel army during the revolutionary period these campaigners took pains to call themselves instructors rather than regular fighting men, as they were afraid to incur the severe punishment by the authorities of their respective nations at the treaty ports had it been recognized that they were warring against the Chinese government.

In the present case they unquestionably would be severely dealt with if they fall into their consuls' hands. Several nationalities were said to be represented, including America, by at least one or two members of the "little" corps.

Judging of School Gardens Near End

Committee, Expected to Conclude Work This Afternoon; Prize Gardens Will Be Inspected Tomorrow by Officials.

The judging of the 43 school gardens of the city will be completed late this afternoon by the committee consisting of N. C. Maris, industrial club organizer for the state department of education; Professor Arthur L. Peck of the horticultural department, and Professor A. G. Bouquet, head of the vegetable division of that department of Oregon Agricultural college; Merrill O. Evans Jr., supervisor of garden work, and G. S. Crego, Commercial photographer, accompany the committee.

The gardens are divided into four classes, according to size of gardens and number of years' experience of the school in gardening. Keen competition in all classes for the ribbon awards is reported. The judging is based upon consideration of vegetable growth, freedom from weeds, condition of soil, arrangement of distinguishing features and decoration.

Tomorrow morning a party of state, county and city officials and educators will leave the city for the inspection of the gardens for the annual inspection of the prize gardens. Superintendent L. R. Alderman and Mr. Evans have issued 240 invitations for the trip. Tomorrow noon the party will be tendered a school garden product luncheon by the Washington high school domestic science class.

Poor Lo Defended By Senator Lane

Fixing of Irrigation Costs Would Be Unfair to Indians; Would Not Hit Man When He's Down.

(Washington Bureau of The Journal.) Washington, June 18.—Senator Lane, in championing the capitol bill for the Indians, the Indian appropriation bill being under discussion, declared that unfair advantage is taken of the Indians in fixing irrigation costs and otherwise, and declared he was opposed to passing the bill before the Indians being "on their backs and helpless wards of the nation."

American Goods in Demand.

Washington, June 18.—The state department, announced that inquiries through American consuls by dealers wishing to handle American apples, salmon, preserved fruits, meat and fish are being made.

Urges Passage of Bill.

Washington, June 18.—The Cordova, Alaska, Chamber of Commerce urges on Senator Chamberlain the necessity of passing the coal leasing bill before congress adjourns to facilitate the opening of the resources of Alaska.

Postmaster at Verboort.

Washington, D. C.—Louis A. Le-miller of Forest Grove, has been appointed postmaster of the new office at Verboort.
