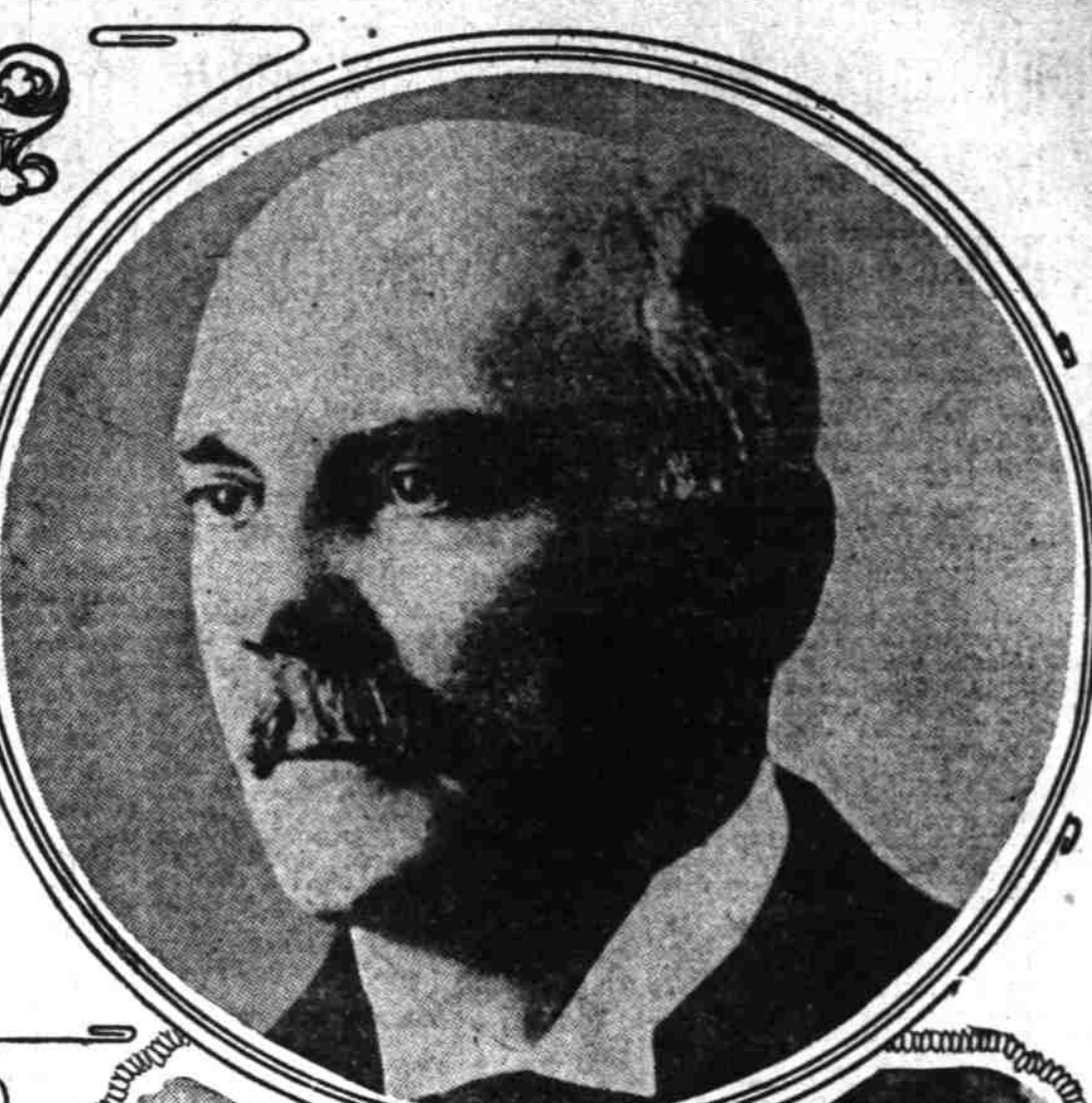
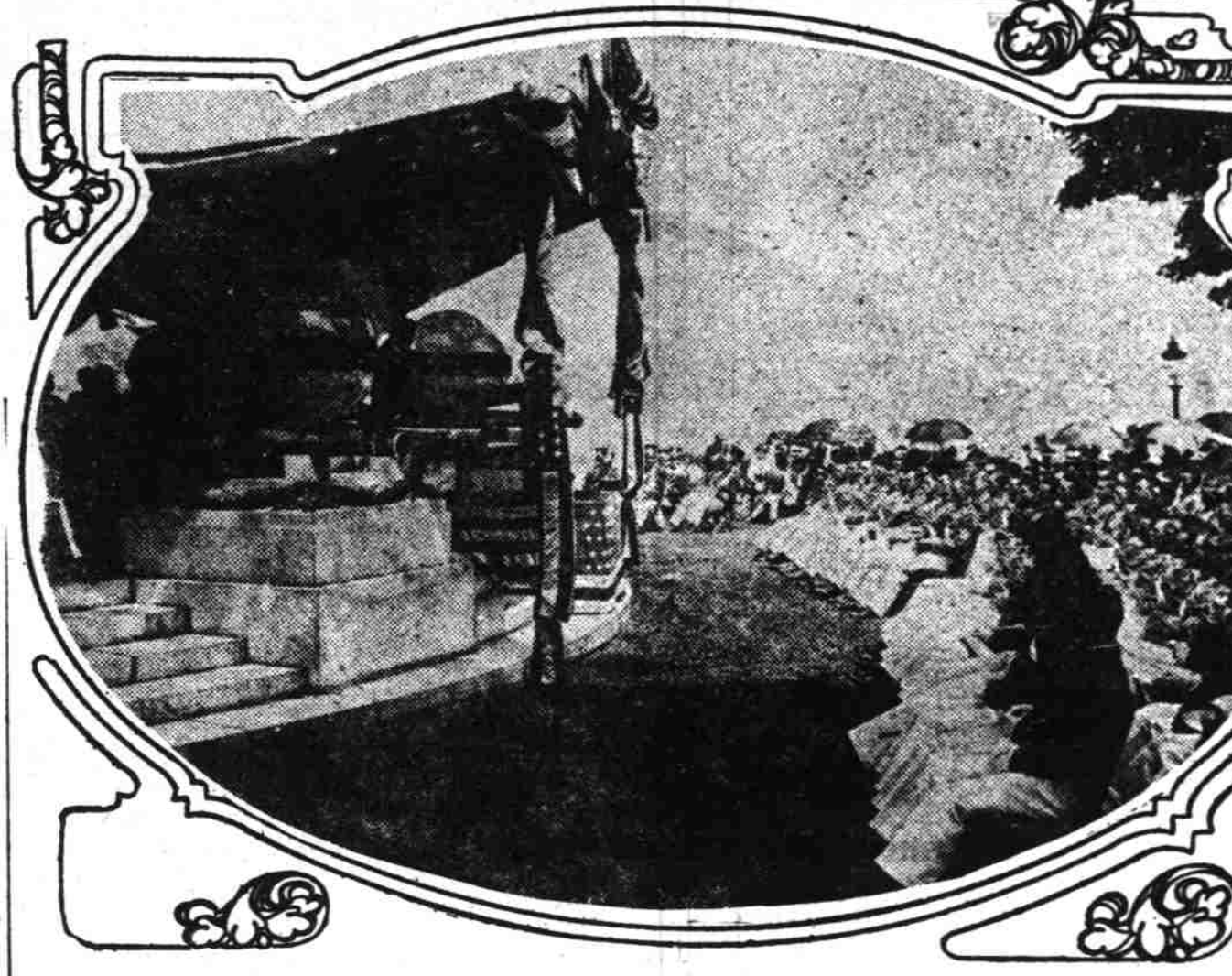
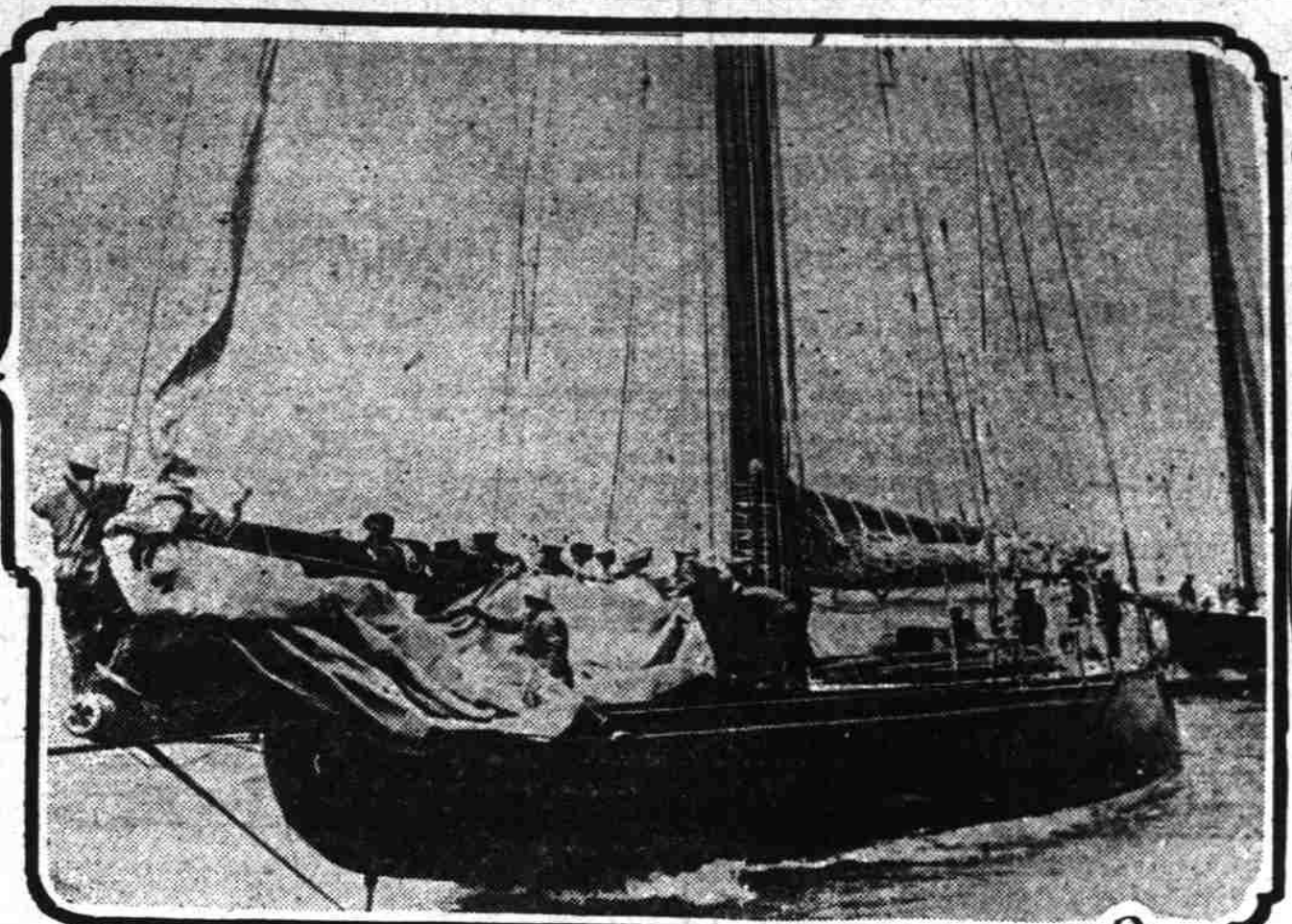
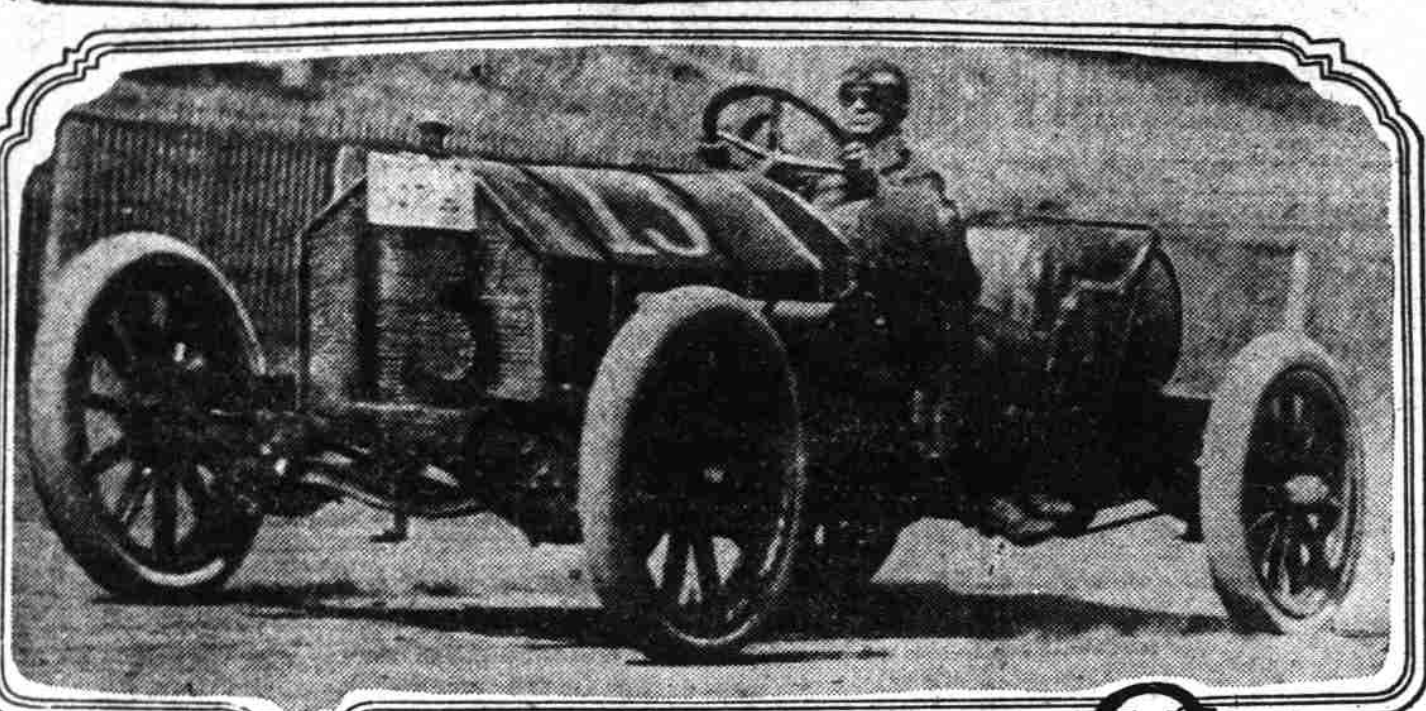


# BRIEF REVIEW OF THE WORLD'S NEWS IN PICTURE AND PARAGRAPH



All the Principal Events of the Week Briefly Sketched for the Information of the Busy Reader — Foreign, Eastern, Political and Congressional News Notes to Be Preserved for Reference.

### Mexican Situation

GENERAL VILLA placed scores of officers of Carranza's army under arrest and sent them to Torreon, and took charge of the telegraph station at Juarez, thus giving rise to the rumor that he had revolted.

Friends of Villa in Juarez deny that he is at the paring of the ways with Carranza. Action in taking over the wire stations with his own men is laid to dissatisfaction with the censorship of news regarding action at the front.

The peace mediators at Niagara Falls were nearly at the point of discontinuing negotiations because of the inability of their plans to select a successor to Huerta that would be agreeable to the rebels.

The rebel forces are claiming that if left alone, they will settle the affairs in Mexico in due course of time. Friends of State Bryan expresses hopes that the peace plans will yet win out. However, he admits that the work of the mediators and peace envoys is hard selling.

The rebel gunboat Tampico was sunk in battle with the federal gunboat Guerrero, and 20 men were killed. The rebel captain and chief engineer of the Tampico committed suicide when he saw defeat was certain, it is said.

Washington authorities are deeply concerned over the report that Villa is in revolt against Carranza and border agents have been instructed to report all details regarding the rumor, they can find.

Peace negotiations between the United States envoys and representatives before the mediators at Niagara Falls is admittedly near failure.

United States is firm in its demand that a constitutional representative be the provisional president of Mexico to hold office until after the general election.

Mexican envoys declare they will not accept a constitutional representative as provisional president in an attack on the federal, but he would aid the rebels by lifting the embargo on arms and ammunition.

President Wilson states, in his answer to the Huertistas letter that his motive in the present settlement is misconstrued.

General Villa, will, it is said, be placed in full command of the rebel forces in their operations against Zacatecas where Natera met disaster.

An unconfirmed rumor was circulated that General Carranza was fleeing to the United States following his break with Villa.

It is reported that 48 of the officers of the Carranza faction had been executed at Samalayuca, 40 miles south of Juarez. It was admitted that the officers were missing.

### Executive

PRESIDENT WILSON named Mrs. Grace B. Calkin, an original Wilson supporter, receiver of public moneys in San Francisco, and John B. Sanford, editor and proprietor of the Ukiah, Cal., Dispatch, was named receiver of the land office in San Francisco.

### Legal and Criminal

IN a quarrel over the payment of a water bill William Betes shot and slightly wounded L. T. Mulvaney, superintendent of the Pacific Power and Light company.

Ten per cent of the more than 100,000 to the state-wide prohibition initiative amendment filed at Olympia, Wash., will be thrown out because of irregularities.

The court martial of J. H. Griffith, United States army paymaster, accused of embezzlement, has been finished at the Presidio and the findings forwarded to Washington, D. C.

Auraurice M. MacManus has filed suit for \$28,000 damages against Frank B. Hax, aged 19, of Los Angeles, Cal., whom he accuses of biting the former's note and calling him vile names.

Eugene Zimmerman, of Cincinnati, father of the duchess of Manchester, was sued for \$100,000 for breach of promise to marry, by Ivy Wareham, a dog fancier of New York.

The estate of the late Adlai Stevenson, which is valued at \$100,000, will be shared by the three children of the former vice-president of the United States. Will filed for probate at Bloomington, Ill.

The degree of doctor of laws has been conferred on General William Crawford Gorgas, chief sanitary officer of the Panama canal and Rumulo S. Nason, Argentine ambassador to the United States and one of the "A. B. C." peace mediators.

An alleged conspiracy to rob grocery stores of goods valued at \$2000 has been barred with the arrest of drivers of scavenger wagons and store clerks at San Francisco.

The case of embezzling \$50,000 preferred against E. F. Green, former president of the Pacific Coast Casualty company, was dismissed at San Francisco because felonious intent was not proved.

### Foreign

SUFFRAGETTES are believed to have been responsible for the explosion of a bomb in historic St. George's church, Hanover Square, London. The famous painting, "The Last Supper," was not injured, although the window above it was splintered.

An attempt was made by suffragettes to burn down the St. Margaret's church at Chifstead, says a report from London. The fire was put out by villagers.

Two of lightning killed six persons, four of them children, at Wadsworth commons, London. Many buildings in South London were struck.

The World's congress of the Salvation Army met at London, more than 4000 persons representing 45 nations and 23 languages, being in attendance.

Regular scale of prices is said to be paid for committing various acts of violence by the Woman's Social and Political Union, of London.

Smashing of a famous picture calls for reward of \$500.

The Hindu held on the Japanese steamer Komogata at Vancouver, B. C., because of the refusal of the immigration authorities to let them land, are said to be facing starvation, and an appeal for aid has been sent out.

The house of commons passed the third reading of the plural bill, which provides for one vote for one man, says a London report.

The British government has ordered a warship to Durazas, Albania, to insure the safety of Prince William and his family. Other nations will send war vessels to the scene, it is declared.
