

GERMANS CHARGE THE FRENCH TRENCHES AS SNOW HIDES ADVANCE

Five Times They Charge at Les Epargnes, Each Time to Be Driven Back.

ATTACK WAS A SURPRISE

French Artillery Wearing Down Germans; Yesterday One of the Quietest Days Since War Began.

Paris, Nov. 21.—Under cover of a blinding snow Germans massed forces in great strength today and attempted one of the most desperate and determined assaults of the campaign about Verdun and St. Mihiel when they charged the French trenches five times in solid ranks within a period of two hours. Les Epargnes in the Woerthe region, was the scene of the conflict.

The attempt was in the nature of a commander apparently depending upon the heavy fall of snow to screen his approach to the French works. But the emergency had been provided for by throwing out more outposts.

The fighting was terrific. Terrific fire was poured into the German ranks and this served to arrest the advance. Where detachments of the attack were able to break through and pour over the outer works they were set upon and either annihilated, beaten back or captured.

Day Was Calm One.

The main facts of this action was all the news contained in the mid-night official statement issued from Bordeaux.

The day was reported about the entire front to have been one of the calmest yet experienced.

Freezing weather prevailed throughout the war zone, the mercury falling as low as 20 degrees above zero.

Heavy snows are reported along the entire front.

The French artillery plainly is wearing down the rival gun detachments. In the afternoon official statement the war office claims the advantage at every point of contact. Intermittent artillery actions are reported from Dixmude to a point south of Ypres and at Neuport the gunnery of the French and Belgians has put many of the German pieces out of action.

Two Attacks Repulsed.

The only infantry movements of importance in Flanders were two attacks of foot troops directed against the French positions at Houleboke, both of which were swiftly repulsed.

Superior positions have been gained by the French artillery corps along the Aisne and the fire of the French gunners has been so accurate that the Germans have been prevented from completing their trenching operations between the two rivers.

German attacks were executed in the morning and the French were forced to withdraw in order to save themselves from being cut to pieces.

Fighting in the Vosges.

The most bitter fighting of the whole battle front is proceeding in the region of Verdun and in the Vosges. Here the French troops have been able to record several advances. As illustrating the desperate nature of the fighting in this district the official statement declares that the French have established themselves at certain points within 30 meters (about 100 feet) from the German positions.

The following official bulletin was issued tonight:

"The day has been exceedingly calm. There is nothing interesting to announce except possibly from the Woerthe district where at Les Epargnes five German attacks were executed in a mass within a period of two hours and were arrested sharply by our artillery fire."

Damage Suit Dismissed.

The suit of J. E. Daigle, proprietor of a Burnside street hotel, against Deputy Juvenile Officer W. J. Jeffries and Special Officer S. B. Sanders for alleged false arrest in which \$10,000 damages was claimed, has been dismissed on motion of Daigle's attorney. Circuit Judge Morrow signed the order of dismissal. No reason was given for the move, but the case was about to come to trial when the motion was taken. Daigle was charged with contributing to the delinquency of two boys and the charges against him were dismissed by District Judge Jones.
