



## FROM SEA TO THE **VOSGES ARTILLERY** CONFLICTS VIOLENT

(By the International News Service.) Paris, Jan. 2.-Violent artillery conflicts have raged along the entire batthe front from the sea to the Vosges during the past 48 hours to the al-most utter exclusion of infantry attacks., So furious have been the bombardments and the reply of the hos-tile guns and at such short range that to send the foot troops into the field of fire at any of the various storm centers of the general battle would be suicidal. Moreover, the open fields over which troops might advance have been turned into great seas of mud, honeycombed with trenches and sap-pers' tunnels and furrowed and blasted by exploding shells until passage across them is almost impossible. Tonight's official statements report a flerce fusillade by the Germans against the allies' earthworks to the east of Vermelles (between Bethune


