

CANNING MAY BE PERMITTED TO WORK TWO MEN OVERTIME

Personal Understanding Reached at Meeting of the Committee at Salem.

MEETING NEXT MONDAY

Twelve Hours for One Shift Plans, Ten for Two, Is Plan That May Be Made for a Compromise.

(Salem Bureau of The Journal.) Salem, Or., Jan. 21.—At a meeting concluded at an early hour today a committee consisting of Father Edwin Y. O'Hara, representing the state welfare commission; L. T. Reynolds, representing fruitgrowers; O. L. McPherson, representing the fruit canners; and Mrs. H. R. Talbot, representing the Consumers' League, a personal understanding was reached in regard to overtime work and arrangements for learners and apprentices in fruit canneries.

The committee decided to consider the points further for a few days and will hold a meeting in Portland next Monday afternoon, when the members hope to reach a conclusion. The members feel confident that a recommendation will be found that will be satisfactory to all concerned. It is practically certain that the committee will recommend that canners will be permitted to work women 12 hours in emergencies.

As the law now stands, women can not be permitted to work more than 10 hours per day no matter what emergency may arise in a cannery, and the canners want to work longer when there is a rush of fruit and it must be handled without delay or it will be spoiled. The appointment of the new committee came at a hearing before the senate committee on horticulture last night, when Senator La Follette bill No. 12, worked so as to wipe out all restrictions as to the hours of labor of women in canneries, was considered. The bill had been recommended for passage and came up for final vote but was referred and the hearing last night was requested by the welfare commission. The bill was opposed by other organizations and individuals who opposed the measure. It developed that the canners and fruit growers had reached an agreement yesterday afternoon to accept a bill modified so as to make the maximum hours of employment 12 hours for women where one shift was employed and 10 hours where two shifts were employed.

Father O'Hara denounced the La Follette bill as reactionary and ineffectual and having no semblance of justice or equity. He declared that the hours of women had been restricted so that their health would be safeguarded and the regulation of hours of employment was based on the belief that the chief asset of the state was the health of the future workers. The health of the future workers, he said, was the chief asset of the state and the health of young women and the health of young men and the health of the state of Oregon should be maintained. He stated that it was planned by welfare commissions to get similar regulations for Washington, Oregon and California.

Father O'Hara's attack on the bill brought a heated reply from La Follette, who declared that he had introduced it in the interests of the fruitgrowers. He declared that the first year after the canners' bill was passed in Salem he received \$1600 for fruit that the year before he could not have sold for more than \$50. He insisted that the present law restricting employment of women was unfair to the canners and reacted on the grower to the extent that he often sustained losses.

Fruitgrowers Made Good? Representative Sam Brown of Marion county, a fruitgrower, asserted that the fruitgrower was the goat of the proposition. He was under the impression that the welfare commission was responsible for the 10 hour law, and had been instructed by his neighbors to "swat it hard."

Carelyn Gleason, secretary of the welfare commission, and O. L. McPherson, superintendent, and some other employees of the Oregon Packing company's plant, and some others, clashed over the earnings and hours of women employees there. Miss Gleason read a list showing that employees got as low as 50 cents a day. She capped some of the canneries for failure to furnish tables and benches at which girls and women could work in any but cramped positions.

Employers Defend Company. W. E. Allen of Hunt Bros., Salem, canners, urged the adoption of the substitute agreed upon by fruitgrowers and cannery owners. George M. Cornwall of The Timberman thought an amicable adjustment should be reached. President Stockton of the Oregon Retail Merchants' association denounced the present 10 hour law as working a hardship on fruitgrowers and canners.

A delegation, consisting of Mrs. H. R. Talbot, Mary Hellman, Mrs. Aron Moore and Miss K. L. Trevell, was present and spoke in favor of retaining the present law restricting women to 10 hours' work. A forlorn and a woman employee of the Oregon Packing company warmly defended the company and stated that women were paid what they earned.

Uniform Branding Asked by Correll

Idea Is to Bring About Registration of Brands to Prevent Cattle Rustling on the Ranges.

Salem, Or., Jan. 21.—Support for Senator Gray's uniform branding bill was urged before the eastern Oregon delegation yesterday afternoon by S. O. Correll, president of the Cattle & Horse Raisers' association. The bill is designed to bring about the registration of all brands to prevent cattle rustling. The office of state brand inspector is created, with county inspectors appointed by the governor.

Mr. Davey suggested that the county court appoint these inspectors rather than the governor, but Mr. Correll protested that this would tend to build up a political machine. The proposed law allows 10 cents a brand for inspectors of cattle coming into the state, while the old law allows a straight salary of \$3 per day.

Taxation matters and bounties for coyotes occupied the delegation most of the afternoon. It was decided to make no recommendation for the reduction of sheriff's salaries with the enactment of the proposed law restoring county assessors the duty of collecting taxes.

FRENCH DRIVEN BACK FROM METZ DECLARE GERMAN IN REPORT

They Announce Recapture of Trenches Lost to French Earlier in the Week.

Berlin, by wireless to Sayville, Jan. 21.—The French offensive against Metz has been halted and rolled back. This was the announcement contained in the official statement issued by the war office today. It added that the Germans had opened a strong offensive northwest of Pont-a-Mousson and had recaptured the trenches lost earlier in the week. Four cannons were taken in this engagement. The government admits that the ground gained yesterday at Notre Dame de Verdun was recaptured by the French. It is a series of strong attacks. French assaults on the German lines northeast of Arras were repulsed. The statement declares, and southwest of Arras the Germans captured two trenches. Fighting continues along the Viatula river especially violent in the vicinity of Ligny where the Russians are attempting to drive a wedge into the German lines and reach the fortress of Thion. The statement says 10 Russian prisoners were captured east of Ligny.

Turks Are Routed. Petrograd, Jan. 21.—The Turkish retreat in the Caucasus is rapidly becoming a rout. The Moslems are fleeing in disorder toward Erzerum and their attempts at the rear guard are being taken prisoners by the pursuing Slavs. The Russian commander is pursuing the enemy relentlessly, hoping to annihilate or completely shatter his forces before Erzerum can be reached.

Russian troops have occupied Ardanutsch, 60 miles northwest of Kars. A Russian torpedo boat has sunk 12 Turkish freight steamers in the Black sea.

Fighting Along Donajec. Vienna, via Amsterdam, Jan. 21.—Several hundred Russians have been captured in fighting along the Donajec river. It was officially announced at the war office this afternoon. The Russian positions were heavily shelled by the Austrian artillery and the Russians forced to retreat to the river.

Arkansas Miners Admit Conspiracy

Seven Union Men Fled Guilty to Federal Indictments Among Them Candidate for Governor.

Fort Smith, Ark., Jan. 21.—Seven union miners pleaded guilty yesterday to federal court indictments charging them with conspiring against the government. Charges against 13 others were returned. The charges were the outgrowth of disturbances following the lockout of miners employed by the Eads-Denman company in the Prairie Creek district. Among those who pleaded guilty today were Fred W. Holt, Socialist candidate for governor of Arkansas in the November election, and Peter Stewart, former district president of the United Mine Workers of America. The sentences will be pronounced later. It was reported that four other union men were taking prisoners from federal deputy marshals, and will appear before the court later and plead guilty. Sententary sentences and fines will be imposed, it was said, upon seven union miners who pleaded guilty.

Medical Bills Not Favored. Salem, Or., Jan. 21.—The house medical committee today decided to report adversely on Paisley's "reciprocity bill," which allows graduate physicians of other states to receive a license to practice in Oregon without examination. It also will report adversely on Hunt's bill requiring physicians' prescriptions to be written in triplicate and to be in the English language.

GAS FRANCHISE BOBS UP AT MEETING OF PORTLAND MEMBERS

Senator Kellaher Brings Up as Bluff, Declares Speaker Selling.

Salem, Or., Jan. 21.—A message from Governor Withycombe recommending the immediate appointment of a joint committee of the house and senate to investigate a proposition to employ convicts of the penitentiary in the flax industry, was read today in the house. I. G. O. Crawford, of Belfast, Ireland, a representative of a large spinning company, is in Salem, according to the message.

HOT WORDS ARE PASSED

Committee of Three Will Investigate and Report on Advisability of Introducing Bill to Repeal.

(Salem Bureau of The Journal.) Salem, Or., Jan. 21.—The biennial agitation over whether action should be taken by the legislature to revoke the gas franchise held by the Portland Gas & Coke Co. thrust itself upon the first meeting of the Multnomah delegation, held yesterday afternoon.

After reports from ex-Governor West and City Commissioner Will H. Daly of Portland, were given, most of the members of the delegation were in favor of dropping the matter. This did not meet with the approval of Senator Dan Kellaher, who was a member of the delegation. He proposed that 10 or 12 years ago, when the city investigated the franchise.

On motion made by Senator Kellaher, the delegation appointed a committee of three to investigate and report on the advisability of introducing a bill to repeal the franchise, on the ground that its conditions have been violated, or to grant an amended franchise, fixing a definite date for its expiration and insert other provisions that usually go into franchises granted by cities at this time.

Selling Quotes West's Report. Discussion over the matter between Speaker Ben Selling and Senator Dan Kellaher became heated. Speaker Selling read the governor's report, in which the governor stated that he had been "unable to gather evidence as to whether the franchise had been violated to support proceedings to declare a forfeiture of the franchise." He said the matter has been brought up in session after session of the legislature. He declared that Senator Kellaher brings it up every session for a bluff.

Senator Kellaher resented this and hot words passed between the two. Representative Horne said the Central Labor Council was interested in the matter and he would like to have the question of the company's right to the franchise any longer settled once and for all time.

Asks for Percentage of Fees. County Clerk Coffey of Multnomah met with the delegation and asked for indorsement of bills providing that the county clerks of the state should receive a percentage of the fees collected by the introduction of bills and money collected for inheritance taxes. He wanted the counties to get 10 per cent, but consented to a cut to 5 per cent.

More Matter of Bookkeeping. Speaker Selling opposed the measure as involving a mere matter of bookkeeping and not worth the trouble to change the present laws. In the course of the discussion reference was made to the bill for the reform of religious institutions. Speaker Selling said he would abolish them if he had his way about it.

Good, I am with you, agreed Senator Farrell. The delegation indorsed a bill to repeal the law requiring a prospective bridegroom to obtain a medical certificate of railway and communications for obtaining a marriage license.

Schuebel Fishing Bill Is in Favor

House Committee Decides to Recommend Measure for Passage; License Fees Will Be Doubled by Law.

Salem, Or., Jan. 21.—The house fisheries committee last night decided to recommend for passage the Schuebel fishing bill. The measure imposes on fishermen using nets and stationary appliances in the Oregon rivers, and the fees exacted of canneries, and the fees exacted of canneries. Convicts May Work At Flax Retting

Governor Withycombe in Message Urges Joint Committee of House and Senate to Investigate.

Salem, Or., Jan. 21.—A message from Governor Withycombe recommending the immediate appointment of a joint committee of the house and senate to investigate a proposition to employ convicts of the penitentiary in the flax industry, was read today in the house. I. G. O. Crawford, of Belfast, Ireland, a representative of a large spinning company, is in Salem, according to the message.

The primary mission of an extended flaxing is to develop greater production of flax, it appearing that the European war has practically wiped out the supplies whence English and Irish spinners have usually drawn their raw material," said the governor in his message.

"A cursory investigation of the subject makes it appear that an important agricultural development may be effected by the introduction of flax, and that in connection with the production of raw flax, a manufacturing industry might be provided at the penitentiary which would give employment to the idle there, with profit to the taxpayers and with general satisfaction."

Idaho Will Vote On Prohibition

Hart Resolution, Providing for Submission of Constitutional Amendment, Adopted in Both Houses.

Boise, Idaho, Jan. 21.—Idaho will vote at the general election in 1914 on the question of forever prohibiting within the borders of the state the manufacture and sale of intoxicating liquors.

The house of representatives of the state legislature today, without a dissenting vote, passed the Hart resolution, which provides for the submission of a constitutional amendment. The same resolution was passed by the senate yesterday. The only member of either house who voted against the resolution was Senator Whitcomb of Lemhi county.

All parties were pledged to the submission of a prohibition amendment. An attempt to repeal the public utility commission act passed by the last legislature was launched in the senate, but the measure was defeated by Representative Johnson of Franklin county, which provides for doing away entirely with the joint public utilities and tax commissions.

Russians Order Cars on Coast

Consul at Seattle Says 15,000 Railway Cars Have Been Arranged for by the Government.

Seattle, Wash., Jan. 21.—"An order for 15,000 railway cars has been placed by my government with Seattle Car & Foundry company," reads an official statement issued today by N. Bogoiavlensky, imperial Russian consul.

While the officers of the company would not confirm the statement in its entirety, they admitted they had been negotiating with the Russian minister of railways and communications for two months, and that they were to confer late today with the local consular in regard to the order. The rolling stock, said to be designed for use on the Transiberian line, will cost more than \$10,000,000. Shipments would be made by the Russian volunteer fleet service, recently established on the sound.

NO TRACE OF SLAYERS

Not the slightest trace of the robbers who shot T. Matsunaga, a Japanese rancher reputed to be wealthy, on a railway one mile from Eighteenth street on the Base Line road last night, had been secured today by deputy sheriffs who are working on the case.

Matsunaga died at St. Vincent's hospital two hours afterwards from the shot that pierced his brain. Two other bullets went through his right leg near the hip.

The shooting occurred upon the return home of Matsunaga and his family. They were traveling in the house and Matsunaga left the wagon and ran to see who was within. Next the shots rang out and three men ran across the road an instant later, disappearing in the brush. Matsunaga was found lying in the bushes about his home, unconscious. BISHOP SUMNER HAS COME TO OREGON FOR WORK NOT TO PLAY

Episcopal Executive Hopes to Put Church in Touch With Social Problems.

Will Begin Tour of Diocese Next Week Reception Tonight Will End a Busy Day.

"Bishop Sumner," said Conductor Grady on the O-W. R. & N. overland train yesterday, "you have entered your diocese."

"Then will you stop your train that I may get off and gather some roses?" "That won't be necessary, bishop," said the conductor glancing at the landscape, which was decidedly frosty, "we gathered them all for you last night."

"That was my real introduction to Oregon," said Bishop Sumner, laughingly this morning as he sat in the study at the home of Dr. A. A. Morrison, rector of Trinity church, where he will be guest for several days.

"And when I entered my room I almost believed that I must give them a happy, now that I am in Oregon I feel a great interest in the work and a zest for the service that will be expected of me. I am in Oregon for life. This will be my home."

Bishop Sumner attended holy communion at St. Stephen's Pro-Cathedral this morning, a most impressive service. After breakfast served to the clergy attending by the women of the church in the afternoon with the clergy of the diocese.

"People are hungry for service," he said to the clergymen. "They want to do things, and we must give them the opportunity they desire."

Bishop Puts Pretense. "I hope to put the church—the clergy and laity—in touch with the social problems of the day," he said, continuing the conversation at Dr. Morrison's home. "I believe we should reach out and mingle with people and have them do good in a way, they will appreciate."

"I shan't assume to know all about the problems of Portland and Oregon until I have been here for some time. I shall make no public addresses until I have familiarized myself with conditions here."

Bishop Sumner used a phrase which better than anything else reveals the character of the man. "I hate pretense, sensationalism and playing to the galleries. The man who knows his duty and is conscious he knows it all is a public menace."

There will be a reception in honor of Bishop Sumner this evening from 8 to 10 o'clock at the Multnomah hotel. Next Sunday at 11 a. m. he will preach at Trinity church. February 4 there will be an informal layman's banquet in his honor. The place is yet to be announced. He intends to begin a tour of the churches and missions in the diocese next week.

Not Here for Vacation. "I am here for work," he explained. "I need no time for rest. For three years I had not had a vacation and I do not intend to make my coming to Oregon a vacation."

Bishop Sumner's promised study of local conditions will undoubtedly include attention to subjects with which he was closely connected in Chicago—organization of voters for clean administration of public affairs, housing and employment problems, public health, sanitary inspection, playgrounds, parks and city plan, public schools and juvenile courts, and, not least, charitable organization. He was chairman of the committee on investigation of the United Charities in Chicago and no man has had broader experience in aiding the needy than he has.

INCREASE OF SCHOOL TERM

Salem, Or., Jan. 21.—Miss Marion B. Towne, representative from Jackson county, yesterday introduced her second bill before the house. This measure is designed to increase the minimum term of school from six to eight months, chiefly for the benefit of the country districts.

Increase Is Asked In Compensation

Three Amendments to Workmen's Act Submitted to House This Morning; Privilege of Response to Sen Is Taken

Salem, Or., Jan. 21.—Three amendments to the workmen's compensation act were submitted to the house this morning in two bills introduced by Representative J. Ervin Lincoln and Representative Thomas Brown of Marion.

The first bill provides that when injury or death comes from the intentional failure of his employer to provide suitable safety appliances, the dependents shall be paid 50 per cent increase over the benefits allowed by the present law. This to come out of the funds of the employer.

Another amendment provides that if injury or death comes from the deliberate intention of the workman, his dependents shall have no recourse under the act. The part of the section in the present law allowing dependents to sue independently of the act in cases where the intention is deliberate on the part of the employer, is repealed.

The amendment introduced by Representative Brown repeals the right of the employer to bring suit under the law for an injury.

MOSES WAS GREATEST PROPHET WHO EVER LIVED, AVERS BULGIN

Evangelist Also Lauds Famous Character as Statesman, Doctor and Lawyer.

Moses as a statesman, a prophet and one of the greatest characters in human history, was the theme for the address of Evangelist E. J. Bulgin at the Belmont street tabernacle last night.

It was Jesus Christ himself, asserted Bulgin, who first pointed out Moses as a character containing enough to convince the world of the need of preparedness for death.

"Moses, who was the greatest prophet that ever lived," said the evangelist, "put false ideas into the mind of the Christ child who was born of woman and not of man. He foretold the entire circumstances that surrounded the 33 years of Christ's life. He told us that the Jews would become a scattered nation. He told us that God would hold universal sway over the nations of the world."

"Didn't Moses tell the truth when he wrote those things?" "Moses was scientific when he said families that put false ideas into their children would suffer to the fourth and fifth generations?"

Moses headed the list of greatest literary geniuses of the world. Spencer says the Bible takes no cognizance of the five creative periods. Herbert says there was the creation of time, space and matter. The Bible answers him in Genesis 1:1. In the beginning (that's time), God created the heavens (that's space) and the earth (that's matter), and the Spirit of God (that's force) moved (that's motion) on the face of the earth."

SALARY CUT IS OBJECT OF BILL

Salem, Or., Jan. 21.—Senator Robert S. Farrell introduced a general salary reduction bill this afternoon. It provides that on and after July 1, 1915, and extending for a period of two years, the salaries of all officials and employees of the state, and county officials and employees, who are at present receiving a salary of \$3000 or more, shall be uniformly reduced 20 per cent.

NAVAL MILITIA WILL PROBABLY BE SAVED BY SUBSTITUTE BILL

Majority Report of Senate Committee on Military Affairs to Decide Question.

APPROPRIATION REDUCED

BILL RELATING TO REGULATION OF ZIMMERMAN IS RE-SUBMITTED TO THE COMMITTEE.

(Salem Bureau of The Journal.) Salem, Or., Jan. 21.—The fight to abolish the Oregon naval militia will revolve around the majority report of the senate committee on military affairs, which likely will be submitted to the senate this afternoon with a substitute bill for the one introduced by Senator Dimick.

Senator Dimick's bill provides for the abolition of the naval militia. Senators Farrell and Burgess, a majority of the committee, shall introduce, oppose this and have prepared a substitute bill. Senator Vinton, chairman of the committee, favors the Dimick bill.

This substitute bill reduces the membership of the naval board from five to three members. It provides that the board shall consist of a member and president of the board. At present he is not a member of the board. The bill carries an appropriation of \$1500 a year for 1915 and 1916. In the budget the naval militia asked for an appropriation of \$26,000 for the two years.

Senator Farrell said he was opposed to the abolition of the naval militia, as he thought eventually the militia would be granted the battleship Oregon as a training ship, and that it would mean much to the state to have the ship.

Senator Dimick's bill was up for the third reading yesterday afternoon, but, owing to a mix-up in parliamentary rules, it was re-submitted to the committee to give opportunity for the majority members to report a substitute bill.

Suspecting that there were jokers in senate bill 62, to provide for the licensing and regulation of embalmers, the senate yesterday afternoon declined to take final action on the bill and had it resubmitted to the committee. Senator Moser pointed out a provision which he said would be interpreted to mean that nobody could be buried 30 hours after death without being embalmed.

Senator Day objected to the reference made in the bill to livestock, saying that there were enough laws on the statute books now relating to that subject.

The senate voted down a memorial submitted by the legislature of Wisconsin, asking the national congress to submit a constitutional amendment making polygamy unlawful, and giving the federal government exclusive jurisdiction over the enforcement of the law against it.

Senator Butler declares that existing laws were ample to suppress polygamy. After the roll call was taken Senators Ragdale, Barrett and La Follette, the majority of the memorial, changed their votes to no. This left only 12 affirmative votes.
